## DIRECTIONS FOR USE:

### RESTRAINTS

DO NOT apply to a ground surface which is wet or to areas that are washed.  
DO NOT allow product to directly contact humans, pets, exposed food, food preparation areas, food utensils or food packing materials.

### SITUATION

Commercial, Industrial and Residential Buildings including food processing premises.

### PEST

German and American cockroaches.

### RATE

Apply as a 5 mm (0.1 g) diameter bait spot. Apply 2 bait spots per m<sup>2</sup> and up to 5 spots for heavy infestations.

### CRITICAL COMMENTS

- Inspect premises thoroughly and locate all cockroach harbourages.
- Place ZENITHOR bait spots as close as possible to cockroach harbourages.
- Place bait spots into cracks and crevices away from where they are likely to be removed by cleaning programs.
- When placing baits remember that the label refers to the full surface area that the cockroaches are likely to traverse e.g. in a kitchen allow for the full surface area of each bench, cupboard, etc.
- Good hygiene is essential in any pest management situation. Encourage the removal of other food materials.
- Do not use chemical sprays near baits.
- In areas of poor sanitation use more bait placements.

### RETREATMENT:

In areas of high activity the bait may be consumed and further placements needed. Schedule a second inspection about a month after the initial treatment. Retreatments only need to be applied in areas where cockroaches remain or are likely to enter a premises. ZENITHOR is very stable; it does not harden or lose its attractiveness to cockroaches. Only reapply baits when the original bait has been consumed.
