## **DIRECTIONS FOR USE**

Chemwet 1000 can be used where the addition of a Surfactant is required or recommended on the agricultural chemical label. Variations in conditions of use can require some changes in the amount of Chemwet 1000.

## **GENERAL INSTRUCTIONS**

**NOTE:** Where product labels recommend the addition of a non-ionic wetting agent as a percentage (%) dilution, add 100mL Chemwet 1000 per 100 litres of spray mixture to give 0.1%, 250mL/100L to give 0.25% or other rates as required using these examples.

## MIXING

Add Chemwet 1000 into the spray tank last, after a good emulsion is formed.

Harmful to fish. DO NOT contaminate ponds, streams, rivers or waterways with chemical or used containers.

## STORAGE AND DISPOSAL

KEEP OUTOF REACH OF CHILDREN. Store in the closed, original container in a cool, well ventilated area. DO NOT store for prolonged periods in direct sunlight. Triple or preferably pressure rinse containers before disposal. Add rinsings to spray tank. DO NOT dispose of undiluted chemicals

on-site. If recycling, replace cap and return clean containers to recycler or designated collection point. If not recycling, break, crush, or puncture and deliver empty packaging to an approved waste management facility. If an approved waste management facility is not available, bury the containers below 500mm in a disposal pit specifically marked and set up for this purpose clear of waterways, desirable vegetation and tree roots, in compliance with relevant Local, State or Territory government regulations. Empty containers and product should NOT be burnt.

## Envirodrum 110L Mini Bulk Returnable Container

Store the original sealed Envirodrum in a cool, well ventilated area. DO NOT store for prolonged periods in direct sunlight. DO NOT tamper with the Micro Matic valve or the security seal. DO NOT contaminate the Envirodrum with water or any other foreign matter. After each use of the product, please ensure that the Micro Matic coupler, delivery system and hoses are disconnected, triple rinsed with clean water and drained accordingly. When the contents of the Envirodrum have been used, please return the empty Envirodrum to the point of purchase. The Envirodrum remains the property of Nufarm Australia Limited.

#### Refillable Containers (1000L)

Store in the closed, original container in a cool, well-ventilated area. DO NOT store for prolonged periods in direct sunlight. Empty contents fully into application equipment. Close all valves and return to point of supply for refill or storage.
