An introduction to Scotland's national third sector intermediaries

What do intermediaries do?

Intermediaries are third sector organisations (TSOs) whose members are other TSOs and whose role is to support and represent those members.

Representation & policy influencing

"Most of our members are not 'policy people' – they just want to deliver a good service locally to the people that rely on them" (Intermediary body)

Intermediaries inform members about current policy issues and identify emerging issues, facilitate discussions, agree shared policy positions, and communicate these views to policy makers in Scottish Government, Scottish Parliament, and local authorities etc. Raising the profile of their members and the impact of the work they do is part of this influencing role.

Campaigning work is often the driver for an intermediary being set up, when a gap or need is identified, for example:

Several conservation, landscape and recreation bodies got together in 1980 to challenge a proposed ski development in the Highlands.

The campaign showed that "by acting together, the various objecting bodies had been much more than the sum of their parts"

Environment LINK Scotland was founded in February 1987 to facilitate future joint working

Communication & networking

Intermediaries provide communication and information channels and facilitate networking.

40,000+

voluntary organisations

are active in Scotland today. These thousands of groups are supported by a strong network of intermediaries.

60 national intermediaries

represent groups of organisations working in the same field, such as youth work, arts, health or heritage.

Scotland's intermediaries directly reach thousands of member organisations and indirectly support many thousand more organisations and individuals across Scotland.

Intermediaries are also called umbrella bodies, membership bodies. or network bodies. Most are membership bodies, which support and represent other voluntary organisations that all work in the same field.

A recent survey of 20 intermediaries found that they collectively reach thousands of people and organisations through events, meetings and various media.

Information & support

Intermediaries provide a range of practical support services, from general information and signposting to direct services such as members' helpline, payroll, finance, HR and IT.

Organisational development & capacity building

Many intermediaries provide organisational and staff development support, including support with business planning, funding and tailored training for staff.

Intelligence & evaluation

Intermediaries help develop the evidence base for policy and practice, such as the recent Social Enterprise Census to map and understand social enterprise. Many support members with research, monitoring and evaluation.

Promoting good practice

Intermediaries facilitate the sharing of good practice among members and highlight best practice from elsewhere. This can include training programmes and toolkits for members, and setting agreed quality standards.


Why has the role of intermediaries become more important?

- The third sector has grown in recent years, with voluntary organisations working in more spheres and delivering more services across Scotland than ever before. The sector's turnover reflects this, more than doubling from £2billion in 2000 to nearly **£5billion** in 2015. As voluntary organisations become larger and more professional, the level of support they require to keep themselves abreast of new developments increases.
- The Scottish Parliament brought a new emphasis on **policy and development**, with more opportunities for the sector to provide briefings, evidence to committees and influence policy.
- The Scottish Government has been keen to develop policy collaboratively with the sector e.g. via meetings and consultations, and has been very supportive of the role of intermediaries including funding the work of many intermediary organisations.
- Intermediaries work. They help organisations achieve more than they could on their own, provide tailored support and information, and help keep costs down by offering shared services that stop wheels having to be re-invented by individual organisations. They can push forward on shared agendas while member organisations focus on their own specific priorities.

What is the reach and impact of an intermediary?

Some intermediaries support hundreds of groups. Others provide tailored support to a small number of organisations. But all intermediaries indirectly reach beyond their direct members to thousands of local communities and individuals across Scotland. See some examples on the next page...
