Minutes of Meeting:

1. SEADOM information sharing

CEO welcomed SEADOM members to the annual General Assembly.

1.1 President's Report

1.1.1 President was heartened to see SEADOM's continued international engagement through events, and the diversity of inputs and interaction developed over the last decade. This was particularly evident in the 30 under 30 presentations this week. It has also been heartening to see the degree of on-line interaction over the past twelve months.

1.1.2 President would like to advocate for continued connections with SEADOM schools and events that SEADOM would support.

1.1.3 Call for more institutions to support SEADOM initiatives as part of their own strategic plan (as with Mahidol & YST Conservatory at present).



- 1.1.4 Reflecting on last year's meeting, 2022 was projected to be held in Cambodia. Meeting clarified that in view of ongoing COVID situation and in managing post-COVID challenges, the meeting would be planned to be held in Bangkok.
- 1.1.5 Meeting acknowledged the developing situation in Myanmar and SEADOM sends thoughts to members there.

1.2 CEO Office Report

CEO acknowledged the work of SEADOM administrative officers including the graduate assistants for their continued work. He also thanked the Assistant Dean of International Relations at Mahidol for her work in supporting SEADOM administration.

Newsletter/social media contributions including events notification would be welcomed from members.

1.3 Membership Info

CEO shared that membership numbers remain healthy. There are 85 members from 24 countries (as of January 2021).

2.1 SEADOM Fiscal Information 2021
