

Andrew C. Billings (Ph.D., Indiana University, 1999) serves as the Associate Dean for Faculty in the College of Communication & Information Sciences, co-director of the Beyond Sports Initiative, and the Ronald Reagan Endowed Chair of Broadcasting at the University of Alabama. Previous administrative experiences range from direction of a campus-wide communication center to founding director of the Alabama Program in Sports Communication.

Having authored 27 books and over 280 journal articles and book chapters, he is the most published sports media scholar in the world. His work has been cited over 11,000 times, largely focusing on issues triangulating sport, media, and issues of identity. He is the Editor-in-Chief of the prominent academic journal Communication & Sport, member of the Digital Cultures & Sports Research Laboratory at the University of Salerno, and has been interviewed over 700 times by news outlets including The New York Times, Associated Press and ESPN.

Billings has studied sports media phenomena in over 20 nations, earning over 60 awards from the International Communication Association, National Communication Association, Broadcast Education Association, and Association for Education in Journalism & Mass Communication. He is a Fellow of the International Communication Association and North American Society for the Sociology of Sport. He also is a former Visiting Chair of Olympism at the Autonomous University of Barcelona and a past Research Symposium Chair for the Broadcast Education Association. In 2025, he was given the Lifetime Achievement in Scholarship Award by the Broadcast Education Association.

Dr. Albert D. Pionke is the Associate Dean of General Education and Academic Affairs at the College of Arts & Sciences and the William and Margaret Going Endowed Professor of English. As Associate Dean, his responsibilities include leading all aspects of the college's response to the first revision of the general education curriculum at UA in over forty years, overseeing the college-level academic misconduct, grade change, academic grievance, and undergraduate program review processes, and coordinating the college's response and public statements of principle with respect to the use of GenAI in teaching and research.

Pionke has previously served as the Assistant Dean for General Education, the Director of Undergraduate Studies and the Assistant Chair, the latter three different times, for the English Department, and the leader of several sensitive administrative tasks at the college and university levels at UA, and the Secretary, Vice-President, President, and Executive Board Member for the Victorians Institute, as well as Editor of the Victorians Institute Journal and Digital Studies in Language and Literature. He was the 2024 recipient of UA's Blackmon-Moody Outstanding Professor Award.

Cassander L. Smith is the associate dean of academic affairs for the Honors College, which serves more than 7,000 students. In this position, she oversees the college's academic operations to ensure that course offerings meet the needs of students and faculty. Her work includes supervising the college's academic advising team and registrar, ensuring compliance with academic procedures and policies, and maintaining the College's handbook. She also manages faculty affairs, which involves professional development and annual evaluation for the college's 12 full-time faculty and 30+ part-time instructors. In addition, she serves an external-facing role for the college, building and maintaining cross-campus and other external partnerships. Prior to serving as associate dean, she served two years as the Provost Faculty fellow for diversity, equity, and inclusion. She worked to improve the University's diversity infrastructure with a specific focus on teacher training.

Her research focuses on race, literature and the transatlantic slave trade. She has written two books, Black Africans in the British Imagination: English Narratives of the Early Atlantic World (LSU Press, 2016) and Race and Respectability in an Early Black Atlantic (LSU Press, 2023) and co-edited several volumes, including one focused on pedagogy and race, titled Teaching with Tension: Race, Resistance, and Reality in the Classroom (Northwestern University Press, 2019). She earned her B.S. degree in newspaper journalism from Florida A&M University, a historically Black university in Tallahassee, Florida, and earned a MFA in fiction and a PhD in literary studies, both from Purdue University.

Professor Gregory B. Thompson serves as the Executive Director of the Alabama Materials Institute (AMI), one of five cross-cutting institutes for strategic research investment by the University of Alabama. AMI facilitates interdisciplinary materials research with faculty, staff, students, and external stakeholders that advances new material types, understanding of their fundamental properties, and the development of novel synthesis, fabrication, and manufacturing processes. Thompson oversees two major user facilities within AMI, the Core Analytical Facility, which houses analytical instruments that characterize the chemical structure of materials, and the Powder Processing Facility, which enables novel alloys and ceramics to be made and consolidated. Thompson leads a team of eleven full-time AMI staff members who provide training to more than 100 users per year of AMI's instruments, with other team members translating applied research programs with the Army Research and Air Force Research Laboratories as well as state, regional, and national industrial partners.

Before his appointment to AMI, Thompson served as the Director for the Interdisciplinary PhD program in Materials Science (2012-2023), where he led an increase in the graduate enrollment from 9 to more than 40 students during his tenure for a program that involves more than 10 academic departments within three colleges. He is recognized as a Distinguished University Research Professor for the UA System and has held the James Cudworth Chair in Engineering.

Dr. Jacquelyn Mosley is a Professor and the Associate Dean of Bumpers College at the University of Arkansas. She served as Assistant Dean from 2022-2025. Her primary research appointment has been with the Division of Agriculture for the past 15 years focused on issues related to interpersonal relationships and cultural competence.

She has received several national research and teaching awards, including the National Agriculture Experiment Station Award (2023), APLU's USDA National Teaching Excellence Award (2022), and the national Cognella Innovation Teaching Award in Family Science (2019), and both the University of Arkansas Teaching Academy New Fellow and Jack G. Dr. Chase Rainwater is Professor and Department Head of Industrial Engineering at the University of Arkansas. Rainwater holds a Ph.D. in Industrial and Systems Engineering from the University of Florida and a B.S. in Industrial Engineering from the University of Arkansas.

Rainwater has secured over \$20 million in research funding from agencies including the National Science Foundation, U.S. Department of Transportation, Walmart Foundation, and Department of Education. His collaborative efforts have advanced food supply chain safety, autonomous systems, and computational optimization.

Rainwater has engaged in multiple leadership roles, including serving as Department Head for Industrial Engineering for the past two years and Associate Department Head for three years prior. He directed the J.B. Hunt Innovation Center of Excellence for six years and has co-directed the Arkansas Security Research and Education Institute for the past seven. He is the chair of the University of Arkansas Artificial Intelligence Task Force. He is serving as the Provost's Fellow, leading efforts in integrating artificial intelligence into the academic and operational campus missions.

Rainwater has advised numerous graduate theses and dissertations and consistently earns top teaching evaluations. He was recognized as a Fellow of the Institute of Industrial and Systems Engineers and the University of Arkansas Teaching Academy.

Rainwater is also engaged in service leadership in his professional societies, having chaired the IISE Board of Trustees Scholarship Committee and the INFORMS Doing Good with Good OR Committee. In addition, Rainwater was co-Chair and General Chair of the IISE annual conference.

Dr. Marc A. Scott currently serves as the Associate Department Chair of the JB Hunt Transportation Department of Supply Chain Management in the Sam M. Walton College of Business at the University of Arkansas. Scott is also an Associate Professor of Practice in the department. As Associate Department Chair, Scott is responsible for the oversight of the teaching, research, service and outreach activities of the department which includes both traditional and online bachelor's and master's programs in supply chain management, hybrid and executive graduate programs, a doctoral program, and a research and outreach center. Scott also works with college or university administrators to leads or coordinate various college- and university-wide efforts to develop and implement innovative educational and research programs and partnerships with governmental, private sector or other stakeholders.


Xiao Qin is a Professor and Director of Graduate Programs in the Department of Computer Science and Software Engineering. Since joining Auburn in 2007, his research has centered on big data, parallel computing, and storage systems, resulting in 361 publications in top-tier venues such as IEEE and ACM Transactions. His work has garnered 10,664 citations, reflecting its broad impact in the computer science field. As PI or co-PI, Qin has secured more than \$10 million in external funding, including an NSF CAREER Award.

As a dedicated educator, Qin has graduated 36 doctoral students including an NSF CAREER awardee, two GEM Fellows, and three Distinguished Dissertation winners. His teaching excellence has been recognized with the William F. Walker Teaching Award in 2023. As Director of Graduate Programs, he expanded Ph.D. enrollment from 48 to 129 students. Qin also drives graduate curriculum innovation by leading the graduate faculty to develop master's degree program in AI Engineering and master's degree program in data science and engineering.

Qin serves on multiple committees at various levels, including the Samuel Ginn College of Engineering's Graduate Student Professional Development Committee, the University Senate's Faculty Grievance Committee, and the CSSE's E-Day Committee. By bridging academia and industry, Qin positions Auburn University at the forefront of technological innovation and graduate education.

Her background as a TV reporter and producer, where she collaborated with international colleagues and successfully managed multi-sport productions and tight deadlines, has proven to be a valuable precursor to her academic career. During Coche's tenure as chair, the MPMT department has created new media-related hands-on experiences for students, established a minor, experienced an increase in student enrollment, and overhauled its curricula.







As associate dean, Fales leads a team of staff that provide academic advising, recruitment, career services, scholarships, and support for high impact practices such as student organizations and undergraduate research for over 3000 undergraduate students with increasing enrollment and high retention rates. He has led efforts and built a team that implemented a new first-year engineering program with a two-course instructional sequence and a peer mentoring program that engages over 600 engineering students each semester resulting in retention rates that are higher than campuswide average for Mizzou.

His primary research focus is on robust control design and stability of dynamic systems with applications in fluid power, respiratory support and the dynamics of blood oxygen saturation in premature infants. His work resulted in a device that automatically controls the oxygen concentration in air for non-invasive respiratory support for premature infants. The device was successfully tested in a clinical trial completed in 2024.

As Director of the School of Languages, Literatures, and Cultures (SLLC) at the University of Missouri, Professor Megan Moore has led a profound cultural transformation within a newly merged department. Deploying a collaborative leadership style to achieve her structural vision, she prioritized establishing trust and cohesion across distinct work cultures. With transparency and deep listening as foundational principles, Moore led the School in articulating a new collective identity grounded in inclusivity, shared governance, and academic excellence.

Her most significant accomplishment in this area was the development and passage of new School bylaws, a process that involved skillfully facilitating dialogue across multiple units with divergent histories, power structures, and priorities. Through a series of inclusive town halls, working groups, and open feedback mechanisms, she guided faculty and staff through difficult yet productive conversations, culminating in a unanimously approved governance framework. Central to this transformation was a strategic shift in communication norms: Moore implemented regular, transparent updates; created channels for anonymous feedback; and established equitable, rotating leadership roles to ensure broad participation in decision-making. She also nurtured a culture of belonging, emphasizing equitable workload distribution, recognizing hidden labor, and integrating diversity and inclusion into all aspects of departmental life.

Her leadership has not only stabilized and unified the School but has laid a foundation for sustainable growth and morale and helped the unit's contributions to—rather than its dysfunction within—the larger institution to become seen and valued. Moore's work offers a model for culturally sensitive academic leadership in complex institutional landscapes.

For the past five years (2020-2025) Dr. David Schulz has served as the Director of the Division of Biological Sciences and has recently become the Director of the Interdisciplinary Neuroscience Program at MU. Biological Sciences at MU has over 1100 undergraduate majors, 41 full-time faculty, and currently trains about 60 graduate students and 12 postdocs. In FY25 it generated over \$3m in research expenditures and submitted over \$50m in proposals for external funding.

As the Director of the Interdisciplinary Neuroscience Program Schulz oversees a PhD program of approximately 32 students as well as coordinate the activities of over 50 faculty in 7 different colleges on the MU campus towards interdisciplinary research ventures and training.




