7.1 In October 2024, Hastings Technology Metals Ltd entered into a \$5,000,000 unsecured Loan Notes with Equator Capital Management Ltd with the drawdown of loan notes and funds settlement also completed in October 2024.		
7.3 Redeemable exchangeable notes - In October 2022, \$150,000,000 in secured, redeemable exchangeable notes were issued, convertible into ordinary shares of Hastings Technology Metals Ltd at an adjusted exchange price of \$4.91/note at the option of the holder, Wyloo Consolidated Investments Pty Ltd. The notes mature 11 October 2025, with interest accruing at the rate equivalent to the 3-month BBSY plus 9% per annum and to be paid-in-kind via the issue of additional notes on a quarterly basis subject to a cash payment election. To date \$49,718,212 in interest has been paid-in-kind.
