Agenda Review

Staff Report

Events

- NANOG 88 total registration numbers were reviewed
- NANOG 88 meeting space - Additional spaces were set aside for:
 - Network Lounge
 - Meet Me Room
 - Ombudsman space
 - Two additional rooms for premium sponsors
- NANOG 87 Survey Results - Survey results were shared with the board.
- Future of SEL
 - New agreement with the Ombuds has been negotiated and signed.
 - No RFPs were sent but agreement is for 3 years so set for a while.

Reviewed the financials around sponsorship sales with the board.

Financials

- NANOG 87

- Reviewed the budget and final numbers for N87
- First Quarter 2023
 - Reviewed the first quarter financials.
- Audit Status
 - Draft audit report has just been released, the audit committee will meet with the auditors soon.
- Investments
 - Edward, David and Claudia met with IEQ (our investment advisors) for their assessment of NANOG's portfolio.
 - Suggestions from the meeting around optimizing the investments were shared with the board.

Alternative Funding

- Edward is working with potential new sponsors for the education program.
- The board discussed the current scholarship program.
- Additional leads are being researched for funding.

Development

- There is a pause in development projects to focus on UI cleanup and refinement.
 - Bootstrap to tailwind and a newer version of Python makes the website faster.
- Still plan to deliver v1 of the Appointment Tool for NANOG 88.
 - Beta testing is still ongoing but limited, so seeking further feedback from the community.
- The Sponsorship tool is being delayed until after NANOG 88.

Outreach

- We will support both ABQNOG and CHI-NOG by promoting them on our events page, newsletter, and social media.
- Edward to attend ABQNOG and Vincent to attend CHI-NOG.
- NANOG updates will be presented at both events.
- NANOG will be hosting the virtual portion of ABQNOG's event.

Community

- Newcomers make up about 25-30% of NANOG conference attendees.
- Stats were provided for newcomers from NANOG 82 - NANOG 87.
- Not surprisingly, the highest percentages were male, senior engineers in service providing companies.
- Of those reporting, 13% listed female as their gender.
- The stats are similar to the overall industry.
- Additional reports will be created by Greg to keep track of trends and demographics.

Review and Vote on Election Committee's proposal for ranked choice voting:

The Election Committee has met a couple of times but most of the work was done by last year's committee. The discussion has centered around Ranked Choice Voting.

- NANOG uses the Simply Voting platform which has ranked choice voting options with default settings which seem to work well.
- The committee recommends ranked choice voting with the default settings making it easiest to understand for the voter and staff.
- Their specific choice is what is called the preferential question type with single transferable vote counts.
- The PC has been using a similar option for 2 years now and they support it.
- **MOTION:** The board voted to approve for one year, the Simply Voting Rank Choice Voting methodology as recommended by the Elections Committee. The motion passed unanimously.

Committee Updates:

DEI

- Contracted with Spheres for a 100 person event planned for Women in Tech.
- The committee is consulting ombuds to assure they are staying inclusive.
- Budget money was requested for a scavenger hunt and the request will be reviewed before a future vote to see if there are funds available.
- Free alternatives would be table topics at lunch and organizing events for the affinity groups.

Education Committee

- No major changes for N88.
- DNS tutorial will again be done by Eddy Winstead with updated presentation materials
- The committee is looking to add an automation class for a fall NANOG.

- A class on the Fundamentals of Designing and Deploying Computer Networks is being offered and to open sometime in May.

Mentorship

- Most mentees and mentors have now been matched.
- Staff is working on an ambassador draft program to present to the committee.
 - Designation of an ambassador to be printed on the badges.
 - They will be present at the newcomers meeting.

Scholarship

- The committee is going through the candidates recently received from Scholarship America.
- Top choices will be selected by Memorial Day.
- After N88 in June, the committee plans to do some research on ROI of prior recipients.

Program Committee

- The deadline for slides was just the past Monday so there are many talks in the hopper.
- Currently at 70 talks total submitted, 22 pending, 20 being voted on, 18 accepted and 2 deferred.

Elections

- The committee would like some time to explain the new voting system and tutorial at the Membership meeting.

Other Business:

- Confirmed that the Seattle NANOG 88 board meeting would occur on Sunday, June 11th. The formal meeting will run from 1pm to 5pm PST.
- The chair confirmed that the next boarding meeting would take place at 12pm EST on May 19th, 2023.
