### Agenda Review:

# PC Update:

The PC has recorded 30 percent of talks, with the remainder scheduled for next week. Staff created a new design layout for the recordings to provide more clarity and cleaner appearance.

### **Election Committee update:**

 Review and approve ballot - Valerie sent the proposed ballot and a test voting option to the Board. Sean submitted a test ballot, and it had worked well. He noted that the user cannot change a vote once cast, but this is made clear. The Board approved the specific text of the ballot for submission.
