# Fee Harmonization Updates

**Feedback results continue to be positive and continue to allow ARIN to interact with customers in ways we may otherwise have not been able to**

# Fee Harmonization Updates

Fielding questions has provided unique opportunities for ARIN to collaborate directly with our customers

- Consolidate customer organizations - get a lower total invoice for same services!
- Provide more detail for the enhanced services that are provided under the RSP fee schedule (IRR, RPKI, DNSSEC)
- General education
- Customer Data cleanup

# 2022 Membership Structure

- Service Members (NEW for 2022)
  - Service members are entities that have a valid ARIN Registration Services Agreement (RSA or LRSA) for IPv4 and/or IPv6 address space.
  - If they meet eligibility requirements they may receive General Member status upon request, allowing them to participate in ARIN Elections.

# 2022 Membership Structure

- General Members (YTD)
  - ~7460 General Members
  - ~110 are newly converted Service Members (previously End Users) who have expressed their commitment to participating in ARIN elections and are now General Members.

# RPKI Stats

A growing number of organizations are taking advantage of the RPKI services offered by ARIN

**51,055** ROAs\*

+9,407 / +23% In 2022

+15,222 / +42% YoY

**2,722** Resource Certs\*

+476 / +21% in 2022

+925 / +51% YoY

# ARIN-NONAUTH IRR Update

- Retirement of ARIN Non-Authenticated IRR went as scheduled 4 April 2022
- ARIN staff performed active monitoring and real-time support for customers
- Very little follow-up activities were required, driven in large part to an active communications and customer support campaign prior to shutdown



# IPv4 Waitlist

**Waitlist resources are anticipated to become very scarce in 2022. Starting in 2023 only returned/revoked resources will be the primary source for waitlist applicants**

# Transfers completed in Q1 2022

- Transfers Due to Mergers, Acquisitions, and Reorganizations (8.2): **175 completed (23,346 /24s)**
- Transfers to Specified Recipients Within the ARIN Region (8.3): **217 completed (10,084 /24s)**
- Inter-RIR Transfers (8.4): **82 completed**
  - Inbound: **1,336 /24s**
  - Outbound: **786 /24s**

# Community Grant Program: Last Call

- Application deadline extended until **June 15**
- Four categories project must fit into:
  - Internet Technical improvements
  - Registry processes and improvement
  - Informational outreach that advances the Internet
  - Research related to ARIN's mission and operations

# IANA Class E Update

- RFC 1122 (1989) reserved 240/4 for future use
- Discussion over the years
  - Does all hardware/software support it for unicast use?
  - Should we be finding ways to extend IPv4?
- Draft proposal to formally designate it as unicast submitted 10/19/2021, revised 3/7/2022
- Unclear whether IANA would issue it under the “recovered address space” policy or the “old” policy
