Further to your application for a Reception place, on behalf of the Board of Governors I wish to inform you that your child is being offered a place in School.

For a small number of schools this offer of a place may be conditional on you providing them with verifying information in line with their admissions criteria. In this case, if the school requires further information, they will write to you separately, when it is possible for them to do so.

It is recommended that you should email the school to confirm you are accepting the place offered. The school will contact you at a later date to advise you about any induction arrangements.

If you are not accepting the place offered, you should email the school and provide your reasons for declining the offer and copy primaryadmissions@eani.org.uk into your email.

If you had nominated a primary school on your child's application form in preference to this school, there is provision for an appeal against the decision of the Board of Governors of the school in not selecting your child.

An appeal can only be upheld if a Tribunal finds that the admissions criteria were not applied or not correctly applied and that if the admissions criteria had been correctly applied the child would have been admitted to the school. You may wish to contact the primary school which has not selected your child for admission to discuss the reason why he/she was not offered a place, to assist you in deciding whether to appeal the decision.

If you wish to appeal against the decision of a Board of Governors not to admit your child, you can access further information on the appeals procedure and an appeal form at www.eani.org.uk/admissions **You must submit your completed appeal form by 4.00 pm on Wednesday 13 May 2020.** EA is investigating how and when admissions appeals may be able to take place, given the ongoing pandemic.
