Primary 1

EXTENSION OF THE NORTHERN IRELAND CHILDCARE SUBSIDY SCHEME (NICSS) TO SCHOOL AGE CHILDREN

As we approach the end of the school term, I want to thank you for your continued support throughout the year and share some important news that may benefit your family from September 2025.

On 15 May 2025, I announced new funding for early learning and childcare initiatives, including an expansion of the Northern Ireland Childcare Subsidy Scheme (NICSS), which helps make childcare more affordable for working families.

The scheme, launched in September 2024, currently provides a 15% subsidy on childcare costs for working parents of children below primary school age. From 1 September 2025, it will be extended to include:

- All children aged 11 and under attending nursery, primary or special schools;
 and
- Children with a disability in post-primary or special schools, up to the age of 16.

If you are registered for HMRC's Tax Free Childcare (TFC) scheme, you may be eligible to receive a 15% subsidy (up to £184 per child per month) on qualifying costs, including before and after-school activities, provided your school or childcare provider is registered for both TFC and NICSS.

Each school or provider decides whether to register for TFC and NICSS. If your child's school or provider is not yet registered, I encourage you to speak with them about joining the scheme.

FOR PARENTS / CARERS

WHAT IS THE NORTHERN IRELAND CHILDCARE SUBSIDY SCHEME?

The Northern Ireland Childcare Subsidy Scheme (NICSS) is a Department of Education initiative that provides a 15% subsidy on registered childcare costs for eligible working parents in Northern Ireland. The scheme aims to make childcare more affordable and accessible for eligible working parents.

Currently the scheme is available to families who:

- Are eligible for Tax Free Childcare (TFC);
- · Have a child who has not yet started primary school; and
- Are using registered childcare.

From 1st September 2025, the scheme will be extended to include school age children up to age 11, allowing eligible working parents to receive the 15% subsidy (up to the capped amount of £184 per month per child) on qualifying costs. This may also include some before and after school activities provided by schools or on a school's premises by a registered childcare provider.

WHAT DOES THIS MEAN FOR ME?

To benefit from the NICSS, you must:

- Be a working parent; and
- Be registered for TFC with HMRC a government scheme that contributes 20% towards childcare costs.

From 1 September 2025, the NICSS will apply to:

- · All registered childcare providers; and
- Some before and after-school activities in schools, as long as your school is registered for TFC. It will also be for your school to advise which activities are eligible under TFC.

Eligible families will include:

 Children aged 11 and under attending nursery, primary, or special schools. Children with disabilities attending post-primary or special schools, up to age 16.

WHAT DO I NEED TO DO?

You need to ask your school and/or registered childcare provider if they are registered for TFC, as only registered and eligible providers can apply the Northern Ireland Childcare Subsidy Scheme.

Registration for eligible children will open week commencing 21st July. The registration process for school aged children is simple and will take around 10 minutes to complete.

You will not be able to enrol a school aged child on to the scheme until 21st July.

To register, you will need:

- Your Tax Free Childcare Number; and
- A copy of your quarterly reconfirmation notice/certificate from HMRC.

If you have more than one eligible child, you will need to complete the process separately for each child.
