Respective Functions of the Board of Governors and the Principal in relation to admissions.

The Board of Governors draws up the admissions criteria and delegates responsibility for applying the admissions criteria to an Admission Sub-Committee, which includes the Principal. Any reference herein to the term The Board of Governors includes any Sub-Committee appointed by the Board of Governors for the purpose of applying the admissions criteria.

Integrated Education Act (Northern Ireland) 2022

The Board of Governors of Phoenix Integrated welcome the introduction of the Integrated Education Act (Northern Ireland) 2022 and look forward to its implementation. We note the definition of an Integrated School as outlined in the Act and believe our criteria will allow us to successfully meet this definition.

Declaration of Ethos

Phoenix IPS is a grant maintained integrated school intentionally supports, protects, and advances an ethos of diversity, respect and understanding between those of different cultures and religious beliefs and of none, between those of different socio-economic backgrounds and between those of different abilities.

Rationale (Nursery)

Our Admission Criteria reflect the integrated nature of the Nursery and its links to the Integrated Primary School. It is committed to educating Protestant and Catholic children together and strives to maintain a balanced enrolment, with a minimum of 40% from the Roman Catholic tradition, and 40% from the Protestant tradition and 20% from those who identify as OTHER in accordance with the Statement of Principles of the Council for Integrated Education (NI).

Children who are not normally resident in Northern Ireland will not be considered for places until all children who live in Northern Ireland have been considered.

Admissions Criteria

A timetable of pre-school admissions procedures setting out the dates by which an application is to be submitted is available at www.eani.org.uk/admissions under 'Pre-School Admissions'. During the admissions procedure when applying the criteria punctual applications will be considered before late applications are considered.

The application procedure opens on 10 January 2023 at 12noon (GMT) and an application submitted by the closing date of 27 January 2023 at 12noon (GMT) will be treated as a punctual application. An application received after 12noon (GMT) on 27 January 2023 will be treated as a late application.

As the pre-school admissions procedure is in two stages the timetable also specifies the relevant dates at Stage 2 which will determine if an application is to be considered as punctual or late.

Statutory Criteria

1. Children from socially disadvantaged circumstances in their final pre-school year who were born:
 - on or between 2 July 2019 and 1 July 2020 (inclusive) and whose parents have not exercised their right to defer their child's entry to primary school; or,
 - on or between 1 April 2019 and 1 July 2019 (inclusive) or were due to be born on or between those dates but were born earlier; and,
 - have not attended or are not currently attending a funded pre-school setting under the Pre-School Education Programme as a target aged child; and,
 - that child's parent has completed a request to defer their child starting P1 until September 2024.

Note: Children from 'socially disadvantaged circumstances' means a child whose parent has an entitlement to (i) Income Support, or (ii) Income-based Jobseeker's Allowance, or (iii) Income related Employment and Support Allowance, or (iv) Universal Credit. When parents apply for places for their child on this basis they must provide Benefit Verification to confirm that they have an entitlement. The application procedure for Pre-School will outline how Benefit Verification can be submitted.

2. Children not from socially disadvantaged circumstances (as defined above) who are in their final pre-school year (as defined by Criterion 1).

If there are more applicants who meet a particular criterion than there are places remaining to be filled the Board of Governors will determine, after consideration of the balance of representation within the nursery class of the 2 main communities within Northern Ireland, how many children of each main denomination should be admitted from those who meet that criterion. The balance between Roman Catholic and Protestant children is at least 40% from each of these denominations and the remaining 20% OTHER. If you fail to identify your child's perceived religion, we will identify that child in the OTHER CATEGORY.

The Board of Governors will then apply in the order indicated the sub-criteria listed below to those who meet the oversubscribed criterion. The sub-criteria will be applied separately to Roman Catholic, Protestant children and children from other religions as appropriate.

Admissions Sub-Criteria

In the event of over-subscription in any of set criteria 1-3 above, the following sub-criteria will be applied in the order listed:

- (i) Children with brothers/sisters/half-brothers/half-sisters, including those fostered or adopted or children living under a residency order in a family where other child/children of the family are presently enrolled in Phoenix Integrated Primary School (Please state name and class clearly) ;
- (ii) Children whose siblings have previously attended Phoenix Integrated Primary (Please state name and class clearly)
- (iii) Children who, at the date of their application, are the eldest child in their family eligible for admission. Twins will both be treated as the eldest child.
- (iv) Remaining places will be allocated for admission based on initial letter of surname in the order set out below which was determined by a randomised selection of letters of the alphabet.

In the event of surnames beginning with the same initial letter then subsequent letters of the surnames will be used in alphabetical order. In the event of two identical surnames the alphabetical order of the initials of the forenames will be used. The surname selected will be "as per birth certificate". In the event of a double barrelled surname the first surname will be used for purposes of selection.

Non-statutory criteria

Note: Applications falling under Criterion 3 are processed only during Stage 2 of the admissions process, after final pre-school year (Statutory 1and 2) applications.

3. Children who were born:

- on or between 1 April 2019 - 1 July 2019 (inclusive), or were due to be born on or between those dates but were born earlier; and,
 - and have attended or are currently attending a funded pre-school setting under the Pre-School Education Programme as a target aged (not penultimate aged) child; and,
 - that child's parent has completed a request to defer their child starting P1, or
- on or between 2 July 2020 and 1 July 2021 (inclusive); or,
- on or between 1 April 2020 and 1 July 2020 (inclusive) or were due to be born on or between those dates but were born earlier; and that child's parent has completed a request to defer their child starting P1 until September 2025.

Tie Breaker – Non Statutory Criterion 3

Children within Criterion 3 will be selected in Chronological Order of Age – eldest child first. In the event of two or more children having the same DOB the above random selection of letters will be used.

When considering which children should be selected for admission, the Board of Governors will only consider information which is detailed on the ONLINE application or verifying information which should be submitted to the school in line with the guidance. Parents should therefore ensure that all information pertaining to their child and relevant to the school's admissions criteria is stated on the ONLINE application. Examples of such information include; whether the child is the eldest child; your child's perceived religion. **PLEASE MAKE SURE YOU READ THE CRITERIA.**

The application form from the Education Authority will ask for you to state the perceived religious tradition of the child, it is vital that you record this as this will enable the committee to ensure that the religious balance of the school is maintained.

Duty to Verify

The Board of Governors **reserves the right to require such supplementary evidence** as it may determine to support or verify information on any applicant's application form.

To enable the Board of Governors to verify addresses, applicants may be requested to provide two accepted documents (a list of accepted documents will be provided to the applicant, should this be necessary).

If the requested evidence is not provided to the Board of Governors by the deadline given, this will result in the withdrawal of an offer of a place. Similarly, if information is supplied which appears to be false or misleading in any material way, the offer of a place will be withdrawn.

Waiting List Policy

Should a vacancy arise after 13th June 2023, all applications for admission to nursery that were initially refused, new applications, late applications and applications where new information has been provided will be treated equally and the published criteria applied. The waiting list will be in place until June 2024.
