TERMS AND CONDITIONS

The Promoter:

The Promoter is RaLET Parents/Guardians and Teacher Association (PGTA), Rush & Lusk Educate Together, Rathmore Road, Lusk, Dublin (CHY No. 20176c) (the "Promoter") under licence submitted for approval to the superintendent at Balbriggan Garda Station November 2025

The purpose of this raffle is to raise funds which will be used to enhance the school experience of pupils at RaLET. The teaching staff, school management and student council in consultation with the PGTA Committee will agree on how the funds raised will be utilised, this will be shared with the RaLET Board of Management and the wider parents and guardians at PGTA AGM or newsletter(s) as appropriate.

By entering this raffle all entrants agree to be bound by these terms and conditions and any other conditions in the messaging or promotions of this raffle (which may be amended at any time by RaLET PGTA). Any entries not complying with these terms and conditions will not be valid.

The terms and conditions herein are governed by Irish Law and the parties submit to the exclusive jurisdiction of the Irish Courts.

The Prizes:

Other prizes of similar or lesser value may be added to the raffle in the run up to the draw.

The Promoter accepts no responsibility or liability to any winner for any dissatisfaction with a prize. No alternative prize will be offered. The prizes are not redeemable for cash.

The winners may be required to provide proof of identity when claiming their prize.

How to Enter:

The raffle will run from Monday 24th November 2025 to 10pm on Tuesday 16th December (inclusive).

All competition entries must be received by the Promoter no later than 10pm on the 16th December (closing date). Any tickets received after this date will be disqualified.



To enter the raffle:

1. Purchase an online raffle ticket at the price of €5 per ticket (3 for €10, 7 for €20, 15 for €40 or 20 for €50) at <https://www.idonate.ie/raffle/RushandLuskEducateTogetherWinterRaffle>
2. On purchase of an online ticket for the raffle draw, all purchasers of tickets are automatically entered.
3. In relation to the 'free' raffle draw (open to every student in the school), entry will not be automatic. Parents/guardians will be required to give consent, via Aladdin, by opting in, in order to qualify for entry to the free draw.

Eligibility:

The online draw is open to all persons aged 18 or over at the date of the draw.

The promoter reserves the right to reject any entry (and award the prize to an alternative winner) if it has grounds to believe the entrant has breached any of these terms and conditions, acted fraudulently or illegally, or on other reasonable grounds and shall have no liability to an entrant for any loss or damage arising from such rejection

The Promoter respects and is committed to protecting your privacy. The personal information you provide will remain private and will only be used for the purposes outlined here.

The promoter reserves the right to cancel, amend, terminate or temporarily suspend this raffle at any time with no liability to any entrant or any third party. If, due to lack of availability of a particular prize beyond the promoter's control, the promoter reserves the right to substitute a particular prize for another prize of similar value.

Winner Selection:

The winner will be drawn on Wednesday 17th December 2025 on the grounds of Rush and Lusk Educate Together School and will be supervised by an independent scrutineer(s) from the student council.

The prizes are non-transferable.

Winners will be chosen by random selection using a number generator.

The winners will be notified within 3 working days of the closing date either by email or telephone.

If we cannot contact any one of the winners within 28 calendar days after the draw, another name will be drawn, and a new prize-winner will be declared

By entering the draw, winners confirm their agreement to take part in any associated publicity.

The promoter's decision is final, and no further correspondence will be entered into.



Data Policy

a) Online Raffle

The personal data that you provide including name, address and email address will be subject to privacy policy and terms of conditions of the idonate.com site, visit <https://www.idonate.ie/privacy-policy/> to read. The promoter (RaLET PGTA) will only process your data in a manner consistent with the purposes for which it was gathered. The promoter will not contact you except in the event that you have won a prize in the raffle. Your information will be retained by the promoter for a period of 2 months after the raffle draw has taken place. Data will be stored securely, so that confidential information is protected in compliance with relevant legislation.

b) Free Raffle

This draw will be conducted in line with RaLET data policy, click <http://ralet.ie/policies/> to read. The PGTA will not have access to children's data and the winner will be notified in person on 17th December 2025.

Limitation of Liability:

Insofar as is permitted by law, the Promoter, its agents or distributors will not in any circumstance be responsible or liable to compensate the winner or accept any liability (under contract, or otherwise under law) for any loss, damage, personal injury or death occurring as a result of taking up the prize except where it is caused by the negligence of the Promoter, its agents or distributors or that of their employees.
