RESPECTIVE FUNCTIONS OF THE BOARD OF GOVERNORS AND PRINCIPAL IN RELATION TO ADMISSIONS

The Board of Governors draw up and apply the criteria for admissions.

ADMISSIONS CRITERIA

During the admissions procedure when applying the criteria punctual applications will be considered before late applications are considered. The application procedure opens on 10 January 2022 at 12noon (GMT) and an application submitted by the closing date of 28 January 2022 at 12noon (GMT) will be treated as a punctual application. An application received after 12noon (GMT) on 28 January 2022 will be treated as a late application.

The Board of Governors will apply the following criteria in the order indicated to identify which children should be admitted either at initial admission to education or on transfer from another school.

1. Children of compulsory school age who have brothers/sisters (half-brothers/sisters) currently enrolled in the school. (This is to ensure that siblings can be educated together).
2. Children of compulsory school age who normally reside in the Parish of Aghaderg.
3. Children of compulsory school age who reside in other areas.

In the event of over-subscription in any one of the criteria, taken in order, the following sub-criteria will be applied in the order set down:

- i. Children of compulsory school age who have listed St Francis' Primary School Aghaderg as their first preference.
- ii. In the event of over-subscription in any criterion, selection for all places remaining in this category will be on the basis of initial letter of the surname, in the order set out below.

The above was determined by a randomised selection of letters of the alphabet carried out on behalf of the Board of Governors on 18th November 2021. Where surnames begin with the same initial letter, the subsequent letters of the surnames will be used in alphabetical order. In the event of two identical surnames the alphabetical order of the initials of the forenames will be used.

DUTY TO VERIFY

The Board of Governors reserves the right to require such supplementary evidence as it may determine to support or verify information on any application. Documentation submitted in support of your application should be provided directly to the school of first preference. If the requested evidence is not provided to the Board of Governors by the deadline given, this will result in the withdrawal of an offer of a place. Similarly, if information is supplied which appears to be false or misleading in any material way, the offer of a place will be withdrawn. Birth Certificates must be supplied to the school by 4th February 2022.

WAITING LIST POLICY

Should a vacancy arise after 28th April 2022, all applications for admission to Primary 1 that were initially refused, new applications, late applications and applications where new information has been provided, will be treated equally and the published criteria applied. This waiting list will be in place until 30th June 2023. The school will contact you in writing if a child gains a place in the school by this method.

Your child's name **will not** be automatically added to the list. **Please inform the school in writing if you want your child's name added to the list.**

ADMISSION TO P2-P7

Admission to Primary 2 to Primary 7 and admission to Primary 1 later in the school year are subject to the enrolment number not being exceeded and to any admission not being prejudicial to the efficient use of resources.

SCHOOL HOURS

During the 2020/21 year, the school day has been impacted by Covid-19. In the event that the restrictions are relaxed, the draft school hours are as follows:

The school opens at 8:00am for children attending our Breakfast Club. For children not attending the Morning Club the school will open at 8.45am; all children should be in the school for roll call at 9.00am. Lunch is from 12.00pm – 1.00pm. A 'Bus Club' operates from 2.00 until 3.00pm for children who travel to or from school by bus. A range of after-school activities operate from 2:00pm until 3:00pm for Primary 1 – 3 pupils and from 3:00pm until 4:00pm for Primary 4 – 7 pupils. Please contact the school for further details on the Breakfast Club or after school activities. Parents are asked to arrange to have their children collected no later than 3.10 pm as the staff have In-Service Training Courses and meetings after school.

PASTORAL CARE ARRANGEMENTS

As a school we are committed to providing a comfortable and safe environment for learning. Each class teacher has the responsibility to look after the pastoral needs of the children in his/her class, this is made possible through partnership with parents. Parents are asked to inform the teachers of:

- any medical problems their child may suffer,
- any medication their child is receiving
- an up to date address or phone number at which they (or the child minder) may be contacted.

In the event of an emergency, arrangements will be made to have the child taken to hospital. In all cases it will be the school policy to act in the best interest of the child. In the event of a parent having concerns about a Pastoral Care or Child Protection issue the following teachers should be contacted:

Mr E O'Malley (Designated Teacher for Child Protection) or

Mrs K Trainor (Deputy Designated Teacher for Child Protection).

Positive Behaviour and Discipline

In St. Francis' Primary School, we believe that respect and self-awareness are the foundations on which good manners and the ability to regulate actions and feelings are built. These are essential if pupils are to build strong, supportive relationships with peers and staff. Through our collaborative work on pupil well-being and mental health, they are encouraged to reflect on their thoughts and feelings, how they process these and how they react to challenging situations. This helps pupils develop the self-awareness needed to recognise challenging situations and respond to them in a safe and measured way. We also spend considerable time developing a clear understanding of our expectations for and from pupils, staff and parents. This means that our entire school community has a very clear sense of what is expected and, more importantly, why. Pupils understand that games where peers are respected and turn-taking happens are games that are enjoyed by all. Classes where pupils and teachers are listened to, where the environment lets pupils work comfortably without interruption, and where the resources they need are accessible and well-looked-after is a class where pupils have the opportunity to shine. This is how we promote positive behaviour. These strategies are supplemented with merit and reward systems at class level to encourage positive behaviour and celebrate instances when pupils demonstrate commitment to our values, above and beyond what we expect.

Where pupil behaviour falls short of acceptable standards, where there is persistent disruptive behaviour within the classroom, disrespect through word or action for either pupil or staff member, it will not be tolerated. School is a place where all pupils and staff – and visitors – should, first and foremost, feel safe and respected. When unacceptable behaviour occurs, the necessary sanctions will be employed as detailed in the School's Positive Behaviour and Discipline Policy.

The school is proud of its approach to inclusivity for all pupils and our commitment to supporting pupils with Special Educational Needs (SEN) or Social, Emotional and Behavioural Difficulties (SEBD). Whilst we acknowledge that specific conditions/needs mean that pupils may manifest certain associated behaviours there is still an expectation that pupils with SEN or SEBD would show the same respect for peers and staff, and that any associated behaviours should not place peers or staff at risk of injury. If this occurs, support and intervention from the relevant agencies will be sought and a SEN support review protocol will be enacted in partnership with parents, so that staff can review and amend provision accordingly, with the full support of parents.


SCHOOL CURRICULUM POLICY

Curriculum Policy Statements

It is the policy of the Board of governors of St Francis' Primary School that each child will have the opportunity to access the full Northern Ireland Curriculum.

"The Northern Ireland Curriculum aims to empower young people to achieve their potential and to make informed and responsible decisions throughout their lives"

It comprises seven general learning areas: Language and Literacy; Mathematics and Numeracy; the World Around Us; the Arts; Personal Development; Physical Education and Religious Education. At the heart of the curriculum lies an emphasis on the development of skills: (a) Thinking Skills and Personal Capabilities and (b) formally assessed cross curricular skills: using Mathematics, Communications and ICT. The Northern Ireland Curriculum embraces the principles of Assessment for Learning with an emphasis on improvement, raising achievement and celebrating success.

We also strive to promote the values associated with our patron saint: Francis. We make every effort to help pupils develop compassion and understanding for each other and those they meet on life's journey so that collectively, we leave a trail of kindness, appreciation and betterment wherever our path takes us.

St Francis' Primary School offers a balanced and broad curriculum which promotes the intellectual, spiritual, moral, cultural, emotional and physical development of pupils. We endeavour to help pupils unlock the unique learning opportunities provided by our local environment and the curriculum we deliver is designed to stimulate thinking and reasoning; to develop skills that help pupils challenge themselves; and navigate the overwhelming amount of information they can access to, in order to discern what is true and important.

It is essential that children learn to apply themselves to their school work. This is a message they will absorb, first and foremost, at home. Where children feel supported and encouraged in their learning, their appetite to succeed and excel grows and the school recognizes the absolutely essential role parents and guardians play in this. The nurturing of body, mind and soul; the establishment and nurturing of a Catholic faith onto which they can grasp in times of need or difficulty; the awareness of the gift of good health and our need to actively maintain it through food, exercise and rest; all of these steps begin at home and are built upon in school. With this solid start, staff are able to take your child(ren)'s hand and support them as they take their next steps. Staff will attend to your children's needs, their problems and confidences will be taken seriously so that they build self-confidence and are certain of their teacher's love and friendship, realizing that the love and care they first encountered in the home, exists in the wider world too.

Francis PS, we believe that learning can be a source of joy and a solid basis for establishing self-belief; especially through work of a practical nature. Practical lessons include Drama in Literacy, RE and History; practical work and experiments in Numeracy, Science and Geography and field studies in the World Around Us. We believe in the power of 'growth mindsets' and helping children unlock the power of the word 'yet' when identifying what they can and cannot do. Resilience, accepting challenge and being able to reflect and improve are all important skills that begin with the acceptance that, at our core, we can always get better and that we should give ourselves the chance to get better by keeping going.

Pupils are offered a range of extra-curricular activities, either within the school day or after school. Participation in these activities is voluntary but we would encourage our families to avail of every opportunity to widen children's breadth of learning experiences.

Activities offered change throughout the year and include; Gaelic football, camogie/hurling, tin whistle, fiddle, choir, Irish dancing, languages, and art. Music tuition is also offered by the EANI Music Service. After school activities on offer in previous years include: drama, soccer, Gaelic football, ukulele and yoga.

Religion at St. Francis' Primary

St Francis' is a Catholic primary school which teaches our pupils in accordance with the rites, practices and observance of the Catholic faith. We would ask that children who join our school community take a full and active part in the religious life of the school through prayer, acts of kindness and compassion both in and outside of school and striving to reflect the values, held so highly by St. Francis, in daily life. Christian belief and values inform our teaching and our conduct. These are not just confined to the Religion lessons but permeate the whole school curriculum. Formal religious education takes up at least 10% of teaching time and is based upon the Grow In Love religious scheme. Prayer is part of the daily school life and school masses, confessions and other religious services are part of the yearly programme.

We extend an equally warm welcome to families of other faiths and none. In fulfilling our commitment to 'Love our Neighbour', we celebrate opportunities to learn and teach pupils with differing beliefs, be that through our broad curriculum; participating in Shared Education or recognising signs of our differences in everyday life. These opportunities to reflect and consider what makes a tradition unique help our pupils to grow in understanding and compassion, building on the progress made and forging a sense of community between differing traditions and faiths.

In this way, we live out our own faith, fully.



Education for Safeguarding and Child Protection

St Francis' Primary School, Aghaderg is a caring, responsible school with the children at the core of our endeavours. We strive to respond to the personal, emotional, social and educational needs of our pupils daily.

Preventative education is a key aspect to our pastoral care, our child protection and our safeguarding strategies. As part of this preventative education, pupils learn about the dangers of misusing alcohol, tobacco, medicine and any other drugs the children are aware of. We work in collaboration with the Police Service of Northern Ireland in order to give our pupils a clear sense of the risks associated with all of these and how to keep themselves, and those around them safe if they are faced with a challenging situation. Our approach is measured and appropriate to the experiences of children in our school, where emergent concerns arise, our approach adapts to meet the needs of our pupils. Further detail is available in our Drugs Education Policy.

The school also uses the CCEA programme "Living. Learning. Together" to support teaching on what healthy relationships look like. This is the key tenet of our approach to Relationship and Sexual Education. From an early age pupils are taught about healthy boundaries, personal space and permission, all of which form the basis upon which pupils can build an understanding of healthy relationships with peers, friends and family look and feel like. Pupils are taught about the ways they can reach out for support or help if they find themselves feeling unsafe and they are taught to never suffer in silence. We are currently updating our Relationships and Sexual Education Policy to reflect updated guidance from the Department of Education, in consultation with parents of families in the school.

Underpinning our education in all of these areas, is the partnership between the school and parents, where we work together towards educating and preparing our children for each stage of their lives. It is important that pupils receive consistent, clear information from both home and school so that they have a clear sense of their rights and responsibilities; they have a well-established moral compass that will help them find their True North in any situation; and that they find themselves living well and helping others to do the same.



Supporting Learners of All Abilities

Some of the children attending the school will have particular educational, social, physical or emotional needs. These may arise from developmental, physical or specific learning challenges they navigate and work to overcome, daily. St. Francis PS is an inclusive, welcoming school and as such we will make every effort, within our resources, to meet each pupil's needs. Concerns may be raised by either teacher or parents and both will collaborate for the best interests of the child in question. Where additional support is required, the appropriate steps of the Code of Practice will be followed in order for the Education Authority to determine and secure the appropriate level of support or intervention required. This path will begin with class/school-based support (differentiation of work or support through resources/ small-group work) and may require the involvement of other agencies (RISE/ AAIS/ Educational Psychologist/ OT).

Ultimately, our approach to supporting learners with overcoming particular challenges is guided by where the pupil is, where they wish to go and what they need to get there. We rely on the support and engagement of parents throughout this process, and throughout each child's learning journey, in order to achieve the best possible outcomes for our pupils.



HOMEWORK

Homework is an important part of the learning process. It is a means of revising work done in class, extending work done in school and accessing information, which is not available in the school. Homework may be done in booklets or online through the Seesaw app; this involves the parents in the learning process and is a means of keeping parents abreast of the curriculum that is being taught. Homework will be based on one or more of the following: Reading, Spellings, Literacy, Numeracy, other curricular areas or personal research. The amount of homework should generally not exceed that which can be done in:

- 15 minutes in Primary 1 and 2
- 20 minutes in Primary 3
- 40 minutes in Primary 4 and 5
- 60 minutes in Primary 6 and 7.

Normally homework will be set each week night, though this may be relaxed for holidays and other special occasions.



ASSESSMENT AND REPORTING

Knowing how your child is performing at school is important. Monitoring progress has always been a key responsibility for teachers. The main purpose of assessment is to:

1. Establish through a variety of means the progress that each child is making.
2. Assist the teacher in planning appropriate tasks for each child.

Formal assessments are carried out at the end of Key Stage 1 (P4) and Key Stage 2 (P7) and the results of these are included in the child's end of year report. A written record of achievement will be provided for each child transferring from the primary school to a secondary school. Information on the school's end of Key Stage results is available on request. Parents will be informed of their child's general progress at the November Parent – Teacher meetings and through the annual report which is issued in June. The Principal or teacher can arrange a special meeting for an individual parent if there are particular matters of concern. Children on the Special Education Register will have Individual Education Plans or Personal Education Plans, parents will be invited to review their child's progress on these plans with the class teacher or SENCO.

Questions, queries and complaints.

In St Francis' PS Aghaderg, we take complaints seriously. We have the best interests of all our pupils and their families at the centre of all that we do. For this reason, we would encourage anyone with a concern to speak to us as soon as possible. We believe that if concerns are dealt with at an early stage, then they are more likely to be resolved promptly, to the benefit of all. Many issues can be dealt with simply by talking to the relevant staff in the school who will be happy to help. Open communication and regular engagement between the school staff, parents/guardians and other school users is vital to the effective management of the school. We welcome open communication with our staff; you can contact our staff by phoning the school or messaging the teacher to request a meeting. Concerns about matters other than in the classroom should be raised directly with the Principal.

Where parents feel that their concern has not been satisfactorily resolved they should follow



the Two Stage Complaints Procedure by firstly writing to the Principal; if the parent feels the outcome is unsatisfactory or that the school has not followed due process, then they should write to the Chairperson of the Board of Governors. Further information is available in the school's Complaints Policy.

CHARGING AND REMISSIONS POLICY

Education in St Francis' Primary School is provided free of charge for all lessons and activities connected with the child's entitlement under the Education Reform Order. In the event of a school trip or music tuition (not statutory lessons), payment is required.


The Morning Club, Bus Club and various After School activities are in addition to statutory requirements; these are voluntary activities and donation towards running costs is required.


The school may appeal to parents for voluntary contributions but no child will be disadvantaged if parents choose not to make a contribution.
