Change in share capital

On 7 September 2010 the Company has deposited at the Register of Companies the results of the conversions of Vittoria Assicurazioni's Fixed/Floater 2001/2016 subordinated bonds convertible into ordinary shares, for the period from 1 August to 31 August 2010.

Further to the conversion of 1,000 bonds, 2,000 new shares have been issued. Therefore the new share capital now amounts to Euro 66,522,498.

The residual bonds in circulation are 488,751 for a nominal value of Euro 2,346,004.80.
