# **Annual Ordinary and Extraordinary Shareholders' Meeting**

The Vittoria Assicurazioni Board of Directors, which met today in Milan, has reviewed the first 2012 figures.

Total written premium amount to €1,018.3 million (+8.6%).

Direct Life Premium amount to €119.4 million (-6.2%).

Direct Non Life Premium amount to €898.5 million, with an increase of 10.9%.

Motor Premium amount to €670.1 million (+10.6%).

Other Non Life Premium amount to €228.4 million (+11,9%).
