NEGOTIATING COMMITTEE NOMINATIONS

In preparation for the negotiations of a July 1, 2019 Memorandum of Understanding (MOU/contract), SLOCEA is seeking members interested in serving as representatives on the 2019 Negotiating Committee for the Trades Unit.

Interested candidates can nominate themselves by completing and submitting to the SLOCEA office, a NOMINATION FORM (attached) by 5:00 p.m. on Friday, January 18, 2019. Completed forms can be mailed, emailed, faxed or hand-delivered to the SLOCEA office.

Following the submission of nominated candidates, a ballot with the slate of candidates, will be mailed to SLOCEA Trades Unit members.

The Trades Unit Negotiating COMMITTEE consists of:

- A maximum of nine (9) members who must represent the diversity of the job classes in the bargaining unit.

The Role of the Negotiating COMMITTEE (9 members):

- The Negotiating COMMITTEE will elect a Negotiating TEAM from the members of the Negotiating Committee.
- Negotiating Committee members assist in identifying meet and confer issues in the workplace; bringing meet and confer issues to the Negotiating Committee; and communicating with the Trades membership at large.

The Role of the Negotiating TEAM (5 members):

- The Negotiating TEAM is comprised of the SLOCEA President, Vice President, and Secretary-Treasurer or a designee; AND filled with elected Team members to constitute a five-member team.
- The Negotiating TEAM participates in all negotiation sessions at the Bargaining Table with SLOCEA'S Lead Negotiator and representatives from the County.
- Members of the Negotiating Team attend all Negotiating TEAM meetings and serve for the duration of the contract.
