Update of September 12, 2022 on the purchase of treasury shares

Smartphoto group, the innovative e-commerce group from Wetteren, announces that, as part of the share repurchase programme started on June 17, 2022, and announced on June 16, 2022, with a target value of 1,500,000 euro in treasury shares, the transactions listed below were carried out in the period from September 1, 2022 to September 9, 2022.

In this period, smartphoto group purchased a total of 4,261 shares via the Euronext trading platform.

These transactions were carried out on the regulated market NYSE Euronext Brussels, in accordance with the discretionary mandate given to KBC Securities by the Board of Directors.

After the above-mentioned transactions, smartphoto group owns a total of 260,304 treasury shares, or 6.60% of the total number of shares issued (3,941,950).

Under the new share repurchase programme, which stipulates that treasury shares can be purchased up to and including June 30, 2023, or until the target value of 1,500,000 euro in shares has been acquired, treasury shares can still be purchased for a total value of 1,217,279.16 euro.
