



2025 NSTA Membership Meeting Minutes

Friday, October 25, 2024

The meeting was called to order by President Greg Pink. A quorum was present.

Opening Comments: Greg Pink opened the meeting and asked membership for approval of last year's annual meeting minutes.

- Motion by Corky Peters to approve, second by Jon Slinker
- Vote carried to approve 2024 NSTA Annual Meeting Minutes.

Officer Update, Vice President Jon Slinker:

- Informed members that the 76th State Shoot attendance is 33% larger than the previous year, and thanked membership for their support.
- Reported that the state shoot was running very well and receiving many positive comments from attendees.

Officer Update, President Greg Pink:

- Reported that NSTA put on 28 Shoots this year in Las Vegas and Pioche.
- Greg recognized the efforts of Larry Gearheart, Club President of Lincoln County Trap Club, for hosting two Big 50 events and also the July Western Zone Shoot.
- Informed membership NSTA is continuing efforts to expand shoots at northern Nevada clubs, including Yerington, Fallon, and Winnemucca.
- Greg reported the NSTA Financial status.

Board Of Directors Elections:

- President Greg Pink informed membership of the three board positions up for reelection: Corky Peters, Jeff White, and a third open seat. He also explained that each election is for a two-year duration.
- Greg asked Corky Peters and Jeff White if they would like to be considered for another term in office. Both accepted.
- Greg asked the group if there were any others from the membership interested in running for a Board of Directors position.
- Patrick O'Neal nominated Melvin Tabion for Director. Melvin accepted the nomination.
- Greg asked membership for other nominations for Board of Directors, none were made.
- Greg asked members if there were any discussions regarding the board member elections. None were made.
- Motions were made by members, and seconded, to nominate Corky Peters, Jeff White, and Melvin Tabion.
- A vote by membership was taken and motion carried. All three members were each approved for a two-year term of office as NSTA Directors.

Nevada Delegate and Alternate Delegate Elections:

- Jon Slinker informed membership that he and Leticia Slinker were respectfully stepping down as Delegate and 1st Alternate Delegate.
- Jon Slinker made a motion to nominate Director Danny Talbot as Nevada's ATA Delegate, Danny accepted.
- Greg Pink asked for other nominations for Alternate Delegate.
- Patrick O'Neal nominated Gary Rusch, Gary accepted.
- Greg Pink asked 2nd Alternate Delegate Sam Boatman if he would continue, Sam accepted.
- Members voted to appoint all three Delegates, all three were accepted for a 2-year term.

- Linda Hand acknowledged membership for their great support throughout the year, citing success comes from them. She encouraged members to continue bringing ideas to the Board of Directors.
- Jeff White acknowledged Linda Hand and Greg Pink for their efforts selecting, ordering, inventorying, organizing and transporting the vast trophy package at the 76th Nevada State Shoot.
- Jon Slinker recognized Larry Gearheart, President of Lincoln County Trap Club for hosing NSTA Shoots.

- Jon Slinker recognized Jack Wang for his efforts setting up and running the overwhelmingly popular Cosmic Trap Shooting activities at the 76th Nevada State shoot at his personal expense. He also recognized Jack for his successful efforts at increasing youth shooters' participation to 92 shooters.
- Jon Slinker recognized the NSTA Board of Directors for their continued efforts organizing and supporting the 76th Nevada State Shoot.
