All Major Summer Inspections will consist of the following procedures:

- Installation of air filters, provided by us
- Visual inspection for leaks, vibration, noise
- Check general operation & condition
- Check refrigerant & oil pressure
- Check oil level/condition
- Seasonal check of cooling/heating safety components

- Check belt condition/tension
- Check refrigerant level/condition
- Check condensate drain condition
- Seasonal check of cooling/heating controls

All Major Winter Inspections will consist of the following procedures:

- Installation of air filters, provided by us
- Check motor condition & amperage
- Check all wiring & connections from switch
- Seasonal check of cooling/heating controls and safety components
- Check general operation & condition
- Seasonal check of coil/heat exchanger
- Check belt condition/tension

III. Upon completion of each inspection as outlined in Section II, we will furnish you with a report detailing any major repairs and/or improvements that are necessary in order to maintain satisfactory and dependable operation of the equipment.

IV. Upon proper authorization, we will improve and/or repair the equipment at the following labor rates:

VI. Under this Contract, **SMS** shall furnish semi-annual maintenance service on the listed locations starting upon acceptance of contract, and shall continue to renew annually by endorsement until notice of termination is given. This Contract is subject to price revision

and/or cancellation at any given time upon written receipt of a thirty (30) day notice by either party.
