SUBJECT: Sustainability Advisory Committee (SAC) Charge

The university's commitment to provide leadership in furthering our sustainability practices means we must consider our environmental impacts in everything we do including policy, practice, research, and academic offerings. As such, a new advisory group, the SDSU Sustainability Advisory Committee, will be formed. The charge for this committee will be to provide a forum to bring together academic, research, student, facility planning and campus operating interests to oversee and provide recommendations regarding University environmental sustainability policies and progress towards meeting campus sustainability goals. By increasing awareness of our strengths in these areas and identifying areas for further improvement, the campus will continue to define itself as a community leader in sustainability, while putting into practice the University's Principles of Sustainability across all campus operations, academic areas and research.

The specific intended outcomes of the SAC committee will be to:

- Share information and identify emerging opportunities for collaboration among academic, research, and administrative units, offering the campus as a living lab for students and faculty to promote education, research and outreach activities in the context of environmental stewardship, sustainability and social justice.
- Prepare periodic reports to the President, senior campus leadership and the university community on progress towards meeting SDSU's sustainability goals and objectives.
- Recommend and support efforts to improve environmental stewardship and sustainability in SDSU facility planning and operations.
- Make sustainability part of ongoing education, research, operations and outreach programs

## Membership

Associate Vice President Samarkos and Associate Vice President Hansen will co-chair this working group, with each of you representing your respective role in the university as well as contributing your subject matter expertise. Kristin Larson, Director of the Office of Energy & Sustainability will provide additional subject matter and technical expertise. Other campus members may be invited to contribute to the discussion as determined by the advisory group.

The importance of the university to provide leadership in the areas of sustainability is clearly essential to the long-term success of SDSU as a research-intensive university and the continuing success of our students, faculty and staff. Your support and counsel in addressing these issues is critical and much appreciated. I am confident that through this conversation we can reach a level of transparency and understanding in the process which better suits the campus needs.
