University of Missouri Fiscal Year 2012 Minority/Women Business Enterprises Narrative Report

Overview

The University of Missouri's economic development mission is manifested in its outreach efforts to include all firms that want to participate in design and construction projects, contracting and purchasing transactions. As these businesses successfully compete for contracts, they are able to generate revenues and provide jobs for *Advancing Missouri*. Equally as important, the inclusion of all firms interested in providing products and services to the university allows the university to obtain quality products and services at competitive prices.

Another example of how the University is working to achieve its economic development mission is through its Advocacy-Mentoring program. One of the primary goals of the program is to assist small firms in developing core business competencies so they can become more competitive and greater contributors to economic development. In the Advocacy-Mentoring Program, large firms, particularly Missouri firms that successfully competed for university contracts, voluntarily served as mentors to small minority and women-owned business enterprises (M/WBEs). Similarly, administrators, largely from design and construction at the four-campus system, served as team leaders. Also, university faculty and MBA students provided consultation to small mentee firms in the Program. The students benefitted in that they applied academic theory to business practice; thus, they obtained valuable experience by working with small firms. The Program resulted in a win-win for the university, the businesses and the students. The second class of the Advocacy-Mentoring program will graduate in the fall, 2012. The award winning program, started initially in July 2009, had its first graduating class in June 2011.

In addition, the University's Minority Business Development (MBD) program partners and collaborates within the four-campus system and externally within the greater community. The establishment of the M/WBE Advisory Council, a best practice at the university, is a model of partnering and collaborating among interdependent entities. The M/WBE Advisory Council consists of a diverse group of representatives from city and state governments, public higher-education institutions in Missouri, M/WBE firms, St. Louis Minority Supplier Development Council, Hispanic Contractors Association of Greater Kansas City, as well as leaders from the four-campus system of the University. As the University of Missouri continues its efforts toward excellence in MBD, the Advisory Council provides input to the University's M/WBE firms.

Moreover, the Director of Minority Business Development promotes the University's M/WBE initiatives within the greater community, particularly in St. Louis and Kansas City, and encourages small businesses to bid university projects. Participation in the University's purchasing activities by all interested suppliers ensures the acquisition of quality products and services at competitive pricing, positions the University as a good corporate citizen, reflects the University's diversity initiatives and contributes to economic development, part of the core mission of the University of Missouri.

Architecture/Engineering Services

During FY2012, the total dollar amount of contracts awarded at the University of Missouri (UM) increased 89.02 % (\$9,065,423) relative to FY2011. Likewise, MBE participation amounts increased significantly, 11.05% (\$ 2,671,513); WBE participation increased 4.82% (\$1,653,901).

Construction Services

Conversely, during FY2012, the total dollar amount of contracts awarded by UM decreased by 25.39% (\$ 39,341,421) from FY2011; M/WBE participation as a percentage of total dollars spent by the university increased slightly.

Procurement

During FY2012, total University purchases increased 5.9% (\$ 28,323,011) from 2011; MBE participation increased significantly, 62.01% (\$11,453,180). To the contrary, WBE participation decreased 63.39% (\$5,012,222) during FY2012. Moreover, 2nd tier spend, dollars spent by the University's prime suppliers with MBE firms, increased 86.68% in FY2012 (\$ 6,400,155); likewise, WBE firms, 2nd tier spend increased 57.07% (\$ 985,077) in FY2012.

Professional Financial Services

In addition to the efforts by Facilities Planning and Development and Procurement Services to include M/WBEs in the procurement of products and services to the University, the Finance and Administration Division (Treasury) of the University continues to seek MBE participation in financial services that involve University funds. The following table highlights MBE participation for FY2012:






