RE: Investment Holdings

The Ohio University Foundation is pleased to provide retrospective disclosure of the Foundation's endowment portfolio investments upon request from interested constituents. These disclosures are offered on a 60-day lag to align with due dates associated with Securities and Exchange Commission ("SEC") filing deadlines.

For a list of the endowment portfolio's investment positions as of December 31, 2016, please see the attached asset allocation report. This report provides the name of each investment fund, the market value of the position, and the weight of each position relative to the portfolio's total market value. The report also provides subtotals by asset class and a grand total for the entire portfolio. Please note that, in order to properly diversify the investment portfolio and gain access to the best investment managers, the Foundation participates in many commingled investment vehicles rather than making direct investments in individual securities. As a result, the asset allocation report provides high level information about how the investments are managed, but it does not include information about individual holdings within each investment fund.

Much of the Foundation's investment portfolio is invested through the HC Capital Trust (the "Trust"). The Trust is a diversified open-end management investment company that consists of several separate investment funds (the "funds"). The funds' individual holdings are disclosed quarterly and made available to the public through SEC filings. The most recent report provides information as of September 30, 2016, and it was filed on November 29, 2016.
