The University of Rochester is committed to using and purchasing environmentally preferable products in the most cost effective and environmentally responsible manner. Our purchasing strategy, includes buying items that do not generate waste in the first place, buying less to prevent waste, and buying from recycled sources to promote recycling. See www.facilities.rochester.edu/sustainability/purchasing.shtml
For example, the mops that we purchase use 35 less gallons of water per day when compared to their conventional counterparts.

Our Green Cleaning Supplies Policy encourages the use of non-toxic, environmentally responsible cleaning reagents. Examples of cleaning reagents that are used in compliance with our policy are shown in Attachment B. Our policy of using of these products results in a reduced exposure of building occupants and maintenance personnel to potentially hazardous chemical contaminants that adversely impact air quality, occupant well-being, and the environment. Furthermore, our training program teaches staff the importance of using the smallest amount of chemicals possible to clean. To minimize the amount of chemicals used, we dispense all chemicals through Diversey[®] J-Fill Select Dispensing Units.
