Hi Martha,

I went back and looked through our invoices from A & D Recycling and discussed with them over the phone, unfortunately they don't provide us with much. I've counted the quantities of dumpsters we ordered through them and can multiply that by the "average" filled weight of each container that they advised, see below math. This provided us with a rough idea of total tons of waste, and although the waste would be sorted at the dump sites there is no way to tell at this point what amount of material was recycled. We can request this from the haulers in advance for next summer's projects.

7x 10 yd containers	4 tons	= 28 tons
8x 20 yd containers	6 tons	= 48 tons
3x 30 yd containers	7 tons	= 21 tons
TOTAL		= 97 tons

There was also some quantity of metal waste that was recycled from our buildings into metal dumpsters that were on site. I believe were provided by Steinhagen, but contributions from our building were not tracked uniquely by us or them.
