III. Waste Management Plan

Waste Management Plan:

Project: IUPUI North Hall

Date: December 2015

Owner: Indiana University

Architect: MSKTD

General Contractor: Messer-Powers

Overview:

The owner and Messer-Power's primary focus is to minimize the amount of wasted material on the project that would be sent to landfill disposal. Messer has enlisted the services of **Ray's Trash**, which is a licensed waste management company to dispose of all wastes from the project. All contractors on site will dispose of all their wastes into roll-off containers and take them back to their facilities and sort each container, recovering all materials that are able to be recycled and or reused. After all the materials are sorted, they will weigh the totals and record these amounts. Each month they will submit a report providing an update of the current percentages. At various phases of the project, additional dumpsters may be needed for a certain material such as concrete while the foundation walls and concrete decks are being constructed and yard waste during the landscaping stage to help maximize the amount of material that is reused and/or recycled.

See attached plan and sample calculations from Ray's Trash.

Goals of the Waste Management Plan:

The Project has established a goal that at least **75%** of waste materials from the project must be reusable and diverted from landfill disposals.

Application of the Waste Management Plan:

The goal of this plan is to divert the following, but not limited to items from a landfill so they could be recycled or reused:

- Concrete
- Masonry
- Metal
- Wood
- Paper/cardboard
- Drywall
- Insulation
- Plastics
- Asphalt

LEED PROGRAM INFORMATION

For your information, here is a description of each of the commodities that will be recycled by Ray's Trash Service, Inc. throughout your LEED projects:

Wood – this includes clean skids and pallets, dimensional lumber such as 2x4, 2x6, and wood dunnage.

***Painted and or treated lumber is not acceptable.**

***Plywood and OSB are not acceptable.**

Drywall – this includes clean drywall scraps.

***This does not include painted material or joint compound.**

Metal – this includes any and all metals: sheet metal, conduit, wiring, beams, structural iron, as well as copper, brass and aluminum.

***Many metal items that have small plastic non-metal attachments can still be recycled.**

Cardboard – this includes clean corrugated cardboard boxes.

Plastic – this includes shrink-wrap, packaging and banding.

Clean Fill – this includes block, brick, mortar and cement-like materials.

Concrete Washout – this includes all concrete washout in our individual roll off containers.

*The combination of items such as wood and plastic, drywall and wood, or plastic and cardboard will not be acceptable for recycling. If two non-like materials are attached in a way that they cannot be separated, this material will need to be trashed.

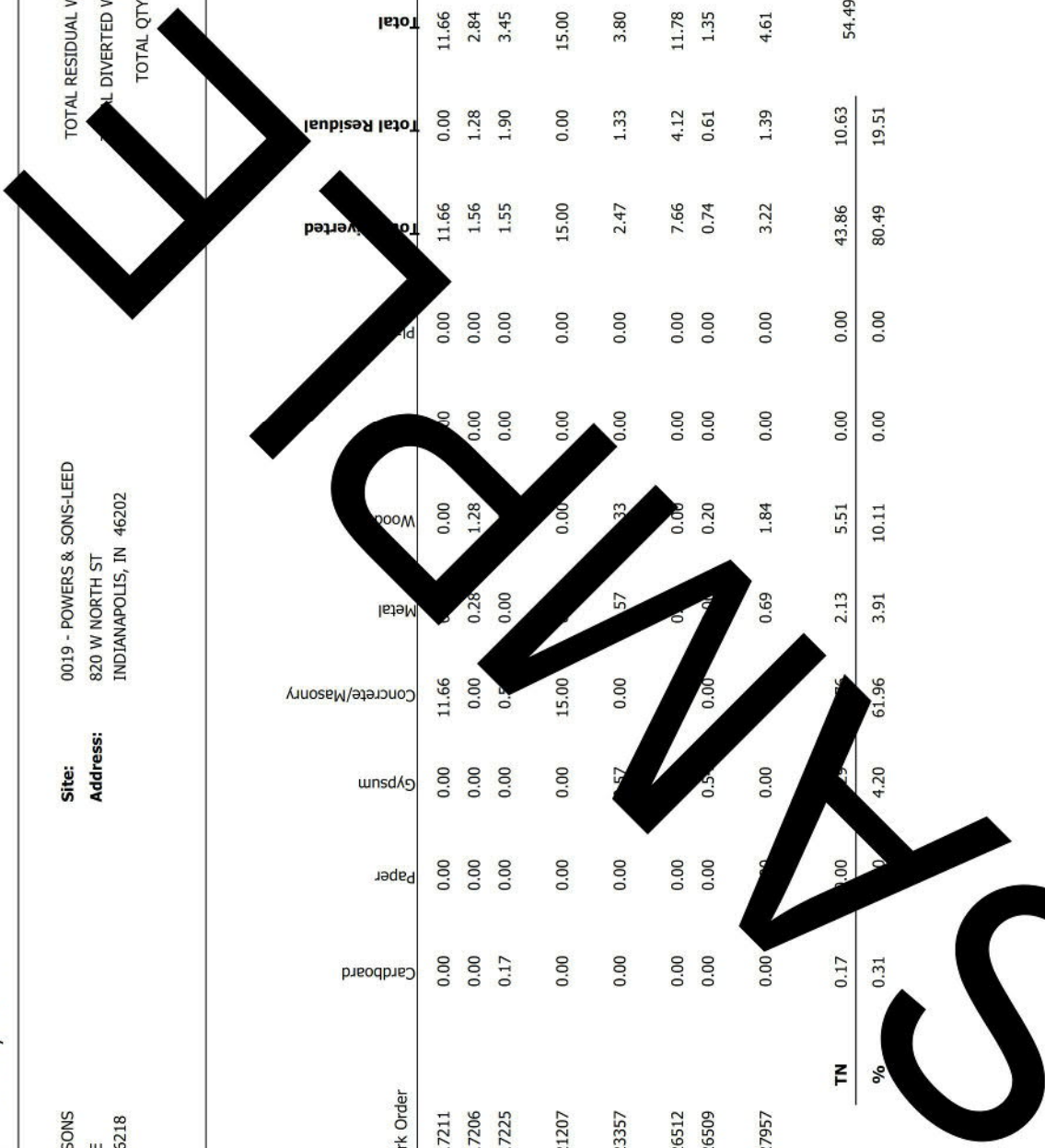


