#### **EXECUTIVE SUMMARY—STARS REPORT 2019**

The Sustainability Tracking, Assessment and Rating System (STARS) is a sustainability reporting tool for colleges and universities to measure their sustainability performance.

Completing the STARS report does the following:

- > Provides a framework for understanding sustainability in higher education
- Allows for comparisons over time and across institutions
- > Creates incentives for continual improvement
- > Facilitates sharing of best practices
- > Builds a stronger, more diverse campus sustainability community.

There are 934 institutions in 80 countries that use the STARS Reporting Tool. In the CSU system, 18 of the 23 campuses participate in the STARS report.

Because of the breadth and depth of this report, over 50 faculty, staff and students contributed information. Capital Programs and Facilities Management took the lead on this effort, which included identifying potential reporters, training individuals on how to complete the report and reviewing data submitted.
