The Assistant Director of Sustainability and Campus Farm Manager will assist DePauw's sustainability director with Ullem Campus Farm and Center for Sustainability initiatives. The Assistant Director supports the overall mission of the Ullem Center for Sustainability and Campus Farm, including through DePauw's Sustainability Leadership Program (SLP) and Center for Sustainability efforts (50%). The employee also directs all elements of the farming operation at the Ullem Campus Farm, (50%) including overseeing all interns and laborers; serving as primary contact for Bon Appétit, Bridges, and local charities; managing volunteer and educational groups; and leading the planting, growing, and harvesting of seasonal crops.

- Serve on Ullem Center for Sustainability and Campus Farm Advisory Board.
- Manage harvesting and selling/donating of produce to vendors and local charities.
- Plant seasonal crops at Ullem Center for Sustainability and Campus Farm location.
- Oversee all volunteers at Ullem Campus Farm.
- Lead growing of seeds at Manning Field Station and new greenhouse.
- Research and maintain soil quality of the land at Ullem Campus Farm.
- Present at regional conferences and meetings about the Ullem Center for Sustainability and Campus Farm.
- Serve on Student Academic Life committees as needed.
- Complete other duties as assigned.
