Green-e Energy is an independent certification program for RECs sold in the voluntary market. The Green-e Energy logo identifies RECs that meet the program's high environmental and consumer protection standards. Summit Energy Services, Inc., a subsidiary of Schneider Electric ("Schneider Electric") represents and warrants that the RECs to be retired under this Agreement (i) have not been sold, transferred, contracted for or otherwise committed to any third party, or otherwise used or claimed by Schneider Electric or, to the best knowledge of Schneider Electric, any third party and (ii) have been or will be independently certified under the "Green-e" program of the Center for Resource Solutions or its successor. EXCEPT AS SPECIFICALLY SET FORTH HEREIN, THE RECS ARE SOLD "AS IS", AND SCHNEIDER ELECTRIC SPECIFICALLY DISCLAIMS ANY AND ALL OTHER REPRESENTATIONS AND WARRANTIES, EXPRESS OR IMPLIED, STATUTORY OR OTHERWISE, INCLUDING WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE.

No Transfer. Customer (and any party purchasing RECs on behalf of Customer under this Agreement) acknowledge and agree that any RECs sold under the Agreement are sold strictly for Customer's own use, and cannot and shall not be resold or otherwise transferred to or used or claimed, directly or indirectly, by any third party other than Customer for any purpose whatsoever.

Delivery and Retirement. The RECs (or any portion thereof) are considered retired when Schneider Electric removes them from inventory in accordance with the requirements of the Green-e Energy program. Retirement of RECs for any vintage year shall occur on or before the first day of June in the next year. Upon request of the purchaser, Schneider Electric shall deliver to the purchaser an attestation that the RECs purchased under this Agreement have been or will be retired on the purchaser's behalf.

Termination/Cancellation. The purchaser may terminate the Agreement the event that Schneider Electric has failed to perform any of its material obligations under this Agreement and has not cured the same within thirty (30) days after receipt of written notice by the purchaser. Schneider Electric may terminate the Agreement in the event the purchaser (a) fails to pay any sums when due to Schneider Electric or (b) files a voluntary petition for bankruptcy or has filed against it an involuntary petition for bankruptcy, makes a general assignment for the benefit of its creditors, or applies for or permits the appointment of a receiver or trustee for substantially all of its property or assets.

Limitation on Liability. In no event shall either Schneider Electric or the purchaser of RECs hereunder be liable to the other or to any third party under or in connection with this Agreement for any special, indirect, incidental, punitive, consequential or similar damages, including, without limitation, any damages resulting from lost profits.
