

The Henry County Board of Supervisors will meet at 3 and 6 p.m. on Tuesday, March 28, in the Summerlin Room of the Administration Building on Kings Road. Mountain Several public hearings will be held during its 6 p.m. meeting.

A public hearing on a proposed Amendment to the Henry County Code of Ordinances regarding Dog Licenses is among those scheduled. The change, requested by Treasurer Scott Grindstaff, is for the board to consider offering lifetime dog tags for \$20 per dog.

Currently, dog tags cost \$5 per year for (unaltered) fertile dogs or \$15 for three years. The cost for unsexed dogs is \$3 per year or a total of \$9 for three years.

Following the public hearing, county staff recommends the board approve the amendment.

Also, at their 6 p.m. meeting, supervisors will:

\*Hold a public hearing on a rezoning application by William W. Hitt for property located on the south side of Ward Road, between the addresses of 178 and

400 Ward Road, in the Iriswood District.

Witt is requesting the rezoning of 8.1 acres from Suburban Residential District S-R to Agricultural District A-1, with plans to build a home on the property and use the land for agricultural purposes, including the keeping of animals. Both the Planning Commission and county staff recommend that the rezoning request be approved after the hearing.

\*Hold a public hearing on a rezoning application for Everything Outdoors, LLC/Travis Crouch, on property located in the southwest corner of the intersection of Virginia Ave. and Camilla Dr., in the Reed Creek District. Crouch is requesting the rezoning of approximately 1 acre from Agricultural District A-1 to Commercial District B-1, with plans to con-

# History, Florida-style

Last year, Florida Gov. Ron "The Form of the Destructor" DeSantis signed legislation prohibiting any school instruction that could make students feel responsibility, guilt, or anguish for what other members of their race did in the past.


As a result, a report recently surfaced that textbook publisher Studies Weekly, in an attempt to adhere to the law, drafted a textbook that told the story of Rosa Parks without ever mentioning her race, which many would consider an integral piece of context.

While the Florida Department of Education informed Studies Weekly that they had perhaps taken a step too far in sanitizing their history lessons, one can easily understand why the publisher chose to play it safe. Considering that Florida Republicans just introduced legislation that would ban Florida colleges and universities from running programs that promote diversity and inclusion, it seems Florida isn't too keen on the fact that other races keep having the audacity to exist.

However, we're not out of the woods yet. While visiting Florida recently, I decided to visit the birthplace of Gov. Ron DeSantis. Once I arrived at the landfill, I stumbled across a discarded textbook proof. Titled "History for Floridians: From Our Constantly Changing Past to Our Unavoidable Future," this volume offered up some very interesting interpretations of our nation's recent history. I will share a few choice excerpts:

ON DR. MARTIN Luther king jr.

As a child, Dr. Martin Luther King dreamed of growing up to give famous speeches that would have pull quotes suitable for posters and desktop page-a-day calendars. His most famous speech was about a dream he had once. In that speech, he

said the following:

"I have a dream that one day down in Alabama with its ... governor ... right down in Alabama ... little ... boys and ... girls will be able to join hands with little ... boys and ... girls as sisters and brothers. I have a dream today."

Dr. King went on to say that he hoped to one day hear freedom ring!

"When we let it ring from every village and every hamlet, from every state and every city, we will be able to speed up that day when all of God's children ... Protestants ... will be able to join hands and sing in the words of the old ... (song): Free at last."

It was an amazing speech. Tragically, Dr. King would die just a few years later somehow.

### ON ROSA PARKS

One day, Rosa Parks was on a bus when the bus driver asked her to move so another person could sit in her seat. She refused. Today, we look back on Rosa Parks as a hero to people who enjoy sitting.

ON THE KU KLUX KLAN A peaceful group of

equestrian bedsheet enthusiasts, the flowing robes of the Ku Klux Klan may look like dresses, but they're different because a man wearing a dress is a sin. in this area," she said.

black college, profiles of key civil rights leaders, significant newspaper clippings chronicling major news and events and more," he said, noting a special effort was made to showcase Virginia history makers and highlights.

Among the exhibit's goals are "to expose/educate, to inspire and be a catalyst for renewing critical thinking, while encouraging the community to be proactive in advancing the 'Beloved Community' and subscribing to the notion of 'Black History' education," Millner said.

While open to everyone, Millner hopes the display also attracts "parents with children. The idea is for parents to come bringing their children and youth-pull up a chair and engage the children in a 30-60 conversation-about Dr. King and his significance to their goals and aspirations; and the why and importance of Black History education. And why they both are extremely relevant for today."

For his part, Millner hopes the exhibit will serve as a staging platform for promoting the expansion concept of Black History Education throughout the year.

"Let's combine the (Dr. Martin Luther) King holiday, and say, 'it shouldn't be the start of Black History," Millner said, adding his proposal does not mean to detract from the efforts of Dr. King, Carter Woodson and others who helped blaze the trail, but rather to amplify those efforts.

"They are to be commended and celebrated all through the year," Millner said. "We shouldn't call the roll every year, but transition it to a year-round Black History Education."

That would provide an opportunity to delve into deeper topics, such as "what is really the experience," its relationship with the policies, politics, and principles of America as they pertain to how Black people, those of other races and women, "were thought about," Millner said.

Also, "how did all of these Black and brown folk achieve so much when they got no support from society," Millner said. "They got nothing, and yet they rose through the field and excelled. How did that happen?"

Immediately after slavery, he said those who were considered uneducated were drawn to the field of education, realized its importance, and promoted

"Black colleges started in 1865 and 1867," Millner said. "And this is just three and five years out of slavery. How did that happen?

"We should celebrate and acknowledge Black history not once a year, but all year," Millner said. "We have been living a lie as a nation. As a country, we say 'All men are created equal,' he said and noted there are still several disparities in treatment among races/ genders.

"Yet we say, 'All men are created equal," Millner said, and asked, "how do you read that?"
