Public outcry for preservation of St. Luke and Odd Fellows Hall heard by Blacksburg Town Council

The Blacksburg Town Council heard many comments by local community members concerning the preservation of St. Luke and Odd Fellows Hall in Blacksburg at its June 27 meeting.

Latonya Walker of Blacksburg, a member of the Montgomery County Community Review Council (MCCRC) spoke with concern of the historic St. Luke and Odd Fellows Hall and museum for African American culture and history, which has fallen into disrepair. The two-story building is located on the corner of Barger and Gilbert Street and was once also a place of social gatherings for African Americans in the area of Blacksburg known as New Town.

“My family has been a part of Blacksburg and Montgomery County since the early 1800s,” Walker said. “New Town and Odd Fellows Hall are important reminders of the resilience, pride and community spirit of the people who lived in this neighborhood.”

Christine King, also a member of the review council, addressed Blacksburg council members about the problems occurring today with the historic landmark of “institutional neglect and under preservation.”

The presentation by Walker and King also revealed the results of the Conservation Assessment Program (CAP) Report stating that the building itself is no longer safe. Additionally, their presentation expressed problems in racial and

gender diversity on the board, workplace harassment based on race and gender, and that Museum Best Practices and Standards are not being followed.

Potential resolutions to some of these issues asked for oversight from the Blacksburg Town Council. Mayor Julie Hager-Smith added that anyone wishing to follow-up with this organization can find these presented documents on the town’s website at www.blacksburg.gov.

Heather Nicholson, a resident of Montgomery County and also a member of the MCCRC, expressed her discontent as well with the Blacksburg Museum of Cultural Foundation’s “derelict[ion] of duty.”

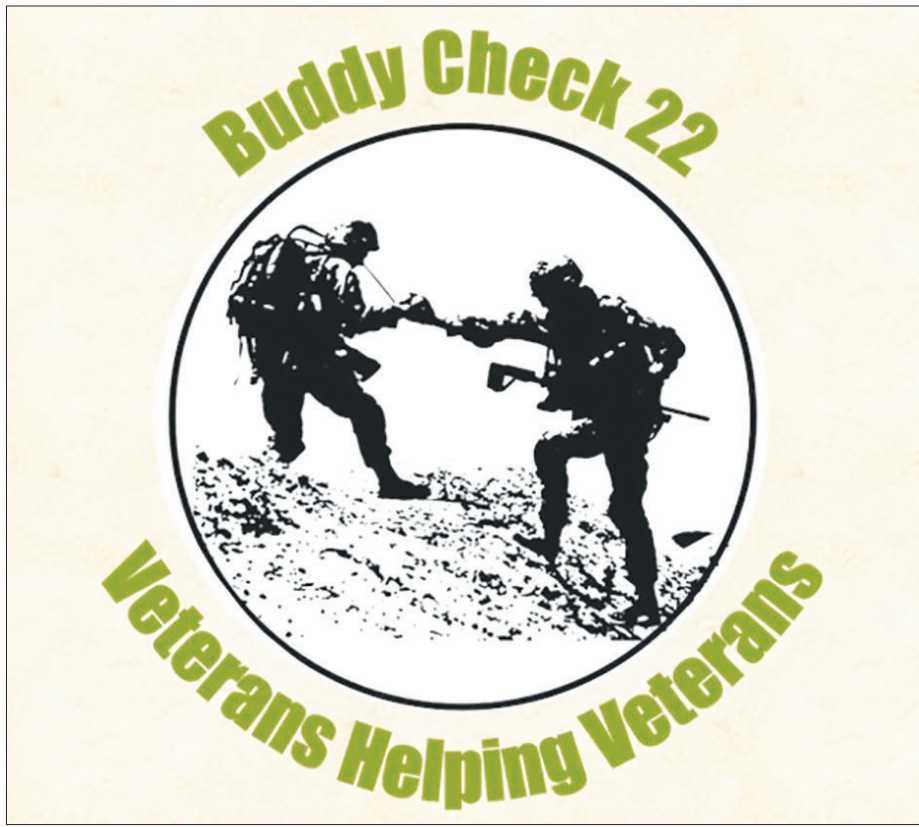

Buddy Check-22 continues mission for prevention of veteran suicide

The group is seeing growth in the NRV, allowing veterans, their families and friends to check in once a month

RADFORD - On the 22nd of every month, veterans, their families, friends, and supporters gather at the Radford Macado’s restaurant for a time to laugh, eat, and share in camaraderie and friendship.

It also provides a way to check-in on local veterans.

According to the Buddy Check-22 New River Valley Facebook page, a 2013 study by the Department of Veterans Affairs revealed that 22 veterans take their own lives every day. As a result of the sobering statistic, a national movement began, making the 22nd symbolic as a reminder

to check-in on service women and men that may be experiencing suicidal thoughts.

Marine Corps League Detachment #1190 is the host for a New River Valley gathering at Macado’s in Radford. All branches of the military are welcome and will receive a 50% discount off their meal, courtesy of Macado’s.

“It is a really neat event and has grown tremendously. Macado’s have been wonderful partners too,” the founder and coordinator of the New River Valley Buddy Check-22, Ted Veggeberg said. “I know personally four different veterans that said, ‘Ted, if it wasn’t for the Buddy Check-22, I would not be

here.”

From 6-8 p.m. every month on the 22nd, the group gathers in their own spot in the restaurant. Veggeberg emphasizes this is not a group therapy situation, just a good time for everyone to spend together. Anyone that works with veterans or wants to support veteran suicide prevention are also welcome to join the group each month.

Blacksburg needs to recognize that this historic site opens a window into not only Blacksburg history, but Virginia and U.S. history," Nicholson said. "Maggie L. Walker at the 1901 Independent Order of St. Luke Annual Convention laid out her goals. First, we need a savings bank, let us put our monies together. Let us use our money. Let us put our money out and reap the benefit ourselves."

Nicholson went on to say that they purchased the bank through a joint-stock corporation and exemplifies the wealth of a community.

Jody Daniels, Chair of the History and Preservation Committee and a MCCRC member, shared additional information about the lack of protection and preservation of the building itself and artifacts housed inside the property. Daniels stated that among many issues that need to be addressed with the historical building and museum, the unsecured building has held artifacts in a non-climate-controlled environment since 2014. Additionally, the insurance policy for the property went unpaid during the years 2019-2021.

"The most egregious issues noted in the report was the poor treatment of rare objects found in the St. Luke and Odd Fellows Hall," Daniels said.

Some suggestions made by Daniels include, but are not limited to, hiring a professional museum curator with experience in African American culture and artifacts and establishing quality control reporting to the town of Blacksburg.

Nikki Giovanni, award-winning poet, activist, and Virginia Tech University Distinguished Professor Emerita, who resides in Christiansburg, echoed the previous comments of citizens public outcry to preserve and maintain the St. Luke and Odd Fellows Hall.

"What are we afraid of in saving a building and dealing with the history of New Town?" Giovanni said. "It is something we should be proud of. This is a wonderful place to be."

Dolores Walker of Radford, a student of the Christiansburg Institute, the historic segregated school for African Americans in the region, also addressed council.

"I'm trying to figure out how, piece by piece by piece, this town has leveled Black neighborhoods," Walker said. "Now, I don't know if it was institutionalized racism, but that is how I feel."

Council member John Bush also serves as the liaison to the Blacksburg Museum and Cultural Foundation Board. Bush agreed with the comments presented to council and thanked them for their commitment to be there. He also addressed the CAP report presented to Council, stating that they had received it about a month and a half ago.

"That report is fairly thorough; we are reviewing it now," Bush said. "I think what we will do as I understand it, is form two subcommittees; one to take the recommendations of the Black house and the other to take the recommendations of the St. Luke's and Odd Fellows Hall."

Also at the June 27 meeting, the continued use of a chlorinated water mixture, fluorinated water, and lead in the citizens of Blacksburg's public water were topics of concern for Gabrielle Parker of Blacksburg. According to Parker, the chlorine mixture is bad for leaded pipe systems.

"A scientist also discovered that chlorine can react with naturally occurring materials in water and create disinfection byproducts which have been known to cause cancer. These include THMs and TTHMs. These occur when the water is not being properly chlorinated," Parker said.

Parker asked that Council tests the water for these water additives and contaminants.

The following resolutions were unanimously approved by the Blacksburg Town Council during Tuesday's regular meeting and can be found on the agenda:

Resolution 6-C-23: A Resolution declaring the Town's intention to reimburse itself from the Proceeds of One or More Financings for Public Improvements.

Resolution 6-D-23: A Resolution Transferring \$695,000 between American Rescue Plan/ Coronavirus State and Local Fiscal Recovery Funds Projects.

Resolution 6-E-23: A Resolution Writing off the Town's uncollectible Water, Sewer and Refuse Service Receivables, Miscellaneous Receivables and Real Estate Taxes.

Resolution 6-F-23: A Resolution Authorizing the Waiver of Sidewalk Closing Fees in Downtown Blacksburg.

Council conducted several appointments as well during the Tuesday night regular meeting. The Blacksburg Planning Commission, the Blacksburg Housing and Community Development Advisory Board, the Board of Building Code Appeals, Zoning Appeals, the Business Relations Committee, Corridor Advisory Committee, Historic or Design Review Board, Public Arts Committee, and the Recreation Advisory Board.

"We have a Citizens Institute that takes place every spring, I think it is April, and we keep a running list of people who would like to be involved with that free activity. It runs about eight weeks and it is a deeply immersive education on how town systems work," Mayor Leslie Hager-Smith said. "So, we really do work on citizen power."

Vice Mayor Susan Anderson moved to approve all appointments as presented to Council, which are all found in the agenda. The appointments met with unanimous approval.

Financial Focus: Should you consider 401(k) loans or withdrawals?

At some point, you may have more money in your 401(k) than in any other investment. And even though your 401(k) is intended for your retirement, you may one day think you have to tap into your account early — but should you? And if you do, how should you go about it?

If it's possible to avoid taking money from your 401(k) before you retire, you probably should do so. You could spend 25 or more years in retirement, and you'll need to pay for those years, so you may want to look for alternatives to your 401(k). If you've built an emergency fund containing several months' worth of living expenses in cash or cash equivalents, you could use some of this money. If you have a Health Savings Account (HSA), you could use it to pay for qualified medical expenses. Or you could sell some of your taxable investments, rather than going into your tax-deferred 401(k).

But if you have determined that you must look at your 401(k) plan to meet a short-term funding need, you'll want to carefully consider how to go about it. You typically have two main choices: loans or withdrawals.

For plans that allow loans, employees can generally borrow up to 50% of the vested amount of their 401(k)s, up to a maximum of \$50,000 within a 12-month period. Administrative fees may apply, and Interest will be charged, but it will be added back to the 401(k) account as part of the loan repayments. Except when they're used for a home purchase, loans must be repaid within five years, with equal payments made at least quarterly, unless payments are allowed to be paused temporarily. If you leave the company or don't repay the loan according to the agreement, the loan balance will likely be treated as a taxable distribution.

Now, let's consider withdrawals. For 401(k) plans that allow current employees to make withdrawals, the withdrawal requests are usually considered either hardship or non-hardship. To qualify for a hardship withdrawal, you must demonstrate an immediate and heavy financial need to pay for certain expenses, including a home purchase, college, a medical issue or other specified costs, and your withdrawal is limited to the amount necessary

to meet the need. Non-hardship withdrawals can typically be taken for any purpose but usually are not granted until you're 59½ or older.

Unlike with a loan, a hardship withdrawal can't be repaid, while a non-hardship withdrawal can usually only be repaid by rolling over the amount to an IRA within 60 days. But the bigger issue may be taxes. If you withdraw funds from your 401(k), any previously untaxed money is generally taxed as ordinary income and a 10% penalty will apply if you're younger than 59½, unless you qualify for an exception. Plus, your 401(k) plan typically must withhold 20% of the withdrawal for taxes, so you'd have to take an even larger withdrawal to meet your needs.

Before embarking on a 401(k) loan or withdrawal, you may want to consult with a financial professional and your tax advisor. Taking money from your 401(k) is a big move, so make sure you know everything that's involved.

AARP warns against on-line quiz scams

Let's be honest, most of us have done it: taking one of those viral social media quizzes or threads that seem so fun and innocent. Post a picture of your first car. What cartoon princess are you? What record was number one the year you graduated high school?

They may seem like harmless fun, but the Better Business Bureau and digital-security companies warn that criminals sometimes use quizzes to pry loose personal data. Launching a quiz app may give its creators permission to pull information from your profile, offering hackers an opening to steal

your online identity. Here are three social media scams to avoid.

Avoid queries about innocent-sounding things like your high school mascot or first car that might be linked to common security questions that banks and financial firms use to protect accounts. Be suspicious of any personal messages appearing to come from celebrities you follow. Criminals often impersonate celebrities online and offer special access for a price or ask for help with a new investment or charitable contributions.

Another classic social media scam involves a

direct message from one of your personal contacts asking "is this a picture of you" with a link to click on. Clicking the link takes you to a site that mimics one of the popular social networks and prompts you to log in, a ploy for hackers to get your credentials and access your account.

Be a fraud fighter! If you can spot a scam, you can stop a scam.

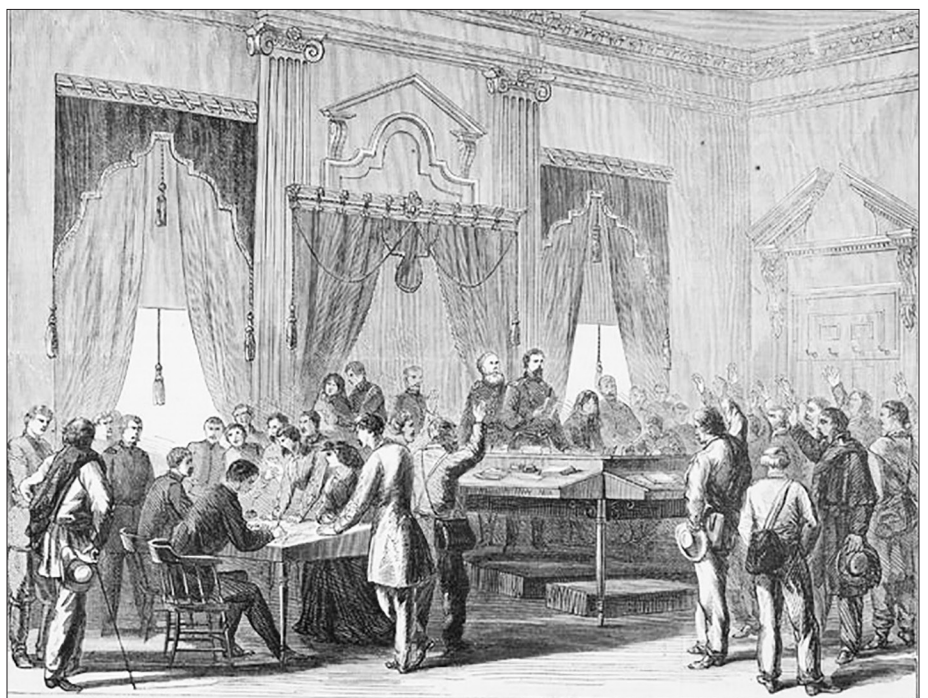

Glencoe Mansion social media offers history lessons

RADFORD – Glencoe Mansion, Museum and Gallery's Instagram and Facebooks pages are a great resource for local history lessons. Each week, for example, Glencoe publishes "Wharton Letter Tuesday," an excerpt from Glencoe builder and inhabitant General Gabriel Wharton's letters to home during the Civil War.

"On April 9, 1865 Gen. Robert E. Lee surrendered to Gen. Ulysses S. Grant at Appomattox Court House, Virginia. Although that was the beginning of the end of the Civil War, it would take a few more months for the Confederacy to fully fall," the latest post reads. "For Gen. Wharton's part, he was in or around Lynchburg on April 9. He and his men were granted a leave of absence on April 12, which they used to return home. Gabe returned to Nannie and William at Arnheim until June of 1865. On June 20 he traveled to Lynchburg to formally surrender. He

wrote to Nannie on June 21: "Well the Count and I marched up this morning surrendered ourselves & were paroled." They took an oath of allegiance to the United States, similar to

the scene depicted in this picture. Then they were given passes to go home, and Gabe once again his family at Arnheim."

Fixsen's road to gold

At the 2023 NCAA Outdoor Track and Field Championships, Julia Fixsen made winning a national title look effortless.

Her title-clenching vault (14 feet, 7 inches; 4.45 meters) wasn't by the skin of her teeth, as she cleared it with ease on her first attempt.

Fixsen felt confident and relaxed stepping on the runway that evening, knowing world-class coach Bob Phillips and three nationally ranked teammates were by her side.

But Fixsen's path to national champion was certainly not easy – it required switching schools, battling foot pain and hours of hard work.

As a former gymnast and a 2021 transfer from Georgia, Fixsen joined the Hokies to take her vaulting to the next level. She knew how much Tech's track program valued the event, being one of the few schools in the country with a coach dedicated exclusively to pole vault.

"Coach Phillips is just an amazing coach, and it's special because his focus is completely on us," Fixsen said. "That's actually a huge deal. Every practice of every week, he's there, he's coaching and it makes us consistent."

Phillips, a former All-American at Tech, has mastered the formula for success. During his 37 years as the coach of the Hokies' pole vaulters, Phillips' vaulters have won 38 individual ACC titles and two national titles. It also helps that head coach Dave Cianelli buys into the event, providing poles and any resources that are needed to help the program.

Fixsen knew that Tech's program, dubbed "Pole Vault U" by some circles, had what she needed to win.

Transitioning to a new school had its challenges. Fixsen faced an unfamiliar community and a different training program. She also

had to regain confidence in her vaulting. Coming out of Georgia, she had missed the pit and landed on the right side when jumping on larger poles.

But after Coach Phillips corrected her technique on the short-run jumps, her impact as a Hokie was instant. At the 2022 NCAA Indoor Track and Field Championships, Fixsen earned bronze, finishing a couple spots behind her national champion teammate Rachel Baxter.

As the 2022-23 season began, Fixsen knew she could win both an ACC and national title. She just needed to stay consistently confident.

"The whole year I was working on my confidence," Fixsen said. "For me, that meant jumping bars [as opposed to using a bungee] in practice so that I wasn't afraid when the bar came up in meets."

Fixsen's mental toughness was tested at the 2023 ACC Indoor Track and Field Championships. Due to a previous injury, her foot had been flaring up during the season, so she felt intense pain when making her attempts. But Fixsen knew that she needed to clear the 14-foot, 5-inch (4.40 meters) bar for points.

"Everything was on the line for that jump," Fixsen said. "I knew I wasn't going to win, but I didn't care. I had to step up because my team needed the points."

Despite the pain, Fixsen managed to clear that bar. Many teammates and fans later told her that she was the reason Tech won the team competition by one point.

Fixsen no longer felt she was lacking in confidence, setting her sights on winning the 2023 NCAA Outdoor Track and Field Championships. It was only a matter of keeping her foot pain free.

"The most important thing she did [to prepare] was stay patient and do an

excellent job of cross training as we worked through the issues with her foot," Phillips said. "It made a big difference."

On the day of the championship, Fixsen focused on conserving her energy so that she could jump as many heights as possible. There were 24 vaulters, meaning a long competition. To allow for maximum recovery time, she didn't complete the full warm up, laid down between jumps and made sure to clear each bar on the first attempt.

Even more importantly, she had three teammates competing alongside her.

"One of the things that made her confident and comfortable," Phillips said, "was having three teammates right there with her, so there wasn't the pressure of being the only person there."

For Fixsen, having those girls by her side made the meet seem less daunting and more like practice. Instead of feeling any unnecessary pressure, she felt a whole new level of support from the girls she spends hours with every day.

It was the perfect way to win a national title.

"When I cleared that final bar, I was just so excited," Fixsen said. "I had to scream. I've cleared that bar before many times, but never like that."

She's not done yet, either. With two seasons remaining, Fixsen has her sights set on jumping even higher. She aims to compete at the pro level after graduation, just like her teammate Baxter.

It's a genuine love for the sport that drives Fixsen, and she hopes that her journey can inspire the next generation of athletes.

"I'd love to be an inspiration to people," Fixsen said. "Growing up, I looked up to some amazing female athletes. To think that I could be a role model for younger girls is pretty cool."

One of the top available softball pitchers in the transfer portal has announced plans to attend Radford University.

Abby Peace said on Twitter this past week she would transfer from WVU Potomac State College.

In one season at the Keyser West Virginia, she earned third-team All-America honors for the National Junior College Athletic Association Division II. In 29 games, Peace pitched 152.2 innings and had a 22-2 record (tied for eighth in NJCAA Division II in wins), 1.33 ERA (fifth nationally), 22 complete games, two saves, 270 strikeouts (third nationally, 12.38 per seven innings).

Peace also excelled at the plate in leading the Catamounts to a 43-5 record and a berth in the NJCAA DII College World Series, hitting 18 home runs, 60 RBIs, a .340 batting average and a .745 slugging percentage.

Peace will be a sophomore for Radford, which went 16-34 overall and 5-16 in the

Big South last year.

This transfer news comes just days after Radford University lost one of its best softball players to cross the river rival Virginia Tech.

The Virginia Tech softball team and head coach Pete D'Amour announced the addition of Cori McMillan to the 2023-24 squad on Monday. McMillan joins the Hokies as a transfer from Radford after playing two seasons with the Highlanders.

During her time at Radford, McMillan posted a .345 career average, tallying 102 hits, including 22 doubles and 17 home runs. She had 59 RBI for the Highlanders, with a .611 slugging percentage, .391 on base percentage, adding 31 stolen bases.

McMillan had a standout freshman season in 2022, named an NFCA Top-25 Freshman of the Year Finalist after batting .365 with 14 home runs and 13 doubles to lead the team. In 148 at bats, she posted a .736 slugging percentage, adding 36 RBI, which was another team-high.

McMillan scored 38 runs and also stole 11 bases in her rookie

campaign. Defensively, she had 87 assists to lead the team, as well as 70 putouts. In addition to being a Freshman of the Year Finalist, she was named First Team All-Big South, Big South All-Freshman, First Team NFCA Mid-Atlantic Region and VaSID All-State Second Team.

As a sophomore, McMillan continued to lead the Highlanders, ranking in the top three on the team with a .324 batting average with 48 hits, earning All-Big South for the second straight season. She finished the 2023 season with nine doubles, three triples and three home runs, adding 23 RBI and a team-high .486 slugging percentage.

On the base paths, McMillan stole 20 bases on the year and had a .375 on base percentage. Defensively, she recorded 93 assists and 52 putouts on the year at third base.

In the classroom, McMillan is a two-time NFCA Scholar Athlete, as well as a member of the Dean's List and President's List at Radford for all four semesters she attended.

Tech, Auburn in ACC/SEC Challenge

Virginia Tech and Auburn will clash in the inaugural ACC/SEC Challenge as announced by ESPN, Wednesday morning. The eighth all-time meeting between the two programs will take place Wednesday, Nov. 29 at Auburn Arena in Auburn, Ala. Tipoff is slated for 9:15 p.m. ET.

Coverage details, including platform designations and commentator information, will be announced in the fall.

"Our program is very much looking forward to representing our institution, our fans and our conference in the inaugural ACC/SEC Challenge," head coach Mike Young said. "Auburn is an outstanding opponent for us led by Coach [Bruce] Pearl, whom I have great respect for."

November's matchup will be the first time Tech and Auburn have met since Dec. 21, 1999. The Tigers lead the head-to-head series, 5-2. This will be the second meeting in series history at Auburn, but fourth meeting overall in Alabama.

The Hokies return three starters from a squad that finished 19-15 overall last season. Headlined by 2022 ACC Tournament MVP Hunter Cattoor and second-leading scorer Sean Pedulla, Tech will look to recapture the momentum that had the Hokies 11-1 and ranked as high as No. 21 in the AP Poll through 12 games last year.

VT will also be bolstered by sophomore guard Rodney Rice, who had his first season in Blacksburg shortened by injuries. The Hokies should be much deeper this year with the addition of three transfers,

Tyler Nickel, Mekhi Long and Robbie Beran, to go along with freshmen Brandon Rechsteiner and Jaydon Young.

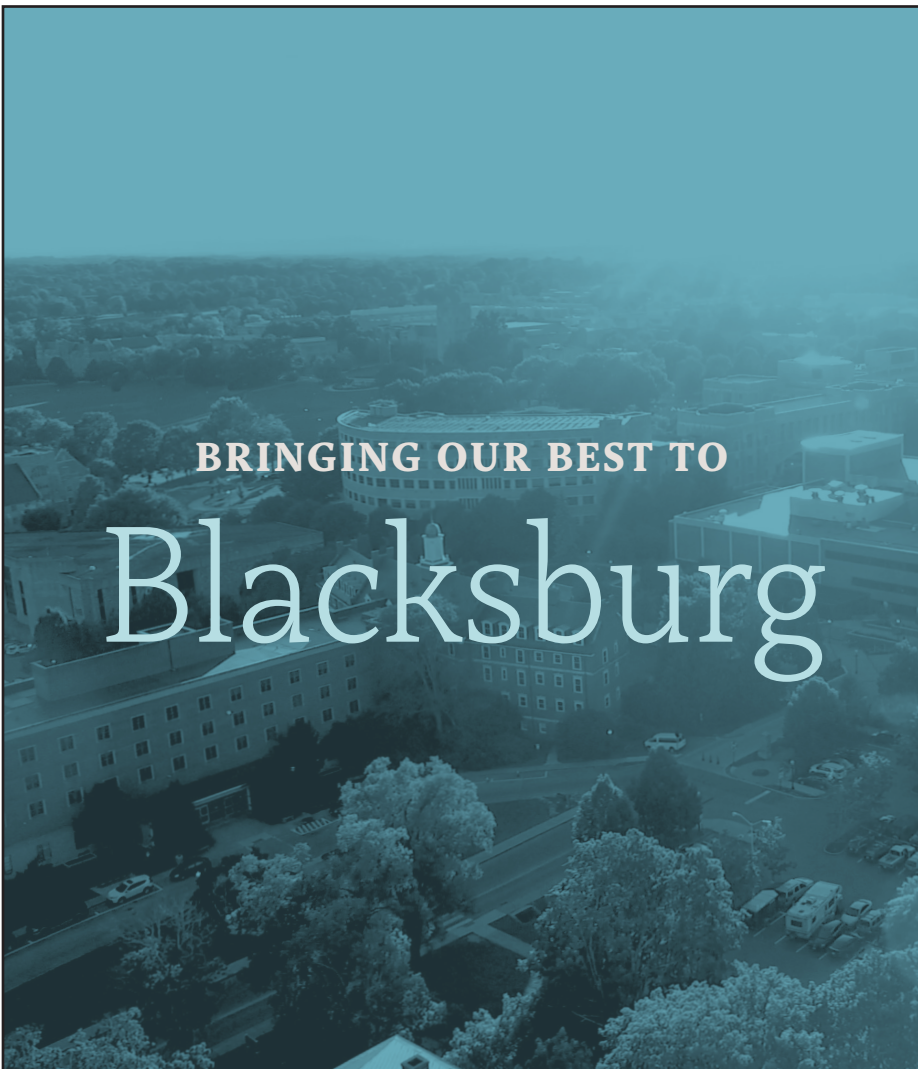
Auburn concluded last season with a 21-13 record and advanced to the second round of the 2023 NCAA tournament as the No. 9 seed.

With the announcement of the ACC/SEC Challenge, Tech now has three events confirmed for its 2023-24 schedule. In addition to playing Auburn, the Hokies are facing SEC foe South Carolina as part of the HOF Series in Charlotte, N.C., on Nov. 10. Two weeks later, Tech will compete in the loaded ESPN Events Invitational in Orlando, Fla.

The Hokies' full nonconference schedule will be released in the coming weeks.

Final Four rematch to take place Nov. 30

In a rematch of the national semifinal in March, the Virginia Tech women's basketball team is set to face national champs LSU in the 2023 ACC/SEC Challenge, ESPN has announced.

Tipoff is set for 9 p.m. ET on Thursday, Nov. 30 from the Pete Maravich Assembly Center in Baton Rouge. Specific details about the television designation will be announced at a later date.

The Hokies fell to LSU 79-72 in Dallas in March at the Final Four in the first national semifinal. In that game Elizabeth Kitley recorded a double-double with 18 points and 12 rebounds and she was joined in double figures by Georgia Amoore (17), Kayana Traylor (17) and Cayla King (14).

LSU holds a 3-1 edge in the all-time series

which dates back to 1984. The Tigers have won each of the last three meetings, which took place in 2001, 2006 and 2023.

The Tigers, led by Head Coach Kim Mulkey return superstar forward Angel Reese and have added impact transfers Hailey Van Lith (Louisville) and Aneesah Morrow (DePaul).

The Hokies return Kitley, a Second Team All-American and two-time ACC Player of the Year. Last season she averaged 18.2 points per game and 10.7 rebounds, collecting 23 double-doubles and helping the Hokies to their best season in program history. She was amongst the national leaders in blocks, double-doubles, field goals and rebounds. For her career, she tops the Virginia Tech record book in

numerous categories: points, double-doubles, 30-point games, field goals, field goal percentage and blocks.

All-American point guard Amoore who made the second-most threes in the country a season ago (118) is back for her senior season. She was named the MVP of the ACC Tournament and the Seattle 3 Region's Most Outstanding Player, connected on 24 threes in the NCAA Tournament and set an ACC Tournament record with 14 in Greensboro en route to lifting the program's first ACC Championship trophy.

Tech's third returning starter in 2023-24 is King. She ranks fourth all-time at Tech with 225 threes and owns the record for threes in a game with nine.

Christiansburg native full-time at Averett

Averett University football head coach Patrick Henry announced Wednesday the full-time hiring of longtime assistant Patrick Bolen as offensive line coach.

Bolen has been affiliated with the Averett football program

for a majority of its existence as a part-time coach. He coached the Cougars' offensive line from 2006-09 before rejoining the program, where he helped coach the defensive line during the 2011 season.

He then served as a linebackers' coach and defensive assistant coach before moving to offense to coach the offensive line and tight ends. During his tenure, he's also helped coach long snappers and various special teams positions with Averett.

"Coach Bolen is someone who has dedicated 16-going-

on-17 years to this program," Henry said. "He knows how we recruit, how we practice and, most importantly, he knows our players. The rapport he has created in his time here is why I am so excited to move him from a part-time to full-time role."

Bolen has coached 24 all-conference selections and four players who went on to play professionally.

Before joining Averett's football staff, Bolen was a linebackers coach at Christiansburg High School from 2003-06.
