## Radford University sees significant growth in local enrollment through targeted recruitment efforts

RADFORD - Radford University's strategic focus on local recruitment efforts has yielded impressive results, with a substantial increase in enrollment from high schools and community colleges within a 100-mile radius of the campus.

The growth is evident across both freshmen and transfer student categories, marking a significant, and historic, milestone for the university.

Over the past year, Radford University has amplified its outreach to local high schools and community colleges, leading to remarkable enrollment gains from various counties and cities in the region. The top 10 high schools contributing to this growth include:

- Patrick Henry High School, Roanoke: 157% increase
- William Fleming High School, Roanoke: 212% increase
- Floyd County High School, Floyd: 128% increase
- Cave Spring High School, Roanoke: 23% increase

increase Giles County High School, Pearisburg: 233% increase Franklin County High School, Rocky Mount: 46% increase

Radford County High School, Radford: 166% increase

Pulaski County High School, Dublin: 32% increase

Northside High School, Roanoke: 357% increase

Christiansburg High School, Christiansburg: 54% increase

The university also experienced a 41% increase in transfer students from the New River Valley and Roanoke areas, with 279 new students joining from these regions.

"This year's enrollment figures reflect the success of our targeted local recruitment strategy and our strong commitment to serving the educational needs of our community," said Dannette Gomez Beane, Vice President for Enrollment Management and Strategic

Communications. "By focusing on strengthening relationships with local high schools and community colleges, we have been able to attract a diverse group of students who are eager to invest in their futures by continuing their education at Radford University."

"Radford University has done a phenomenal job partnering with local school divisions in visiting and presenting information about their new initiatives with the Tuition Promise," said Tara Grant, Pulaski County Public Schools Assistant Superintendent of Curriculum and Instruction. "President Bret Danilowicz helped Dr. Danette Beane in an informational session for seniors and their families. They brought current Radford students that graduated from Pulaski High School to talk about their experience. Radford University has invited students in high school and elementary schools for field trips to give students

the opportunities to visit campus and think about those next steps. Their athletics department has an Education Day where elementary schools can bring their whole school or specific grade levels of students to watch a division one athletic event. Students and teachers enjoy this event! We partner with Radford University with interns

from the education program. That's a great way for us to recruit teachers for the next year and we really spend a lot of time getting to know them. Radford University does a great job with reaching out to alumni and creating alumni ambassadors at schools, especially high schools to promote their university. I have three graduates from

Radford University and I'm so proud to be a part of the Highlander family."

This encouraging trend underscores Radford University's role as a vital educational institution within the region and commonwealth, providing accessible, high-quality education to students close to home.

RADFORD - The Radford Public Library is inviting families to come to the library to register children under five for free books from Dolly Parton's Imagination Library courtesy of the Lamplighters.

The event is set for this Saturday, Sept. 7 at 11 a.m. There will be a ribbon cutting ceremony with the Radford Chamber of Commerce along with prizes for the first 50 kids registered.

"We'll also have cute animals visiting from Southwest Virginia Wildlife Center, and we'll celebrate it all with delicious cake," the library announced.

According to imaginationlibrary.com, Dolly Parton's Imagination Library is a "book gifting program that mails free, high-quality books to children from

birth to age five, no matter their family's income."

"After launching in 1995, the program grew quickly," the website states. "First, books were only distributed to children living in Sevier County, Tennessee where Dolly grew up. It became such a success that in 2000 a national replication effort was underway. By 2003, Dolly Parton's Imagination Library had mailed one million books. It would prove to be the first of many millions of books sent to children around the world. After the United States, the program launched in Canada in 2006 followed by the United Kingdom in 2007, Australia in 2013 and the Republic of Ireland in 2019."

The Town of Blacksburg and CHA Consulting, Inc., will perform smoke testing in the upper Harding Sewershed during the week of Sept. 9 and Sept. 16. The process blows smoke into the sewer system, which then escapes through leaks found in the lines. Leaks allow rainwater, creek water, and other stormwater runoff to enter the system. The area within the Harding Sewershed that will be impacted by this work includes the Apperson Park development and Windsor Hills. During this work, citizens may see smoke coming out of the ground, and occasionally, when household plumbing is not in conformance with code, smoke may enter residences. For this reason, CHA will place informational door hangers at residences that may be affected several days in advance of the testing. 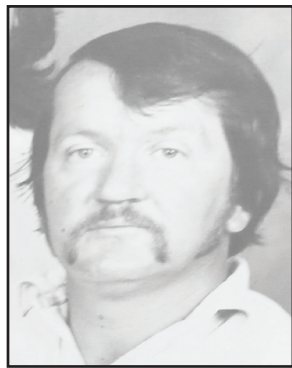

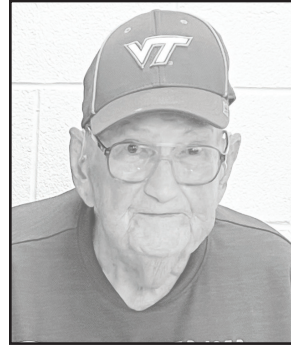

Phyllis Hudson of Dublin; daughter-in-law, Rose Lawson of Radford; numerous grandchildren; and many other relatives and friends.

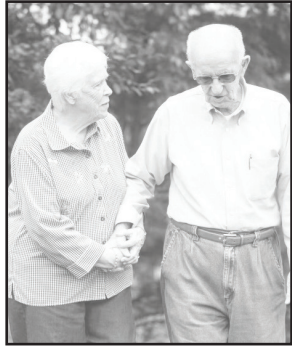

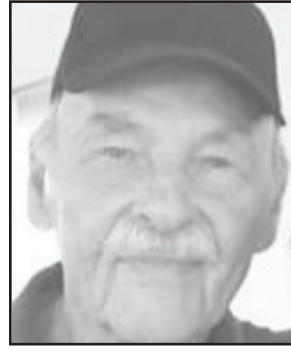

## NRVRC addresses Board of Supervisors about new office building

MONTGOMERY COUNTY- Kevin Byrd, Executive Director of New River Valley Regional Commission, addressed the Montgomery County Board of Supervisors on the NRVRC's need for a larger office space at the BOS Aug. 26 meeting.

Byrd, in his presentation, explained that the New River Regional Commission has existed for about 55 years (since 1969) and for the first 30 years, was based out of Radford. In the past 25 years, Byrd explained, they have expanded their space multiple times but now needs a larger space and a space that is accessible after hours for public meetings. Byrd said the NRVRC has 22 employees currently and in their current space, many of them share offices, even explaining that one office is 383 square feet and shared between three employees. This new building would not only locate NRVRC within Montgomery County, but also, with some construction, provide the organization with the space and offices needed to comfortably provide for their staff.

The NRVRC is currently planning on purchasing the old American National Bank Building off of Market Street in Christiansburg. With this location, Byrd explained, they would build out the drive-through area and enclose that to create a large conference room that would have after hours access for their public meetings where they need space. This would also allow them to lock down the

rest of the building. Byrd also addressed this building's central location as ideal because it also faces Franklin Street and is close to Uptown Mall and other Uptown Christiansburg amenities.

"This is," Byrd said, "ideally centrally located for the organization and right in the middle of what happens in the New River Valley in that main intersection there. It's also accessible through public transit which is not the case where we are currently."

The purpose of Byrd's presentation was to gain a consensus from the Board of Supervisors before reaching out to the other localities the NRVRC serves and explain the proposed changes to the building when it is purchased. Byrd also showed a breakdown of the financial cost with the building currently priced at two million dollars to purchase before any construction is done. The estimated total project cost with the purchase of the building and construction is 3.5 million dollars.

"This is an important asset," Angela Hill, County Administrator, said, "for the county, and I think for our region. I think that Montgomery County is in a good position, a critical position, to help the Regional Commission to move forward at this point."

Hill explained that at the next board meeting, it would be best that the Board of Supervisors sign a support agreement to help the NRVRC in terms of helping them with banking and funding. This would be the next step so that the NRVRC could begin to entertain financing options.

## Virginia motorists adjusting to hand-held phone ban

RICHMOND—The 2021 law banning the use of hand-held communications devices while driving on Virginia's roadways was a good start toward altering motorist behavior and reducing distracted driving crashes.

Now a culture shift is needed to reframe what the public views as acceptable when it comes to digital distractions inside vehicles.

Traffic safety and law enforcement officials discussed the ban's viability at Drive Smart Virginia's 11th Annual Distracted Driving Summit, recently held in Richmond. Virginia Farm Bureau Mutual Insurance Co. co-sponsored the summit.

Danny Sharp, retired chief of the Oro Valley Police Department in Arizona, said he remembers when alcohol-related

traffic fatalities were simply considered "unfortunate accidents." But public attitudes toward impaired driving have changed over the decades.

"It has to become socially unacceptable to kill somebody while driving under the influence of electronics as well," Sharp said in a panel discussion. "The reaction of seeing someone driving down the freeway drinking a beer needs to be the same as seeing someone driving and texting."

He was instrumental in crafting a local ordinance that ultimately became a statewide hand-held phone ban. Virginia's law was drafted using Arizona's as a template.

Distracted driving accounts for about 17% of all traffic crashes in the state, dropping slightly since 2021, according to Virginia Crash Facts. In 2023, 61 fatalities

and 7,200 injuries resulted from 21,528 distracted driving crashes.

The Department of Motor Vehicles assigns three demerit points for the primary offense, plus fines starting at \$125.

"And there are other consequences to that," said Dana Schrad, Virginia Association of Chiefs of Police executive director. "Not the least of which is insurance."

Insurance companies often view drivers who use their phones while driving as high-risk, which can lead to higher premiums.

Henrico County Police Lt. Rob Netherland said in the law's first year, about 900 summonses were issued to local motorists who violated the ban on hand-held devices.

"Now we're down to about 400, and that's a good thing," he said. "The message

is getting out there."

He said some motorists mistakenly believe the hand-held law only applies specifically to texting while driving.

"Programming a GPS or dialing a phone number while driving—you can't do that either," Netherland explained.

Unless reporting an emergency, drivers must be lawfully parked or stopped to handle their phone behind the wheel.

Sharp said 34 U.S. states and the District of Columbia have enacted hands-free driving laws. As Virginia motorists adjust their behavior, public officials continue driving the message home.

"You know the old saying," Schrad concluded. "Ignorance of the law is no excuse."

Another school year has begun, and for Hokie sports fans that means the start of a new football season and a lot of tailgating. But tailgating brings unique food safety challenges that you don't necessarily have to worry about when eating at home.

Virginia Tech food safety specialist Melissa Wright is here with a few tips you can follow to make sure your tailgate fun isn't spoiled by foodborne illness.

"One of the biggest food safety issues people run into at tailgates is related to transporting and handling food," Wright said. "The danger zone is between 40 degrees and 140 degrees Fahrenheit, and allowing hot or cold food to be in that zone for longer than two hours can allow bacteria to multiply rapidly, leading to foodborne illness."

When the outdoor temperature is above 90 degrees, that window closes to one hour, Wright said.

"The same guidance extends to serving food as well as transporting it," Wright said. "You want to keep hot foods hot and cold foods like coleslaw and potato salad cold, so keep the crockpot on while serving meatballs and sausages and keep dips and cold spreads on ice."

Because access to electricity

might be limited, Wright said wrapping cooked foods and their containers in aluminum foil or towels can help keep their temperature up.

Cross-contamination between raw meat and other foods is another common way foodborne bacteria can spread.

"It's a good idea to use separate coolers for raw meats and ready-to-eat foods that won't be cooked," Wright said. "Make sure raw proteins, including seafood, are packaged in sealed containers and kept in an insulated cooler below 40 degrees prior to cooking."

There are plenty of opportunities for contamination during the cooking process as well, so never use the same cutting board or preparation surface for raw meats and other foods and use a clean pair of tongs that haven't come into contact with raw foods when removing cooked foods from the grill.

"You never want raw meat to come into contact with cooked meat," Wright said.

"Ground beef needs to reach an internal temperature of 160 degrees and all poultry needs to reach an internal temperature of 165 degrees to be safe, so bring your food thermometer as well."

Some other helpful tips, Wright said, include:

Food safety begins with clean hands and surfaces, even in an outdoor setting. Practice good hand hygiene, which might be as simple as a water jug, some soap, and paper towels. If the surfaces you have access to are not cleanable, consider using disposable tablecloths.

Consider using a dedicated cooler for beverages because that cooler tends to be opened frequently as guests grab drinks throughout the tailgate, which likely won't keep any food inside cold enough.

Marinate meats under refrigeration (less than 40 degrees) and discard the excess. "A marinade should never be brushed onto a cooked item. They often contain raw ingredients and are meant to be cooked with the food, so throw out any leftover marinade you have left after putting food on the grill."

Wright said many people don't think of these things at an event like a tailgate, but with over 3,000 deaths and 128,000 hospitalizations due to foodborne illness in the U.S. each year, they're worth keeping in mind.

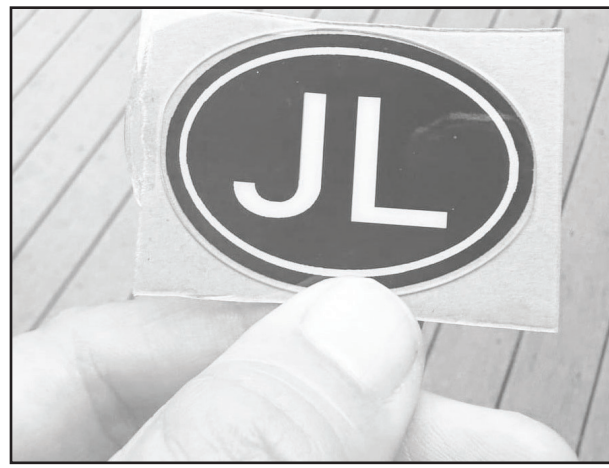

# Hokies try to rebound after Vandy loss

Virginia Tech returns home from Nashville, where they were shellshocked in its first football game of the year by Vanderbilt.

Coach Brent Pry and the Hokies were burned by a Southeastern Conference (SEC) team. Now they will turn their attention to Marshall, who is coming off a 45-3 win over Stoney Brook.

The game served as the first action for Marshall in the new Air Raid offense, although the rushing attack proved just as effective throughout the matchup. The Herd amassed 549 yards of total offense with 259 yards on the ground and 290 through the air with three quarterbacks combining to complete 65 percent of their passes with five touchdowns and no turnovers.

A.J. Turner led the way for the Herd on the ground with 119 yards on eight carries

Fans will remember a 2023 Marshall team that beat (24-17) the Hokies in a 3-10 season.

Under Pry, Tech last year won four of its final six regular season games to clinch bowl eligibility. The Hokies advanced to the 2023 Military Bowl presented by GoBowling.com, where they defeated No. 23 Tulane, 41-20. Now, they turn their attention Marshall in the first home game of the 2024 season.

Virginia Tech achieved a 5-3 ACC record during Pry's sophomore head coaching season, finishing in a tie for fourth place in the year-end standings.

The Hokies averaged 41.8 points during their five ACC victories and sported a +126 scoring margin, including November road romps at Boston College (48-22) and at Virginia (55-17).

Virginia Tech ranked fourth among NCAA FBS programs and led the ACC in fewest passing yards allowed (168.8 per game), trailing only Ohio State (145.9), Michigan (157.0) and Notre Dame (157.3).

Defensively, the Hokies tied for the nation's 10th most sacks per game (3.00) and the 10th most total sacks (39), ranking second among ACC programs in both categories. Individually, defensive end Antwaun Powell Ryland tied for the 14th most sacks per game (0.73) and the 16th most total sacks

(9.5), also ranking second among ACC players in both categories.

Tech ranked 13th nationally in team TFLs per game (7.2) and 14th in total team TFLs (94), ranking second and third, respectively, among ACC sides.

Virginia Tech boasted the country's 20th best team defense, holding opponents on average to 316.8 yards per game.

Virginia Tech retains 42 letterwinners from its 2023 roster.

In February 2024, ESPN staff writer Bill Connelly ranked Virginia Tech as the No. 1 FBS program in terms of returning production, clocked at 86 percent. Connelly also ranked the Hokies as the No. 1 FBS program in returning offensive production, assessed at 95 percent.

The Hokies return 19 of their 22 offensive and defensive starters from their 2023 Military Bowl victory against No. 23 Tulane, including all 11 starters on the offensive side of the ball.

The incoming freshman class includes 15 scholarship players who had impressive high school careers. The group includes 13 players who served as team captains and five state championships as a class.

Pry and his staff continue to focus on the Hokies' recruiting footprint, inking five in-state signees, all ranked within the top 25 in the Commonwealth per 247 Sports. Six of the 15 signees are from within a 325-mile radius of Blacksburg, including defensive lineman Deric Dandy and running back Tyler Mason, both from Mount Airy, North Carolina, along with defensive back Quentin Reddish from Charlotte, North Carolina.

The class represents seven states. In addition to Virginia, three signees hail from North Carolina, with two each from Maryland and Ohio and one each from Georgia, Florida and New Jersey.

During preseason camp, Coach Brent Pry announced the seven 2024 team captains following a program-wide vote. This year's captains are redshirt junior QB Kyrion Drones, senior OL Kaden Moore, redshirt senior LB Sam Brumfield, graduate WR Da'Quan Felton, graduate CB Dorian Strong, senior DL Cole Nelson and senior P Peter Moore. Kaden Moore is a repeat captain from 2023 while Peter Moore is a captain for the third straight year.

wait to see what else this collaboration can achieve."

Metallica first introduced "Enter Sandman" in 1991 as the lead single from their self-titled album. It hit No. 16 on the Billboard Hot 100 that same year and later earned platinum status. The "Enter Sandman" music video was only the second music video from Metallica and premiered on July 30, 1991.

The rhythmic jumping to "Enter Sandman" started a few years after its debut as the football team's walkout song, when a Marching Virginian began to hop around to warm up during a cold snap. That spontaneous act evolved into the legendary electrifying entrance that now invigorates home games. Accompanied by fireworks and pyrotechnics, "Enter Sandman's" noise and fanfare even cause the stadium to shake - occasionally setting off seismographs.

"Enter Sandman" carried over to both the men's and women's Virginia Tech basketball teams, and even some graduations feature the iconic production.

Regarded by many as college football's most powerful entrance, "Enter Sandman" is a beloved tradition for Hokies.

According to a release, the initial lineup of merchandise co-branded with Metallica features designs inspired by the band's logo and original

sketches by Virginia Tech doodle artist Steven White.

"Enter Sandman" is a tradition that dates to Aug. 27, 2000, when Virginia Tech installed its first video scoreboard in Lane Stadium and needed a new walkout song.

Merchandise is on sale now at merchants that include the Hokie Shop and the Hokie Sports Shop.

Managers at both retail locations say the items are flying off the shelves.

The T-shirts made an appearance on Aug. 12 during the "Today" show's birthday celebration for co-anchor Hoda Kotb '86, when the HokieBird and other Hokies visited the set and presented Kotb with the co-branded T-shirts and other Virginia Tech goodies.

Renee Alarid, director of the Office of Licensing and Trademarks, said collaboration with partner and brand management organization College Licensing Company (CLC), Virginia Tech's agent, facilitated the co-branding.

"It was a very effective collaboration," Alarid said. "It was quite an effort, taking about a year to hammer out and finalize, and we had to keep it top secret."

"It took a community and the right team," she said. "Without CLC, the Original Retro Brand, athletics, and the trust of our local retailers, Licensing and Trademarks would not have been able to make this dream a reality. Thank you everyone who helped us in the process."

"Enter Sandman" and the unmatched fan intensity at Lane Stadium is one of the great experiences in college sports, and we're

excited to work alongside Virginia Tech to expand this amazing tradition to a customized merchandise collaboration with Metallica," said Nicole Armentrout, CLC's senior vice president of marketing. "Our goal is to help bring unique experiences and traditions like this one into the marketplace so that passionate Hokie fans can relive and showcase the great moments well beyond game day."

Virginia Tech Licensing and Trademarks, Downtown Blacksburg Inc., the Town of Blacksburg, the Blacksburg Partnership, and several Blacksburg businesses will host a block party downtown - Kickoff on College Avenue - on Sept. 6.

"We're delighted to work with Virginia Tech to showcase this exciting collaboration with Metallica at the Kickoff on College Avenue event," said Ann Cassell, president of the Blacksburg Partnership. "Virginia Tech and Blacksburg are so closely linked and this will only add to the energy and excitement in town as students return and a new football season begins. It's been a busy summer of infrastructure improvements in Blacksburg, and we look forward to welcoming students, alumni, and visiting fans back home this fall."

Everyone is invited to share in the excitement at the Kickoff on College Avenue from 5 to 9 p.m. Sept. 6, the eve of Virginia Tech's first home football game of the seasons. The block party is open to the public as well as students, faculty, and staff at Virginia Tech and their families and friends to celebrate the greater Blacksburg community.
