

## Greenbrier Valley Airport awarded \$2.8M from the U.S. EDA

Greenbrier Valley Airport is pleased to announce that it has secured \$2.8 million in federal funding for significant infrastructure improvements and expansion. The U.S. Department of Commerce's Economic Development Administration (EDA) has approved the airport's application under its Economic Adjustment Assistance Program. The total project amount of \$3.5 million includes a \$700,000 local investment.

This landmark project shows EDA's commitment to fulfilling their mission to lead the federal economic development agenda by promoting innovation and competitiveness and preparing American regions for growth and success in the worldwide economy.

The project includes:

• Construction of ten new T hangars, each measuring 1,135 square feet

• Building of a 550-square-foot meeting room and bathroom facilities

• Installation of approximately 1,800 linear feet of water line

• Addition of 3,500 linear feet of sewer line

"We are thrilled to receive this crucial funding from the EDA," said Martha Livesay, Airport Director of Greenbrier Valley Airport. "These improvements will not only enhance our airport's capabilities but also contribute to the economic growth of our region."


The new facilities, particularly the T-Hangars and training center, are expected to attract more aviation enthusiasts and businesses to the area, fostering job creation and economic development.

This project aligns with the airport's long-term growth vision and commitment to serving the Greenbrier Valley community. Construction is slated to begin in spring 2025, with an estimated completion date of Spring 2026 Region 4 Planning and Development Council assisted with the Airport's grant application process and was instrumental in laying the groundwork for a successful award.

County Commission supports new fire truck lease for Rainelle VFD, grant support for God's Way Home and Seed Sowers recovery group

The Greenbrier County Commission meeting held on Sept. 24 included a presentation by the Convention and Visitor's Bureau (now known at Experience Greenbrier Valley), a letter of support for the Rainelle Volunteer Fire Department, discussion of support for God's Way Home and Seed Sowers, and more.

The County Commissioners welcomed Kara Dense, President and CEO of the Greenbrier County Convention and Visitors Bureau, to discuss the CVB's annual report. The CVB has been the designated marketing organization for Greenbrier County since 2001, with a mission to positively impact the area's economy by marketing the region as a premier tourism designation.

The organization is made up of 20 board members and

11 staff members with six being full-time employees and five being part-time. They have been accredited with the Better Business Bureau since 2006 and have recently decided to begin operating under a new name, Experience Greenbrier Valley.

Each year, it is required that a presentation be made to the County Commission as well as year-end financials be sent to the state auditor's office, WV Joint Committee on Government and Finance, and the WVACBB Office. Dense stated that in 2023, WV saw a record breaking 75 million visitors bring Greenbrier County's direct spending number to \$399.4 million and \$41.73 million in local and state taxes generated, adding that if it were not for visitors, taxpayers in Greenbrier County would have to pay an addition \$2,834 per household in taxes to keep services the same as they currently are. She also shared that Lewisburg was named the Best Small Town Food Scene in USA Today's Readers Choice for 2024 for the second year and the organization recently won a reward at the Governors Conference for Best Print Media on their Visitors Guide. The commissioners expressed their gratitude to Dense and the Visitors Bureau for all their hard work and dedication to the county.

The next item on the agenda was the consideration of

approval of a letter of support for Rainelle Volunteer Fire Department for a fire truck Lease Purchase Agreement. Matt Osbourne, Fire Chief at the Rainelle VFD, was present to speak on the matter, stating that their newest engine to current date is a 2007 model, and the fleet is starting to show age. They are looking to replace the first engine out for structure fires, a 1987 model. Commissioner President Tammy Shifflett-Tincher added that the Rainelle VFD is their own entity but the finance company, being a municipal leasing company, requires a letter of support from a government entity within the coverage area of the fire department. The letter of support was approved unanimously.

Next, a letter of support was also requested by God's Way Home and Seed Sowers, both recovery support groups of Greenbrier County, for a grant application through the WV First Foundation. Andrew Bales, director of God's Way Home and Jay Phillips, director of Seed Sowers, spoke about their applications. Bales stated that their application for \$210,000 would not only

# Man injured after explosive device accidentally detonates

On Sunday, Oct. 6, at approximately 4:25 a.m., Captain J. J. Martin, of the Greenbrier County Sheriff's Office, responded to a 911 call to meet White Sulphur Springs EMS at the Shell station at the Sam Black Church exit off I-64. Initial information indicated an individual complaining of abdominal pain was being transported by a personal vehicle to the Shell station to meet the EMS unit. Subsequent information revealed the patient may have been impaled by some type of foreign object.

Upon his arrival at the Shell station, Captain Martin observed an individual being prepped for transport in the ambulance and a second person standing beside him. Captain Martin inquired as to how the patient sustained his injury and he stated he was riding a 4-wheeler and was involved in an accident. The patient added that the accident resulted in him being impaled by a stick or some other type of object. Captain Martin observed the injury and noted it was inconsistent with the explanation that was provided. The patient was then transported from the scene and ultimately to an out of the area medical facility.

After speaking with the second individual, who confirmed the 4-wheeler accident, he agreed to show the officers with the Sheriff's office where the crash occurred. The officers would learn that the two individuals had arrived at a friend's house on James River Kanawha Turnpike the previous evening to ride 4-wheelers and assist the homeowners with gathering firewood.

Upon arrival at the alleged accident site, the officers did not observe any evidence to suggest the 4-wheeler to have been involved in an accident, nor did the area suggest a crash site.

After additional investigation and interview of the second individual, it was learned that the patient was operating some type of explosive device and it accidentally blew up. The officers were able to locate the blast site and evidence consistent with something exploding.

The Greenbrier County Sheriff's Office Crime Scene Team responded to process the scene and officers with the West Virginia State Police Explosive Ordinance Disposal Unit responded to ensure the site was safe and there was no threat to area residents. Multiple additional officers from the Sheriff's Office responded to the scene and traffic was diverted away from James River Kanawha Turnpike until the site was secure and officers were confident no additional threat remained.

The incident remains under investigation.

Captain J. J. Martin, of the Greenbrier County Sheriff's Office, is the lead investigator.

## Senator Capito announces funding for Greenbrier Medical Center improvements

Earlier this month, U.S. Senator Shelley Moore Capito (R-WV), Ranking Member of the Senate Appropriations Subcommittee on Labor, Health and Human Services, Education, and Related Agencies (Labor-HHS), announced eight Congressionally Directed Spending (CDS) awards from the U.S. Department of Health and Human Services (HHS) for education and research programs, facility construction and renovations, and healthcare treatment resources in West Virginia.

These awards, which were secured through CDS requests made by Ranking Member Capito in Fiscal Year 2024 (FY24), will be used to improve medical centers and treatment, bolster cyber security education, and expand the educational opportunities for future healthcare workers in West Virginia.

"After partnering with organizations across our state and listening to their needs, I am excited to see these awards help West Virginia institutions meet critical goals to expand medical services offered by providers in our state in both scope and quantity. I am also particularly excited to see Marshall expanding its National Center of Excellence for Cyber Security in Critical Infrastructure, which I have championed," Ranking Member Capito said. "These CDS awards will help deliver medical and educational outcomes in West Virginia and I am proud to have secured them. As Ranking Member of the Labor-HHS Appropriations Subcommittee, I will continue to partner with local leaders to identify their most pressing needs and work to build up our medical and educational infrastructure."

Locally, a \$7,516,000 HHS CDS award to the Charleston Area Medical Center (CAMC) Greenbrier Medical Center, Inc. in Ronceverte was made to construct a stateof-the-art facility to house an employed multispecialty physician practice of CAMC Greenbrier Valley Medical Center.

Currently, the employed physicians supporting the hospital are not located on the campus of the hospital. The current rented locations are neither modern nor accessible and were not constructed to meet the needs

of patients and providers. The new medical staff office building on the CAMC Greenbrier Valley Medical Center campus will support improved access to multispecialty services for the hospital's patients. It will also enhance the hospital's ability to attract new physicians and retain the ones already recruited to the area. The enhanced ease of access will ultimately improve the health of residents in the Greenbrier Valley Region. The project will allow CAMC Greenbrier Valley Medical Center to expand its Family Medicine, Cardiology, Urology, Pulmonology, ENT, and General Surgery departments. It will also provide room for the addition of Neurology Services and a telemedicine hub as CAMC Greenbrier Valley Medical Center becomes a full services community hospital.

Phillips stated that Seed Sowers will be submitting two applications, one in the amount of \$225,000 that would target the location that serves pregnant and parenting women and children up to the age of three. The application would also cover the expansion of the transitional recovery housing, some being used for continual support, some minor facility upgrades and repairs, and any remaining funding will be used for operational support for the peer recovery staff. The second application, in the amount of \$325,000 will more recovery workforce and transportation focused as well as being used for renovations of a new facility. The commissioners approved both letters of support unanimously.

Before the meeting was adjourned, a change to the organizational chart for the 911 Communication Center in the Greenbrier County Homeland Security and Emergency Management agency was documented to eliminate two part time communicator positions and add a full-time communicator position and the commissioners approved the separation of employment for Iris Jean Burdette from the Greenbrier County Assessor's Office, who was hired February 9, 2017, effective October 7, 2024 and Shelly Vaughan from the Greenbrier County Prosecutor's Office, hired Jun. 18, 2024, effective Aug. 26, 2024.

Financials discussed at the meeting included an Arts and Recreation transfer of \$15,950 for the New Skyline Production 2024-25 Bluegrass Festival on the River in Ronceverte, as well as the following budget revisions: Increasing the general account by

## **Gov. Justice announces** nursing expansion initiative results in record number of nursing graduates in WV

Gov. Jim Justice announced that his successful Nursing Workforce Expansion Program, established two years ago to address West Virginia's nursing shortage, has helped the state's colleges and universities produce an all-time high number of nursing graduates.

From 2022 to 2023, there was a nearly 15% increase in the number of registered nursing students graduating with associate degrees - from 590 to 676 graduates in one year alone - which represents a record number of nursing graduates in West Virginia. In comparison, the total number of nursing graduates among all degree levels in 2023 was approximately 15% higher than a decade ago.

"I am incredibly proud of the results we've achieved with the Nursing Workforce Expansion Program," Gov. Justice said. "By investing in our future nurses, we've set new records for nursing graduates in West Virginia. Nurses are the backbone of our healthcare system, and this initiative ensures we're not just filling jobs, but equipping these healthcare heroes with the best training and support possible. This is a historic step forward for our state, and it's only the beginning of what we can accomplish to strengthen our healthcare workforce."

Gov. Justice initially provided \$20 million in 2022 and added \$26 million last year to support expanded and newly created registered nursing and licensed professional nursing programs at community colleges, fouryear higher education institutions, career centers, and other schools of nursing.

"We are tremendously grateful to Gov. Justice for providing this historic funding to support the expansion of nursing education programs across West Virginia," Dr. Sarah Armstrong Tucker, West Virginia's Chancellor of Page 5





Higher Education said. "Through these thoughtful investments by the Governor and Legislature, our higher education community is more strongly positioned to shore up West Virginia's devoted nursing workforce, and we are already seeing the results."

In the first two years of the expansion program, funded projects - which are awarded and administered by West Virginia's Higher Education Policy Commission and Community and Technical College System - aimed to increase enrollment in pre-licensure nursing programs through innovative approaches focused on timely degree completion and licensure for graduates.

If funded for a third year, the program will focus on further expanding cohorts of nursing students, supporting scholarships, and creating additional grant opportunities.

#### Dear Recycle Lady,

My kids do lots of projects with colorful construction paper. Can it be recycled?

#### Dear Artsy Reader,

Unfortunately, your construction paper can't be recycled locally, and very few locations have the special equipment necessary to do so. Construction paper, also known as sugar paper, is used primarily for children's drawings and craft projects. It is a heavy paper made from wood pulp and was originally used to make bags for sugar, thus the name sugar paper. In the late 17th century, these sugar bags were used as packaging for macaroons made by English confectionery bakers. In the 19th century, with the advent of industrialized paper manufacturing, construction paper was advertised as a canvas to be used for holding several children's drawings. The brilliant primary colors used in producing this construction paper came from Germany. With the onset of World War 1, Germany stopped exporting the dyes so synthetic dyes were then used which had a wider range of colors but tended to fade over time.

#### Dear Recycle Lady,

Last week you wrote about compostable dog waste bags. However, what is the value of a compostable bag when dog waste can't be composted?

Dog Lover

#### Dear Dog Lover,

You are correct when you say dog waste can't be composted. Dog waste can contain parasites and harmful bacteria such as E. coli and Salmonella which require much higher temperatures to kill than is reached in home composting. Thus, composting dog wastes is not recommended. According to Environmental Protection Agency, just two or three days of waste from 100 dogs can contribute enough bacteria, nitrogen and phosphorous to close 20 miles of bay-watershed to swimming and shell fishing. Currently, the only solution is sending the bagged waste to the landfill, but problems exist even there because dog waste produces methane. Researchers are now studying options for better, more environmentally friendly ways for processing the 10.3 million tons of dog waste produced each year.

#### Dear Recycle Lady,

Why can't bags of recyclables be left at the Recycling Center in Ronceverte? We just moved here and where we lived before took recyclables all in one bag.

Why Sort Recyclables

#### Dear Why Sort Recyclables,

You must have lived in a very large city that had the expensive equipment necessary for sorting mixed recyclables, equipment the Recycling Center doesn't have. Not only do we not have that equipment, we are short staffed, so our employees don't have time to sort bags of recyclables. Five large trash bags of recyclables were left at the Recycling Center last week, and those bags of valuable recyclables are now in the landfill. As much as we wantedto sort the recyclables in all those bags, therejust was not time to do so.

Good News: On Jan. 1, 2025, the state of Minnesota will implement a sweeping ban on products that contain PFAS, or per- and polyfluoroalkyl substances, also known as "forever chemicals." (fto.com)

Shown in this 1904 photo is the remarkably ornate West Virginia State Building that was built for the Louisiana Purchase Exposition (aka World's Fair) in St. Louis, Missouri.

The exhibition commemorated the Louisiana Purchase that nearly doubled the size of the United States. The 76' x 76' building was designed by Wheeling architects, Geisey & Ferris, and cost \$20,000. Among the purposes of West Virginia's exhibit was to promote its oil, coal, and timber industries.

When the exhibition opened in 1904, the press described it as "more colossal and more stupendous" than the Chicago World's Fair. There were 30 state buildings and 24 foreign buildings on 1,240 acres. Under armed guard, the Liberty Bell was transported by train to be exhibited in the Pennsylvania building. On opening day, April 20, 150,000 people attended. At the conclusion of the exhibition, all the buildings were destroyed. Some elements of the West Virginia building were salvaged and can be seen in a private home in Oakland, Missouri. Also, some of the lumber from the buildings were used by Italian immigrants to build houses in St. Louis.

In a handbook distributed at the West Virginia State Building, Virgil Lewis, former school superintendent wrote, "Let West Virginia exhibit her people to the world and let them see what the world can teach - for the world is at St. Louis. In this gathering from all lands of every kindred and tongue in which all are so wondrously alike and yet so marvelously unlike, West Virginia does not suffer by comparison."







## WVSOM chief operations officer and an alumna names 'West Virginia Wonder Women'

Two women employed at the West Virginia School of Osteopathic (WVSOM) Medicine have been recognized for their work throughout the state.

Drema Hill, Ph.D., MSP, WVSOM's chief operations officer, and Katherine Hill Calloway, D.O., MPH, regional assistant dean for the South Central Region of WVSOM's Statewide Campus, were named to this year's "West Virginia Wonder Women" by WV Living magazine.

They are two of 50 women featured in the publication's fall 2024 issue for being identified as leaders who raise the bar in their communities and force change for the greater good in their industries.

"I am pleased to join my female colleagues across the state who were selected to be honored as West Virginia Wonder Women," Hill said. "We all have different areas of expertise, but together, we make West Virginia stronger."

Hill received a bachelor's degree from West Virginia State University, a Master of Public Service Management degree from Cumberland University and a Ph.D. degree in human services with a specialization in health care administration from Capella University.

The Boone County, WV, native joined WV-SOM in 2016 and became one of the school's vice presidents in 2019. She has more than three decades of experience in public health leadership, including positions with the West Virginia Bureau for Public Health, the Tennessee Department of Health, Vanderbilt University's Nashville Health Office. She currently serves as WVSOM's vice president for community engagement and chief operations officer.

Hill develops and implements processes that help WVSOM achieve its strategic objectives. She also oversees the school's Center for Rural and Community Health, Audio Visual and Production Department, Information Technology Department, Marketing and Communications Department and WVSOM's rural health policy director. Her previous work in public health facilitates her ability to collaborate with external partners on statewide initiatives to improve the health of West Virginians.

"I have had a long career in public health and I still most enjoy working with community partners to foster and implement innovative ideas that improve health outcomes in disenfranchised populations. West Virginia is my home. I love the mountains and I love the people," Hill said.

Before earning a D.O. degree from WVSOM in 2008, Calloway graduated from Wake Forest University with a double major in sports medicine and medical anthropology, and completed a Master of Public Health degree from Boston University.

She said she is honored to be recognized among so many women making positive change in West Virginia.

"It reminds me of how much strength we have in West Virginia. The things these women are doing are incredible and impactful in a way that will bring a legacy and will make a difference for generations to come," she said. "To

The school's Statewide Campus consists of seven regions across the state. In her role, she oversees third- and fourthyear medical student curriculum development and student clinical rotations. In addition to her

duties at WVSOM, the Kanawha County native is the director of clinical development and provides inpatient care with HospiceCare West Virginia, the state's largest nonprofit hospice service.

She has spent much of her adult life working overseas, with efforts such as assisting with post-conflict health care development in war-torn Kosovo, where she first managed a reproductive health program with the International Rescue Committee and later implemented health policy for 17 primary care health clinics as a health officer with the United Nations. She worked with the Clinton Foundation to reduce disparities in AIDS prevention and treatment in Mozambique, and with Emory University's HIV

ton Internal Medicine and then began serving in public health by shifting her practice to Cabin Creek Health Systems, where she developed and supported a nonpharmacologic pain management program as part of their medication-assisted treatment program for people in substance use recovery. She then moved to HospiceCare and WVSOM.

"The things I did globally were relevant to what we do here in our rural communities because there are so many similarities to chronic disease management or to working in areas that are resource poor. Coming back to West Virginia has been incredibly fulfilling to not only apply some of what we were doing with health care globally to our communities but also because


