



'Ninja Summit' in Buchanan this weekend

Board approves conditions of IRF, text amendments for Buchanan project

The Botetourt County Board of Supervisors approved three Industrial Revitalization Fund grant agreements during last week's meeting.

Director of Economic Development Ken McFadyen presented the project and agreements for the board's consideration noting that Commonwealth of Virginia and the Department of Housing & Community Development (DHCD) awarded Botetourt County a \$450,000 grant from the Industrial Revitalization Fund (IRF) program.

The grant award is proposed to serve as the principal for a loan to Factory Flats, LLC, the development company working to renovate the former Groendyk manufacturing buildings in Buchanan. Factory Flats, LLC has planned for the 3,381-square-foot building that has received the DHCD funding support to be repurposed as a commercial brewery and brewpub. To make the loan to Factory Flats for this project, the Economic Development Authority is authorized by the Code of Virginia to administer loans for the purposes of economic development in the county.

The IRF project budget to repurpose the subject building is \$913,276.50, including IRF loan funds of \$450,000 (\$433,402 for construction and \$16,598 for

New Fincastle museum feasibility conceptual work approved, Springwood Road extension project to be 'refreshed'

County Assistant Administrator Jon Lanford provided a brief update last week to the Botetourt County Board of Supervisors on a new museum located in Fincastle and presented a draft scope of services for a "phase one" feasibility study and conceptual design for the new museum project in Fincastle. Del. Terry appropriated Austin funds for \$6 million

grant through administered by the Department of Historic Resources (DHR).The county matched the appropriation with \$500,000 through civil site work at courthouse square.

AECOM, a consulting firm hired by the county, will handle the study through the conceptual design. The company

#### Citizens show support for library policies, oppose Rails to Trails at supervisors' meeting

The public comment period at last week's Board of Supervisors meeting in Daleville was met with remarks in response to last month's comment period regarding library content and more comments in opposition of the proposed Rails to Trails project from Eagle Rock to Oriskany.

Several county residents expressed their concerns over comments during the March meeting asking for books to be removed from the Fincastle Public Library due to content that could be "confusing" to younger readers.

The collective expressed support for Botetourt County libraries. Many noted that it's up to the parents to "parent" their children, not the library.

One Botetourt resident said, "As a parent, it is your responsibility to supervise your children and make

# Sheriff's Office welcomes citizens to another educational Senior Social

Botetourt County senior citizens had to the opportunity to gather at Fincastle Baptist Church last week for another "Senior Social" event presented by Sheriff Matt Ward and Botetourt County Sheriff's Office.

The sheriff updated attendees on what was discussed at the previous event, continuing to urge local seniors to avoid fraudulent calls and to "hang up the phone" when scammers are trying to take advantage.

In Virginia last year, \$60 million was lost by citizens due to fraud (caller asking for money regarding tech support or gift cards purchases).

Cindy Markham, Community Outreach Specialist with Virginia Navigator, spoke about how to better connect senior citizens to the website's resources. Virginia Navigator provides free information about health, aging, disability and post-military resources available in Virginia. Virginia Navigator helps people with disabilities, veterans, older Virginians, caregivers, and their families access local resources, such as transportation, caregiver support, respite care, recreation, rehabilitation, in-home assistance, benefit assistance and more.

Seniors got a chance to meet with members from local organizations. Those in attendance were: Botetourt County Parks & Rec, County Fire & EMS Dept., Moving Forward Designs, County Treasurer's Office, VDH, Local Office on Aging, Botetourt Libraries, InnovAge, Botetourt Funeral Home, Dept. of Social Services, Botetourt Resource Center, Solomon's Mission, Good Samaritan, and Virginia Navigator.

Ward hopes to hold a "Senior Social" quarterly moving forward.



#### Legal Notice NOTICE TO THE PUBLIC OF AN APPLICATION BY APPALACHIAN POWER COMPANY FOR A 2023 TRIENNIAL REVIEW OF ITS BASE RATES, TERMS AND CONDITIONS URSUANT TO § 56-585.1 OF THE CODE OF VIRGINI PURSUANT TO VIRGINIA CÅSE NO. PUR-2023-00002

•Appalachian Power Company ("APCo") has filed its 2023 triennial review of its base rates, terms and conditions pursuant to § 56-585.1 of the Code of Virginia.

•Among other things, APCo requests a revenue increase in the amount of approximately \$212.6 million. The overall impact of the Company's proposals would increase the monthly bill of a residential customer using 1,000 kilowatt hours of electricity per month by approximately \$25.03, or 15.9%. For low-income customers qualifying for the proposed basic service charge waiver, the Company's proposals would increase the monthly bill of a residential customer using 1,000 kilowatt hours of electricity per month by approximately \$15.53 or 10.5%.

•A Hearing Examiner appointed by the State Corporation Commission will hold a telephonic hearing in this case on August 23, 2023, at 10 a.m., for the receipt of public witness testimony.

•An evidentiary hearing will be held on August 24, 2023, at 9:30 a.m., in the Commission's second floor courtroom located in the Tyler Building, 1300 East Main Street, Richmond, Virginia 23219.

On March 31, 2023, Appalachian Power Company ("APCo" or "Company") filed an application ("Application") with the State Corporation Commission ("Com-mission"), pursuant to § 56-585.1 A 3 of the Code of Virginia ("Code") and the Commission's Rules Governing Utility Rate Applications and Annual Informatio-nal Filings ("Rate Case Rules"), for a triennial review of the Company's rates, terms and conditions for the provision of generation, distribution and transmission

The Application states that this proceeding entails, among other things, determinations regarding: (i) APCo's cost of service during the three successive 12-month periods ending December 31, 2022 ("Earnings Test Period"); (ii) whether prospective changes to APCo's rates for generation and distribution services are necessary; and (iii) the Company's prospective fair rate of return on common equity ("ROE").

The Application states that, pursuant to Code § 56-585.1 A 8, the Company's earned ROE during the Earnings Test Period is compared to a 140 basis-point band of earnings that ranges from 70 basis points above a previously authorized ROE to 70 basis points below that ROE ("ROE band"). The Application further notes that Code § 56-585.1 A 8 states that if earnings fall below the ROE band during the Earnings Test Period, the Commission shall order increases to APCo's rates necessary to provide the opportunity to fully recover the costs of providing the Company's services and to earn not less than such fair combined rate of return, most recently ended 12-month test period as the basis for determining the amount of the rate increase necessary. Finally, the Application states that Code § 56-585.1 A 2 g provides that if APCo's combined earned return is below its authorized return, "whether or not such combined return is within 70 basis points of the return as so determined," the Company may request that the Commission approve "an increase in rates in accordance with the provisions of subdivision 8 a as of this section."

APCo states that the ROE band for the analysis of the Earnings Test Period is based on an ROE of 9.20%, which is the return authorized by the Commission in APCo's 2020 Triennial Review. APCo states that the Company earned a return of 5.39% on its common equity during the Earnings Test Period, which is the equivalent of over \$124 million in pre-tax earnings below 8.5%, the bottom of APCo's authorized ROE band for the Earnings Test Period.

Based on this analysis, APCo requests approval to implement retail base generation and distribution rates that are designed to implement an overall increase in the Company's revenues of approximately \$212.6 million over revenues from current base rates. APCo states that this is a 14.3% increase to overall revenues. The requested increase includes a \$5.4 million increase to the generation function and a \$207.2 million increase to the distribution function.

The requested revenue increase reflects, among other things, APCo's requested authorization of a prospective ROE of 10.6%. APCo also requests that the Commis-sion approve depreciation rates that will result in an annual increase in depreciation expenses. APCo also requests to increase distribution O&M expenses by \$47.8 million to allow it to improve its vegetation management program. APCo states that its proposal for an increase devel of vegetation management funds should improve the reliability of targeted circuits and reflects higher costs of materials and labor. APCo also proposes an adjustment to increase federal tax expense in the cost of service to reflect the Company's expected increased tax obligations under the federal Corporate Alternative Minimum Tax. Additionally, APCo requests authority to establish a regulatory liability for the credit that will offset future tax obligations and deferral authority to ensure the Company only collects its actual tax obligations from customers. tax obligations from customers

With this Application, the Company proposes to eliminate the basic service charge for qualifying low-income customers, which for these purposes the Company defines as customers who receive assistance from one (or more) state agency. At the same time, the Company proposes an increase of \$0.54 to the basic service charge from \$7.96 to \$8.50 for all other residential customers, which APCo states is designed to be revenue-neutral for the Company when combined with the estimated level of customers who will be eligible for the basic service charge waiver.

APCo states that even if the Commission finds that it should not increase the Company's rates, the Company nevertheless requests that the Commission approve revised rates to reflect the changes in the underlying costs since 2010. APCo states that its proposed rate design reflects updates to both the functional and class allocations to reflect the current costs of serving the Company's customer classes. Additionally, APCo proposes to incorporate Schedule MGS (Medium General Service) customers into Schedule GS (General Service) and eliminate Schedule MGS from the Company's standard service tariff.

## **Board** reviews incentive funds guidelines, results from public hearings

Botetourt County Director of Parks and Recreation Mandy Adkins presented guideline changes and additions to the Recreation Incentive Fund grant timeline to the Board of Supervisors last week. The board approved the changes and additions to the fund process.

The largest change is the timeline of the grant. Previously, grants come through the department, and then are submitted to the Parks & Rec Commission. The applicants then present their project during the commission meeting. At the same time during that meeting, the commission votes on the project and the recommended funding.

'We recognize that timeline is just too tight and there needs to be more time invested in reviewing the applications, and then giving the commission time to review the projects," Adkins told the board last Tuesday afternoon.

The following timeline was added to the Recreation Incentive Fund Guidelines:

August 1, 2023, Application acceptance window opens.

September 15, 2023, Deadline ٠ to submit applications.

The Parks and Recreation Department will review applications and may provide feedback to applicant for recommended changes or improvements. Applicants are encouraged

to submit before the September 15 deadline for earlier feedback.

October 30, 2023, Parks and ٠ Recreation Commission begin application review.

November 6, 2023 - Applicant ٠ presentations during Commission's regular meeting, 6:30 p.m.. at Greenfield Administration Center

December 4, 2023 - Parks and Recreation Commission vote on funding recommendations during regular meeting, 6:30 P.M. at Greenfield Administration Center.

19, 2023 December Applications presented to Board of Supervisors for final approval.

June 30, 2024 - Status report one due.

December 30, 2024 - Status report two due.

June 30, 2025 – Project • Completion Form deadline

The following changes were made to the General Policies and Program Eligibility:

All projects must be located in ٠ Botetourt County.

Projects submitted must benefit and be open to the general public, enhance recreational related property or generally assist in the delivery of initiatives and programs sponsored by the Botetourt County Parks & Recreation Department.

Adkins noted that all funds are used annually. Last year's requests totaled \$44,551, leaving the department with less than \$500 left over (from the \$45,000 of annual funding). Historically, the department annually received applications which exceeded the funding or were right at the limit.

Board Chair Dr. Mac Scothorn added the condition that the funding be raised from \$40,000 to \$50,000.

Public hearings

The board unanimously denied Rachel Moss's request for a private kennel Special Exception Permit (SEP) in the Buchanan District. The denial was brought by complaints made by neighbors about roaming dogs. The request may be re-applied, but would require approval from neighbors and the Planning Commission.

The board unanimously approved Lavern and Jessica Miller's request for a Rural Home Business Special Exception Permit, with possible conditions, to manufacture suspenders, in Buchanan District.

New River Electrical Corporation's (NREC) request to rezone four contiguous parcels in the Valley District was unanimously approved by the board. This rezoning is made with the intent of NREC building a training facility to expand their operations. A substation would be built for training purposes and would not connect to any other service stations. Scothorn noted that NREC "needs this space desperately."

The cause of the fire was described in the Shenandoah Herald from May 19, 1870: "THE ORIGIN of the fire was in the livery stable attached to the Western Hotel owned by Mr. John B. Luster, on Main Street (The Western Hotel was located behind the present-day Courthouse.) It was first seen at ?? o'clock (couldn't tell the time from the transcript) when the flames had just been ignited. The alarm was promptly sounded, and the citizens rallied to the scene, punctually, prepared to extinguish the incipient blaze. The "fire" engine was also brought forward and put in active play. But the fire had caught in a bale of hay, and a high wind was prevailing, it spread with terrible rapidity, despite the utmost efforts that were made to arrest its course. The first house that caught was the hotel itself, and several wooden outbuildings adjoining, all of which were speedily consumed. By this time the danger and tenor of conflagration began to fully develop; for the flaming hay and heavy sparks and fragments of burning timbers were flying in every direction through the

#### Read 2 Kings 14:1 through 16:20

And since the Lord had not said he would blot out the name of Israel from under heaven, he saved them by the hand of Jeroboam son of Jehoash (2 Kings 14:27).

Reading through the Old Testament can seem like an exercise in frustration. We read about privileged people who regularly rebel against God and get themselves into trouble. God becomes angry at their constant attraction to sin, and threatens to punish them. From truly remorseful hearts, they repent in sackcloth and ashes, and God stays His hand. He keeps His word by punishing the ringleaders or by allowing them all to go into slavery. However, He always comforts and rescues them. Why, we wonder, do they never learn their lesson?

Interestingly, if we are honest with ourselves, we might just see our own failings mirrored in the lives of these Israelites. Like them, we, too, experience the loyal heart of a God who is unwilling to leave us in our sin and never ever willing to abandon us.

Challenge for Today: Read through the entire Old Testament this summer. Rejoice in God's long-suffering heart of love for you.







## DAR Chapter tours the Historic Smithfield Plantation



Botetourt DAR members and guests toured the Smithfield Plantation in Blacksburg.

Members and guests of the Botetourt County Chapter Daughters of the American Revolution toured the historic home and grounds of Smithfield Plantation on the Virginia Tech campus in Blacksburg on April 15.

Built from 1772 to 1774 by Colonel William Preston, the plantation house was his residence and the headquarters of his farm. The Colonial-style home was based on homes in Williamsburg, and it stands as a fine example of an original pre-Revolutionary structure in Southwest Virginia.

The DAR group was divided into two tour groups, one led by Michael Hudson, the executive director, and the second by Jessica Vance, the Visitor Experiences manager. In addition to touring the home and the grounds, members were able to visit the Preston Family Cemetery where William Preston, his wife Susanna Smith Preston, and many other members of the Preston family are buried. The rooms of the

house are furnished with 18th and 19th century furniture, portraits and other items, while the basement level museum a variety of ontains artifacts found on site. The landscape includes an 18th century kitchen garden tended by volunteers. This historic property linked the great wilderness to the heart of the American Revolution and helped to form a new nation. Many prominent Americans descended from Preston and his wife Susanna, for whom the plantation is named. They were parents, grandparents, or ancestors to governors, senators, presidential cabinet members, founders, university

university presidents, and military leaders.

Education was important to Preston and his family, and he played an important role in the Southwest Virginia frontier where he was a surveyor, justice of the peace and landowner. For 10 years prior to building Smithfield, Colonel Preston lived in Greenfield Plantation in Botetourt County. At his death the Greenfield property was inherited by John, his eldest son, while his wife inherited the Smithfield property.

As the nation is preparing to celebrate America 250, the DAR chapter ncourages everyone to learn more about Virginia's history during the Revolutionary time period as well as the lives, histories, sites, stories and communities of the citizens in the Revolutionary time period. 

sure they select reading materials according to your morals and values, not the library's... Do not ever, for a minute, believe that you are allowed to dictate what anybody else's children think, feel, or believe in."

One resident recommended reading the book "Fahrenheit 451" by Ray Bradbury, a story set in a dystopian future where a "new world order" has control over the media, population, and censorship. The same citizen claimed the LGBTQ information found in the books in question are the reason citizens at the previous meeting were upset.

A Blue Ridge resident mentioned the "danger" in banning books. He claimed that an individual who asked for 12 books to be pulled from

#### the Fincastle Library's collection "suggested that changes are needed to the reconsideration process to include 50 percent professed Christians." He commended Library Director Julie Phillips' "judgements on how books are selected that is backed by a well-reasoned policy aimed at serving the diverse views of this county."

He also noted that "censorship is not a liberal or conservative issue. This is about fundamental constitutional rights enshrined in the First Amendment of the Constitution. Fundamental rights like freedom of expression and the limits on government establishing religion are fundamental to our democracy. Trying to justify censorship using incorrectly applied and made up words... that provoke fear and hatred towards our citizens cannot be used to justify our fundamental rights."

The proposed Rails to Trails project will parallel Craigs Creek and run 26 miles from New Castle in Craig County to Eagle Rock in Botetourt County. It is anticipated to be a gravel trail that utilizes existing railbeds and some shared roadways. Funding will go toward bridge repairs and preparing the trail surface; a multi-use trail for walking, running, biking, and horseback riding, that provides opportunities for residents and visitors to engage with the scenic beauty of Craig and Botetourt counties and Virginia's Blue Ridge.

Four citizens provided comments opposing the project with one woman calling the proposed project a "literal trainwreck."

An Oriskany resident who asked the board to come out to the railbed the month prior, noted, "Still, none of you have taken me up on my offer to visit Oriskany and the issues of what the purposed Craig-Botetourt scenic trail will do to our area." He said that the response from the board told him that they couldn't do anything about the project because it was "coming down" from the state. He thinks that the state will ask the county to fund a portion of the project handling maintenance or work. The man said the press releases related to the project were "50% wrong.'

A group of county residents in opposition of the proposed

pamphlets project had on-hand that expressed the citizens' concerns about the project, noting in the brochure that the project is "unsafe for visitors and residents,' "financially irresponsible," and "ecologically unfriendly."

Finally, a Botetourt resident suggested that the Eldor Corporation "need more workers" and claimed Eldor doesn't have much of a "workforce." He suggested that Botetourt County Public Schools along with the Botetourt Technical Education Center (BTEC) should work on a simulator program to understand what goes on while working for Eldor so that may increase the awareness about the company and the technologies it provides.

with Joseph Rae, a Botetourt native who opened the Buchanan Bujinkan Dojo last year. Rae is a deputy with the Botetourt County Sheriff's Office and is a retired Navy veteran, spending

over 20 years in military service. "I am having a bunch of students and instructors in from out of town to study historical Samurai and Ninja Martial Arts," Rae said when asked about this weekend's Ninja Summit.

"Folks in the area should definitely stop by."

will join the museum committee for a one-day visit to other museums to observe exhibit areas and administration spaces and they will provide several space and program workshops to the committee and county. They will also attend a meeting with the Town of Fincastle Planning Commission to discuss the feasibility study and program objectives.

During the feasibility study, the team will work with the County to determine the optimum location for the museum to sit. The museum building footprint and precise site location have not yet been determined.

Vice Chair Dr. Richard Bailey commended Lanford and his team's efforts in negotiating, feeling like the project is currently "in a good spot" and suggested to the board to continue moving forward with the study. The board approved.

#### Springwood Road extension "refreshed"

At the beginning of April, the Town of Fincastle submitted a request related to the Springwood Road extension project, which was first put on the table approximately 20 years ago. The project was initially a part of the county's sixyear plan around 2006, but was taken off in 2007. Lanford thinks the six-year plan "isn't the best place to place a project such as this."

In recognizing the need for a potential extension of Springwood Road, Lanford asked the board, county, and VDOT to take another look at the project and to authorize a resolution asking for discussions to begin between the county, the town, and VDOT. The board approved moving forward with the discussions.

One of the things suggested was kind of 'refreshing' the concept," Lanford said in a recent interview. "Not just bringing back all of the work that had already been done, and moving forward with it, but really looking at that alignment and saying, 'Does that makes sense today?' Or, should we look at other options that may not be as impactful to the homes that have been built (people's properties)."

Lanford made it clear that the county does not want to "alarm" citizens, understanding a lot has changed in 20 vears.

"A lot has changed in the last 20

years since it was originally conceived," Lanford continued. "What used to be out of the way-through a hayfield or pasture-is no longer that. The first thing we need to do is see if that's the right alignment or if we need to look at an alternate alignment based on what's changed in the past 20 years."

Although the project is being revisited, Lanford noted the county will continue to review the best options. Although the Town of Fincastle asked for the Springwood Road extension to be added back into the county's six-year plan, Lanford believes that today, this project doesn't require being added back to the

"The six-year plan is not the right place for it in 2023," Lanford noted. "It was 10 years ago, but it's not today."



clearance and demolition) and \$463,276.50 in matching funds for construction from Factory Flats. To get under contract with DHCD, there are three agreements for the Board of Supervisors to consider for approval: 1. The Grant Agreement, 2. Restriction Agreement, and 3. Performance Agreement.

The Grant Agreement obligates the IRF grant funds to this project and outlines the general and special conditions applied to this grant funding. The Restriction Agreement outlines that a deed restriction will be placed on the property by the Economic Development Authority for a period of 10 years from the date of loan closing that requires the subject building to be used only for an IRFeligible purpose. The Performance Agreement outlines the goals for the project and outlines what is required to

happen should a change of ownership or use of the subject building occur during the first 10 years following the loan closing. County Attorney Mike Lockaby and the economic development reviewed staff the current versions of these agreements with DHCD. Deputy County Administrator David Moorman stated that this isn't a grant to the company, but a loan. Zero county dollars are

involved in the ongoing project in Buchanan.

Additionally, the board approved text amendments Chapter 6 Buildings & Building Regulations of the Botetourt County Code to add "Article IV. Commercial Property Assessed Clean Energy (C-PACE) Financing Program." According to the agenda, the developer intends "to make substantial investments in the Town of Buchanan" and made the request.

In this program, a private bank makes a loan to a private person. No county money is lent or put at risk. The county has two roles to play. First, it ensures that the financed construction will meet goals for energy efficiency, resiliency, stormwater management, or similar benefits. It then verifies the benefits at the conclusion of construction. Second, if the loan becomes delinquent, it is collectible

in the same manner as a tax lien. Therefore, the county treasurer collects the funds. In order to defray the county's costs, the borrower pays the county an upfront origination fee to do due diligence and then an annual administrative fee.

This program is common in other states, and approximately a dozen localities in Virginia have adopted this program in one form or another.

and their staff sponsor/advisor, Kit Williams, through a tour of the capitol while they were in town for the MGA.

The Model General Assembly (MGA) program was established in 1948 and is designed to introduce high school students to the legislative process of the Commonwealth of Virginia. Legislation is debated in committees and on the floors of the actual Virginia Senate and House of Delegates. Participating students represent grades 9-12, with limited roles for 9th graders. Participants can assume the roles of senator, delegate, officer, lobbyist, reporter, or underclassmen legislator.

Virginia state legislature

receives a report following MGA learning more about the leanings of the younger generation.

Each club or school group submit at least one and no more than five bills along with their registration. The Virginia YMCA encourages the patrons of the bill to discuss the bill with a current or former state legislator during the program. All bills should reference the Code of Virginia or the Constitution of Virginia and should be thoroughly researched. Some of the bills presented fall on the topics of education reform, abortion, family life curriculum, and voting restrictions, to name a few.

The students submit their

bills (for their respective committees) from a list provided by YMCA which they receive a couple of months prior to the MGA. When the bill comes up in committee, students read their bill, explain the bill, and the students are then grilled with questions pertaining to the bill by other members of the student-run committee. Following the session, a legislative assistant will come in and sit down with the students critiquing the questions and answers proposed during session and offering any additional advice.

"As soon as the bill book came out online, we kind of hit the ground running with work," junior Ethan Spickard

explained. "To be able to save time once we actually get to the conference, we have to make ballpark decisions of what we're going to do... Everyone in the executive offices got delegated to research pros and cons and things that could be changed in amendments to bills to make it better. Our main role was to be able to talk to (patrons) so that all their ideas are fully realized to give them the best shot to get everything passed.'

This was James River's fourth year participating in the program. River's participating students noted that the program is not affiliated with any political parties. James River secured donations from Botetourt's Republican and

Democratic Committees for their participation in the MGA.

Spickard explained that during the weekend a lot of the students' time is spent reviewing bills. If bills were changed during session, they have to adapt to ensure that those changes were made for the better, while constantly adapting to the changes.

Spickard was nominated for CONA (Committee of National Affair) that weekend, which takes two students in 35 out of 50 states. Out of the 500 students who attended this year's Virginia MGA, 20 students were nominated. This year's CONA conference takes place in Black Mountain, N.C. at the end of June.




