Genevieve Goss announces retirement from VCC

Botetourt resident Genevieve Goss, of the Valley Conservation Council (VCC), recently announced her retirement from the organization after spending nearly 30 years as an active member, program director, and

The organization was only five years young when Goss moved to Botetourt County in 1995. The Indiana native grew up as a fan of the outdoors. Goss said that being a conservationist was "en vogue" when she was in high school. Her love for being out in the open air naturally meshed well with the VCC. Soon after arriving in Botetourt, she attended the Fincastle Festival where she met Faye Cooper at

"I was a prime candidate for VCC at the first encounter (with the VCC)," Goss said a short time ago in a VCC letter to its membership. "My desire to promote the wise use and protection of these beautiful Virginia lands easily pulled me away from my career in the classroom and into easement and program work.'

the VCC booth that year.

Goss is a former adjunct professor at Roanoke College, who began with the VCC as a volunteer, then became a VCC board member, and most recently acting as VCC's Upper James program director working within the counties of the James River watershed. She loves to promote the lands surrounding natural resources and the connections made

with landowners.

"I have really enjoyed the people that I've worked with both in the organization and the community," Goss said in a recent interview. "It's made me feel like the love of land is the great common denominator."

Goss explained she's been allowed to see the land through the eyes of people who farm, plant trees, or fish in the waters through her visits with landowners. In Goss's work with the VCC, she helped



Dolly Parton Imagination Library is on its way to **Botetourt County**

The Kiwanis Club of Botetourt has announced the launch of Dolly Parton Imagination Library in Botetourt County. Each month the Imagination Library program mails high-quality, appropriate book to registered children, beginning from birth to their fifth birthday, addressed to them, at no

cost to the child's family. Since launching in 1995, Dolly Parton's Imagination Library has become the preeminent early childhood bookgifting program in the world and has gifted over 200 million free books. The program has been widely researched and results demonstrate the positive impact on early childhood development

and literacy skills. Kiwanis Club President John Plenge said, "We are extremely fortunate to have the early support for the program start-up from Craig-Botetourt Electric Cooperative and Altec/ Styslinger Foundation. This will enable us to quickly begin the program including child registrations. Additionally, the current Virginia state budget covers 50% of the book cost."

The Kiwanis Club of Botetourt County Charitable Foundation is the local nonprofit entity partnering with The Dollywood Foundation to raise funds, market, and administer



program locally. As the Local Program Partner, the club will provide outreach and information events throughout the summer and fall.

"We hope to enroll approximately 1000 children through this registration campaign which will begin a 5-year reading program for each enrolled child., Plenge continued. "There is continued. no cost to the families; however, as the Local Program Partner we must raise funds to cover our local share of the program cost. To ensure we can sustain this book-gifting program, we will need additional support from sponsors and individuals to cover our local share of the program cost going forward.



Botetourt County History

This photograph was taken in Buchanan on June 14, 1900, and is part of the exhibit now on display at the Botetourt History Museum. It shows 28 men who were at the last reunion of the Botetourt Artillery. Their names are displayed next to the photograph and correspond to the numbers shown.

The Botetourt Artillery was organized in December of 1861. The soldiers experienced heavy combat and losses during the battles at Vicksburg and Lynchburg. During the war Buchanan served as an important Confederate supply depot for shipment of agricultural produce and pig iron to Richmond via the James River & Kanawha Canal. On June 13, 1864, General David Hunter's Union army burned the covered bridge over the James River and much of the Town of Buchanan.

The battle flag of the Botetourt Artillery is said to have been made from the wedding dress of Cassandra Anderson whose Mount Joy home was burned. Every year re-enactors of the Botetourt Artillery take part in Buchanan's Civil War History Weekend. The Botetourt Museum sells several books about the Civil War in Botetourt. War of the (Information) Worlds

In 1938, people across the U.S. panicked. A radio newscast relayed live reports as Martians invaded New Jersey, and it was clear that humanity's existence was in peril. Word spread like wildfire among family and neighbors, to media outlets and

As it turns out, some latecomer listeners to a radio broadcast missed a crucial announcement: "You are listening to a CBS presentation of Orson Welles and the Mercury Theatre on the Air, in an original dramatization of The War of the Worlds by H.G. Welles.'

Orson Welles may not have intended to prank the nation, but ĥis drama sounded legitimate to people who didn't catch the fact that the actors weren't actual reporters in the field, and that those scary noises were just studio sound effects. Welles was nothing if not a master of his craft.

How many people would have believed (or admitted to believing) that Martians even existed, before that day? Yet it seemed so real without crucial context.

Misinformation is like that. Its convincing, fear-based approach hijacks the rational side

of our brains, and we react blindly. Without careful training and practice, we'll fall for anything - not because we're stupid, but because we're human.

Orson Welles broadcast sounds amateurish today, and it's easy to feel smugly confident that we're smarter than that. Yet now, we face even more sophisticated tools that we haven't learned to detect well, like artificial intelligence and deep fakes. And let's not forget misinformation's favorite vehicle: social media. For example, this

spring, social media rumors circulated that the United Nations decriminalized between minors and adults, and that "they're coming for your children." So we looked into it. As it turns out, this rumor has been debunked by multiple fact-checking sources as false, misleading, and omitting vital context. Yet despite the evidence, including the original text from International Commission of Jurists and clarifying ICJ and UN statements, people still insist that the rumor is true. Attention is the currency of social media, and the best way to get it is to elicit

emotions like fear and rage. The truth is - well, boring. Misinformation tends

to be first on the scene. As they say, a lie will run halfway 'round the world before the truth gets its shoes on. That's why the best journalists wait before releasing their news; they know that fact checking is crucial to accurate reporting, and that takes time. That first tweet or post is probably not the best source of information. Wait it out, and check it out.

Botetourt Resource Center receives grant

provide communications and support to partner organizations resulting in the addition of nearly 5,000 acres of land that features an iron furnace, brook trout streams, and habitat to the national forest system.

For the last 20 years, Goss and the VCC have made efforts to protect the animal crossing areas in Botetourt between the Allegheny and Blue Ridge Mountains animal population so VDOT and the state better recognize these areas for better travel.

One of the last programs Goss was involved in is Better Models in Development, a program that shows ways that economic and environmental goals can be achieved and be compatible with one another. She explained, "The population is growing... people make money building things, but let's put them in the right place. Let's not carve up every farm in the county and put in a gas station, not that we don't need gas. It's hard to see a lot of the development in Daleville, but in a way, that's preferable. If you go to areas that are not protected... They will look for ways to build houses all the way up a mountainside if they can. It really spoils the look."

One project Goss is particularly proud of is the preservation of the Oxbow Farm between Eagle Rock and Buchanan which, through conservation easement, protects a farm of over 500 acres and has over four miles of James River riparian protection and remnants of the historic James River and Kanawha

In 2003, Goss and Donna Henderson started the Botetourt Community Partnership (BCP) as a part of VCC's efforts reaching members throughout the area. The BCP holds quarterly meetings in Fincastle updating the community in ongoing projects and conservation easement efforts. She's also partly responsible for the startup of the Botetourt Farmers Market which takes place every Saturday morning from now until October at the Daleville Town

"Essential to this network has been my natural ability to notice things and sense their importance and my willingness to interact with people at local events, libraries, and businesses," Goss added. "Being a trusted member of the community and a trusted partner in conservation have become a way of life for me. Although many of the earlier easements on which I worked are held by parent organizations, VCC is now holding its own easements here."

Goss has proved to be an inspiration for local landowners to gain a better understanding of the importance of protecting the environment and, through the BCP, has given the community a forum to discuss ongoing issues and ways to improve the land. 'Most folks may have never heard of

Genevieve, but what many love about Botetourt is a direct result of the work she's done quietly and effectively to make Botetourt a better place to live and raise a family," BCP member Ed McCoy said when recently asked about Goss's retirement from the VCC.

Goss has worked with Roanoke Cement Company (RCC) in riparian projects in the area. In 2013, RCC faced issues expanding its limestone quarry as potential impacts with wetland areas imminent. RCC decided it needed to prevent the impacts one of two ways: pay someone to fix the streambank or fix the problem head-on and mitigate potential environmental concerns. Goss worked alongside of RCC Environmental Analyst Lindsey Layman on the project.

"With passion, devotion, and hard work, Genevieve is the embodiment of community values and has been a valued partner," Layman said when asked about Goss's work in the community. "Genevieve is a catalyst for change and her results can be seen throughout Botetourt County. As area residents, the Roanoke Cement family sincerely appreciates her countless

contributions to the community and for enhancing our community outreach."

Along with Goss's ongoing preservation projects, she and her husband, John have played a part in Natural Bridge being designated a Dark Sky Park by the International Dark Sky Association and will continue their efforts in conservation easement and environmental protection.

Goss hopes that her legacy lives on with VCC and will continue her work with the Botetourt Community Partnership. She encourages to continue taking steps to becoming more involved with the preservation of Botetourt's beautiful and important countryside as it's a good way to feel like a part of the community.



Spring turkey harvest highest ever in Virginia

The Department of Wildlife Resources (DWR) announced a harvest of 24,447 turkeys during the 2023 spring turkey season. This represents the highest spring turkey harvest ever recorded in Virginia. The previous record was 20,580, set during the 2015 spring hunting season. DWR Executive Director Ryan Brown said, "Turkey populations remain healthy and abundant across most of Virginia, enabling hunters to enjoy a record-setting spring turkey season.'

DWR biologists anticipated the spring turkey harvest would increase during the 2023 season as indicated by above average brood survey results in 2021. The department's annual brood survey is a measure of productivity and recruitment within Virginia's turkey population. In 2021, the survey indicated above-average recruitment of turkey poults across much of the state. These birds are now 2 years old, and 2-year-old gobblers are typically very eager to respond to hunter's calls. These 2-year-old birds also tend to be more vocal, so they are often easier for hunters to locate. In addition to the increased availability of gobblers, favorable hunting weather contributed to a great season for many Virginia turkey hunters. Temperatures remained relatively cool and dry providing an ample amount of ideal hunting weather.

Às in previous years, more birds were harvested east of the Blue Ridge (68%) than west of the Blue Ridge (32%). Adult gobblers (those with a beard at least seven inches in length) made up 92% of the total harvest, while juvenile gobblers known as "jakes" (those with a beard less than seven inches in length) accounted for only 8% of the harvest. Turkey harvests occurred overwhelmingly in the morning (93%) versus the afternoon The majority of the spring turkey

harvest took place on private lands (93%). Public land hunters (both federal and state) accounted for 7% of the total spring harvest, which was an increase from the prior two years. National Forest lands accounted for the majority of public land harvests. Although many states within the region

are reporting declining spring turkey harvests and populations, Virginia seems to be a bright spot regionally. Four of the top five turkey harvests have occurred since 2020, indicating that populations appear to be robust. However, there are several areas of the Commonwealth where objectives to increase turkey populations are not being met. DWR biologists continue to monitor these areas for potential management solutions. Using best available science and stakeholder input, the agency will begin revising the Wild Turkey Management Plan during 2023 and will provide more information as the process gets underway.





It was what ESPN would call an "Instant Classic" with two teams who came in at 21-1 battling long into the night before River prevailed in the bottom of the 14th for a 1-0 win in a game that lasted over three

Knights pitcher Austyn Moran, brilliant all night on the mound, hit a walkoff single up the middle scoring Jenna Pugh in the bottom of the 14th for the 1-0 victory. The winners dog piled at first base as the Knights secured their first regional title since 2012.


The game was completely controlled by The pitching and defense until that time. Raider pitchers Paisley Mann and Bree Carrico combined for 18 strikeouts with only two walks and five hits allowed, all singles. Moran scattered eight hits, striking out 12 and walking only one.

The game had 98 at bats with only 13 combined hits, three walks and only four errors, two on each team. The best scoring chances for Appomattox came in the fifth, 11th, and 12th innings.

In the fifth inning, Mya Kelso hit a long lead off double the left center. With one out, Carrington Moore hit a hard single to centerfield and Kelso was held at third base. Moran coaxed Kenly Booth to pop to second and Moran struck out Emily Purcell. In the 11th frame, two out hits by Haleigh Tweedy and Mann were wasted as Kelso flew to center.

Perhaps the Raiders' best chance was squandered in the 12th inning. Once again after two quick outs, Booth and Purcell had singles. Lead off hitter Bailey Hamilton walked, loading the bases. Moran battled back from a 3-0 count on Aubrey Fulcher to get a hard grounder McCullogh threw Fulcher out at first base.

The Knights best scoring chance before the 14th came in the 11th inning. With two outs, Jenna Pugh beat out a swinging bunt, then stole second base and advanced

the bunt bounced up and hit McCullough in fair territory for the third out.

The Knights come into the state tournament with a 22-1 overall record. Their only loss was to Class 3 Carroll County, a team they beat the second time around.



LB's Howard is state champion in discus




discus with a distance of 161'07".

Glenvar eliminates James River High boys soccer team






