# Fincastle Town Council approves zoning ordinance incorporation

Fincastle Town Council met at the Fincastle Fire & EMS Training Room last Thursday holding a public hearing to discuss the ongoing voluntary boundary adjustment agreement between Botetourt County and the Town of Fincastle.

The first hearing came at the town's Planning Commission recommendation that the R-1, R-2, R-3, R-4, B-1, B-2, A-1, and AR zoning classifications be incorporated into the Town of Fincastle's zoning ordinance, to be applied to those area taken into the town as a part of

Over the last few months, Fincastle planners completed a review of all such zoning classifications. Planning Commission member Scott Critzer updated council in June about the proposed incorporation. Council agreed to hold public hearings at last month's meeting to avoid "challenges" from residents concerning the ordinances.


Critzer noted last Thursday night that "this (incorporation into the Fincastle zoning ordinance) is an administrative step... (the town has been) borrowing Botetourt County zoning for five years but couldn't changes. This is just a starting point. (The new classifications are) very changeable."

Critzer added that this decision was 'practical." Prior to council's decision, a resident may have to reach out to four different places to find out the zoning ordinances in the town. Planners wanted to have all of the information about the town's zoning ordinances available on the town's newly refurbished website (townoffincastle.org). He added to pay

# School Board hears final report about school facilities

## Taskforce developed possible scenarios on facility management

The Botetourt County School Board heard the final report of the County Botetourt Public Schools (BCPS) Efficiency & Facilities Taskforce from Dr. Robert Avossa, who has been working with BCPS while putting together community-led engagement during this process. Avossa presented the recommendations based on the planning.

One of the main takeaways from the data review was the taskforce developing four scenarios which includes one where BCPS would look into

combining the campuses will be a transparent of one of the high schools with the Botetourt Technical Education Center (BTEC), a new "secondary campus" combining a BCPS high middle and school, and potentially consolidating elementary schools with two closing.

"There have been zero decisions that have been made," noted BCPS Superintendent Dr. Jonathan Russ during last Thursday's School Board meeting. "There are many steps that have to be taken before there are any changes. These are decisions that to build a foundation of won't be made without community input. This

process."

The goal of the taskforce was to examine current BCPS facilities and related operations to recommend ways to increase efficiencies while providing safe, modern and learning focused environments preparing Executive Report of Recommendations to the School Board and Board of Supervisors.

Taskforce members were invited to attend a series of four working sessions over the course of January through May knowledge on current

# 'Tanker 7' apparatus officially revealed at in-servicing ceremony

see the new unit as it


gets placed in service. Tanker 7 is a 2023 Pierce Freightliner that has a 400HP Cummins engine with an Allison transmission. It has a water hauling capacity of 3,000 gallons and a pump capable of supplying 1,000 gallons per minute.

Overall, this is a much-needed truck for the community and completes the system's capability of having one tanker at each of the seven stations. While the Read Mountain service area is mostly covered by hydrants, there are some segments that do not have access to a hydrant for water

# Our Patriot Ancestors

## Col. Stephen Adams Bayard

In recognition of the upcoming 250th celebration of the adoption of the Declaration of Independence, the DAR America 250! Committee of the Botetourt County Chapter of the Daughters of the American Revolution is placing a spotlight on our Patriot ancestors who helped our country achieve American Independence.

Colonel Stephen Adams Bayard is the Patriot ancestor of member Kathy Stevens Austin. Col. Bayard is her fourth great-grandfather. Col. Bayard was born February 23, 1744, in Bohemia Manor in Cecil County, Md. to Samuel Bayard and Francina Mauldin Bayard. He married Elizabeth MacKay, the daughter of Revolutionary War Col. Aeneas Mackay.

Col. Bayard registered to serve in 1776 at age 32 at the same time Thomas Jefferson's Declaration of Independence was endorsed by Congress, signed in Philadelphia and the colonies declared

their independence.

After Col.Bayard's military service, in 1787 he, his wife and her brother, Samuel Mackay, founded Elizabeth, Pa., a town on the banks of the Monongahela River; they named the town after Elizabeth Mackay Bayard. The Bayards remained there the rest of their lives.

Col. Bayard died December 13, 1815. His final resting place is Allegheny Cemetery in Allegheny County, Pa.

Revolution is a non-profit, non-political organization open to any woman who has lineage to a Patriot who contributed to the success of the American Revolution. Founded over 125 years ago, it is focused on service to the community and fosters Patriotism, Education and Historic Preservation.

# Library Buzz

## **Board of Supervisors** addresses concerns surrounding library materials

For several months, we have listened to community concerns on opposing sides of questions surrounding materials in our Botetourt County libraries. We have investigated the library collection, sought legal counsel, and explored all avenues to respond to citizens' varied After careful consideration and

thorough analysis, we have concluded that Botetourt County Library's existing collection policies and practices are more than satisfactory. We found no evidence of a "liberal agenda," pornographic or obscene materials, or materials that could be deemed "harmful to minors" under

On the contrary, we discovered that from 2020-2022, Botetourt community-driven demand for LGBTQ subjects increased by 427%. Even after staff efforts to accommodate the spike in demand, LGBTQ materials comprise only .04% of the children's collection, compared with .51% of Christian materials. In the entire Botetourt collection, LGBTQ subjects make up .29%, compared with 19x that in Christian titles. Botetourt libraries have half the percentage of LGBTQ titles and a higher percentage of Christian titles than any other library in our consortium. These facts and many more demonstrate that Library Director Julie Phillips and her staff have been exceptionally responsive and thoughtful in meeting the varied and evolving needs of our Botetourt

On July 31, 2023, we made our final decision regarding this issue. In

a unanimous resolution, we expressed our full support of the protection of citizens' First Amendment and parental rights in Botetourt County libraries, including:

Protecting citizens' right to read and access information freely and to form their own opinions. Defending parental rights to

choose content that is suitable for their own families and children, but not to determine what is appropriate for other families and their children. Affirming the Botetourt

County Library's existing policies and practices to protect minors by requiring minors under the age of 13 to be accompanied by a parent or responsible adult, and by providing for collection transparency and parental/guardian access and control in minors' use of library materials, services, resources, and events. Supporting the Botetourt

County Library's existing policies and procedures guiding the selection and deselection of materials reflecting the needs and interests of the community, without discrimination against or preference for specific individuals, groups, or viewpoints. Affirming the Botetourt County

Library's vital role in protecting citizens' constitutional and parental rights and enabling all citizens to understand and navigate a complex world. On July 17, we unanimously

affirmed our full support for Library Director Julie Phillips and her staff. We again reiterate that we will not tolerate any level of abuse or slander directed toward any county employees for carrying out the duties they are charged to do. For more information, please visit www. BoCoFacts4U.info.

## Library **Director adds** clarification to August 9 letter

An August 9 letter to the editor contained misinformation that has been repeated for some time by multiple people. I'd like to add some clarity to this discussion. When I worked

in Greenville, S.C., the public library received a meeting space use request from a community group hosting their own Drag Queen Story Hour. This was not a library program, it was not at the branch I managed, I had no connection with the group, and it was a one-time event. My only role was privately expressing my concern that if the group was denied equitable use of the space (as they initially were), the library would certainly lose a First Amendment lawsuit. Evidently, the library's attorney agreed, as the event was quickly reinstated.

It would inappropriate for me to criticize publicly any former employer for their actions or decisions. However, I am happy to share the details of my background anyone who contacts me directly. I was extensively vetted by the Botetourt County hiring team regarding my history, and I welcomed the scrutiny.

The theory that I am part of a supposed agenda driven by the American Library Association (ALA) is interesting, since I am not a member of the ALA, nor does the ALA or any similar organization have any involvement in our library's policies, activities, or collection. Furthermore, I have expressed openly concerns that for all its benefits, the ALA does not adequately support librarians serving conservative, communities. As for the statement

that I intend to "sexualize young children" by including specific materials in our children's collection, may I remind our readers that I do not select materials; YOU do. Every title in our collection is a response to community needs and interests. Many of the same titles that some citizens identify as "harmful to minors" have been acquired in direct response to requests by Botetourt patrons, including parents of young children. They are taxpayers, too. The August 9 letter

describes me as an "activist." I am a product of Christian fundamentalism, graduate of Bob Jones University (two degrees), and a professional librarian with over two decades of experience serving conservative, Christian majority communities in school, university, and public library settings. The idea that I am an activist on any side is amusing to anyone who knows me. I consume media regularly from all sides of the spectrum, I listen to feedback from our patrons, I seek first to understand, and I set aside my personal beliefs and opinions to deliver what our community wants. This isn't about me; it's about our citizens. That means we also respond to minority voices, which include both our LGBTQ patrons AND individuals who agree with the aforementioned letter writer's opinions. Libraries are for everyone.

Across the U.S., librarians are being harassed, threatened, and targeted by groups seeking to remove specific ideas from public discourse. In recent months, I've been labeled a pedophile and groomer, been the target of misinformation campaigns, received unpleasant messages, been stalked on social and more. media, Seeing this behavior, our Botetourt County Board of Supervisors clearly stated in their July 17 resolution that they "will not allow Ms. Phillips or her staff to be persecuted for doing the job that they are tasked to do, and that job is to serve all citizens of Botetourt County."

Our public library stands firmly for the rights of all citizens to access information freely, decide what is suitable for themselves their children, and disagree civilly and with their neighbors. 

is not about how the Botetourt County Board of Supervisors governs; it's about how some citizens engage in bullying.

Contrary to the writer's patently untrue statement, the Board of Supervisors did NOT pass a resolution recommending that the Library Board modify its policies. Rather, Botetourt County leaders unanimously adopted a resolution in support of the protection of citizens' First Amendment and parental rights in Botetourt County libraries. The July 31 Resolution specifically – and unanimously – affirms the Botetourt County Library's existing policies and practices.

During the July 31 meeting, Supervisors Chair Dr. Mac Scothorn simply made a suggestion that he very clearly stated he was sharing on his own personal behalf. He made it crystal clear he was not speaking for the board. His personal suggestion was to merely ask that the Botetourt County Library Board consider prohibiting minors (under age 18) from visiting county libraries unaccompanied except for 16and 17-year-olds who have been granted written permission by a parent to do so. The Botetourt County libraries' current policy, which was unanimously endorsed by the Board of Supervisors in its July 31 Resolution, is that children under the age of 13 must be supervised by a parent or responsible adult over the age of 18.

The August 9 letter writer, like some other misguided, ill-informed, uninformed, and/or willfully ignorant citizens, also continues to ignore the widely and readily available truthful facts and to bray about Botetourt County libraries containing "pornography'

and "pedophilia" and promoting the sexualization of young children. He, like some of his fellow citizens, continues to spout and disseminate demonstrably false "facts."

In stark contrast, Botetourt County has spent much time and money conducting its due diligence and thoroughly investigating these claims. Library Director Julie Phillips, Supervisor Steve Clinton, and County Attorney Mike Lockaby each gave exceptional, detailed, factual presentations at the board's July 17 meeting, directly rebutting these lies. The county's and the library's websites are replete with truthful, factual information that refutes these lies. We will not repeat here the vast amount of actual, verified facts easily available to anyone who really cares about the truth and about actual facts.

Citizens need to educate themselves and refuse to rely on misstatements, half-truths, and outright lies of others. All of the facts discovered during the county's investigations are available online at botetourtva.gov, Botetourt County's official website. Read for yourself the board's minutes. Carefully read the board's July 17 Unanimous Resolution in Support of Library Director Julie Phillips and Botetourt County Library Staff and the board's July 31 Unanimous Resolution. Take the time to read Attorney Lockaby's statements and comments. Peruse BOCO Facts For U.

It is utterly shameful and completely beyond the pale that Ms. Phillips and the Botetourt County Library staff have come under bullying personal attacks by members of our community in person, in local media, online, and again in the August 9 letter to the editor. Fear does not drive these actions and words; ideology, misplaced/misdirected anger, intentional ignorance, and/or just plain hatefulness do.

Although none of the many valuable services Botetourt libraries offers to children includes a so-called "Drag Queen Story Hour," the August 9 letter writer tries to suggest that clownishly made-up men who dress up as women in outlandish clothes should never be around a child, much less read a book to a group of children. The writer fails to recognize the good work done by men dressing up as women for worthy causes - for example, the Womenless Beauty Pageants used as fundraisers and open to all - including children. Indeed, as recently as February 2023, a Womenless Beauty Pageant was held in Botetourt County to benefit a resident who has been fighting cancer for nearly 10 years.

These citizens' claims about Botetourt libraries containing "pornography" and "pedophilia" and promoting the sexualization of young children have been repeatedly heard, thoroughly investigated, and soundly debunked. There can be no "compromise" with people who insist on remaining intentionally oblivious to true factual information. Their minds are made up, and the facts be damned.

We are 100 percent in support of the board's July 17 and July 31 Resolutions. We are proud of the board for unanimously passing the Resolutions. We are proud of and unequivocally support Botetourt libraries, Library Director Julie Phillips, her staff, the Library Board of Trustees, and the library's current policies, procedures,

and practices.

attention to the stated purpose of each purpose of the zoning classification as it's something "often overlooked."

Mayor Mary Bess Smith noted that "people don't do boundary adjustments. We're in a very new area here with (incorporating) what (the Fincastle Planning Commission has) taken in after the fact. We do think the time has come." She noted the town simply wants

more specificity around things close to Fincastle.

Town Council unanimously approved incorporating the county classifications into the town's zoning ordinance. Additionally, the town unanimously approved the Fincastle planners' recommendation to adopt a Light Manufacturing zoning classification for the area along Route 220 north of the intersection of N. Roanoke Street and 220, and on a supporting amendment to the Town Comprehensive Land Use Plan supporting such an ordinance.

The new classification is a merger of the M-1, M-2, and M-3 categories. Planners discovered that they ended up with a "mixed use corridor" limiting new use for the area north of Route 220 and N. Roanoke Street intersection. The

new Light Manufacturing classification

would apply to future use conditions.

Critzer also made note that this merely incorporates the already established zoning ordinances by the county and that planners will continue to review the inclusion. Town council voted Critzer as the new interim Zoning Administrator for the town until a new town manager is hired.

facilities and plans, while creating a collaborative space to discuss future

Collectively, the team developed a set of values that included recognizing the future implications of current investments, with the aim of reducing long-term facility costs, efforts to transparently communicate fiscal decisions and addressing constituent needs, expanding access to existing programs, building new spaces for innovative programming, reinvesting funds in ways that directly impact students and staff, and actions to balance capacity filled across sites and maximize usage of existing facilities/previous fiscal investments.

The taskforce made several site visits to Lord Botetourt High School and Cloverdale and Colonial Elementary Schools. In those visits the team walked through each building during the school day to see how the buildings are being used, talked with students and staff about their experiences, and evaluated specific aspects of the facilities - such as the exterior, entrance, hallways, cafeteria, classrooms, and common learning areas, and gym/athletic spaces. A data review was conducted

focusing on facility factors (age of buildings), population statistics, operational costs, and cross-campus comparison. Avossa spoke about the history of ongoing maintenance projects and identified needs for school buildings but there is currently no funding established on some of the facility needs. In their findings, Avossa spoke

about the current state of Botetourt schools. He shared that BCPS is currently experiencing aging and deteriorating infrastructure across all levels and school sites. Leadership and the School Board have made many financial decisions and tradeoffs to support small school facility operating costs to keep all sites operational regardless of enrollment numbers. Facilities have been well maintained by the division. However, aging infrastructure leads to an increase in risk related to finance and safety. Many parents and community members have personal experiences with high levels of emotional attachment to individual schools, expressing concerns/fears about change. "Kids don't come to school in perfect

little packets of 20," Avossa stated. "There are places that are going to grow and there are places that are going to shrink. There are communities that age and there are communities that draw younger families. This is not unique to Botetourt." Avossa went on to explain in his

presentation that critical capital improvement projects unfunded at most buildings, with the community paying particularly close attention to the necessary upgrades for Lord Botetourt. Available capacity exists at a majority of elementary schools in both north and south areas of the county. The population of school-aged children has remained stagnant or has decreased over the last 10 years. Beginning with the FY 2024 budget, current county leaders plan to provide funds for capital improvements to replenish funds in the BCPS Capital Reserves. There is increasing interest in career and technical education programs. BTEC is at maximum capacity and is unable to expand to offer new programs on its current site.

He went through the scenarios for taskforce planning that included identifying ranges of potential outcomes and impacts when making decisions, allowing individuals to evaluate a variety of outcomes and manage for both positive and negative possibilities. Avossa noted that scenarios were evaluated based on how the scenario aligned to taskforce values, as well as the associated risks and implications.

In the scenarios identified for evaluation, the taskforce came up with three categories ("Capital Improvement Only," "Secondary School," and "Elementary School" scenarios) featuring seven "high priority" scenarios based on the alignment with the established values. The taskforce then looked for "additional expertise" from division

Out of the seven scenarios, the team narrowed them down to four funding the existing CIP, combining a high school campus with BTEC, a combined secondary campus (middle and high school), and consolidating elementary schools with two elementary schools closing.

Additional considerations included a combination of these scenarios with each one not being mutually exclusive, with benefits achieved by combining multiple scenarios, a timeline to initiate, deeper evaluation of new school construction, partnerships with local business to "co-design" educational learning spaces for career preparation, and engaging in a countywide conversation building awareness, understanding concerns, and identifying ways to contribute to change.

Avossa shared that working together and being transparent will help achieve a common goal for the county and reminded the board that "this is just the first step." He noted the longer BCPS waits on facility issues, the more expensive these projects will become.

Valley District School Board representative Tim Davidick added that the board will "take a breather and soak this in... maybe reach out [to the community] and talk a little

Davidick liked the recommendation of the scenarios and that these "are not mutually exclusive."

"Our school system does a phenomenal job of educating our students with what we have," he said. "If we could do something to improve the facilities for our teachers and our staff, where we can go is an amazing place."



## Countdown to kickoff on DirecTV

Here's some concerning news for football fans with DirecTV. You may not have command of the NFL games you're excited to see this season. Last Saturday the Baltimore Ravens

hosted the Philadelphia Eagles in a preseason game. Granted, it was just an exhibition game, and the starters weren't even going to play, but as an Eagles fan I was excited to see how their draft choices and new additions looked in a live game. I check the Philly website every day for reports on training camp, who is looking good and who is moving up or down the depth chart. And hey, it's football and I've been waiting for it since February.

I was excited to see the game was scheduled to be on the NFL Network live at 7 p.m. Not all the NFL exhibition games are live, and when you watch the replay they run scores at the bottom of the screen. So, you can be watching a game in the second quarter and the final score of that game will be crawling across the bottom and impossible to avoid. Again, it's just a preseason game but it makes it even more meaningless if you know the final score while you're watching the

When I tuned in to the NFL Network at 7 p.m. Saturday it informed me that game was blacked out in this area, I guess because Baltimore is close enough to Roanoke to make it one of our "home" teams. I have the baseball package as well on DirecTV and the Nationals' games are blacked out and you have to watch them on the MASN channel. I'm not crazy about the Nationals' broadcasters but at least I can watch the games.

With the Ravens-Eagles game blacked out on the NFL Network, it directed me to WWCW, Channel 5 on my DirecTV. However, that's a Nexstar-owned station and Nexstar is currently in a contract dispute with DirecTV, so all I got was a notice telling me they're working on a new deal. At this point, I started getting aggravated.

One of the reasons I got DirecTV in the first place was so I could watch all the NFL games on Sundays. However, beginning this year the NFL package has moved to YouTube. I've already signed up for the YouTube deal, and I opted for the cheapest package that includes all the regular season games but nothing else. For that, it will cost me about the same thing I was paying when the NFL games were on DirecTV.

YouTube also offers a more expensive package, where they include the preseason games and a bunch of other channels we already get or don't need. My wife, who is good at stuff like this, reminded me that they're offering a 10-day free trial for that service, so she went about the hassle of signing up for that trial with hopes that we could get the preseason football game Saturday night. When she finished all the rigmarole of doing that, it was to no avail, as the game was also blacked out on YouTube.

Now I was really getting frustrated. My grandson had come over to watch the game with us and he's also very good at today's technology. He was somehow getting the game on his phone, but when he tried to relay it to the TV we got the audio but no video, and it was now midway through the second quarter.

My wife tried several other things, hooking up our "Apple Box" and using all three of our remotes to try and find the game. If it was just me I would have given up long ago, but she doesn't let modern technology defeat her like I do. Finally, and I don't know what she did, she was able to find the game on our computer and get it on the TV, but it was now halftime and even the second stringers were done for the evening. It took almost an hour to

get to that point. I point this out because our local Fox station, WFXR Channel 27 on DirecTV, is also in a dispute with Nexstar. DirecTV customers haven't been able to get Channel 27 since July 1, missing the Major League All-Star game, the women's soccer World Cup and other shows I used

When you turn to Channel 27 it tells you to go to "tvpromise. com" for an explanation of why the station is not on. I've done so, and all it pretty much tells me is that two organizations who overcharge already are at odds because one wants to charge even more and the other isn't budging.

to enjoy on that station.

Hopefully, this dispute will be over by the first week of September when the NFL starts for real. Channel 27 is our home Fox station for NFC Football, and if the impasse is still going on that means Washington football fans won't have their games on DirecTV if they're playing an NFC opponent at home or anyone on the road. On days when Fox has the doubleheader you're likely to be blacked out of games with the Cowboys, Giants, Eagles, 49ers, Vikings or whatever NFC team is on Fox Sports that day.

I hope the DirecTV and Nexstar folks can settle this dispute soon. I can get by missing reruns of "Young Sheldon" but I want my football on



## Special needs kids take the challenge to play baseball, fund-raising golf tournament is at Ashley Plantation

'We had 104 sign up," said Sid Witt II, District 12 Assistant Administrator Challenger Little League Baseball in Virginia. "It's good to have a lot sign up, but that also means we have a lot of disabled kids."

The Challenger program is a nonprofit division of Little League Baseball that provides boys and girls 4 years of age and older, with mental or physical disabilities, the opportunity to experience the fun of playing baseball. Botetourt County is part of District 12 and kids in the county qualify for the program.

"Challenger allows every child the chance to experience the rewards of being part of an athletic team while motivating and increasing emotional development, high selfesteem, confidence, and pride, regardless of their ability," said Witt.
Sid has been with

the program since its inception in 1989. At the time the late Willis Walrond, who was heavily involved with Little League Baseball, and Sid's dad, Sid Witt, program here.

All three have since been inducted into the Salem-Roanoke Baseball of participants this Hall of Fame for their summer. That's a good unselfish dedication to these less-fortunate kids, Walrond in 1998, Witt, Sr. in 2005 and Witt II in 2014. Witt, Sr. passed away two years ago but was involved with the program right up until the end.
