Citizen information meeting about Craig-Botetourt scenic trail Sept. 20 & 21

Transportation (VDOT) has scheduled a citizen information meeting regarding the proposed project of constructing a 26-mile recreational scenic trail along the former Chesapeake & Ohio Craig Valley Branch railbed between Last Lock Park near Eagle Rock in Botetourt County and Craig County High School near New Castle in Craig County.

The meetings will take place Wednesday, Sept. 20, from 4-6 p.m. at Eagle Rock Elementary School and Thursday, Sept. 21, from 4-6 p.m. at Craig County High School in New Castle.

In a recent legal advertisement, VDOT explains the trail will be used for walking, running, biking, and horseback riding, is anticipated to be approximately 10-foot wide and mostly gravel. It will follow the former railbed and some low-volume secondary roads and consist of "share the road/trail" sections which will permit the use of motorized vehicles as well as sections of non-motorized use.

County Assistant Administrator Jon

Virginia Department of Lanford said in a recent email that "VDOT has flown the corridor and completed ortho(photo) survey." He explained that, in certain areas, a required "topo(graphic) survey" has been ordered.

Eight existing bridges along the former railbed will be modified to accommodate trail use. The meetings will be held in an "open-house" format and VDOT representatives will be present to answer questions. The same information will be presented at both meetings.

"The meeting will be an opportunity for citizens to talk with us directly and to also give feedback to us on our comment form at the meeting or via an online survey that will be posted the day of the first meeting,' VDOT Communications Specialist Jen Ward said in an email Tuesday. "In addition, we will be particularly interested in hearing feedback about proposed trailheads along the trail."

Citizens may review the conceptual plans and project information at the meeting or after at VDOT's Salem District Office located at 731 Harrison Avenue in



Salem, or by calling 540-387-5353, 800-367-7623, or TTY/TDD 711. VDOT asks to please call ahead to ensure the availability of appropriate personnel to answer your questions.

Additionally, citizens may submit written or oral comments at the meetings or may send them to Project Manager Kelly Dunn at the Salem office or emailing CBST@vdot.virginia.gov by Oct. 1. VDOT requests that the subject heading should contain "Craig Botetourt

Scenic Trail Comment." An online survey will be available at www.virginiadot.org/ cbst beginning Sept. 20, the day of the first meeting, for citizens to share their comments about the project.

In case of inclement weather or other issues, the meeting in Eagle Rock will be held Sept. 27 and the meeting in New Castle will be held Sept. 28 at the same times and locations.

9/11 Memorial Walk this Saturday in Buchanan

Over the last four Buchanan years, volunteer firefighter Bill Price and his non-profit organization, Sirens and Salutes, have put together a memorial walk in Buchanan Town Park honoring the individuals who gave their lives in service during the morning of September 11, 2001.

This year, Sirens and Salutes invites citizens to join them at Buchanan Town Park this Saturday, Sept. 9 in remembrance of that tragic day in American history. The walk lasts for 102 minutes with pauses throughout the walk to recognize significant moments during that tragic morning. Guests are invited to arrive at Town Park at 8 a.m. for a brief ceremony proceeding the walk.

the year, organization welcomes back retired New York City firefighter Al Weber, who returns to the event. He previously spoke at the walk in 2021. Also joining Weber will be John Dester, a retired New York/New Jersey Port Authority police officer who was also on site during the events of 9/11.

Dove Release Ministries also returns to release a single dove for every significant moment in which the walk will pause in a moment of silence, and will release 22 doves at the end of the walk.

An American flag flown over ground zero for three months during the rescue efforts in 2001 will also be on hand during the walk. Numerous military branches have flown this flag all over the world. The flag will be on a flagpole and in possession of the participants during the walk who wish to carry it. Everyone who comes in contact with the flag has an opportunity to sign a log owned by John Sullivan, a flag shop owner in Richmond who came in possession of the flag. Sullivan is currently filling the flag's sixth log book. The names from Saturday's walk will then be logged electronically.

Sullivan had a flag shop in New Jersey on Sept. 11, 2001. He was asked by the Port Authority Police Department (PAPD) to fly an American flag he was selling to fly over the debris field from the fallen towers. The flag was later returned by PAPD. Since then, Sullivan has allowed the same flag to be flown in memorial services all over the world.

There will also be a piece of marble recovered from the South Tower on display and can be carried if anyone wishes to take it with them on the walk.

The dinner featured a local menu, including products from the Homestead Creamery, Layman Family Farms, Ikenberry Orchards, Little Wasprock



Town of Fincastle holding public hearings September 14

The Town of Fincastle will hold two public hearings at the upcoming September 14 meeting at the Fincastle Volunteer Firehouse training room. The hearings are scheduled so Tow Council and the town's Planning Commission can gain public input on the matters discussed.

The first hearing will take place during the Fincastle Planning Commission meeting at 6 p.m. The commission is proposing an ordinance that would establish the procedure and requirements prior to the issuing of a demolition permit for any historic building that is 100 years old or older within the Town of Fincastle. This ordinance would only apply to primary buildings and will not apply to accessory structures such as sheds, garages, or storage

Following the meeting of the Planning Commission, Fincastle Town Council will hold two public

hearings. The first is about a proposal made by the Fincastle Planning Commission to create an Uptown Mixed Use Expansion district extending one block out from the intersection of Main and Roanoke Streets applicable to properties that have frontage on those streets. This proposal will not change the existing zoning for current uses in this district.

The other hearing regards proposed text amendments are to the accessory building or structures ordinance. These amendments are for the purpose of better clarifying several of the terms in the existing ordinance and defining the number

of such structures that are allowed. A copy of this proposed text amendment may be obtained at the Fincastle Town office during regular business hours.



Botetourt County History



Purses were originally made for Egyptian men thousands of years ago and they have evolved throughout history. In the 19th century, purses were made more durable for women to carry their essentials. This small leather and metal handbag (circa 1880) belonged to Ann Eliza Smith Bigler (1847-1928). She was married to Mark Bigler IV and they had five children. They lived on a Botetourt farm where the roads were often impassable. Eliza would travel with herbs, linen strips, mutton tallow and her faith to treat the sick and even set broken bones. She died after a protracted illness and many relatives and friends attended her funeral, which was published in the January 19,1928, "Buchanan News." Her daughters, Ruth and Irene Bigler, donated Eliza's purse to the Botetourt History Museum to honor their mother.



between the Dollar General Market and Elite Nails into a fitness center.

Team Botetourt Wrestling Club, doing business as "Botetourt Training Center," operates a non-profit fitness center out of the facility. The proposal is for the space to house batting cages during training hours at the fitness center and weekly Bingo held in the building during hours when the fitness center isn't in operation. Under county and state code, non-profit Bingo operations cannot be conducted more than two times every week.

The batting cages will have retractable nets that are lowered/raised from the ceiling of the facility with turf that will be applied in the area where athletes work on their hitting skills. There will soon be motorized pitching machines in the facility to aid with baseball/softball

Founder and Executive Director of the Botetourt Wrestling Club and James River High School wrestling coach Bobby Stewart, who noted "a massive demand for indoor batting" training, was on hand to explain the needs for the upcoming additions to the active training center.

"I moved back here in 2000 and I realized that there weren't enough kids training for the next level (of sports), whether that is D-1 (Collegiate Division 1 schools), D-2 (Division 2), or D-3 (Division 3)," Stewart explained to the board. "Today, even trade schools have sports, and why? Confidence. The reason they (kids) don't have confidence, they don't have the training. The kids that did compete at those levels were overtly goal-driven or they had the funding to get the training they need... We have a lot in mind for the kids in our community.'

The suggested conditions noted include that commercial recreation uses are only limited to the tenant space (2708 Lee Highway), uses will be limited to Bingo and batting cages, and noises generated by the development will not violate the county's noise ordinance.

Stewart noted that the goal of his group was to give back to Botetourt and assist in training the county's student athletes. Roanoke Valley Star soccer and the Maroon Crush softball programs were inspirations in giving the group the idea to hold weekly Bingo fundraising events on Saturday and Sunday afternoons.

Residents shared their support for the training facility's efforts in bettering local youth on the field and

One Buchanan resident shared support for the proposed Bingo club program and batting cages. "Obviously, it's going to make it so that more kids can get involved, but there are other reasons Bingo is good for a community. It encourages social interaction... and when people participate in Bingo, a lot of times they can feel a part of a community and that can foster a sense of belonging.

"It's a safe environment where everybody can get involved and enjoy the activity that is provided there. Regularly playing Bingo can keep your mind sharp and this can especially benefit our senior population. For parents, it's going to make it more affordable for our kids to participate in wrestling or other sports. We can make our kids volunteer at Bingo and that teaches them responsibility and gives them a sense of ownership and helps them buy in more to what they are doing... Bringing Bingo to Botetourt would be a way to foster a stronger sense of community and to help more youth get involved and become more active, which I think is a win for everybody."

Currently, the training center works with approximately 65 registered student athletes from Botetourt and surrounding localities. The center offers CrossFit, tumbling, wrestling, volleyball, and football training activities.

Supervisors Chairman Mac Scothorn noted that Botetourt "is absolutely in need" of a sports training facility like the one Stewart and his group offer student athletes in the area.

In the Amsterdam District, a proposed medical facility at 1645 Roanoke Road in Daleville requested a Special Exceptions Permit (SEP) to help provide specialized services in Botetourt that would operate a diagnostic facility for an ADHD, depression, and anxiety testing and treatment planning. The layout will include a waiting room, an administrative office, and two exam rooms. The medical care facility will not allow a drug rehabilitation clinic. Any patient with a history of drug abuse in their medical records will be "screened out," according to the notes provided by the planning and zoning

The property's current zoning (B-1) needs special exception to allow for a medical facility. The total space utilized by this use is 2,000 square encompassing feet, the entire downstairs portion of the building. The county's Planning Commission unanimously in favor of the proposal during its August meeting.

The currently unoccupied location would house the facility on the first floor of the building. The lessee, Renew Psychiatry

Services, will bring three staff members: Michie Bolden, a nurse practitioner based out of Roanoke, and two administrative staff members. Bolden

estimates 8-10 patients visiting the site per day. Bolden explained to the board during the hearing that she will be practicing out of the Daleville location full time.

Fincastle Festival will feature 'History Talks' and much more

Fincastle, known as a town with lots of history, is the county seat of Botetourt County, a county with lots of

During this year's Historic Fincastle Fall Festival on Saturday, September 23, Historic Fincastle Inc. (HFI) will be celebrating some of this history – from the 1700s to present day. One reason HFI sponsors the yearly historic festival is to encourage people to visit and walk around the Town of Fincastle to see its historic churches and homes. This year is no exception. Self-guided tour brochures of the town will be provided at the information tents. The Botetourt County Museum will be open for visitors as well as the two HFI properties, the Early Cabin and the Wysong Blacksmith Shop.

This year's "History Talks" will be held at the Wysong Blacksmith Classroom due to the changes taking place in the present courtroom in the courthouse (plus there has been some water damage from a broken pipe).

At the Early Cabin, Mrs. Early will be showing her cabin and talk about some of the stresses and strains of raising a family in the 18th century. There will also be an encampment of Revolutionary Era interpreters with a living history display. The re-enactors will be dressed in period attire and will be explaining the stresses and strains of life without electricity or refrigeration.

Descendants from the Monacan native tribes who lived in this region for centuries will also be at the cabin explaining how early tribes lived in the Shenandoah Valley.

The Wysong Blacksmith Shop will have a blacksmith

demonstrating how to make horseshoes, nails and other

items that were made by the local blacksmith. This is where the "History Talks" will be held in the classroom

in the Wysong building.

At 10 a.m., Tommy Moore, Clerk of Botetourt Circuit Court, will be showing some of the record books that are kept in the courthouse. Moore will also be dressed in appropriate attire of the 1770s. Thomas Jefferson's signature, as well as other documents of historical interest, will be on display.

At 11 a.m., there will be a showing of a film, "A River Called Home" by Jessica Wiegandt. She and three of her friends chronicled their 21-day adventure paddling the waters and white waters of the James, from the headwaters to the Chesapeake Bay. During their trip, they conducted a water quality study on pollution and how the waterways are being protected and what more needs to be done.

The noon "History Talk" will be held at the main music stage in the Courthouse Square. Chuck Geiger and Kip Burton will be honored with presentations of "Quilts of Valor" by the Roanoke chapter of the Quilts of Valor Foundation. Burton was an attack pilot and Geiger was a fighter pilot during the Vietnam War. They both served their country for many years, and this honor is long overdue. Come hear their stories.

At 1 p.m., the "History Talks" will continue back at the Wysong Blacksmith Classroom. During this time, there will be a round table conversation with people who grew up in Fincastle in the 1940s, '50s and '60s. Come find out how Fincastle has changed during the decades and how it has stayed the same. Bring questions and listen to their stories.

The last "History Talks" (at 2 p.m.) will be a 15-minute video of the 1965 First Outdoor Bluegrass Festival held in the United States. It was held at Cantrell's Horse Farm just outside Fincastle. Flatt and Scruggs, Bill Monroe and Doc Watson were just some of the bluegrass entertainers who performed at this historic three-day event.

Preserving and sharing history is very important to

the residents of Fincastle and Botetourt County. Come to the "History Talks" to find out something new. In Courthouse Square there is a display of banners of present-day Botetourt County with QR codes offering more information about the towns and settlements in Botetourt County. On Murray Street more banners and QR codes that explain more of the early history of Botetourt County will be on display. There will also be the first previews of some of the new banners that will

be put up around the destruction and re-construction of the Botetourt County Courthouse.

At 7 p.m. the Lawson Theater/Attic Productions will hold a concert ("The Most Unique Concert of the Year") presented by Botetourt Preservation Partnership, Inc. Again, the history of the county will be explored through music.

Remember, along with visiting the craftsmen, artists, musical performances, food trucks, quilt show, petting zoo, and touch-a-truck, come to the "History Talks" in the Wysong Blacksmith Classroom at 10 a.m., 11 a.m., 1 p.m. and 2 p.m.

Knights finish strong for second straight win

The James River football team has started off 2-0 for the first time since 2018, and you can chalk that up to their work in the fourth quarter. River finished strong for the second time in as many weeks to take a 34-16 win over Randolph-Henry in Springwood last

"We've become a second-half team, and that's not something we're used to," said River coach Tim Jennings. "Last year the fourth quarter was our nemesis." In River's opening game the Knights

were scoreless through three quarters before rallying for a 13-12 win over Buffalo Gap. Last Friday the Knights led 7-0 at the half but the visiting Statesmen scored with 28 seconds remaining in the third quarter, then hit on a two-point conversion to take an 8-7 lead. But the Knights were only getting

started. Maddox Woodyard ran the ensuing kickoff back 85 yards to regain the lead after just 16 seconds, and a Zeal Hammons to Trey Taylor two-point conversion put River back on top, 15-7. Taylor then recovered an onside kick

and the Knights drove to paydirt again with Gavin Binns scoring on a 28-yard run. Evan Byers' extra point kick made

On Randolph-Henry's next possession, Binns intercepted a pass and took it 48 yards to the house for another score. The kick failed, but River now led 28-8 after three touchdowns within a span of five minutes and 14 seconds. The stunned Statesmen were able to

regroup and answer on a 34-yard scoring pass, and the two-point conversion made it 28-16 with four and a half minutes to go. However, River put it away by killing the clock and putting some icing on the cake with Byers running for a nine-yard score with 1:08 on the clock. "Our kids are getting some confidence,"

said Jennings. "We're 2-0 and they're very coachable.

Binns, a sophomore, has been a big weapon for the Knights. The speedy back scored three touchdowns while rushing for 157 yards on 20 carries. He also caught a pass and had the big "pick six" in the fourth quarter.

"He's been something else," said Jennings. "He's fast, he sees the field well and he's tough to tackle. He's not big but he's strong.'

Taylor rushed twice for 31 yards and Woodyard had 11 yards rushing as the Knights outgained Randolph-Henry on the ground, 173-55. Hammons was six for 13 passing for 76 yards with four to Taylor for 72 of

The Knights came up big again on defense, holding the Statesmen scoreless through the half and giving up a total of seven first downs and an average of 3.9 yards per play. Gabe Staton led the team with 15 tackles, including seven solos, two sacks and three for losses. Keegan Mundy had

11 tackles and Woodyard had nine. This Friday the Knights will be home for the third straight week as they host Parry McCluer at 7 p.m. This is always a special game for Jennings, who played his high school football for the Blues.

This year is special because one of my best friends is the coach there," said Jennings. "We were in each other's weddings and he has a couple guys on the staff who played with us."

Jeremiah Brockenbrough is off to a good start as the first year coach at the Buena Vista school. 

Cavaliers put up record number of points in blowout win

The Lord Botetourt football team set a school record for points in a game when the Cavaliers won at Blacksburg last Friday, 83-6. That was six more than the previous record of 77.

For the longest time LB wasn't known for putting big numbers on the scoreboard. The school first had football in 1959 and for the first 36 years the team only scored 50 or more once. That was in 1962 against the Virginia School for the Deaf and Blind and the final score was The Cavs had never reached the 60 mark before Jamie

Harless came on the scene to coach in 2012, and since then they've put up some big numbers with regularity. Prior to last Friday the school record was 77, and that was accomplished on three occasions. The Cavs had back-to-back 77-point games against Bassett and Ft. Defiance in 2016 and in 2019 they hung 77 on the board against Staunton High School.

Last Friday they had 77 at halftime! Botetourt scored 29 points in the first quarter, then found the end zone seven times in the second quarter to score 48 more and take a 77-6 lead into the locker room. Needless to say, the clock ran continuously in the second half.

'We had three defensive touchdowns and another time they turned it over deep in their territory," said Harless. "We started pulling people near the end of the second quarter and we got to play a lot of kids. Everyone got in the game."

LB had nine rushing touchdowns. Quarterback Jakari Nicely ran eight times for 162 yards and four scores before taking a seat. That's an average of just over 20 yards per attempt, and he didn't throw a single pass. Cade Lang, LB's top receiver, didn't see a pass come his way from Nicely but he had two "pick sixes"

The jayvees played a nine-hole match with Glenvar and Alleghany last week. The Knights tied Glenvar for first behind a 43 from Caden


