Last Saturday saw local runners young and old sprint, jog, and leisurely stroll through the Town of Fincastle during the 2023 First Bank 5K and 10K Fall Run.

The Botetourt Rotary Club presented the 37th fall run with Botetourt County Public Schools (BCPS) serving as the primary sponsor for the event. This year's run saw 546 participants register to dash through the county seat, according to First Bank's Cindy





## Botetourt County History



This is a large 19th century ironstone platter. It has a decorated feather edge often referred to as "Leeds." The shell-shaped edges are transfer printed with cobalt. Much of this popular pottery was made by Leeds in England. The War of 1812 caused Congress to ban all English imports, but when the embargo was lifted demand for English ceramics was high and resumed. Ceramics like this one are easily damaged and archaeologists have found pieces of this same type of pottery around the homesite of Colonial William Preston in Greenfield. Alfred, Betty and Clara Firebaugh donated this platter to the Botetourt Museum of History and Culture where it is displayed. Previously, it belonged to their great-grandmother Elizabeth McCoy Rieley. She was married to Irish immigrant, William Rieley. Botetourt resident, Greg Rieley, is her great-great-grandson. Being able to see what your ancestors touched and used makes the History Museum special.

· Appalachian Power Company ("APCo") has filed an application seeking to decrease its fuel factor from the current factor of 4.319 cents per kilowatt-hour ("\$\psi/kWh")\$ to 4.139\$\psi/kWh, effective for usage on and after November 1, 2023, which will result in an annual net decrease in revenue of approximately \$25 million.

 $\cdot$  To mitigate the impact of a fuel cost under-recovery position, APCo is proposing to recover its deferred fuel balance as of October 31, 2023, over two years. If the Company does not recover this balance over a two-year period, the current fuel factor of 4.319 /e/kWh would increase to 5.130 /e/kWh, which would result in an annual net increase in revenue of approximately \$111,765,155.

 $\cdot$  According to APCo, the total proposed fuel factor would decrease the average monthly bill of a residential customer using 1,000 kWh of electricity per month by \$1.80. Without the Company's proposed two-year mitigation, the monthly bill of a residential customer using 1,000 kWh of electricity would increase by \$8.11. On September 14, 2023, Appalachian Power Company ("APCo" or "Company") filed with the State Corporation Commission ("Commission") an application ("Application") pursuant to § 56-249.6 of the Code of Virginia ("Code") seeking a decrease in its fuel factor. The Company proposes to decrease the current fuel factor of 4.319 cents per kilowatt-hour ("\$\psi/k\Wh")\$ to 4.139\$\$\psi/k\Wh\$, effective for service rendered November 1, 2023, through October 31, 2024 ("Fuel Year"), which is an annual net decrease in revenue of approximately \$25 million. The Company states that to mitigate the impact of a fuel cost under-recovery position, APCo is proposing to recover its deferred fuel balance as of October 31, 2023, over two years. If the Company does not recover this balance over a two-year period, the current fuel factor of 4.319\$\psi/k\Wh\$ would increase to 5.130\$\psi/k\Wh\$, which is an annual net increase in revenue of approximately \$111,765,155.

The Company's proposed fuel factor consists of both an in-period component and a prior period component. APCo's proposed in-period component is designed to recover its estimated Virginia jurisdictional fuel expenses during the Fuel Year of approximately \$433,839,311, which includes non-incremental costs associated with APCo's wind contracts; a credit for 75% of projected Off System Sales margins; PJM Interconnection, L.L.C. ("PJM"), Load Serving Entity transmission losses; PJM congestion charges; 100% of incremental transmission line loss margins; and Financial Transmission Right revenues. The Company proposes an in-period factor component of 3.148¢/kWh.

The prior-period component is a true-up component designed to recover from customers over a two-year period an estimated under-recovered deferred fuel balance as of October 31, 2023, of \$273,125,395, or \$136,562,698 per year. The Company states that it divided the per-year amount by the projected Virginia jurisdictional energy sales for the Fuel Year to obtain the prior period under-recovery component of 0.991¢/kWh. Without APCo's proposed two-year mitigation, the Company indicates that the prior period under-recovery component would increase to APCo maintains that its proposed fuel factor would decrease the monthly bill of a residential customer using 1,000 kWh of electricity by \$1.80, from \$161.77 to \$159.97. Without the Company's proposed two-year mitigation, and a resulting fuel factor of 5.130 e/kWh, the monthly bill of a residential customer using 1,000 kWh of electricity would increase by \$8.11, from \$161.77 to \$169.88.

The Commission entered an Order Establishing 2023-2024 Fuel Factor Proceeding ("Order") that, among other things, directed the Company to place its proposed fuel factor decrease into effect on an interim basis for service rendered on and after November 1, 2023. The Order further scheduled public hearings on APCo's Application. A hearing for the receipt of testimony from public witnesses on the Company's Application shall be convened telephonically at 10 a.m. on January 17, 2024, with no public witness present in the Commission's courtroom. ## **Brick Union** has long history in the county

Brick Union Church, known originally Howerytown the congregation, once stood near Troutville but was lost to Interstate 81 construction many years ago. The Brick Union congregation was started in 1796 by the Rev. John George Butler. The church is believed to have been constructed around 1837, around the same time that the land the church was built on was deeded by Christian

and Eva Housman. The church was mainly used by Lutherans, Dunkards (now Brethren), and Methodists, giving the church its "Union" name. Bricks from the original church building were used by Fincastle Presbyterian Church to expand its educational space in the 1950s. Eventually, the Lutherans built their own church near Wheatland and the





Dunkards constructed a church in Troutville, leaving Brick Union Church abandoned.

However, church's cemetery is still existent and contains approximately 200 graves of many early Botetourt residents, including the Raders, Campers, Kesslers, Naces, Shays, Sniders, among many more. The earliest known burial on the site is that of Elizabeth Kesler, wife of John Kesler; she died on September 30, 1822. There is also a section that has the graves of enslaved people that worked on the properties of some of the residents buried there. Many graves are without markers.

Burials stopped at Brick Union around the 1920s. Before her death in 1939, Lou Rader, wife of George Rader, had collected money from the relatives of those buried at Brick Union as well as from citizens to help maintain the property, enough so that visitors could still access the cemetery. After her

passing, weeds, trees,

and groundhogs took

possession of the cemetery

grounds. In 1967, the trustees

for Brick Union Cemetery were appointed follows: Robert Murray, Jr., John (Jack) Rader, Sr., Jacqueline Rader, Dorothy Hughes, and Neville Brugh. This group helped to get the cemetery accessible once again and created a list of all legible headstone inscriptions and people known to be buried without markers. Presently, John (Jack) Rader, Sr. is the only surviving trustee for Brick Union. Much of the ongoing

maintenance, for many years, has been tended to and funded by the Rader family. A fund has been established to help with the ongoing upkeep of the property. Through the generosity of an anonymous donor, any contributions to Brick Union Cemetery will be

matched up to \$10,000. The Botetourt County Historical Society acknowledges the importance of the Brick Union Cemetery and has agreed to be the passthrough organization contributions to help with its continued maintenance. 





Fleming had another drive going late in the third period but a fumble gave the ball back to LB with 1:49 remaining in the quarter. Then, with 9:42 to go in the game, Nicely found a wideopen TJ McGinnis for a 53-yard scoring play that gave the Cavaliers their first lead at 14-7.

"We drew that up in the huddle," said LB coach Jamie Harless. "We noticed their outside linebacker was playing in tight and figured we could get TJ out there all alone. We called time out and drew it up and it worked."

Fleming drove down the field and scored with 7:18 to go, but the extra point snap was fumbled. Fleming tried to pass the ball for two at that point and completed the pass, but Ben Gilbert was able to tackle the receiver just before the goal line to preserve LB's 14-13 lead, and that would prove to be big.

Botetourt took the ensuing kickoff and tried to run out the clock. However, that's when things started to get hairy.

The Cavaliers were faced with a fourth-andthree on their side of midfield and decided to go for it, and a first down would have likely ended any chance for Fleming. However, a procedure penalty on the Cavs prior to the snap changed Harless' mind and the Cavaliers punted with

Fleming needing only a field goal to win the game.

The Colonels put on a late drive and had some chances. A fourth down play resulting in a pass interference kept Fleming's drive alive, only to have Grooten intercept a pass just above his shoe tops to kill the threat and give LB the win.

Nicely finished with 114 yards rushing on 22 attempts to lead the Cavs. Tristan Overbay had 25 yards on 14 carries and McGinnis and McCounnaghey had one
