Fincastle Town Council holds February meeting

Fincastle Town Council met for its monthly meeting at the Fincastle Fire Department Training Room last Thursday. Council discussed various town matters including the current cost of town pump operations. Mayor Mary Bess Smith noted during the town financial report that it is there was a spike in sewage pump electrical fees in the months of December and

Smith said that the town previously talked with the Western Virginia Water Authority about trying to install solar panels

to generate additional electricity. At the time, Smith said "the technology hadn't caught up" with the town, but they will begin to look into that option once again.

Town Manager Melanie McFadyen recently explained in a recent email that the sewage plant operator will soon be "checking to make sure there isn't some faulty equipment that is running excessively and should find out something soon." The town's Sustainability Committee has been discussing the use of solar panels as well as


environmentally projects, sustainable according to McFadyen.

Fruit trees have been planted at Big Spring Park. The town recently received wood for the benches located in the outdoor classroom. Additionally, the Appalachian Trail Builders will also build benches that will be located along the trail.

"So, come a little bit warmer weather, there should be a lot more going on," Councilman Ed Bordett added when discussing the trail's winter preparations for spring. Council also discussed an upcoming volunteer clean-up day for anyone interested in helping out

clearing branches and trash along the trail this spring. Signage for the park is currently in the design stage. Bordett said he is currently looking around at pricing for the

Last week, Smith completed the last reimbursement request for the trail work. She explained that other than attorney's fees on surveys and similar work, the town has been "blessed and surprised" in the her appreciation for the amount of volunteer group of people who work on the trail. School Board discusses JROTC program possibilities in schools



During the monthly Botetourt County School Board meeting last Thursday, Superintendent Dr. Jonathan Russ discussed division leaders and high school principals recently observing two local JROTC programs on January 23. The site visits provided an opportunity to learn about the structure and requirements for establishing a JROTC program in Russ's monthly report.

Buchanan District representative Jenny Wilson then asked Russ about where BCPS is in terms of having a JROTC in Botetourt schools moving forward.

Russ explained that one of the focus points of the Strategic Direction Survey last year was to get students ready for work, school,


or military following graduation. BCPS is "in the very early stages of observing and getting to see how these programs operate

the instructors of the observed programs were willing to answer any questions BCPS may have about a JROTC program.

Russ recommended to have a JROTC program through the Botetourt Technical Education Center (BTEC). He thinks it is more "advantageous" for the division to bring students to a central location as opposed to the expense of having JROTC programs at Lord Botetourt and James River High Schools. Russ said those decisions would be made "down the road" and that further discussions amongst the School Board about bringing a JROTC program to Botetourt will be planned for the future.


Ingram has written over 2,600 articles for magazines and other publications. He also is the author of books




"The Murder of Fincastle's Daniel Pegee, Antebellum Free Black Entrepreneur, Preacher" is a booklet that is for sale in the Botetourt Museum of History and Culture. It was written by David W. C. Bearr and published by Historic Fincastle, Inc. The cover was designed by Phyllis Austin Burch. It tells the history and importance of free blacks in Botetourt during the 1800s. Many family names and ages are given from the 1850 census. The fight and murder

took place in Fincastle over an order of oysters. The true story was well researched and is a fascinating collection of dates and laws. It tells how life was before the Civil War and about the courthouse trial for the murderer.

Mountain Castles SWCD holds winter awards banquet

Mountain Castles Soil & Water Conservation District recognized four local farms with Clean Water Farm Awards at the winter awards banquet in Fincastle. Ginny and Will Barkett and Greg and Barbara Teets were the Botetourt County award winners. Jeannette Kremer and Graylen Alley were the Craig County winners. "Due to several factors, we weren't

able to recognize the 2022 Clean Water Farm Award winners last year, so it was great to recognize four very deserving farms on the same night," said Dan Naff of Mountain Castles SWCD. Each year, the conservation district recognizes farmers who have demonstrated a commitment to conservation through Best Management practices such as livestock stream exclusion, rotational grazing, and planting cover crops. Mountain Castles also recognized

Beth Wiegandt of Camp Bethel's Your Outdoor Classroom as the district's Educator of the Year. "Beth has been an instrumental part of our outdoor program over the years, particularly our seventh grade canoeing program," said Tim Miller, district coordinator. "We knew from the beginning that if we wanted to provide an experience on the James River for every Botetourt County student, then Beth was the person to do that safely and with passion."

The district also premiered a new video highlighting local farmers. The video was directed by Jess Wiegandt, a graduate of Lord Botetourt High School. "We need to do a better job of storytelling instead of just bombarding people with facts," said Miller. "We're thrilled with the way it turned out."

Thomas Maxwell is the

Patriot ancestor of member Dana Manos.

Thomas Maxwell was born September 8, 1742 in Middlesex County, Va. He was a Revolutionary War soldier in the Blankenbaker, Culpeper militia class. Before and during the war, he preached the Baptist faith and was arrested many times during the reign

of religious persecution. Many were arrested during that time if they did not follow the beliefs of the Church of England.

According to tradition, Thomas rubbed away part of his prominent nose by preaching through the bars of the jail and was once able to convert the jailer and his family. When he was arrested in Culpeper County, Va., he was defended by none other than Patrick Henry. After the war, he

moved his family to Elbert County, Ga., where he founded the Falling Creek Baptist Church. The Rev. Thomas Maxwell died in 1837 at the age of 95.

During its 2020 Session, the Virginia General Assembly enacted Chapters 1193 (HB 1526) and 1194 (SB 851) of the 2020 Virginia Acts of Assembly. These duplicate Acts of Assembly, known as the Virginia Clean Economy Act ("VCEA"), became effective on July 1, 2020. The VCEA, *inter alia*, established a mandatory renewable energy portfolio standard ("RPS") program ("RPS Program") in § 56-585.5 of the Code of Virginia ("Code"), which requires Virginia Electric and Power Company ("Dominion") and Appalachian Power Company ("APCo") to procure and retire renewable energy certificates ("RECs") for an increasing percentage of the utility's total electric energy sold in the previous calendar year. The VCEA directed that all costs related to compliance with the mandatory RPS Program, including costs related to the retirement of RECs, shall be recovered from all retail customers as a non-bypassable charge, regardless of generation supplier, with certain limited

Additionally, Code § 56-585.5 D requires Dominion and APCo to submit annually to the State Corporation Commission ("Commission") plans and petitions for approval of new solar and onshore wind generation capacity ("RPS Filing"). In APCo's 2023 RPS Filing, two proposals were presented relating to the proper calculation of total electric energy for the prior compliance year. The first proposal was to count the RECs from Rider WWS and Rider REC towards APCo's RPS Program compliance, and the second proposal was to remove the 100 percent renewable customers' load from the calculation of "total electric energy," thereby reducing the number of RECs required for RPS compliance. In its Final Order in that proceeding, the Commission found that the issue warranted additional consideration and directed APCo and Dominion to make a filing addressing these issues and presenting specific proposals for approval, including any proposed mechanism for netting the benefits of such RECs. Specifically, the Commission determined:

On or before January 16, 2024, APCo and Dominion shall make a filing, either jointly or separately, containing the proposed treatment of RECs associated with (i) customers taking service under each [utility's] voluntary renewable tariffs [("Renewable Utility Customers")] and (ii) shopping customers purchasing 100 percent renewable energy, for purposes of RPS Program compliance [("Renewable Shopping Customers")]. Such filing shall include any associated proposal for netting the benefits of such RECs, including applicable tariff language

On January 16, 2024, in Case No. PUR-2024-00009, APCo submitted its petition ("APCo Petition"), which stated that the Commission should exclude the load associated with the Renewable Utility Customers and Renewable Shopping Customers from the calculation of APCo's annual RPS requirement, thereby allowing them to bypass VCEA compliance costs, if the Commission finds that approach to be permissible under current law. APCo asserts that using RECs to meet the utility's RPS requirement that have either been dedicated to one of its voluntary renewable energy riders or have been purchased by Renewable Shopping Customers is an impermissible double-counting of the RECs. Further, APCo claims that participants in voluntary renewable energy programs would effectively subsidize non-participants to meet the utility's RPS compliance requirement. compliance requirement.

Also on January 16, 2024, in Case No. PUR-2024-00010, Dominion submitted its petition ("Dominion Petition") (collectively with the APCo Petition, "Petitions") requesting that the Commission reconsider its decision in Case No. PUR-2020-00164, in which the Commission held that RPS Program compliance requires recognition of RPS eligible renewable sales from competitive service providers ("CSPs"). Dominion requests that the Commission instead find that the RECs of Renewable Shopping Customers cannot be used by the utility for its RPS Program compliance. Dominion further asserts that, if the Commission determines that Renewable Shopping Customer RECs may be used for a utility's RPS Program compliance, their load should be deducted from the utility's calculation of "total electric energy" and they should be excluded from paying Rider RPS. Dominion further states that if the RECs of Renewable Shopping Customers can be used for compliance, the RECs of other similarly-situated customers, specifically Renewable Utility Customers, should also be used to reduce the utility's compliance obligations.

Interested persons are encouraged to review the Petitions and supporting documents in full for details about these and other proposals

The Commission entered an Order for Notice and Hearing in this proceeding that, among other things, consolidated the two Petitions into one case, Case No. PUR-2024-00010, and scheduled public hearings on the Petitions. A hearing for the receipt of testimony from public witnesses on the Petitions shall be convened telephonically at 10 a.m. on July 31, 2024. On or before July 24, 2024, any person desiring to offer testimony as a public witness shall provide to the Commission (a) your name, and (b) the telephone number that you wish the Commission to call during the hearing to receive your testimony. This information may be provided to the Commission in three ways: (i) by filling out a form on the Commission's website at scc.virginia.gov/pages/Webcasting; (ii) by completing and emailing the PDF version of this form to SCCInfo@scc.virginia.gov/pages/Webcasting. This public witness hearing will be webcast at scc.virginia.gov/pages/Webcasting.

Beginning at 10 a.m. on July 31, 2024, the Hearing Examiner will telephone sequentially each person who has signed up to testify as provided

On July 31, 2024, at 10 a.m., or at the conclusion of the public witness portion of the hearing, whichever is later, in the Commission's second floor courtroom located in the Tyler Building, 1300 East Main Street, Richmond, Virginia 23219, the Hearing Examiner will convene a hearing to receive testimony and evidence related to the Petitions from the Petitioners, any respondents, and the Commission Staff ("Staff").

To promote administrative efficiency and timely service of filings upon participants, the Commission has directed the electronic filing of testimony and pleadings, unless they contain confidential information, and required electronic service on parties to this proceeding

On or before July 24, 2024, any interested person may submit comments on the Petitions by following the instructions found on the Commission's website: scc.virginia.gov/casecomments/Submit-Public-Comments. Those unable, as a practical matter, to submit comments electronically may file such comments by U.S. mail to the Clerk of the State Corporation Commission, c/o Document Control Center, P.O. Box 2118, Richmond, Virginia 23218-2118. All such comments shall refer to Case No. PUR-2024-00010.

On or before March 28, 2024, any person or entity wishing to participate as a respondent in this proceeding may do so by filing a notice of participation at scc. virginia.gov/clk/efiling. Those unable, as a practical matter, to file a notice of participation electronically may file such notice by U.S. mail to the Clerk of the Commission at the address listed above. Such notice of participation shall include the email addresses of such parties or their counsel, if available. The respondent simultaneously shall serve a copy of the notice of participation on counsel to the Petitioners. Pursuant to 5 VAC 5-20-80 B, Participation as a respondent, of the Commission's Rules of Practice and Procedure ("Rules of

Practice"), any notice of participation shall set forth: (i) a precise statement of the interest of the respondent; (ii) a statement of the specific action sought to the extent then known; and (iii) the factual and legal basis for the action. Any organization, corporation, or government body participating as a respondent must be represented by counsel as required by 5 VAC 5-20-30, Counsel, of the Rules of Practice. All fillings shall refer to Case No. PUR-2024-00010.

On or before June 5, 2024, each respondent may file with the Clerk of the Commission, at scc.virginia.gov/clk/efiling, any testimony and exhibits by which the respondent expects to establish its case. Any respondent unable, as a practical matter, to file testimony and exhibits electronically may file such by U.S. mail to the Clerk of the Commission at the address listed above. Each witness's testimony shall include a summary not to exceed one page. All testimony and exhibits shall be served on the Staff, the Petitioners, and all other respondents simultaneous with its

filing. In all filings, respondents shall comply with the Rules of Practice, as modified herein, including, but not limited to: 5 VAC 5-20-140, Filing and service, and 5 VAC 5-20-240, Prepared testimony and exhibits. All filings shall refer to Case No. PUR-2024-00010.

Any documents filed in paper form with the Office of the Clerk of the Commission in this docket may use both sides of the paper. Reader questions conduct at recent public hearing

I saw the letter by Karen Clark that was published on January 31. If I were to copy the last two sentences of her first paragraph, word for word, I would be accurately stating why I am writing to you, although I would state it more firmly! It is what is stated thereafter which makes it sound as if I attended a totally different meeting and I might have, as I attended only the public hearing at 6 p.m. and not the afternoon session at 2 I attended the public

hearing on the request for two Special Exception Permits (SEPs) Daleville Town Center for a Wawa to be built there, my first attendance at such a meeting in quite some time. I left in disbelief! It was if I were attending a sporting event when Supervisor Michael (Karen Clark calls him "Walt Michael" – maybe a close friend?) was introduced - an outbreak of clapping, cheering, yelling, whistling as if their team had just scored the win. I found that strange as I would have thought that both new supervisors (Mr. Michael being the "newest," per Karen Clark) would have been introduced at the 2 p.m. meeting and that would have been the ceremonial occasion, but once that was over, I thought the meeting would proceed with orderly conduct of governmental business. I could not have been

more mistaken. During the public comment part of the public hearing which soon followed, the same type conduct occurred after each person spoke opposing the granting

of the SEPs, after any vote made by Supervisor Michael and after he muttered anything. If anyone were to speak in favor of the matter, they were rudely interrupted or personally attacked. It appeared as if they were Supervisor Michael's private cheerleading squad, and their conduct was quite disruptive and well out of place at such a meeting.

As the hearing went

on, it almost appeared as if the method of conduct by those in opposition were an effort to intimidate or bully the Board of Supervisors into making its decision their way. Before I spoke, someone commented that few, if any, were there who supported the matter being heard. No wonder! When I spoke in favor of it, one or two blurted out and interrupted my comments because I was actually presenting sound reasons for granting the SEPs, and they did not want my voice heard! Another unsuccessful attempt to bully and

intimidate. Board The Supervisors has "Procedures and Governing Rules for Public Hearings and Meetings," copies of which are posted and made available to all in attendance. Governing rule No. 8 reads "Recognized speakers and the audience should exercise courtesy at all times." Apparently, there were many there who either can't read, can't understand or think this rule does not apply to them. Truly shameful!

And now we get to what Karen Clark said about Supervisor White. After the public hearing was closed and supervisors were asked for comments, Supervisor Michael announced that he had done three surveys and that they were all overwhelmingly opposed to granting the SEPs. That announcement was the first I and many

others in attendance had ever heard about any such survey. Why did Supervisor Michael not make everyone aware of these surveys while the public had an opportunity to comment about them? Nevertheless, Supervisor White asked him a very relevant question about whether or not his surveys had been scientifically conducted. His response fell far short of answering that question just, as I suspect, his surveys fell far short of having been scientifically conducted.

Opinions can certainly differ about whether or not such a question is condescending and/or disrespectful. I thought it was quite pertinent. The question she should have asked is why he did not share the existence of same at some time during the public hearing. Frankly, she could have asked many more questions about the "surveys" he conducted on Facebook and on his personal website such as (1) How were the survey question(s) developed? What methods were used to ensure that whatever questions were asked were neutral, unbiased and clear? (3) What software/ collection platform was used to perform the survey(s)? and (4) How were survey respondents selected, and how were they determined to be representative of the overall population of Botetourt County? Answers to those questions should have been a part of Supervisor Michael's answer to Supervisor White's question, as they could have been the basis for determining whether or not the "surveys" were scientifically conducted. They were not a part of his response and probably for obvious

reasons. I hope they are forthcoming. I did not notice what Karen Clark says "was







Report from the House from Del. Terry Austin

To the Constituents of the 37th House District:

Week five of the 2024 General Assembly has concluded, and the House of Delegates is working through hundreds of bills as Session approaches Crossover – the point where the House and Senate complete work on their respective legislation, and successful bills "crossover" to the other chamber. This was a difficult week, and not just because of the grueling schedule. Legislation that would allow some of the worst criminals in Virginia to be released before serving their full sentences moved forward, while bills to extricate Virginia from California's unrealistic automobile standards failed to report out of committee.

Victims of violent crimes drove from all over Virginia to testify and ask House Democrats to withdraw HB834, which enables those convicted of the most serious offenses to have a "second look" at early release. Families pleaded for violent criminals to remain behind bars and prevent the need to repeatedly relive these traumatic experiences at "second look" hearings. Unfortunately, they were given a total of six minutes combined to tell the tragic stories of their loved ones. A mother whose son died in her arms sought just one minute to talk and was turned away. The bill continues to advance, and Republicans will continue to highlight the significant impact of everyone affected.

Legislation passed by the Democrat majority in 2021 linked Virginia to California's emission standards mandated that all new vehicles sold be electric by 2035. This aspirational piece of legislation has proven itself to be unrealistic and Republicans introduced two bills that would have eliminated, or at least delayed, its implementation. Unfortunately, they both died in committee.

Numerous examples of impracticality abound. Only 9 percent of new car sales in Virginia last year were EVs, and sales growth would need to increase at an exponential rate for Virginia to meet this target in 10 years. Consumers have made it clear that cost, limited driving range, and long charging times have not met expectations. Manufactures are adjusting to this reality. Ford recently announced major cuts in EV production, a pause in \$12 billion of EV investment, and a halving of its electric F-150 production targets. General Motors declared a delay in plans to expand EV production in Michigan and is discontinuing its best-selling EV in 2023. Half of all Buick dealers across the country recently took a buyout rather than invest in the brand's all electric plans.

Furthermore, Commonwealth's charging infrastructure is both inadequate for the EVs already on the road and biased toward higher income communities. Virginia has a little more than 1,400 charging stations, with the majority in Northern Virginia. Almost twothirds of these stations are in census tracts above the median household income. The paucity of these stations elsewhere in the Commonwealth make predictable timely

road travel impracticable. Aspirational legislation is not practical, and it has become increasingly apparent that electric vehicles are not realistic option for consumers, manufacturers, or the current state of our infrastructure.

As for my bills, I am pleased to report that HB191 and HB1425 passed out of the House unanimously, while HB843 passed out of the House 89-11. HB191 improves

predictability of the automobile dealer franchise sales establishing objective measures

for the process. HB843

supports equine industry by enabling the distribution of revenues generated by Historical Horse Racing machines. A portion of these revenues will be directed to support the Virginia Horse Center in Lexington and Virginia Tech's College of Veterinary Medicine.

HB1425 exempts the Virginia Passenger Rail Authority (VPRA) from the Statewide Uniform Building Code, and the Fire Prevention Code Act. These code standards are meant for occupied buildings, not bridges and tunnels, and VDOT has the same exemption for this reason. The purpose is to give VPRA the clarity it needs as it advances critical rail infrastructure projects, including extending rail west

4 P.M. Burning Law takes effect tomorrow

Virginia's 4 PM Burning Law is in effect from February 15 through April 30 each year. It is important to note that some localities may have even more restrictive regulations on outdoor burning than the state's 4 PM Burning Law. All burners are encouraged to check with their locality before starting any outdoor burning.

The 4 PM Burning Law bans open-air

burning prior to 4 p.m. if the fire is within 300 feet of the woods or dry grass which could carry fire to the woods. Burning is allowed between 4 p.m. and midnight as long as the burner takes proper precautions and attends the fire at all times.

It is critical that burners take precautions before using fire, as there may be legal and financial implications. Even if a person takes all proper precautions and obtains any locally required permits, whoever started the fire is responsible for suppressions costs should the fire escape. Violation of the 4 PM Burning Law is a Class 3 misdemeanor with a fine of not more than \$500. Debris burning is the number one cause

of wildfires, closely followed by intentionally set or "arson" fires. The 4 PM Burning Law was adopted during the 1940s to reduce the number of wildfires which occurred each spring, when Virginia has traditionally seen an increased number of fires.

Fires are more likely during late winter and early spring because winds are usually elevated, the relative humidity is lower,

PLACE OF REFUGE

Read Numbers 32:1 through 36:13

Select some towns to be your cities of refuge, to which a person who has killed someone accidentally may flee. They will be places of refuge from the avenger, so that a person accused of murder may not die before he stands trial before the assembly (Numbers 35:11,12).

God commanded that if anyone died because of violence, and murder was assumed, the murder suspect was not automatically to be considered guilty. Instead, he was allowed to flee to a city of refuge (one of six to be chosen in the Promised Land) that would assure the accused would be treated justly and justice would be done. In this way God provided justice in a culture where protecting the innocent was not a typical response.

When we hear accusations of guilt against others, our first response should be to provide them with a place of refuge in our hearts. That is, we should not rush to judgment, assume their guilt, and be careless in our speech about them. We should treat them fairly, as God intended.

Prayer for Today: Ask the Lord to make your heart and mouth a place of refuge rather than a fount of accusation for others.

After 4 p.m., winds usually calm down and the relative humidity levels rise, DOF with any concerns or both of which reduce the questions. potential for a debris fire or any outdoor open-air fire to

The 4 PM Burning Law applies to open-air burning, which means any outdoor fire that is not covered and/ or contained within nonflammable barriers and the smoke from the fire does not pass through a chimney. For example, a typical campfire is considered an open-air fire. material from around the However, an open-air fire MAY be acceptable if it meets is completely extinguished the following criteria: it is completely contained within a ring of rocks, cinderblocks, metal ring, or a similar device and is covered by a 1/4 inch or smaller metal screen.

the fire still must be attended at all times, and all flammable material should be cleared from a 20-foot area around the fire. Campers must also have ready access to water, a rake and shovel. Fires built in commercially-

available chimineas or fire pits, which are completely contained, with a 1/4-inch or smaller metal screen across the top of the fire box are

to prevent the spread of fire to surrounding areas. Check with local authorities and/or

This law does not apply to charcoal or gas-fired barbecue grills. However, open-air charcoal grills like those found in a park setting are considered open-air fires and must comply with the 4 PM Burning Law. Users are still encouraged to take proper care and precaution by clearing all flammable grill and stay with it until it

The Salem Civic Center will be the site of the "Big Dance" for Class 1, 2 and 3 state wrestling tournaments once again this weekend. Lord Botetourt will send six wrestlers to Salem for the Class 3 tournament, including a Region 3D champion, while James River will send four wrestlers to the Class 2, three of whom won Region 2C championships at James River High School last Saturday.

The three state tournaments begin in Salem at 10 a.m. Friday with first round bouts. At 1 p.m. Friday, Class 1-3 quarterfinals will be held along with first round consolation matches for Class 3. Consolation matches for all three classes

will be from 4:30 to 8 p.m. Friday night. Semifinals for all three classes will begin at 9:30 a.m. Saturday, followed by semi-final consolations at 11:30 a.m. and consolation finals at 1 p.m. to determine places third through sixth in all three classes. Championship finals are scheduled to begin at 4:30 p.m.

Xaiden Wynn, Brayden Forbes and Nate Stewart of James River will all be top seeds after winning Region 2C championships in Springwood last Saturday. The Knights finished fifth as a team out of 10 schools with Glenvar winning the Region 2C championship.

At 106, Wynn, a junior, earned his third Region 2C championship with a major decision over Jacob Flowers of Glenvar in the final. Wynn goes to Salem with a 27-2 record. Xaiden has racked

up over 20 pins this season and has not lost to a Class 2 opponent all season.

At 120, Forbes, also a junior, earned his second Region 2C championship with a win by major decision over Tanner Atkinson of Dan River High School, 13-2. Forbes enters the state tournament with an undefeated record of 30-0. Brayden is the only undefeated 120-pounder in the state tournament.

At 144, sophomore Nathan Stewart earned his second Region 2C championship with a win by pin over Martinsville's Jordan Draper early in the second period at two minutes and 18 seconds. Stewart's record improved to 25-3 after winning back-to-back region championships. Nathan's only losses this season came from close final championship losses in the best wrestling

tournaments in the valley. Freshman Caiden Martin qualified for the state with a third place finish at 113 and sophomore Jayden Alston will be an alternate at 175 after finishing fourth in the region. Also scoring for the Knights, but falling short of advancing, were sophomore CJ Mullins with a fifth at 215 and two freshman with sixth place finishes, Ryan Daniels at 132 and Efraim


