Town of The Buchanan recently published a newsletter for residents that provides updates regarding town positions, activities, business spotlights, and more.



## **Reader says** Patterson's letter was condescending, arrogant

This is in response to Bob Patterson's letter to the editor on March 20.

His comments were quite condescending, leading to the point of arrogance, and preposterously projecting himself as the authority in other people's affairs.

He started with his purported previous letter to the editor as "striking a nerve" (no sign of humility here) in the county and told people not to be "cherry-picking content," as if he were instructing students on what they should and should not do. I highly recommend he should cogitate on how badly and arrogantly his words and comments come across.

Further, he went on to comment that he reviewed "all of the transfer deeds recorded that day." It is apparent he really doesn't have much to do but scrutinizing others' deed transfers, etc. For what purpose, one must ask, other than for him to use in self-initiated unnecessary quarrels. Moreover, he also chided someone's previous letter that stated "a 93% increase in assessed value." It is not his place to dispute how the 93% increase was calculated or under what circumstances that transpired the figure.

Just a friendly reminder, "An idle mind is the devil's playground." He should spend his idle time in some self-reflection and correcting his inappropriate, disrespectful comments about others. Here's the appropriate paraphrase to help him remember: the free rein of one's loose tongue cuts (metaphorically) one's own throat. One thing for sure, Patterson absolutely deserves at least a ten-fold assessment on his real property, if he has one.

Likewise, he broke his own rules about "cherry-picking" when he remarked on the word "EMS" by comparing it with an insurance policy. Indeed, it is a social contract/insurance policy. What's troubling is he didn't mention anything else but that word, contradicting his own prohibition of "cherry-picking." What hypocrisy! Furthermore, the letter was clearly addressed to and

implored the county assessment official for re-assessment; it certainly was not addressed to Patterson for the purpose of eliciting his pontificating and unwarranted comments.

In addition, as it's like an insurance policy, Patterson is reminded that good drivers without DUI, speeding, and other vehicle violations receive a hefty discount on the insurance policy. Therefore, people who conscientiously take care of themselves to free up public service, i.e., EMS, etc., must be appreciated and praised, rather than "cherry-picked" and making it his self-aggrandizing opportunity for an unsolicited didactical session. What a pity.

Here are some recommendations for Patterson: 1) as an adult (I assumed) he should know that there's eloquence in silence - practice often; 2) if he must utter words or write, make sure his words are true, factual, positive, and/or affirming others; 3) rather than idly "policing" others' affairs and being a nosy, know-it-all, he should do some community volunteer work - like substitute teaching; and 4) he should apologize for the condescending comments he's made about others thus far with impunity, if he's a mature person.

Here's the perennial wisdom prescription for his ailment: "Know Thyself."




that year, but I couldn't get invested in the characters or story, so I didn't recommend the film.

hero Paul Atreides (Timothée Chalamet) living full-time, and stripped of his noble title, on the sand planet Arrakis, known for its valuable "spice." He joins up with the good-but-rebellious Fremen, led by Stilgar (Javier Bardem), in their war against evil spice-controllers House Harkonnen. Stilgar and other Fremen believe that Paul may be a messiah sent to win them the war, so much so that his mother Lady Jessica (Rebecca Ferguson) is immediately granted the high religious position of Reverend Mother and all the powers and responsibilities that come with it. Paul, his mother, his mentor Gurney (Josh Brolin), and his warrior girlfriend Chani (Zendaya) know he's no messiah, but he starts to give input that turns the tide of the war, so are the Fremen so wrong to believe in him? Could it even be that he really is the messiah and never known it?

Over on the bad guys' side, Baron Harkonnen (Stellan Skarsgård) has been weakened, but is still alive following the battle with Paul's father in the first movie. He has since put his nephew Glossu (Dave Bautista) in charge of his army, but Glossu is about as good at leading an army as Bautista was at being a lead babyface wrestler going into WWE WrestleMania 10 years ago, which is to say not good at all. In fact, that's probably why Paul is doing so well in battle he's up against a lousy opponent. The Baron is considering putting his younger, more sadistic nephew Feyd-Rautha (Austin Butler) in charge of the army instead. Also, everyone on Arrakis has to answer to Emperor Shaddam (Christopher Walken), who doesn't care about the war and just wants spice harvesting to go smoothly for economic reasons. His daughter

Irulan (Florence Pugh) is preparing to take over for him, she doesn't have much of a role here but she's sure to be given more development down the line.

And I'm looking forward to seeing what happens down the line. Not so much for the still-bland story and characters, but just to see what this series can do to top itself as a sheer spectacle. After the first "Dune," I didn't care if we ever got another movie. But after "Part Two," I care. Just my luck, I'm hearing that the next installment won't be ready for at least five more years, but this movie is doing so well at the box office that the studio may tell the production to step on the gas. This is the kind of ambitious epic that doesn't come along very often, so when it does, it makes for a special occasion, which is why I recommend springing for special large-scale theater experiences like IMAX or Dolby. This film is likely to fare even better than its predecessor at next year's Oscars, and is frankly the first "must-see" film that I've seen in a long time.

Grade: B-

"Dune: Part Two" is rated PG-13 for sequences of strong violence, some suggestive material and brief strong language. Its running time is 166 minutes. See the sci-fi epic at the Buchanan Theatre starting this Friday, March 29, at 7 p.m.





Neither of us spoke to an assessor and there was no paperwork left indicating a reassessment was done. Did all the other much nicer and larger homes surrounding us also see an increase of over 90% in their reassessment?

We have been told we can appeal the reassessment. The odds of getting our reassessment reduced are about the same as having a UFO land in our backyard.

eclipses. April 8's will be the 15th total solar eclipse this century.

Attendees will receive a free pair of solar eclipse glasses (while supplies last), and they'll be entered in a drawing for a special goodie bag. According to NASA, besides the brief total phase of a total solar eclipse, when the moon completely blocks the sun's bright face, it is not safe to look directly at the sun without specialized eye protection for solar viewing. Viewing any part of the bright sun through a camera lens, binoculars, or a telescope without a special-purpose solar filter secured over the front of the optics

will instantly cause severe eye injury.

There are four types of solar eclipses: total, partial, annular ("full"), and hybrid. The April 8 total solar eclipse is when the moon's umbral (total) shadow traverses Earth.

The last total solar eclipse occurred on December 4, 2021, but took place in the early morning hours. The next solar eclipse is scheduled to occur between 1:58 p.m. and 4:29 p.m., with its "peak" visibility occurring around 3:15 p.m. In the Botetourt region, onlookers will see approximately 88% of the sun obscured by the moon. This solar eclipse is the first of two scheduled eclipses in 2024. The next one is cycled for October 2. This century, 2024's solar eclipses are just two of 224 scheduled events, of which 77 will be partial, 72 will be annular, 68 will be total, and seven will be hybrids.



## Blue Ridge man arrested for murder

Zachary Alan Bishop, 33, of Blue Ridge, has been arrested and charged with murder in connection with the death of a 5-year-old boy. On August 2, 2023, at approximately 10:12 p.m., the Botetourt Emergency County Communications Center E-911 received a call about a 5-year-old male being unresponsive. Deputies and emergency medical personnel responded to the 2900 block of Blue Ridge Springs Road to find an unresponsive child. Botetourt County Department of Fire and EMS transported the child to Roanoke Memorial Hospital.

Detectives immediately began working to determine the events that led to the child's hospitalization. The child was pronounced dead at the hospital on August 4, 2023. The Office of the Chief Medical Examiner, Western District, performed an autopsy and ruled the manner of death as homicide.

On March 4, 2024, detectives with the Botetourt County Sheriff's Office presented case information to the grand jury. The grand jury returned true bills resulting in direct indictments of felony child endangerment and murder

for Bishop. Bishop is currently being held in the Botetourt-Craig Regional Jail without bond.

The information in the news release from the Sheriff's Office is based on a preliminary and ongoing investigation, which continues to evolve as investigators interview witnesses, review physical and electronic records, and analyze forensic evidence. The department's understanding of the facts and circumstances may change as additional evidence is collected and analyzed, the news release said.





The James River softball team has played just two games in the first two weeks of the spring sports season and will be off all this week for spring break. The good news is, River is 2-0.

The Knights were scheduled to host the "James River Bash" at the Botetourt Sports Complex last Saturday, which would have been two more games. run in Vinton last week.




McConnaughey pitched two and a third hitless innings of relief in picking up the win. He walked one and fanned a pair.



Nolan Medley is congratulated by Cavalier coach Todd Smith as he rounds the bases after a first inning home



with a rematch against the Blue Demons on Wednesday, April 3, only this one will be in Christiansburg.


