Local nonprofit organization Sirens & Salutes placed memorial stones at the graves of former Roanoke City police officers last Saturday morning in Buchanan and Daleville.

A memorial stone was set for late Roanoke City Police Patrolman David Rickman last Saturday morning by his son, Chad Rickman of Roanoke. David was killed in the line of duty on April 12, 1986 after responding to an early morning domestic disturbance call. He was a U.S. Army veteran of the 82nd Airborne and had only served on the RCPD for less than one year.

David Rickman was honored by members of his family that included his son, Chad, with his wife, Abby, and son, Levi; siblings Linda Kelly, her son, Wayne Spangler and his wife,

Hung Cao won last Tuesday's Republican Primary to run against incumbent Virginia Sen. Tim Kaine (D) in November's election for the U.S. Senate in Virginia. Cao took in 57% of the votes over Republican candidates Edward Garcia Jr., Jonathan Emord, C.L. Smith Jr., and Scott Thomas Parkinson.


Pickleball is back for the summer










Botetourt County History



Although this fancy teapot is missing its lid, spout and handle, it has significance. From the stains on the cream and gold artifact, it appears to have been discovered underground. Mrs. W.P. Morgan of Charlottesville said when she donated it to the Botetourt County Historical Society, Inc. that the teapot is from the Greenfield Plantation. The Greenfield Plantation had its beginnings in 1759 when Col. William Preston (1729-1783) purchased the tract from Stephen Renfro on Buffalo Creek in Amsterdam, Va. While serving in the Virginia House of Burgesses, Preston was able to purchase fine imported china from England for his home. Several archeological studies have been done at the Greenfield site, which is owned by Botetourt County today. The Historic Greenfield Advisory Council is working with Botetourt County and the Botetourt Museum of History and Culture to preserve a historic area at Greenfield to include the enslaveds' cabin, summer kitchen, farm manager's house and two cemeteries.

DAR learns about the Bedford Boys

County Chapter of the Daughters of the American Revolution met in the Family Life Center of Fincastle United Methodist Church for their annual June luncheon. Family members, prospective members and guests joined the DAR members for this meeting.

The guest speaker for the meeting was associate member Čindy Higgins who presented a program titled "Following in the Steps of the Bedford Boys." June 6 was the 80th anniversary of Operation Overlord, commonly known as "D-Day." The "Bedford Boys" were a group of 37 young men from Bedford County who were in the first wave of the attack. As a result, Bedford suffered the worst per capita loss of any community in the nation.

Higgins has visited Normandy several times with her mother and sisters who are all members of the Bedford International Alliance - a group dedicated to preserving the memory of the Bedford Boys through relationships with Bedfordshire and Ivybridge in England and the Omaha Beach area in Normandy, France. Her mother grew up in Bedford and knew several of the families whose sons were lost in that attack. It was inspiring to learn about the journey the Bedford Boys took - from their enlistment, through their training in England, to the morning in 1944 their landing crafts came ashore on Omaha Beach.

The Good Citizen winners for 2024 were recognized. Isabelle Sanchez of Lord Botetourt High School attended with her father, Rob Sanchez (below photo). She will be attending Virginia Tech this fall. The James River High School winner was Paul Theimer; his parents are Michael and Jennifer Theimer. He will also be attending Virginia Tech this fall. AARP Fraud Alert:

Lost Wallet? What's Next

We've all been there; debit cards, which are you reach for your wallet and find nothing in your pocket or purse. The panic we feel in that moment is real because our wallet can be a treasure trove for criminals, who can go on to perpetrate credit card fraud or identity theft. Most times that feeling is short lived but sometimes that wallet really is gone. Here's what to do if this happens to you. First, cancel all

debit or credit cards. By reporting them lost or stolen ASAP you may be able to avoid illegal charges. This is especially important for

gateways to your bank account. Next, file a fraud

alert. With your driver's license in hand, identity thieves can do a lot of damage. You can request that the credit bureaus – Experian, TransUnion and Equifax – place a fraud alert on your credit. (Contact one and the others will add the fraud alert, too.) A fraud alert notifies creditors, lenders or anyone viewing your credit report that someone may be trying to apply for credit in your name.

Lastly, if you think

your wallet has been stolen, call your local precinct to get a police report on record. Even though the police may not be able to recover your missing wallet, it's a crucial piece of documentation to have on hand.

Be a fraud fighter! If you can spot a scam, you can stop a scam.

peer support initiative.

Esther, and their son, Wyatt; Sandra Rickman, and Steve Rickman and his wife, Jennifer; along with Roanoke City Police officers Lt. Jennings Tardy and Cpt. Andy

Pulley, and Roanoke City Police Chaplain Darren Potter. Lt. Tardy spoke about the brief time he spent with Rickman as a police officer and made mention that Rickman's passing helped in bettering the department's

"At the time of David's death, none of us had ever heard of the term 'peer support,'" Tardy said. "We rallied around each other and supported ourselves as best we could, but we really didn't take time to process our loss. These days, our peer support team is robust and always there in the event of a tragedy. I'm confident that David would be proud that his department has the emotional support to deal with a loss like this. I am proud to stand here today to honor David, and even though 38 years have passed, I still have vivid memories of how I felt during those days."

Sirens & Salutes continues honoring veterans, police officers and emergency workers. David's son, Chad, recently talked about how he learned of the memorial service honoring his late father.

"I found out (about the service) around a month or so ago," Rickman explained. "Bill Price (co-founder of Sirens & Salutes) reached out to my aunt Linda after he found out that my dad was buried at Fairview and what his story was. My aunt is the one who manages and attends to the family plot at Fairview, so it makes sense that someone would have pointed him in her direction. I appreciate Bill and his organization for doing this and I believe their mission is a noble one. I honestly had no idea what to expect when I was told this was happening, but I think the ceremony was beautiful and dignified, and honored my dad's memory."

Cpt. Pulley spoke of Rickman's legacy with RCPD and how Rickman's story influenced RCPD's officer survival tactics training and the department's current

peer support management.

"Today, in a large part due to this tragic event, many of the officers that went through this at that time who didn't understand how to cope with and move through this tragic situation, did years of research... but they created the Roanoke Police Department Peer Support Team because of this tragic event," Pulley said.

Pulley mentioned that the team started by Rickman's fellow officers has helped other peer support teams at departments across the nation. "The legacy that David

leaves behind, please do not worry, he is not forgotten and his spirit continues to live on every day." David's legacy lives on through the department and

with Chad, who revealed that he never knew of his

father's legacy with the Roanoke Police's peer support program.
"I had no idea that my dad's situation directly led

to the creation of peer support programs to improve mental health support for officers in response to tragedies like this," Chad said. "This really means a lot to me. I also appreciate the Roanoke police and other law enforcement organizations for participating in this. They emphasized that the department has not forgotten Dad, but honestly, I already knew this... Over the years I have kept in touch with several officers who worked with Dad, some of whom I would consider lifelong

friends, almost family. I've always felt support and love from the Roanoke Police Department."

Later that day, Sirens & Salutes placed another memorial stone at the grave of Roanoke City Police Patrolman George Pettit Thomas at the Amsterdam Cemetery in Daleville. Thomas succumbed to gunshot wounds on November 20, 1930, over a week after encountering a man with a handgun in Roanoke.

The Roanoke City Police Department Honor Guard fired off a three-volley salute for both Rickman and Thomas during Saturday's proceedings

I'll tell you what I remember most. The Giants had runners on second and third and Mays was due up, but Phillies manager Gene Mauch ordered an intentional walk to load the bases, setting up a force at every bag. The move backfired when Orlando Cepeda drilled a grand slam home run off the auto dealer billboard atop the leftfield pavilion roof. If I close my eyes I can still see it now.

Mays was always my favorite "non-Phillie" player. In the intro to the Game of the Week they would show him making that catch in right center where he climbed the chain link fence at Candlestick Park and soared over Bobby Bonds to make the most incredible catch of a baseball I have ever seen.

I actually got to meet the man in 1985. That year the owners of our local Carolina League team, the Salem Redbirds, were two guys from New York who grew up idolizing Mays when he played for the New York Giants. They brought him to Salem for "Willie Mays Day" and had a Redbirds' jersey No. 24 to present him, which I'm certain he was thrilled to receive.

That afternoon, prior to the game, Willie toured the Veterans Hospital in Salem and visited with patients. The late Jon Kaufman, who was a good friend of mine and assistant GM for the Redbirds, was assigned to accompany Mays to the VA. It was funny to hear Jon tell the story about how Mays kept hurrying him along and ordering him what to do. Then, just as Jon was getting totally agitated with our famous guest, Willie took off his watch and gave it to one of the

That night Willie came early and signed autographs in front of the clubhouse at what is now Kiwanis Park in Salem, then home to the Redbirds. A long line of folks waited to meet the all-time great and he pleasantly chatted and signed until rain started to fall. Willie was to throw out the first ball but the game was rain-delayed and he started to get annoyed because he was supposed to catch a flight that evening. Finally the rain stopped, Willie threw out the ball and left the ballpark before the game even started.

And it was a probably a good thing he did. We were a Texas Rangers farm team at the time and one of their top pitching prospects, Mitch Williams, was Salem's starting pitcher. Williams, who had a good career in the big leagues, was known to be wild and he didn't get out of the first inning. I don't remember who the Redbirds were playing but he walked a few and hit a few more and Salem was down five or six runs before Willie even got to the airport. That season in Salem Williams pitched 99 innings and struck out 138 but walked 117.


It was sad to see Willie pass last week.

Although most of us aren't going to make it to 93, he was a player I admired in my youth and when you lose someone like that your own mortality really hits you. Losing Jerry West and Willie Mays in the same month! Where has the time gone?

And so, Thursday's game was not so much a celebration for Mays, but of Mays. You saw all the highlights over and over,

catching that ball over his head in the World Series against Indians, running the bases with his hat flying off, hitting tape measure home runs and strutting around the bases like the King of Baseball that he was.

Yeah, I may be getting older, but I saw the "Say Hey Kid" play live and in person and that's a memory I'll always cherish. He was,

Willie Mavs a favorite of mine

A celebration to honor Willie Mays turned into a wake last week when one of baseball's all-time greats died two days before the big event. Mays passed on Tuesday, June 18, with his Giants set to play the Cardinals at historic Rickwood Field in Birmingham, Ala. on Thursday. As most of you know by now, Mays grew

up near the ballpark built in 1910. It was home of the Negro League Birmingham Black Barons, a team Mays played for

before signing with the New York Giants. Last week's game between the Giants and Cardinals was set for a day after Juneteenth and, while all Negro League players were remembered for the occasion, this one was special for Willie Mays. He was one of my favorites. Willie was

still in his prime when I was a little kid developing a love for baseball. I was 7 years old when I started collecting baseball cards a friend of my dad who was visiting. He pulled out a couple cards to look at more closely and made sure I knew Willie Mays was the best player of the bunch. My dad wasn't a big baseball fan, but he

was a big church guy and every summer our church took a bus to see a Phillies game at old Connie Mack Stadium. My dad always made sure we had a seat on that bus and I was 10 years old when trip organizer

informed the congregation we'd be going to see the Phillies play the Giants this summer.

I was thrilled. I would get to see Willie Mays play in person. It's 61 years later but I still recall watching his every move in warmups, all in brilliant color. We didn't have high-def games on big TVs in 1963, everything was black and white but beautiful nonetheless to a 10-year-old fan.
