Fincastle Town Council unanimously approved the town's FY 2024-25 budget (\$545,000) at its monthly meeting at the Fincastle Volunteer Fire Department Training Room last Thursday night.

There were no questions or concerned expressed by citizens about the budget at the public hearing at the May meeting. At Thursday's meeting, no council members had any further questions.

Mayor Mary Bess Smith noted to council that one new line item that was included in the budget regarding the new contract between the town and the Western Virginia Water Authority (WVWA). Smith

BCPS School Board updated on ESSER III spending and finances

The Botetourt County Public Schools (BCPS) School Board received an update on the ESSER III spending plan from BCPS Finance Director Brandon Lee at its regular meeting held in Fincastle

last Thursday night. Every six months, the School Board is required to present the spending plan for public comment. The School Board did not receive any comments about the spending plan at the meeting. The funds have to be spent

by September 30, 2024. The ESSER III document remained unchanged since it was last presented at the December 2023 meeting. Lee added that more than 20% of the award was

spent toward learning loss. Lee explained that BCPS is still currently in the process of spending

the funds. Following the reimbursing ESSER spending from this fiscal year, and after the summer sessions (Summer Academy), BCPS will then know what it needs to spend and what it may need to reallocate, if

Supervisors hold public hearings regarding proposed budget

The Botetourt County Board of Supervisors held public hearings last Wednesday at the Lord Botetourt High School auditorium to hear from citizens about the proposed budget, tax rates, tax increase, and tax relief for the elderly and disabled.

The supervisors, who will vote on the proposed budget and their June 25 regular meeting, took no action.

According to a county official, there were 46 comments from roughly 30 speakers that were part of over 100 Botetourt residents in attendance who mostly spoke in opposition to the subjects related to the budget and



Botetourt County changes and related

budget woes

Botetourt County's population has grown only a little over 2 to 3 percent in the last decade and a half, but the county has been undergoing constant change. Overall student enrollment has steadily declined, even as some schools have become crowded; others barely have enough students to remain viable. State financial support for local schools is tied to enrollment, so state funding is declining on a relative basis. Yet the need for teachers and administrators in inefficiently sized schools and classrooms has not declined accordingly. Wage demands for scarce qualified teachers have continued to climb, and the numbers of required instructional assistants has also grown.

During that same decade and a half, the county's population has steadily aged and its average number of occupants per household has declined. Whether related to population aging or other cultural and economic changes, volunteerism has also steadily declined. The lower availability of volunteers, the increased number of emergency response calls with an aging population, and the need for more sophisticated medical emergency response capabilities have led to the need to more than double the number of professional paid fire and rescue personnel as well as a dramatic rise in the costs to provide emergency The need for law enforcement

personnel, including more deputies in schools for security and for patrolling, has also steadily increased, though not as dramatically as has been experienced with fire and medical emergency responders. All area localities are having similar experiences, so the competition for qualified personnel has driven up wages to attract qualified candidates to fill these needed positions. All of these budgetary pressures

were on full display Wednesday night, June 12, when the Board of Supervisors held its annual budget and tax rate public hearings. The process this year was complicated with additional public hearings related to the impact of a general reassessment on real estate property values used to assess property tax levies to pay for county expenditures related to schools, law enforcement, the jail, emergency response, courts, social services, solid waste disposal and other services. The big question before the Board of Supervisors was how much to lower real estate tax rates to offset the impact of significantly higher property values while still increasing the taxes collected

to a level which would pay for county services impacted by the changing realities noted above, plus higher interest rates and inflation.

The supervisors proposed lowering the real estate tax rate from 79 cents per \$100 of assessed real estate values to 73 cents per \$100. Most of the attendees at the public hearing held in the auditorium at Lord Botetourt High School favored 60 cents per \$100, stating that the 60 cents rate would result in a net zero increase in taxes from the impact of the reassessment of property value. The 13 cents tax rate difference would result in a budgeted revenue decline for the county of approximately \$7 million.

The position of the vast majority of the public speakers/protestors was that the supervisors should adopt a budget that did not increase revenue, while still providing for increased pay for teachers, law enforcement and emergency responders. None explained the drastic reality and measures it would take to actually reach the 60 cents per \$100 rate, such as consolidating/ closing schools, cutting the number of deputies on patrol, reducing the numbers of Fire and EMS staff, and increasing the response time for critical

In addition, many speakers declared the supervisors unqualified to develop a responsible and fiscally prudent budget - an interesting claim given that the members of the board include a retired engineer and engineering company CEO, a doctor, a college administrator, a former building official, farmer and businessman, and a retired railroad financial manager. In addition, the board collectively has well in excess of 20 years of county board experience.

emergencies.

The vitriol and disrespect shown to the elected members of the Board of Supervisors by the majority of speakers has gotten to be nearly commonplace in the new world of political activism empowered by social media and oneupmanship among the perpetually angered. Social commentators and some psychologists have for several years warned that such disrespectful and strident behavior by otherwise normally rational people could lead to endangering those in elected or appointed positions of authority.

It appears that just that outcome has now occurred in Botetourt County. The night immediately following the unruly public hearing, crude slurs against the board were painted on a well-traveled Botetourt County road. Most disturbing to those who saw "graffiti" before it was covered was the statement "[Expletive] 9 mil to murder all." A 9 mil, of course,

On June 3, 2024, Appalachian Power Company ("APCo" or "Company") filed an application ("Application") with the State Corporation Commission ("Commission") pursuant to § 56-585.1 A 4 of the Code of Virginia ("Code") for approval to implement factors to recover a decrease to its revenue requirement through its transmission rate adjustment clause ("T-RAC"). Pursuant to Code § 56-585.1 A 7, the Commission must issue a final order in this matter not more than three months after the date of filing. In its Application, APCo requests permission to recover a proposed total revenue requirement of \$380.1 million through the

T-RAC for the October 1, 2024 through September 30, 2025 rate year ("Rate Year"). The Company states that its proposed revenue requirement consists of the following: (1) a forecasted Virginia jurisdictional current-period formula rate (current) revenue requirement of \$369.8 million for the Rate Year, based on Federal Energy Regulatory Commission-approved PJM rates for transmission service that went into effect on January 1, 2024; (2) a cumulative Virginia jurisdictional actual under-recovery formula rate balance, through March 2024 (true-up) of \$7.1 million; (3) a forecasted Virginia jurisdictional under-recovery amount of \$0.6 million for the period April 2024 - September 2024 (update); and (4) a forecasted Virginia jurisdictional revenue requirement of \$2.6 million associated with the Business Park Program.

APCo states that its proposed revenue requirement is a decrease of approximately \$33.1 million from the annual T-RAC revenue requirement approved by the Commission in 2023. The Company indicates that its proposed T-RAC rates would decrease the monthly bill for a residential customer using 1,000 kilowatt hours per month by \$2.12. Interested persons are encouraged to review the Application and supporting documents for the details of these and other

that she considered between hiring a "town waste water treatment operator" or sticking with WVWA. Currently, it costs the

town \$10,108 to operate the waste water plant and another \$3,160 a month for the water that totals \$13,286, which is the new rate (10% increase), the mayor explained. The town was paying around \$12,000 every month. WVWA was previously charging the town \$1,200/mo. for billing, but will soon charge \$1,500/mo. "What I've done

pretty religiously since we contracted with (WVWA) was try to go through and do a little rationalization for myself of if it's still cheaper to have the Water Authority do this than for us to hire our own waste water treatment operator and do it ourselves." Smith explained to council.

The mayor asked council members to go into their meeting packet to see the analysis she came up with about a "hire vs. contract" between hiring a brandnew town staff member or renewing their contract with WVWA. In summary of council's discussion, Smith came up with the projected salary of around \$116,000 spent on staff, not including a truck and/or other needed equipment. Smith came to the total of around \$136,000 annually for someone to operate the plant and equipment. She also noted that total doesn't include finding someone who properly training and ensuring they stay up-todate with their training while operating the waste

water plant.

public utilities and perform the monthly billing and collection services, compared to the newly increased rates proposed by the Western Virginia Water Authority. isolate and capture all of the costs associated with operating the plant, along with funding a capital replacement fund for major repairs infrastructure improvements. Smith also reminded Council that the plan is almost 20 years old, and therefore, repairs may become more commonplace. Council member Bill

Gaul noted the benefit of WVWA's expertise (and the town agreeing to a new contract) outweighs potential issues in having to hire new town staff that could potentially not have the experience and/ or knowledge in dealing with the everyday issues WVWA sees in other localities.



Knights name Eggleston girls basketball coach

When incoming James River athletic director Ryan Firebaugh needed to replace himself as girls basketball coach, he didn't have to look far. The new Knights' head coach was sitting on the same bench for the past three seasons.

Donald Eggleston was named the new girls coach at James River last week, replacing Firebaugh who stepped down as coach when he was named AD. Ryan will officially take over the athletic department reins from Chase Davidson on July 1, and he feels the girls basketball program will remain in good hands.

"I think Donald will do a fantastic job with this program," said Firebaugh. "We thought alike on many occasions when we coached together. Certain scenarios would come about during the games and it was almost like we were thinking the same thing. For example, let's keep this possession before we have a tie up and the possession arrow was against us, let's get a quick time out to keep possession. I truly believe Coach E is the right man for this job."

Eggleston has paid his dues for this opportunity. A 1989 graduate of Cave Spring High School, Donald didn't play sports for those Knights. After graduation he attended Radford University and graduated in 1994 with a degree in Health and Physical Education. He earned his Master's at West Virginia University in Athletic Coaching in

While at Radford he met the late Brenda King, a legendary girls basketball coach who had stints at Pulaski County, Radford High and Hidden Valley before succumbing to cancer at the age of 46. Donald joined Brenda's staff at Radford in 1991 and coached there through the 1994 season.

"The basketball coach who has had the biggest impact on me was Brenda King when coaching at Radford High School," Eggleston said. "She was the person who inspired my love of coaching basketball."

In 1996 Eggleston took a position in Botetourt County coaching and teaching at Read Mountain Middle

School. He was a big part of the Stars' program, serving at head coach of the girls basketball team from 1996 to 2007, head coach of the boys team from '96 to '03 and also serving as boys soccer coach from '96 to '03.

In 2008 he moved up to the high school as head coach of the Cavalier boys jayvee team during the 2007-08 season. After one season he had the opportunity to coach on the varsity level when Craig County hired him as head varsity girls basketball coach. He held that position from 2009 to 2013, and during that time he coached Grace Faw, one of Craig's alltime best players and daughter of current Craig County High School Athletic Director Carrie Hutton.

"We just loved Donald," said Hutton. "We "Grace really enjoyed playing for him and we hated to see him leave. I know he'll do a great job at James River." Eggleston got back

into coaching in 2021 when Firebaugh took the girls head coaching job at James River. The team was coming off a winless season of seven games due to the Covid pandemic. The previous year they were 4-17, so there was nowhere to go

"I got to know Donald through my father and brother," said Firebaugh. "He referees football with their crew on Friday nights. When I first was hired, I was looking for assistants and I wanted to surround myself with people who knew the game as well as people who were great with kids. My father told me about Donald, that he was the head varsity girls coach basketball at Craig County and he also coached some at Read Mountain and at LB. We had a couple of phone calls and we interviewed him and I felt like he was the man to be my assistant."

With Eggleston assisting Firebaugh the team saw steady improvement. This season they were 14-11 playing in the tough Three Rivers District and River's season ended just one win away from making the state tournament.

"Being on Coach Firebaugh's staff for three years, knowing the players

and the teams we play, will be a big advantage coming into next season, Eggleston. learned a lot from Coach Firebaugh these last three years. The biggest thing Í took away from him was how to prepare for upcoming games; film study, preparing scouting reports on the opponents, communicating the goals for the game to the team. We have been called a young team the past two seasons. However, that can't be said for this upcoming year. The team is one with returning and talented juniors and seniors."

Eggleston doesn't plan

to change much now that he's in charge.

"For this season the style of basketball we are going to play is solid defense and continuing the motion offense Coach Firebaugh installed," he said. "We will continue to attack the basket while also getting shooters into position to shoot 3's."

Donald has a daughter, Abby, who is married to Cameron Collier. Both are 24 and excited to see Donald get the job.

"Abby and Cameron have said they are excited to watch the live-streamed games and support the James River girls," he





Aliveto is new boys basketball coach at Lord Botetourt

Josh Aliveto and JJ Redick have taken different paths since Aliveto guarded the Cave Spring freshman in 1999. Redick is waiting to see if the Lakers will hire him as their new coach, while Aliveto has a job in hand, and he didn't have to wait for Dan Hurley to make a decision before Botetourt County hired him.

Josh was officially named the coach of the Cavaliers last week, replacing Andrew Hart who stepped down to spend more time with his growing family. Aliveto is a person who needs no introduction to Botetourt sports fans, as he's been part of the Cavalier program for most of his life.

A 1999 graduate of LB, Josh played football, basketball and baseball for the Cavaliers and was a standout in all three. He was the Cavaliers' quarterback on the football team and went on to play at Concord University, graduating in 2004. However, he also had some highlights in basketball playing for Ed Purdy and Chuck Pound.

"We were around the top of the Blue Ridge District during my junior and senior years," said Aliveto. "The Blue Ridge was much different then. A lot of the River Ridge teams such as Salem were part of the district. I averaged around 10 points a game while typically guarding the opponent's best player. I guarded JJ Redick my senior year and his freshman year."

As most fans know, Redick survived

the matchup and went on to star at Duke, followed by a long career in the NBA. He's now the top analyst on NBA broadcasts and is waiting for the Lakers to decide if he's going to be their next coach.

Aliveto took a different route, and

Aliveto took a different route, and the folks in Botetourt County are glad he did. Over the past 19 years Josh has coached middle school and high school football and basketball, high school baseball, middle school track and field and, yes, even high school girls tennis in the county.

"Up to this point, I have coached 50 teams from a variety of levels such as rec, travel, middle school, junior varsity and varsity programs," he said.

Josh is also a teacher, so he's quite familiar with the boys on the basketball team. He sees a group who is excited to learn and win games.

"There are a bunch of kids who are passionate about getting better as a basketball team," he said. "I have either had most of these kids on the athletic field or court, and/or the classroom, and I believe they are a good representation of the Botetourt community. We have returning players who I believe will be strong leaders."

As a player, Josh was influenced by his coaches at LB. including Purdy, Pound, Tony Hart and Jim Phillips. He's also taken notes while watching the



"We're going to establish a style of basketball that is tough on defense with a team-oriented offense. I hope at the end of the day we will be viewed as a mentally and physically tough team, a team that takes pride in doing the grunt

work necessary to be successful."

Aliveto has a wife, Charlene, and two children, 11-year-old Michael and 7-year-old Eva. He's been coaching Michael's recreation football team, often getting up early for Saturday games after coaching on Jamie Harless' LB varsity staff Friday night. Josh said he still plans to help out with the Cavalier football team in the fall.
