County board approves new tax rate, operating budget

The Botetourt County Board of Supervisors approved reducing the county's real estate tax from 79 cents per \$100 to 70 cents per \$100 with a vote of 4-1 at its much-anticipated meeting last Tuesday in Daleville. Blue Ridge Supervisor Walter Michael was the only board member that voted no.

The county released a statement from the board regarding its decision last week. In the release, the county updated citizens on their recent decisions.

"The past few months have been very challenging for the Board of Supervisors," Botetourt County Board of Supervisors Chair Steve Clinton said in the release.

"We have been trying to make the best decisions for all of the residents, businesses, and employees of Botetourt County. The largest decision was how to develop a budget that would lower the real estate tax rate and still be able to provide the exemplary services that are expected by the citizens. Property values have continued to increase due to housing demands nationwide, and Botetourt County is no different."

During last Tuesday's meeting, the Board of Supervisors also voted on the

following budget-related issues:
• The Fiscal Year Operating Budget totaling \$90,422,886 was approved with a vote of 4-1 (Walter Michael voting no). This was an 8% increase from the previous year, mainly

due to increased funding for public safety/first responders and Botetourt County Public Schools. More than 64% of the county's general budget is dedicated to public safety/first responders and education. Botetourt County increased

aid for elderly and disabled persons relating to exemptions from real estate tax to become one of the most generous communities in our region. Vehicle personal property tax

remains the same at \$2.71 as in the

Business property tax will increase from \$2.71 per \$100 to \$2.94

Machine and Tools tax will increase to an effective rate of \$1 per

> Meals Tax rate will increase from 4% to 6% (The effective date of the proposed Prepared Food & Beverage tax rate adjustment is October 1, 2024)

The meeting brought a crowd for the citizen comment period, with many hoping for a greater reduction. Several citizens continued to share their opinions regarding the tax cut during the meeting's citizen comment period.

Board members shared their own thoughts at the meeting's conclusion. Board Co-Chair and Buchanan Supervisor Amy White felt that "there's no way we could make that kind of cut (net neutral) without impacting

One of Fincastle's Naysmith's 28th project. historic homes is getting a new look.

Caroline and Donald Naysmith, who have spent the last year restoring the town's "Old Jail," are now turning their attention to Aspen Hill, better known to local historians as The Peck-Figgatt House. While working on the improvements at the Old Jail, the Naysmiths heard about Aspen Hill and inquired about purchasing the home. Six months later, the historic home is getting a facelift.

A land clearing crew came out to the home last week and began clearing out a lot of the overgrown vegetation that surrounded the home, which was originally built around 1822. The home saw a bit of disrepair over the years, which is now being restored in the

The house is designed in an adaptation of the Italian Villa style, also referred to as the Tuscan style. A Virginia Department of Historic Resources survey record in 2006 noted the house as being in excellent condition. The survey described the house as follows: "The main

Suspect identified in Sports Complex vandalism

In a press release from the Botetourt County Sheriff's Office made available last Thursday, a suspect has been identified in the spraypainting vandalism that occurred at the Botetourt Sports Complex at some time between the evening of June 13 and early morning of June 14.

Last week, information obtained detectives identifying a suspect in these incidents. Preliminary investigation suggests the suspect had increasingly

vocal and more focused on carrying out acts violence, according to the release. The suspect has been taken into custody and the investigation is ongoing. Currently, the suspect is not being identified due to the ongoing investigation. There is no immediate threat to the public and more details will be released as the investigation allows, the release went on to say.

A previous incident occurred last April involving "threatening



Botetourt County History

The history of the Botetourt County Courthouse goes back to 1770 when a log frontier structure was built to serve the newly formed county. Stocks and a dunking stool were used as forms of punishment for those who violated the laws. This picture shows the third courthouse, which was built in 1847. The courtroom was located on the second floor and heated by a fireplace in the north end of the room. In 1970, this building burned due to a faulty heating system. In the Clerk's Office, the fireproof vault saved documents that refer directly to Lord Fauquier, Lord Botetourt, Lord Dunmore, George Washington, Thomas Jefferson, Patrick

Henry, Robert E. Lee, Col. William Clark and other prominent local citizens. This information was compiled by researcher and Botetourt County Historical Society board member Patricia A. Honts. The photograph, courthouse bell, a witness box and other artifacts can be seen in the Courthouse Display at the Botetourt Museum of History & Culture in Fincastle. The current Botetourt Courthouse is scheduled to be replaced by a larger building on the same






that you have to pay for in advance is likely no deal at all. Your best bet is to proactively seek out the services



Clarifications about the Unlicensed Farm Use Vehicle Program

New legislation clarifies and makes improvements to the unlicensed farm use vehicle program administered through the Department of Motor Vehicles (DMV). These changes work to clearly define the program, how the exemption can be used and limits the collection of personal information.

TO RECEIVE A FARM USE

- 1. Complete the application at https://tinyurl.com/
- 2. Present your application, vehicle title and \$15 payment at your local DMV or DMV Select.
- 3. Receive your placards which are valid for the life of the vehicle, but are not transferable.

Farm Use Placard Requirements

Enforcement of changes to the farm use vehicle program begin July 1, 2024.

Must be covered under liability insurance.

Must Be Titled. Continues the longstanding requirement for a title on any pickup truck, panel truck and SUV obtaining a farm use placard. However, if a title is needed, a separate \$15 titling fee will be imposed, but no sales and use tax would be imposed as long as the vehicle claims the exemption.

Placards are Nontransferable. Permanent farm use placards issued by DMV are not transferable between vehicles but are valid for the lifetime of the vehicle and must be displayed in front and rear of vehicle at all

Items Needed for Application:

- 1. \$15 application fee per vehicle
- 2. Vehicle title
- 3. Name of owner or lessee of the vehicle
- 4. Approximate farm location and acreage where the vehicle is used

block of this brick house is a side gable, two-story structure that holds a one story porch with turned posts, decorative brackets, sawn balustrade, and triglyphs in the frieze. Polygonal bay windows are found at the south and west sides."

they would rather come to Fincastle for the fireworks because it was always such a wonderful event," Ware said in a recent interview. "You wouldn't believe how many people from Roanoke come here (for the fireworks). I've had people come and say, Well, we were going to Roanoke, but we read that there were fireworks down here and we'll be back from now on.'

Ware took coordinating the fireworks for Jeff Bowles, who took over from Harold Robertson, who originally set off the pyrotechnics uptown. She has several memories of the fireworks shows of years past but one vear, in particular, Ware recalled a great fog that swept over the Fincastle area.

"One year, a fog rolled in," she recalled. "Willie Simmons and his crew used fire them off at the baseball diamond (at Breckinridge). Well, we couldn't see the fireworks at all due to the fog. Patty Ellis lived on the hill behind the Quickette and she could see it. They saw this beautiful fireworks (show across the road), but anyone that was over (at Breckinridge) couldn't see it because of the fog!"

She remembers how Willie Simmons would travel to Tennessee to purchase the fireworks every year and would bring back a display that would outshine the previous year's show. She recalled that one year Simmons met "the man in charge" who would donate additional pyrotechnics on top of the town's purchase for the Fincastle show. The crew would arrive a few hours prior to folks arriving to rig up the display. Now, the company who sets off the fireworks, Master Displays, Ltd. of Roanoke, arrives shortly before the

event ready to go. Ware feels that people enjoy the setting and that there is less "hustle and bustle" involved with parking and setting up to watch the spectacle. 





Firebaugh moves from coach to AD this week

Ryan Firebaugh moved from the James River basketball office to the athletic director's office on Monday as he officially takes over those chores. Firebaugh is replacing Chase Davidson, who has taken a job as assistant principal.

"I'm about done rearranging but I need to get the janitor down here to put some nails in the wall so I can hang up pictures," said Firebaugh on his first official day on the job. "I'm excited for this opportunity. I always thought this was something that would happen down the road, I just didn't think it would come this quickly."

Ryan knows his way around the building. He's a 2007 graduate of James River High School and he was a three-sport athlete for the Knights. He was a quarterback and defensive back on the football team under coach Philip King, a forward on the basketball team for Mike Goad and a third baseman for baseball coach Gehrig Ferguson. Sheila Proffit was the athletic director when Ryan was in school and he thought about her when he decided to leave teaching and coaching to

"I remember how she used to get out and just walk around and talk to kids," he said. "I think she missed the classroom. She was a really good athletic director."

Ryan leaves his positions teaching weight training, driver's education and ninth and 10th grade physical education. He expects to still be involved in the daily comings and goings of the River students in his new position.

"My wife and I have talked about it," he said. "I'm sure I'm going to miss coaching, but I can always go back to it." Firebaugh has been involved in sports

all his life. His family bleeds black and red and Ryan has had some kind of ball in his hands for as long as he can remember. His father, Nicky Firebaugh, has officiated basketball for 51 years and also does football. Older brother Chris also officiates basketball and football, and his sister, Julie Firebaugh Lacey played on championship softball teams at River and is now the volleyball coach at Bassett High School.

'It runs in the blood in our family," said Ryan, who also officiated high school basketball for two years and volleyball for

Firebaugh is a graduate of Ferrum College, where he played on the basketball team for four years. Ferrum legend Abe Naff was the athletic director at that time, although Ryan had little contact with the longtime Panther baseball coach.

"He seemed to be busy all the time," said Ryan. "I remember we won the USA South Conference basketball championship when I was a freshman. Before the game he came into the locker room with one of those things you use to size rings, and promised we'd get one if we won.'

Ryan is still the proud owner of that ring and he keeps up with Ferrum athletics. The Panthers recently announced they were moving to Division II, where they can give athletic scholarships.

"I think it's a good thing," he said. We have a lot of athletes around here who aren't Division I players, but they're still good college players and now they don't have to go all the way to Concord or somewhere to play Division II sports." Firebaugh spent a fifth year at Ferrum

as a student assistant, then worked for the recreation department, first under Jim Farmer and then Shelby Bryant. He was on the maintenance crew, but he kept his eyes open. "I saw what they did, setting up

schedules and stuff," he said. "It was a lot like what I'll be doing here." Firebaugh tried to get a job coaching

basketball in college but that wasn't working out when he got a call from former River football coach King. One of his assistants, Shahan Burrell, was taking a leave of absence and King asked him to help with the football team. That led to a stint coaching football at Central Academy, one year as assistant and four as head coach, and a couple years on the high school staff. On Friday nights he served as the "spotter" for the varsity Ryan coached on Goad's basketball

staff for a year before his good friend Chad Conner, the Lord Botetourt varsity boys coach, asked him to come to LB. He spent two years with the jayvees, then moved up to be varsity assistant for three years. Eventually he took the job as head girls coach at James River when E.D. Schechterly resigned. He took a team that was winless in seven games during the COVID season and in three years the girls improved to 14-11 playing in the tough Three Rivers District. This past season ended just one win away from making the state tournament.

The Knights hired assistant Don Eggleston to replace Ryan as head girls basketball coach, and Firebaugh will also be stepping down as softball assistant. He's been Steve Austin's assistant for 11 years and that was a tough position to

"Steve is great," said Firebaugh. "After the last game I was fighting back tears. We sat and talked for a long time."

Ryan decided to retain the Knights volleyball coach. His wife of three years, the former Linsey Bailey, coached the girls to a 14-10 record and made it to the Class 2 state quarterfinal in her first year leading the team. The Firebaughs have a 16-month-old son, Cooper, and he looks to be following the family tradition.

"He's already picking up balls and throwing them," said Ryan. "Any time he sees a ball he goes 'ball, ball."

Firebaugh expects a smooth transition as he takes the reins of the James River athletic department this week. He's been working with outgoing AD Davidson, who got rave reviews for his time on the job.

'Chase has been very helpful, he knows so much," said Firebaugh. "Most of the stuff is done. He's right up there with Sheila and Chuck (former LB athletic director Pound).'

back when!!

When you watch kids playing in high school, you have no idea what the future may hold. Certainly, you don't envision them striking out New York Yankees with the bases loaded or coaching the Los Angeles Lakers.

I consider myself very lucky to have seen two of the area's best compete in the high school ranks - Lord Botetourt graduate Zack Kelly and Cave Spring's JJ Redick. It's not like I saw this coming, but it's fun looking back.

Let's take Kelly, who played baseball for LB and is now coming out of the bullpen for the Boston Red Sox. I asked longtime Cavalier coach Todd Smith if he looked at Zack as a future major leaguer when he donned the red and gray of LB.

"Possibly as a hitter, maybe, but not a pitcher," said Smith. "He's worked really hard to get where he is today."

Kelly is one of Boston's most reliable relief pitchers. Through Monday he appeared in 21 games with 29 and a third innings pitched. He has a 2-1 record, four holds and an outstanding earned run average of 1.53. His WHIP, which is figured by combining walks and hits allowed and dividing by innings pitch, is just 0.92. Anything under 1.00 is considered exceptional, as Zack has allowed 14 hits and 13 walks over close to 30 innings.

Kelly has 32 strikeouts, an average of over one per inning, and opposing batters are hitting just .136 when he's on the mound. He hasn't given up an earned run since June 12, a span of nine and a third innings and seven games.

Perhaps his signature game of the year came on June 16 against the Yankees at Fenway Park. The Sox were up 4-2 in the top of the seventh but the Yanks had the bases loaded and no one out when manager Alex Cora signaled for Kelly. Zack struck out Gleyber Torres and Jose Trevino, both swinging, then got DJ LeMahieu to fly out to center to end the inning unscathed. The Sox scored three in the bottom of the inning and went on to win, 9-3, but Kelly's performance was the highlight of the game. Zack had some friends from the Roanoke Valley drive to Boston for the game and they enjoyed time on the field after the big win.

Kelly, who was inducted into the Lord Botetourt High School Hall of Fame in 2023, has worked hard to get to this point. He's battled several injuries and had pitched just 23 innings in the big leagues prior to this season. Last year he appeared in eight games with a 3.86 ERA and spent a weekend in Salem the first week of September rehabbing with the Salem Red Sox.

Now an established big leaguer, Zack recently got his own bobblehead. On June 22 the Salem Red Sox gave away Zack Kelly bobbles to fans while Zack's

mother, Tracy Kelly, threw out the first ball. Zack couldn't make it, as he was busy picking up the win in a 4-3 victory over the Reds in Cincinnati that evening. And then you have JJ Redick, who was recently named head coach of the

Los Angeles Lakers. While Kelly was somewhat of a surprise to make the big

show in baseball, Redick was destined for

big things at a young age. But head coach

of LeBron James and the LAKERS?!!! I've been around for a while, and I can

remember some hype about JJ prior to his freshman season at Cave Spring. I went to an early season Knights' game with the attitude, "Okay, big guy, let's see if you're as good as they say."

Well, he was. I left the gym thinking this was one of the best freshman basketball players I'd ever seen, at least live.

People ask me sometimes if so-and-so is a Division I player. I usually tell them, if you have to ask he's probably not. When you see a JJ, a George Lynch or a Richard Morgan, you don't have to ask that question. You just ask where, and you get Duke, UNC and

Area basketball fans know all about JJ; Coach K coming to the gym at Cave Spring, fighting off foot pain to lead his team to a state championship, signing to play for Duke. After a great run with the Blue Devils he goes to the NBA for a solid career with several teams, playing in 940 games over 15 seasons. I went to see him play for the Clippers in Charlotte, and I saw him play for the Sixers in Philly. There was no denying he could shoot it with the best

If that's not enough, he becomes the top analyst on the ESPN broadcast team for NBA games, a job not many would leave. Unless, of course, you're offered the head coaching job of one of the NBA's premier franchises. People wonder how he'll do. I have no reason to believe he won't be anything short of terrific.

Pretty cool, isn't it, to have two guys we saw grow up playing on the biggest stage of their sport? Makes you wonder who will be next.
