



This picture of Dr. Martin Luther (1483-1546) was brought to America from Germany by Henry Firebaugh. He registered in Philadelphia upon his arrival in 1744. His son, Adam, fought in the Revolutionary War. Adam's son, Philip, moved to Botetourt in 1818 and had two sons who served in the Civil War. This picture was kept in the family and donated to the Botetourt Museum of History and Culture by their descendants, Betty and Clara Firebaugh. Martin Luther is largely regarded as one

of the most influential figures of the 16th century Protestant Reformation. He was a German priest, theologian, hymn writer, author, professor and Augustinian friar. His clash with the Catholic Church was supported in Germany and published widely by the newly invented Gutenberg moveabletype printing press.

## 'Conversations with the Ghosts of Fincastle' Nov. 2





## Board approves purchase of new ambulances

During the September 24 meeting of the Botetourt County Board of Supervisors, Fire & EMS Chief Jason Ferguson came before the board seeking approval for the purchase of new ambulances. Two ambulances were previously

ordered at the October 25, 2022 board meeting and were already factored in for FY 26, according to Ferguson, who made the ask of a third truck to be produced at the same time, arriving in Fall of 2025. The board approved the future arrival

of a third ambulance in 2025 (FY 26) and three more to arrive in 2027 (FY During the October 2022 meeting of

the Board of Supervisors, the department asked for the purchase of two ambulances, two firetrucks, and a ladder truck. At the time, the department felt that two new ambulances were sufficient due to possibly getting a better lead time for the arrival those vehicles. "Unfortunately, that lead time has

not diminished at all," Ferguson said in

an interview last week. "From a timing perspective, September (2024) was the right time to take it before the board so that we could lock this in so we are obligating ourselves for FY 26. That's why we increased from two ambulances to a third.'

The department's new goal, as Ferguson shared with the board, is maintaining a fleet that renews at 150,000 miles over eight years. While the ambulances are diesel trucks, the longevity of engines and components with DEF systems and ever-changing technology do not last in a stable and safely operable state.

Ferguson made note of a recent grant request (Rescue Squad Assistance Grant) for 50% of the load systems and stretchers for the two trucks currently on order which would "stifle" about \$60,000 of the cost. While reviewing the fiscal impact of these purchases, Ferguson made an ask for three more ambulances in the future (making six total from FY 25-28) by late 2027. Essentially, from the initial ask in 2022, the department will have one new ambulance per year from 2025-2028 if the three vehicles on the way are accounted for years 2022-24.

## **Our Patriot Ancestors:**

## **Enduring Inspiration**

In recognition of the upcoming 250th celebration of the adoption of the Declaration of Independence, the DAR America 250! Committee of the Botetourt County Chapter of the Daughters of the American Revolution is placing a spotlight on members' Patriot ancestors who helped the country achieve American Independence. Major Francis M. McCorkle is the Patriot ancestor of associate member Laine Crosby. The Revolutionary War had

passed, and at just 30-years-old, Betsy remembered every detail. After all, she had helped her father, Richard Brandon, supply the Patriots. Then she married Major Francis McCorkle and settled on a farm in Catawba County, N.C. Betsy became the mother to six children from Francis's first marriage, and together they had 10 more. Early on May 30, 1791, Francis

had taken the older children into Salisbury to see George Washington on his Southern tour. Soon after, a man knocked, looking for a blacksmith and mentioning his entourage was hungry. While Betsy graciously obliged, she shared her disappointment to miss Washington. After breakfast, one of the men thanked her and added, "Well, young lady, you can tell your family that you served breakfast to George Washington," revealing that he was in fact, the president. Maternal lines reveal unique stories

and traditions, highlighting the vital role women played in shaping our heritage. Elizabeth (Betsy) Brandon McCorkle (1761-1821) is Laine's fourth great-grandmother, and her husband, Major Francis M. McCorkle (1741-1802), is Laine's Patriot ancestor. An unabridged account of this story was passed down from Betsy through her descendants to Laine's father, and that is how Betsy's generous and fearless nature inspired other generations. In 1774, Major McCorkle was

appointed to the Committee of Safety of Rowan County, N.C. When the war began, he fought in the key battles of Kings Mountain, Ramsours Mill, Torrence's Tavern, Cowan's

Ford, and Cowpens. He and Betsy rest in the McCorkle Cemetery in Catawba County, N.C. He was also a farmer, father of 16, and inspired by the burgeoning spirit of freedom that characterized the era. Together, Francis and Betsy passed down the values that inspired generations of their descendants to serve in the military, and honor the sacrifices and principles they fought for - freedom, justice, and the pursuit of happiness.

The Daughters of the American Revolution is a non-profit, non-political organization open to any woman who has lineage to a Patriot who contributed to the success of the American Revolution. Founded over 125 years ago, it is focused on service to the community and fosters Patriotism, Education and Historic Preservation.




## Schmittler, Fredrich Douglas Fredrich Douglas over a career spanning







The Knights had a chance to put the game away in the fourth quarter. They held a 25-19 lead and had the ball. However, an intentional grounding penalty was called on a fourth down sack, setting up the Cavaliers with good field position to tie the game. Jennings disputed the call to no avail, claiming that quarterback Kody Park's arm was hit as he threw. That would have negated both the sack and the penalty.

River was playing without tailback Gavin Binns, who missed the game with illness. Quarterback Pierce Woodyard left the game with an injury but the Knights were still in position to win.

"We had two or three guys out sick, it sort of reminded me of Covid," said Jennings. "But I thought we played well on both sides of the ball, especially in the first half. We had some success on offense and I felt like it was a huge step in the right direction."

Without Binns in the backfield, Brayden Forbes led the rushing with 46 yards on two jet sweeps. Woodyard was three for six passing for 76 yards and a TD pass to Josiah Merchant.

Park relieved behind center and completed five of 10 for 81 yards, including a touchdown pass to Ryder Ward. River had

157 total yards passing. On defense Jayden Älston had a 32-yard fumble recovery for a touchdown and he also had 11 tackles. Efraim Echavarria led the team with a dozen tackles.

With the loss the Knights dropped to 1-5 on the season. After Friday's game with Radford they're off the following week, returning with games against Glenvar and Alleghany, who are both undefeated to this point.


having a bye last week. The Cavaliers will return with their Blue Ridge District opener against Staunton River in Moneta.


that won't be an advantage to either team. "They have some tough kids and they play hard," said LB coach Jamie Harless.
