Fincastle Town Council approves new location for Heritage Market

Following a public hearing last Thursday night at October's meeting, Fincastle Town Council approved a rezoning application submitted by Heritage Market for property located on the west side of Roanoke Road (Rt. 220) on two lots located in front of the Santillane subdivision. Both lots were rezoned from A-1 Agriculture to B-1 Business for the purpose of building

prior to hearing from the residents in attendance. She included specifics about the entry/exit points of the property. McFadyen also made note of the need for this type of business ("local grocery") in the town's comprehensive plan and shared that this new location of the Heritage Market "meets community need for many years to come."

In the staff report provided at the meeting, the applicant (Heritage) and property owner (Santillane) have proffered conditions designed to minimize the anticipated impact of this commercial addition to the otherwise agricultural/residential area. Proffers state that the market "will close no later than 9:30 p.m. each night." Heritage Market co-owner Tim Weaver shared plans remain to close the store no later

than 5:30 p.m. during the week and will remain closed on Sundays. The total combined acreage of the new market's location will be 5.66 acres, featuring an entrance/exit off of Frontier Way, and parking located in the rear of the new

market.

Weaver stated the market is planned to be three times the size of the current market's square footage with the retail







Botetourt County History

The 1970 publication "Botetourt County History Before 1800" was published by the Botetourt County Bicentennial Commission and the Botetourt American Bicentennial Commission. It is available at the Botetourt Museum of History and Culture and contains a description of the October 10, 1774, Battle of Point Pleasant, or Dunmore's War. Gov. Dunmore ordered Col. Andrew Lewis to raise troops and march to the confluence of the Ohio and Kanawha Rivers to try to protect the frontier in what was then Botetourt County. The approximately 800 troops came from the Augusta Regiment, the Botetourt Regiment, the Fincastle Regiment, Bedford and Culpepper "Though both sides sustained heavy losses, the Indians, defeated, were driven across the Ohio River. The frontier



some three years, enabling Americans to concentrate against the British instead of the Indians." It is considered the first battle of the American Revolution. Six months and eight days was thereby stabilized for later, on April 19, 1775,

portion doubling in size, including the addition of a why the meeting Thursday was the first time he heard café area and a larger parking lot. He noted the need to solve the current issue of potential "dangerous traffic scenario" the market faces during its busy hours.

"The Town of Fincastle really welcomed us in about 12 years ago when we first started talking about this idea," Weaver explained. "They have supported us in a variety of ways. As we looked at expansion, it felt like (Fincastle) is home and we felt a sense of loyalty to the town. That's why we found a spot within the town to expand. We also would like to remain loyal to the neighborhood market model. This is an attempt to serve our customers more efficiently, make it a more comfortable shopping experience, and much safer ingress and egress that we have currently."

Weaver said that the current traffic scenario is worrisome and thought the parking design for the new market location is suitable to solve the current parking

Town Council also heard from Bobby Wampler of Engineering Concepts, Inc. Wampler noted that "this is just the first step" in the market's relocation and that there is still more design work ahead. He clarified that this project is not in violation of any of the town's current zoning ordinances.

A Santillane resident said that the traffic from the

market would intensify traffic, claiming it was in violation of the town's zoning ordinance. Another Santillane resident was "appalled" that he thought the project "isn't following the rules." He also stated

Rt. 220 was blocked by construction or an emergency. Bob Patterson, president of the Botetourt Education Foundation that owns property in Santillane, asked

anyone tell the Planning Commission or Town Council that they thought project "isn't following the rules." He mentioned hearing from residents who previously stated that they never would have brought a Santillane property if they knew the land neighboring the subdivision would be commercially developed. Patterson asked those individuals, "What in the world would you expect (of a) property off of a four-lane, divided highway that it wouldn't be a commercial property someday?

The property is planned to have two access points: a road off of Frontier Way and a right-in, right-out entrance/exit near the southeast corner of the lot onto

Ashley Mathena of the Virginia Department of Transportation (VDOT) shared that the project meets all of VDOT's requirements and said that she doesn't see "too many concerns with (potential) traffic." Mathena went over the spacing requirements and site distance requirements that would allow a right-in, right-out off of Rt. 220. She also shared that the current traffic does not necessitate a need for a crossover on Rt. 220 in front of Heritage's new location.

Council members shared their thoughts as well. Council member Pamela Binns stated, "I am very grateful for the people who have spoken. I think that the Heritage Market has been a valuable resource to this community and has been a good neighbor. Anyone can drive by its current location and see that it has clearly outgrown where it currently is.

"It is pretty dangerous to try to go down 220 and turn in or, if not turning, waiting to have to turn into a parking space. I think the impact that the Heritage Market has on Fincastle and the surrounding communities is one that is very commendable. If there is a way for us to keep the Heritage Market in Fincastle then we need to move on that opportunity.'

Councilman Jim Reynolds, a Santillane resident, expressed concern about semi-truck traffic coming in and out of the new market's location. Weaver shared that he expects about a half dozen trucks weekly. While Reynolds admitted that he was once

"skeptical" about the project and the "valid traffic concerns" from residents, Reynolds said he is satisfied with the planning behind the project. He stated that "this project is good for the whole community." Reynolds added that he feels there needs to be a proposed 45-mph zone extended out to Brughs Mill Road as the project moves forward, which has been something council has discussed prior to the approval of Heritage's new Fincastle location.

Mayor Mary Bess Smith doesn't see the concern about traffic coming to and from Santillane. She said that there would be traffic at the foot of Frontier Way but doesn't see a lot of traffic beyond that point heading into the Santillane subdivision. Smith reiterated the community's need for the market, not just in Fincastle, but northern Botetourt as a whole explaining that "something was going there eventually" and feels like Heritage is the "best fit" for that open space.

The Heritage Market is currently located at 36 Botetourt Road in Fincastle, open Monday through Saturday from 9 a.m. until 5:30 p.m.

NOTICE TO THE PUBLIC OF A PETITION OF APPALACHIAN POWER COMPANY FOR APPROVAL TO REVISE ITS NET METERING PROGRAM **PURSUANT TO § 56-594 OF THE CODE OF VIRGINIA** CASE NO. PUR-2024-00161

On August 30, 2024, Appalachian Power Company ("APCo" or "Company") filed with the State Corporation Commission ("Commission") a petition ("Petition"), pursuant to § 56-594 E of the Code of Virginia ("Code") and the Commission's order in Case No. PUR-2024-00047 ("Net Metering Order"), for approval of proposed revisions to its net energy metering ("net metering") program. The Net Metering Order required APCo's Petition to address, analyze, and provide prefiled testimony and data to support certain items identified therein as they relate to net metering, consistent with the requirements of Code § 56-594 E. This included in part, a proposed rate structure related to net metering, consistent with the requirements of Code § 56-594 E. This included, in part, a proposed rate structure related to net metering to govern compensation related to all eligible customergenerators, eligible agricultural customer-generators, and small agricultural generators, except low-income utility customers, that interconnect after the effective date established in the Commission's final order in the net metering proceeding. The Company asserts that its Petition and supporting direct testimony address each of the required net metering considerations laid out in the statute and in the Commission's Net Metering Order. Pursuant to Code § 56-594 E, the Commission must issue a final order regarding the Petition no later than 12 months after this proceeding commences.

In its Petition, APCo proposes to close its current Rider Net Metering Service ("Rider N.M.S.") to all new customer-generators as of the rate effective date set in this case and introduce a new net metering credit compensation structure, designated Rider N.M.S. II. Under proposed Rider N.M.S. II, APCo proposes to charge customer-generators for all metered energy the Company provides during each monthly billing period at standard tariff rates and to credit customer-generators for all the metered energy the Company receives at an avoided cost approved by the Commission. The Company represents that only customer-generators whose electric generating facility receives a Certificate of Completion after Rider N.M.S. II would become effective will be subject a Certificate of Completion before Rider N.M.S. customer-generators and those who submit applications and receive a Certificate of Completion before Rider N.M.S. II takes effect will be grandfathered under the current Rider N.M.S. for up to 25 years. APCo states that under the proposed Rider N.M.S. II, all metered energy delivered to the Company's distribution system via the meter installed at a customer-generator's premise will be credited to the customer-generator's monthly bill at the Company's avoided cost rate, summarized in the table below

The Company represents that the changes proposed in Rider N.M.S. II will appropriately credit net metering customergenerators for the energy they deliver to the grid at the avoided cost to non-participating customers, while ensuring they are paying for the distribution, transmission, and capacity facilities and other services that they rely on when they are not self-generating in full or using the Company's infrastructure to export excess energy

The Company states that using its economic modeling and analytics software, it has concluded that the economic impacts of net metering within APCo's service territory vary. The Company represents that the current net metering rate structure, in place under Rider N.M.S., credits customer-generators with "full retail rate" netting, which compensates customer-generators for energy delivered to the grid at a rate that exceeds the value provided to the grid by their renewable energy systems. APCo states that it is proposing a cost-based compensation structure which the Company asserts would render the need for a net metering cap unnecessary. The Company states that if the full retail rate compensation is maintained as it currently is, there will be inequitable cross-subsidization. APCo asserts that if the full retail rate compensation is maintained, then the Commission should consider reducing the current six percent cap on net metering.

The Company requests that the Commission approve its proposed revisions to its net metering program and Rider N.M.S. and the Company's proposed Rider N.M.S. II.

TAKE NOTICE that the Commission may design rates in a manner differing from that shown in the Petition and supporting documents, and thus may adopt rates that differ from those appearing in the Company's Petition and supporting documents.

The Commission entered an Order for Notice and Hearing that, among other things, scheduled a public hearing on APCo's Petition. On May 20, 2025, at 10 a.m., the Commission will hold the telephonic portion of the hearing for the purpose of receiving the testimony of public witnesses. On or before May 13, 2025, any person desiring to offer testimony as a public witness shall provide to the Commission (a) your name, and (b) the telephone number that you wish the Commission to call during the hearing to receive your testimony. On May 20, 2025, at 10 a.m. or at the conclusion of the public witness portion of the hearing, whichever is later, in the Commission's second floor courtroom located in the Tyler Building, 1300 East Main Street, Richmond, Virginia 23219, the Commission will convene a hearing to receive testimony and evidence related to the Petition from the Company, any respondents, and the Commission's Staff

Virginia Western offers Community College Access Program

Community College Program Access (CCAP) is a public/ private partnership that pays the cost of tuition for two years at Virginia Western Community College if a qualified student does not have sufficient financial aid to pay tuition costs. CCAP supports as many qualified students possible based on student need and funds available for each locality.

As of fall 2024, the scholarship **CCAP** covers the cost of Virginia tuition Western for up to two years, including summer between first and second years, while the CCAP student earns either an associate degree, a maximum of two certificates or two job-ready credentials. At the end of the twoyear period, CCAP eligibility ends.

CCAP does not pay for textbooks or specific course fees. Students are encouraged to apply for the Educational Foundation's general scholarships for additional support. For application details



and deadlines, visit www. virginiawestern.edu/ scholarships/.

CCAP is a "last-in" scholarship, meaning it covers the gap in funding between any federal/state financial aid a student is awarded and their overall cost of tuition. If a CCAP student is awarded a general Educational

Foundation scholarship those funds are applied first and CCAP pays for the balance remaining on the student's tuition bill.

"Byrd still has a lot of pieces left," said Harless.


"They're well-coached and they're a very good football team."
