Fincastle Town Council prepares for the holidays

Fincastle Town Council met last Thursday night giving updates on various items including the Christmas upcoming festivities, a records management policy, and the budget spending at Big Spring Park.

Town management met on Saturday to prepare the Christmas lights prior to the upcoming parade and the First Bank Tinsel Trail which kicks off Dec. 6. Mayor Mary Bess Smith commended Fincastle resident Henry Booze at the meeting Thursday for his apple butter sales helping the town purchase and repair lights. This year, Henry and his wife, Debbie, raised over \$2,000. The lights will be put up throughout town on Wednesday, Nov. 20.

The mayor added, "It's things like that which really make a difference

because there's one thing to be able to physically go out and do all the work, screw in the bulbs, and put the things up. It really takes money to keep it going. Thank you for

doing that."
Smith also updated the upcoming parade activity. Last week, the town learned that County Fire & EMS will be training at the courthouse on the Saturday of the Christmas parade (Dec. 7). The mayor wanted residents to know that there will be a "kick up" of water usage during the crew's training exercises, but "(the water) shouldn't be out where the general public will be gathering for the parade."

Town Clerk Pam Brooks recently went through old records that "the town was hesitant to

Town of Buchanan approves agreement with Comcast

Buchanan residents will soon have the opportunity to experience Comcast's television and Internet services.

At Buchanan Town Council's November 12 meeting, a standard, non-exclusive agreement was unanimously approved with Comcast in order to install cable in town. An advertised public hearing was held prior to approval allowing a Comcast representative to hear any questions and/or concerns from residents. After no residents commented during the hearing, the town and Comcast agreed to the following terms included in the

meeting's agenda packet: Comcast has requested a franchise agreement in order to install cable in the town.

The Botetourt County School Board met last Thursday in Fincastle for its November meeting. The board was happy to present a group of recognitions for Botetourt County Public Schools (BCPS) staff achievements.

Eagle Rock Elementary School was recently announced as a recipient of the Virginia Department of Education's (VDOE) Highest Achievement Exemplar

Performance Award for the 2023-24 schoolyear. For this particular award year, 92 schools met the criteria for the Highest Achievement Award.

Recognition is this program is one of the highest achievements a school can receive in the Commonwealth," BCPS Superintendent Dr. Jonathan Russ shared during Eagle Rock Elementary's recognition. "This recognition is a testament to the hard work and tireless efforts the educators, staff, students, and families make every single day."


Eagle Rock Elementary was recently announced as a recipient of VDOE's Highest Achievement Exemplar Performance Award for the 2024-25 school year.

According to the Virginia Department of Education, Eagle Rock met state benchmarks in reading, math and science based on the current year pass rate on state assessments (not including growth or English Learner progress). Additionally, the

school demonstrates a current year chronic absenteeism rate of 15 percent or lower.

Virginia schools are identified for exemplar performance under the VDOE's



School Board hears first reading of new cell phone policy

The Botetourt County School Board went over the first reading of a new cell phone policy in Botetourt County schools at last week's meeting. Governor Glenn Youngkin authorized "Executive Order 33" earlier this year to establish "cell phone-free education to promote the health and safety of Virginia's K-12 students."

The draft, which is included in the November meeting's agenda packet (go.boarddocs.com/vsba/bcps/Board.nsf/ Public), explains the Botetourt County Public Schools (BCPS) policy in detail. According to the draft, the policy sets guidelines for managing personal devices to prevent distractions during instructional hours. It promotes focused, respectful, and safe learning environments across all Botetourt County schools. The policy governs the use of cell phones, smart devices, and any other personal electronic devices and provides clear expectations for the storage, use, and management of cell phones and similar devices within school settings.

The policy goes on to say that student use of personal devices include will be limited to non-instructional times before the start of school and after dismissal. Devices may also be used during lunch and recess periods in designated areas determined by school administration. Phone use will be prohibited during standardized testing periods and other assessments in accordance with the state's testing security requirements.

School Superintendent Dr. Jonathan Russ added that

over the next month, if no changes are made, the board will vote on the policy next month. An agreed-on policy must be implemented in BCPS by January 2025. Valley District representative Tim Davidick explained

that the policy was developed following the department seeking input from a committee of "parents from across the state." Russ added Virginia Department of Education

(VDOE) provided "listening tours" and received thousands of comments that were in favor of enforcing a "bell-to-bell" no-cell phone policy but wasn't sure of the percentage who responded in favor and those who were not.

Davidick asked about why BCPS's proposed policy would allow times for students to use their phones at specific times when other divisions have implemented more strict policies during the school day, noting that some BCPS parents he's spoke with are for this new cell phone policy to go bell-to-bell, with no exceptions.

Notably, this cell phone policy is one that could go ignored by the school system as pointed out by Davidick, who would later say, "This is a local policy... We could ignore this altogether. There's no funding attached to it. So, really, what we're doing is making a decision on (BCPS's) policy. (VDOE) has given us some bright lines. I think we should adhere to those bright lines.'


School Board Chair Anna Weddle added that she's

heard a positive, "overwhelming response" about the proposed policy's "flexibility to have (access to phone use at) lunch and in hallways." Fincastle School Board representative Dana McCaleb

shared concerns about the policy's flexibility and wanting a revision to the current proposed policy about cell phone usage during those non-instructional times. "I'm against that non-instructional time being allowed," McCaleb said. "I agree with the bell-to-bell policy. I think (cell phones) are an addiction for our students." McCaleb explained that the proposed policy could be

harder to enforce if students are allowed to use phones during specific times as opposed to the phones being put away once the first bell rings to start the day until the final "I have some problems with how this policy is written

based on the final guidance from the VDOE," McCaleb continued. "The final guidance doesn't really match what our policy is stating.'



McCaleb suggested taking out the "non-instructional time" piece of the policy along with the piece in the draft where teachers would allow students to use their phones "for educational purposes."

Weddle gave an example to McCaleb of why "educational" exceptions could be made in the instance where a high school's creative writing class could use a camera on a cell phone to record a short film based on a script written in class. McCaleb understood that exception and still felt that changes in BCPS's policy could be re-written to better define "educational purposes" when students could use their phones in between that "bell-to-

Russ shared with the board that they'll continue to discuss the policy and bring it back as is, or amended, as an action item at the December 12 meeting.

Botetourt County History

November commemorated American Heritage Month. This oval framed collection of Botetourt arrowheads was donated in 1975 by Stuart Barnes Carter (1906-1983). On the back is written "For County Botetourt Museum in memory of Walter and Elbert Brooks." Both men were residents of Eagle Rock and died in 1971 and 1974.

Stuart and his wife, Mary Pechin Shelly Sheridan Carter (1901-1966), purchased their home, Greyledge, in Buchanan in 1954. He was a lawyer in Fincastle, a Delegate in the Virginia General Assembly and later a State Senator. He was actively involved in archeology.

These arrowheads are of various shapes, sizes and stones. They are probably from the Woodland Era (0-1700 A.D.), but could be



from the Archaic (500-5000 B.C.) or even the Paleo-Indian Era (6000-11,000+ B.C.). Indian artifacts are still being found in Botetourt.

DAR recognizes veterans at The Glebe

The Botetourt County Chapter of the Daughters of the American Revolution met on Saturday, November 9, at The Glebe. At the end of the meeting, Daughters gathered around and wrote thank you for your service cards for veterans. These cards were written anonymously to men and women who have served their country

On Monday, November 11, several members gathered at a table near the fireplace on the main floor of The Glebe. Here, they greeted residents who stopped by for a chat, to pick up a thank you card, a veteran's button, a patriotic candy, or to look through a stereopticon which held pictures of scenes from World War I. Veterans who stopped by shared stories from their time serving in the Pacific Theater during World War II through the war in Iraq; it was a delight to hear their stories. The Glebe had also set up tables for these veterans to display their mementoes from their time in the service. DAR members and chapters support the men and women who have served in the armed forces, both abroad and at home.

In November 1919, President Woodrow Wilson proclaimed November 11 as the first commemoration of

Armistice Day by declaring: "To us in America, the reflections of Armistice Day will be filled with solemn pride in the heroism of those who died in the country's service and with gratitude for the victory, both because of the thing from which it has freed us and because of the opportunity it has given America to show her sympathy with peace and justice in the councils of the nations...." In 1938, an act of Congress made the 11th of November a legal holiday – a day to be known thereafter as "Armistice Day." On June 1, 1954, legislation passed by the 83rd Congress declared November 11th become a day to honor American veterans of all wars.

The National Society Daughters of the American Revolution (DAR) is a women's service organization whose members can trace their lineage to an individual who contributed to securing American independence during the Revolutionary War. Today's DAR is dynamic and diverse, with over 185,000 members in 3,000 chapters in the United States and abroad. Over 1 million members have joined the organization since its founding in 1890.

The cable company is aware that the town needs to place Christmas decorations on the front of the poles. Comcast offered assurance to town management that its installation will not affect Christmas decorations. The Comcast construction team reviewed the locations and stated that the poles all overlash, so it will not impact the Christmas designs.

Following approval of a small omission from the agreement's item report, Comcast will finish up engineering, permitting, agreements with the owner of the poles, and easements they intend to use. The town presented an overlay of "phase one" of Comcast's service area for Buchanan.

The installation date is yet to be announced by the town. Shentel Telecommunications currently has a nonexclusive franchise agreement in the town. Comcast will compete as they are both non-exclusive agreements, according to a town official.

In other news from last week's meeting, the town extended the Real Estate and Personal Property Tax

payment deadlines from Dec. 5 to Dec. 30, 2024. According to the town, due to issues with tax conversion and use of the new software system (QuickBooks), the town didn't begin mailing out billing statements until last Wednesday, Nov. 13, which would not allow property owners a "reasonable and practical timetable" to make a payment without penalty before the original deadline. Town staff recommended that residents needed 30 days for taxes to be paid. Town Council unanimously approved a resolution read last Tuesday for the extension.

The town has found its new treasurer, Claudine Stump, who was commended for being "especially helpful working with (Town Manager Angela Lawrence) and (the town's) contractor regarding treasurer duties, conversion of taxes, and southern software transition." All financial accounting will completed in-house by January 2025 with the contractor completing tax paperwork, the town noted. Stump will retain the Clerk of Council duties but all other clerk duties, including front desk duties, bill payment processing, deposits, and others will transfer to a newly appointed clerk. Stump has worked for the town for since March 2021. She has held the position of Town Clerk while handling many of the treasurer duties during interim periods when the town has been without one.

Grant work continues as well in Buchanan. The state recently approved a Lead Pipe Project agreement and will soon send the \$250,000 payment. The project continues and property owners are encouraged to continue sending in inventory information. Property owners for which lead pipes were determined or properties where no determination could be made will receive a mailer. Grants were also submitted for the Park Enhancement Project and Cultural Events/Music Festival Series.

Council approved the 2025 meeting dates on the second Monday of each month as follows: January 13, February 10, March 10, April 14, May 12, June 9, July 14, August 11, September 8, October 14 (Tuesday), November 10, and December 8. Town Council meetings take place at 7 p.m. at Buchanan Town Hall.



get rid of," according to Smith. She mentioned the Library of Virginia adopting a records management policy. In the policy, the library explains that public records be "destroyed or discarded in a timely manner" - if the records are over three years old, they can be disposed of. Instead of destroying the records, the town is boxing them up and moving the old records to another building. "Even though we've got a policy, we want to keep

them as long as we need to," Smith explained. "I talked about maybe needing to adopt a (town) records management plan. There's already one in place for localities, so I wanted to let everybody know that we are following along with that prescribed guidance for how long we keep documents. Some documents related to zoning and matters like that we keep forever. Some of these documents around accounts payable we're going to take out of the office itself and move over into the building." Last month, Town Council member Bill Gaul

provided a proposal for the town budget related to the pond at Big Spring Park. Smith shared that she set aside approximately \$4,000 for pond improvements. The mayor spoke with a local expert and decided to purchase a chemical management system, a dredging operation to install an Agri Drain drainage system, and adding carp in the pond. These items are expected to total around \$3,500. Once installed the town will see how effective they are helping clean up the pond before considering "some of the more costly options." Town Council unanimously approved the purchase, 5-0. (Councilmen John Thomas and Jim Reynolds were absent from the November meeting.) Smith mentioned the repair of a small wall on Jake

Cress's property along Griffith Alley that Cress hired someone to repair. Smith suggested reimbursing Cress for repairs to the wall using some of the town's sidewalk repair money in the budget, which falls within in guidelines of the town's purchasing policy. The town currently has \$14,000 for sidewalk repairs set aside.



Christmas lights return to Fincastle this week. Council agreed to reimburse Cress for the wall repairs.

"Jake has done so much for the town," Councilman Bill Gaul added. "I think it's a small way to repay him (for all he has done)."

Town Manager Melanie McFadyen updated council on the town's CDBG planning grant reimbursements for town expenses. The planning grant is scheduled to end at the end of December and the town expects to receive all reimbursements by then. Additionally, the town hopes to put in for a construction grant this spring, with help from the Roanoke Valley Regional Commission and Hill Studio. McFadyen added that the town would like to have David Hill from the studio come to a meeting to explain what the town plans to do with the construction grant.

The town is currently working on obligating all ARPA funds by the end of the year. McFadyen shared that the town "will have all of those funds obligated" and will produce a final report at the end of April 2025.

New council member training will soon be available this spring for the new members. McFadyen mentioned the town would be willing to offer the training to other surrounding localities for any new council or planning commission members who would like to participate. Fincastle Town Council meets again on Dec. 9 at the

Cavaliers pull out overtime win over Northside, advance to Region football semifinal at Magna Vista

When Northside played Lord Botetourt in football on November 1, the Cavaliers were shut out for just the second time in the past 12 seasons. Last Friday, they met again in the first round of the Region 3D playoffs and the Cavaliers scored 43 points. And, they needed every one of them.

Lord Botetourt took a 43-41 overtime win in Daleville to open the Virginia High School League playoffs and advance to this Friday's region semifinal in Ridgeway. Botetourt's offense was hitting on all cylinders and the Cavaliers got a stop in overtime that sealed the

"We should have scored 42 the first time we played them," said LB coach Jamie Harless. "Like I said at the time, we were spinning our wheels in the mud in that game. I feel we definitely did a better job as coaches this time."

Northside was home for the first meeting but this time LB got to host as the third seed in the Region 3D tournament while the Vikings were sixth. The Cavaliers got on the board first when they surprised Northside with a 51-yard pass from their top runner, Tristan Overbay, who hit Cody McConnaughey for a 7-0 lead after the first quarter.

Overbay's three-yard run and Dean Webb's extra point kick put the Cavs up 14-0, but Northside answered with a 99-yard kickoff return by Mykell Harvey. The Vikings tied the game, 14-14, on a punt return, but Quinton Jones scored

before the half and LB led 20-14 at

The two teams traded third period scores. Overbay ran one in from 48 yards, then scored a two-point conversion for a 28-14 lead. Harvey scored again on a 14-yard run to make it 28-21 after three, then opened the fourth quarter with his third touchdown and it was all tied up at 28-28 for the stretch run.

Botetourt regained the lead on Overbay's third TD run, this one from one yard, but Harvey matched it with this fourth touchdown on a 35-yard gallop to make it 35-35, and that's how the score stood at the end of regulation.

Botetourt went first in the overtime and scored on a four-yard run by Jones, and he converted the two-point conversion for a 43-35 lead. It was unusual for a team to go for two at that point, but Harless was confident of the

"I didn't think they could stop him," he said. "He walked into the end zone."

Northside went next and Harvey scored for the fifth time. The Vikings were forced to go for two at this point but Jones broke up a pass to seal the game for the Cavaliers.

Botetourt finished with 364 yards rushing in the game. Overbay had 188 on 23 carries while Jones had 158 on attempts. That offset Harvey's big night, as the Northside back rushed for 207 yards and finished with over 300 allpurpose yards in the game.
