Auburn High senior wins Harry F. Byrd Leadership Award

Auburn High School senior Tanner Long has been presented with the Harry F. Byrd Leadership Award.


Tanner was one of only eleven high school students across the commonwealth to receive the award, which recognizes Virginia school students

who exhibit excellence of character, leadership, devotion to duty, and academic achievement.

Every year, one high school student from each of Virginia's eleven congressional districts is nominated by his or her principal for the award. The award's board then

conducts an interview process to select the award-winning student.

The board's mission is to recognize and nurture public service in pursuit of preservation of American democracy. The winning high school seniors each receive a \$20,000 cash

Veterinary college's spectrum of care improves 11-year-old Sophie's life after leg injury

When Sophie, the Newfoundland/golden retriever mix, suddenly could not stand on her hind leg, owner Angela McCoy Williams of Giles County sought emergency services at the Virginia-Maryland College of Veterinary Medicine's Teaching Veterinary Hospital. The veterinary staff found that Sophie tore her cranial cruciate ligament (CCL) in her rear right leg.

This was Sophie's second CCL tear. The CCL connects the bones in the knee joint and is similar to the anterior cruciate ligament (ACL) in humans. We typically

think of ACL tears as sports injuries, but dogs usually tear their CCL because of degeneration.

In 2019, Sophie tore her left CCL, and over time, her body built up enough scar tissue to compensate for the loss of stability. But when she tore the right CCL, the old injury meant that her left leg simply wasn't strong enough to hold her

Surgery, the typical treatment, was not going to work for Sophie. It would confinement as she recuperated, and crating simply was not an option. Besides, surgery would be extra stressful

given her advanced age and skin problems would increase her surgical and

anesthetic risks. "We talked to the owner about the spectrum of care we could offer Sophie. A CCL tear is not uncommon, but it can be a huge quality of life issue for older dogs, so it's nice to have different things we can offer, not just one type of pain medication," said Jenny Marin, clinical assistant professor of community practice at the teaching hospital.

Thanks to the teaching hospital's Rehabilitation Service, Sophie can recover

Fungi and zombies

Q: Can the fungus from 'The Last of Us' really create zombies?

No. "The cordyceps fungi are a group of fungi that target insects as their prey. They are classified in the genus Ophiocordyceps with about 140 different species worldwide. These fungi are horrifically fascinating to us because

they survive by invading the bodies of insects and can take control over the insect's behavior."

Q: How can this fungus control an insect? "If a spore from the

fungus lands on a caterpillar, it can begin grow thread-like mycelia that penetrate the caterpillar's body. The

zombie-like state when the fungus has grown all the way into the caterpillar's head. The cordyceps infection can then change the caterpillar's behavior and force the insect to find a high, open spot like a branch tip. The fungus

After realizing he had not checked in, his family activated a GPS locator on his vehicle and observed it to be traveling out of the



"I was so surprised and happy to get the socks and chocolate," she said. "Living here is perfect for me and is the best decision I've made," she said.



can then release spores from the caterpillar's dead body to find a new generation of victims.

Q: Are there any fungi that can be harmful to humans? "There are other fungal diseases that afflict

humans today. These range from mild ailments like athlete's foot to the potentially fatal drug-resistant yeast Candida auris.' Q: Are fungal diseases the only problem to worry

"Another danger posed by fungi is the misidentification of poisonous species. We have lots of great edible species like morels, chanterelles, chicken of the woods, and many others. But we also have some species that can be lethal! Amanita bisporigera is a species of destroying angel mushroom found in the region around Virginia Tech. As its name suggests, you don't want to mess with it! The destroying angel and some other native fungi can sicken or even kill people, so it is very important to be able to identify any wild

mushrooms correctly before eating them."

Q: This sounds like a lot to worry about. Are fungi really all that bad?

"Overall, fungi are a huge help to humanity. We eat morel mushrooms, we use fungal-produced medicines like penicillin, and we bake bread leavened by baker's yeast. Fungi in the environment also help nourish plants world-wide through underground connections and help break down dead organic matter and recycle

from her torn CCL without surgical intervention. 'Surgery is more expensive than rehab, and surgery doesn't mean it won't happen again. I would

rather build up her strength and her muscle and give her what time she has left to be comfortable," said Sophie comes to the Rehabilitation Service twice

a week for laser therapy and underwater treadmill sessions with certified canine rehabilitation practitioner Flori Bliss.

"We're taking the multimodal approach we typically take for rehab patients. Before her right leg injury, she wasn't on any kind of pain management, so that was the first thing to do. She's on joint supplements, anti-inflammatories, and now she's on a new diet. We're coming at it from a lot of different angles," said Bliss. Sophie loves water, so the underwater treadmill is

her favorite rehabilitation activity.

Sophie's story underscores the importance of

the spectrum of care, the concept that the "gold standard" doesn't suit every case. An animal and a client's circumstances may require creative problem solving. Veterinarians need flexibility to use a variety of options to make the best treatment for pets and their owners alike. For Sophie, the spectrum of care means she can

undergo rehabilitation instead of surgery.

"It's harder because she has had two tears, but I'm confident she will improve," said Marin.

etter to Editor: Return to Reason

"Beware lest anyone cheat you through philosophy and empty deceit, according to the tradition of men, according to the basic principles of the world, and not according to Christ." Colossians 2: 8

When I first read nurse John Phillips' letter to the editor on February 15, 2023, invoking God's "creation of gender diversity," it seemed so bizarre to me that I doubted if it should even be dignified with a response. But it is an example of an extremely confused perspective on the straightforward subject of gender, and is part of the problem today.

Thus, my response.

The genders of male and female have been easily

understood for millennia. Why the confusion now? It seems it is the ultimate form of rebellion to deny our gender. Phillips uses the rare mutation of hermaphroditism as a premise to make his case, which is using the exception to make the rule. When ever is disease or mutation promoted True hermaphroditism is one of the rarest causes of sexual

ambiguity and occurs when there is damage and loss of the long arm of the Y sex chromosome. The baby is born with male and female gonadal tissue, and generally raised as female. It is a disease; not a choice. Phillips invokes "God" repeatedly but not the God of the

Bible, who made us male and female (Gen.1:27). As pastor Kevin DeYoung has noted, "Far from being a mere cultural construct, God depicts the existence of a man and a woman as essential to His creational plan. The two are neither identical nor interchangeable.... The anomaly of intersex individuals does not undermine the creational design, but gives another example of creational "groaning" and the realities of a fallen world." The "God" that Phillips refers to is that of New Age

mysticism, betrayed by his reference to Barbara Heider-Rauter, a practitioner and purported expert in aura-soma, a form of divination, in the same category as tarot card The tactic of using the exception to make the rule is used

when moral law, originally designed for our flourishing and freedom, is recast as a means of our oppression. The irony is that if we were to follow Phillips's philosophy to its logical conclusion and are "liberated" by "gender diversity," then we would find that we actually transgress the law of God, in the name of "social justice, equity and equality." The hypocrisy should be clearly evident.

This response is submitted in the hope of warning away those who may be confused by the self-righteous tenor of Phillips's letter and his multiple references to "God" on gender diversity. It is important to understand that his chosen worldview prevents him from seeing otherwise, even if it means his disengaging from rational thought.



Virginia gas prices continue to fall

gasoline prices in Virginia fell 8.3 cents per gallon last week, averaging \$3.12 per gallon as of Monday, Feb. 27, according to GasBuddy's survey of 4,081 stations in Virginia.

Prices in Virginia are 29.8 cents per gallon lower than they were a month ago and 30.8 cents per gallon lower than they were a year

According GasBuddy price reports, the cheapest station in Virginia was priced at \$2.69 per gallon Monday while the most expensive gas price was \$3.99/g, a difference of \$1.30/g. The national average

price of gasoline fell 4.3 cents per gallon in the last week, averaging \$3.33 per gallon Monday. The national average is down 17.6 cents per gallon

26.3 cents per gallon lower than a year ago, according to GasBuddy data compiled from more than 11 million weekly price reports covering over 150,000 gas stations across the country. "The national average

has resumed its decline after a pause last week as oil and wholesale gasoline prices fell on worrisome inflation figures showing the Fed likely to ramp up rates to slow inflation," said Patrick De Haan, head of petroleum analysis at GasBuddy. "Some nine out of 10 states saw declines over the last week, so the drops are showing up for most across the country, with the exception of the West Coast as the transition to summer blends continues, and in the Great Lakes, where prices cycled last week

from a month ago and but have now resumed declining," according to De Haan. "For the weeks ahead, tradition tells us to expect prices to move up eventually, but that could at least be partially offset by inflationary data that continue to be hotter than expected, leading to anxiety that the Fed will boost interest rates and cooling the economy and oil demand considerably."



Frank Parker named to Southern States Wrestling's Hall of Fame

After a professional wrestling career that spanned 20 years, this past week, Christiansburg's Frank Parker was named to the Southern Wrestling Association's Hall of

Parker became a fan of professional wrestling growing up in Southwest Virginia. He watched it on television and attended several live events at the Roanoke Civic Center. Once he was at an event in Roanoke where his favorite wrestlers, the Road Warriors, were performing. Parker was only seven years old and had bought a color photo of Hawk, a member of the Road Warriors.

He was determined to gain his autograph and worked his way through the crowd. Most of the grownups ignored him as he moved closer and closer to his hero.

"All of sudden, I ran into a big solid black wall, stopping in my tracks. I fell to the ground and looked up to see Hawk asking me if I was okay," Parker said.

He had run head-on into the professional wrestler. He didn't gain Hawk's autograph, but he remembers the

Parker was a football player at Christiansburg High School until an injury knocked him off the rail of his

dream of playing college football. "I really wanted to play college football, but it didn't

work out," he said. Parker was working at a Christiansburg car wash

when professional wrestler Jimmy Valiant stopped by. The chance meeting was something that changed his life and

led him down the new path of professional wrestling. Valiant was another wrestler whom Parker had watched from afar and never thought he would meet.

Parker learned that Valiant, who had just retired from the Mid-Atlantic Wrestling, was looking for a home in the New River Valley to open a wrestling camp to train Parker would be Valiant's first student at that camp,

which is still located in Alleghany Springs, outside of "I was skeptical at the age of 22, but Jimmy (Valiant)

took me under his wing and taught me how to perform,"

The Christiansburg native became a sponge, absorbing as much knowledge as he could. From then on, Parker went on the road with Valiant and wrestled independent matches five to six times a week.

His first match was in Frankfort, Kentucky, in 1993. After five years, he broke away from Valiant to start his own independent travels.

"I was living the dream," he said. In 1997, Parker formed a tag team with Roger Anderson, who was also from Christiansburg. The two wrestled matches under masks and black outfits and were known as

"Death and Destruction."

They were wrestling on the west coast one day when they met World Wrestling Federation promoter Jim Cornette. Cornette learned the wrestlers were from the Roanoke area where WWF (now WWE) was starting to hold live events.

The promoter invited them to attend and wrestle as a tag team against unknown individuals. The night of the event Parker and Anderson still didn't know whom they would face until Cornette told them it would be the Road Warriors, which included Road Warrior Hawk, whom Parker had once idolized. Parker got in a punch to start the match, but then was

destroyed by the Road Warriors. Since then, he has wrestled full-time all over the country.

In 2020, at the age of 52, he stepped away from the

This past week, Parker was named to the Southern States Wrestling Hall of Fame, an organization that kept him busy traveling all over the United States.

During those 20-odd years, he suffered four concussions and had the tip of an ear torn off after a shot from a metal chair shot. Thirty stitches later and after having the ear reattached, he was back in the ring.

In addition, he has broken his wrist, his ankle, and some

fingers. He also tore his pectoral muscle, and now he can't turn his neck to the left because of those injuries. "It was tough professionally, and I loved doing it, a dream come true," he said during an interview this past

When asked if he will ever return to the ring in the near future, Parker said he would never say never. But for the

most part, he is satisfied with what he has been able to Still, he never did get Road Warrior's autograph. Maybe

the only regret he still has.

Tech wins third straight ACC indoor track and field championship



History has repeated itself as Virginia Tech's men have swept the ACC indoor track and field championships for the third straight time while the women claimed their second straight title

The Virginia Tech dynasty continues with the men's and women's teams winning both 2023 ACC Indoor Track and Field Championship titles. The men's team picked up their third-straight title with 110.5 points, and the women claimed their second-straight title with 93 points.

The wins at the indoor championships mark the program's 19th and 20th ACC track and field championship titles.

The men's team has won five of the last seven ACC Indoor Championships. The women's team has won three of the last four indoor conference

Day Three of the championships served up one of the most dramatic finishes in conference history as the Virginia Tech women waited for the results from the final heat of the 4x400m relay. Second-place Duke looked to run away with the crown as they led the race, but a last- minute drop of the baton let the Hokies claim victory

These victories also secured Tech two more points in the Smithfield Commonwealth Clash with UVA to tie it up 6-6, as Tech Athletics looks to defend that title once again this year.

Victoria Gorlova and Čierra Pyles started the day for the Hokie women by placing first and

second in the triple jump, providing 18 points for the team's score. In the women's shot put, freshman Katrin Brzyszkowska finished third with a mark of 16.19m. Essence Henderson finished fifth with a distance of 15.95m. On the track, Lindsey Butler and Hannah

Ballowe earned second-team All-ACC honors finishing fourth and sixth in the 800m. Butler crossed the finish line with a season-best time of 2:04.31, and Ballowe followed behind clocking in

Ava Hassebrock placed fourth in the mile with a time of 4:40.99. Layla Anderson placed fifth in the 60m hurdles with a time of $8.2\overline{7}$.

Conner McClure, Jacob Rice, Harrison Rice, Joey Badalamenti, and Jake Spotswood helped Hokies secure the victory for the men by placing five within the top eight in men's pole vault, adding 26.5 points to the team's score. McClure won the event by clearing an ACC season-best height of 17' 7.75" (5.38m). Jacob Rice placed second with a height of 17' 3.75" (5.28m), followed by Harrison Rice in third ((17' 0" (5.18m)), Badalamenti in seventh ((16' 8" (5.08m)), and Spotswood in eighth ((16' 8" (5.08m)).

Senior Chauncey Chambers jumped 51' 9.75"


(15.79m) on his first attempt of the day in the men's triple jump to finish fourth and earn second-team All-ACC honors. Sprinter Cole Beck earned two first-team All-

ACC honors by placing second in the 60m (6.60) and third in the 200m (20.62). Kennedy Harrison took bronze in the men's 400m, clocking a time of 46.48.

In the men's mile, Viktor Idhammar and Declan Rymer added four points to the men's score placing sixth and eighth, respectively. Idhammar crossed the finish line with a time of 4:01.95, Rymer followed close behind with a time of 4:02.58. Senior Antonio Lopez Segura ran a season-best time in the men's 3000m, finishing third at 7:51.52.

The top three finishers in each individual event at the championships earn first-team All-ACC honors while those placing fourth through sixth are second-team All-ACC. First-team All-ACC honors also go to each member of the winning relay teams with members of each second- and third-place team earning second-team recognition.

The 2023 NCAA Indoor Championships will be held at the Albuquerque Convention Center in Albuquerque, New Mexico March 10 and 11.
