Montgomery County Administrator Meadows announces retirement

Administrator Craig Meadows will be retiring on November 3, 2023, after serving in the role since 2009.

According to a statement by Montgomery County, the Board of Supervisors "will be discussing next steps for the County Administrator

"Craig is an absolute champion for Montgomery County," said Montgomery County Board of Supervisors Chair, Sherri Blevins. "His leadership has been and will continue to be valued by both the board and employees. Montgomery County has been extremely fortunate to have such an exemplary leader like Craig. We will all miss him greatly, but we wish him and his family all the very best in his retirement."

Meadows said he will continue to live in the community.

"I have enjoyed my time as County Administrator in Montgomery County," said Meadows. "Our community really is a special place,

with a rich history and a very exciting future. This is home for me and my wife, Rhonda. We will continue to be engaged in our community as we enjoy our retirement and our children and grandchildren."

As Montgomery County Administrator for the past 14 years, Meadows "has led Montgomery County through significant growth and even a few tragic events with grace and strength," reads a statement from the county.

"He has facilitated over 20 new construction and renovation projects in our community to address education, public safety, recreation and key infrastructure needs," the statement reads. "He also continues to focus on economic development and growing and expanding existing businesses in our community."

"I was on the Board of Supervisors when Craig was hired as the Administrator," said Montgomery County Board of Supervisors Vice Chair, Mary Biggs. "As soon as we

met Craig, we knew he was exactly what Montgomery County needed He has always been accessible and approachable. He is a wonderful collaborator with local, regional and even national partners and colleagues. His service and leadership in outside organizations has brought both recognition of and increased knowledge to Montgomery County."

Meadows involvement in regional organizations and initiatives over the years "have had a significant impact on [the] community," the county statement reads, including helping to establish the New River Valley Emergency Communications Regional Authority, includes the towns of Blacksburg and Christiansburg, Montgomery County, and Virginia Tech.

Meadows also organized a forum to discuss the planning and anticipated growth of Carilion Clinic and Virginia Tech and facilitated a

CHRISTIANSBURG The Montgomery County Board of Supervisors unanimously voted to dissolve the Shawsville Volunteer Rescue Squad at its Monday, May 8 meeting.

The area will now be served by Montgomery County EMS departments.

The Shawsville Volunteer Rescue Squad served eastern Montgomery County in support of providing emergency services to the area's citizens for decades. The

board expressed their gratitude for the volunteers' many years of service to their community.

"They have really provided great service to the citizens of eastern Montgomery, and we definitely want to recognize that," said Supervisor Fijalkowski. "Especially that any volunteers that wish to continue, they have that option to continue volunteering with the county EMS."

BLACKSBURG Behind home plate sits Virginia Techs biggest fan, cheering on the girls that are now more than just a softball team in his eyes.

Arthur Erwin has

become the heart and soul of the Virginia Tech softball team. He is six years old and battles cerebral palsy; however, that does not get in his way. The positivity, energy and enthusiasm that he embodies and brings to each game has quickly made

"Arthur is like the team's little brother, and he is our most loyal fan," said Emma Lemley, sophomore pitcher for the Virginia Tech softball team. "He's at every home game and most of our away

Christiansburg Town Council discusses real estate tax rate

CHRISTIANSBURG - A real estate tax increase of \$0.14 for the FY 2023-24 was discussed by Christiansburg Town Council in their regular meeting on May

9, 2023. "We're proposing the tax rate to be \$0.14; that's a decrease from the current \$0.16 tax rate, although because of the reassessment, it is an effective increase," said Christiansburg Town Manager Randy Wingfield, opening the discussion with the council during the public hearing portion of the agenda. "So, we do have to advertise it as such and that is the reason we've advertised it as a tax increase, although we are proposing to actual lower the rate by two cents.'

A water and sewer rate increase for FY 2023-24, of one dollar per thousand gallons, has been proposed. Out of town rates for water and sewer have also been proposed for an increase, with the first 0 to 1,000 gallons increasing from \$13.50

Also in public hearing, Jones Real Estate Investment and Recycling Company, Inc., requested to rezone a 1.1acre portion of a 2.002-acre parcel located between the south side of Scott Street, NE and the north side of Roanoke Street; and approximately 1.21 acres located at 1413 Scott St. NE, and approximately 0.26 acres located adjacent to the east side of 1413 Scott St. NE. The purpose of this rezoning is for a planned housing development of 47 townhomes.


Paul Henegar, Lumson Associates Civil Engineers of Roanoke, addressed the council on the proposed rezoning request. Henegar explained the property

is currently split-zoned, but the owner, lared Iones, wishes to have the property zoned R-3, multi-family residential, to accommodate the proposed plans for

"This property exists in a whole bunch of different parcels so, one of the things we would do if we get the approval today, would be at some point in time, we would vacate all those exterior, or interior lot lines to create one parcel of property" Henegar said.

Jones Company, Inc. also requested a conditional use permit for the same proposed housing development. Henegar spoke in response to some public concern and comments previously heard by the company during planning commission



games. Seeing him there makes me and my team so happy and lifts our spirits."

"Our philosophy is that there is nothing he can't do," said Abbey Rowe Erwin, Arthur's mother. "Sometimes you just have to make things happen, and it is really cool to see him embracing that too."

Their journey with the softball team came out of the blue.

"We went to an open football practice last March and it was a beautiful day, so when we saw that the softball team was also playing that day, we decided to go over and see if they had accessible seating, because you never know where they will be," Erwin said. "Turns out that those seats were right behind home

Little did the Erwin family know that when they made the impulsive decision to go to that softball game, their little boy would capture the hearts of the coaches, the team, the fans, and many others that he encounters.

"It was unexpected really. We were sitting there and before the game even started Coach Pete must have seen us from the dugout because he came up to us and got down next to Arthur to introduce himself, thank him for coming, and then he gave him a softball autographed by Keely Rochard," Erwin said. "Then it was kind of love at first sight, and we have been going ever since."

From that day on, Arthur can be found at each game, sitting in the best seats of the stadium and wearing a big smile. Throughout the game Arthur gets the fans excited and engaged by leading the crowd in the infamous cheer yelling, "Let's Go," followed by the rest of the crowd answering, "Hokies!"

meetings, particularly focusing on plans for setbacks, stormwater drainage, parking, and sidewalks

"We are meeting the front 30-foot setback

right here on the units on Scott Street," said Henegar. "We are actually keeping the 20-foot rear setback along Scott Street here and we're also honoring the by-right setback of 20-feet along this edge of the property line."

A total of 112 residential parking spaces will also be provided, along with a pedestrian and bike lane.

"The idea with the development is to create a courtyard-type of a development," he said.

The project proposes to create a diversion for stormwater runoff that will potentially benefit area residences.

Brian Bush, Christiansburg resident living

in the area and impacted by the proposed housing development said, "based on the exhibits I have presented in the past planning commission meetings, there's three or four townhouse units in the area; Cornerstone townhouses, White Oak townhouses, they all have varying degrees of acreage, but they all meet the 10 units per acre which I think is in

"I think this is overly dense for this area based on all three of those townhouse communities," he added.

We're going to remove 28 percent of the drainage area that's running through his property right now which is the extent of what we can do to help him with the drainage," Henegar responded to Bush.

In another point of discussion during the council's meeting, The Montgomery County Board of Supervisors has agreed to meet with the Christiansburg Town Council for the primary discussion of discussing the employment of School Resource Officers (SROs), via a letter from Craig Meadows, County Administrator. The board has included funding for three additional SROs and will deploy them in the elementary schools if the town agrees to provide SROs at the town's middle and high schools.

The Christiansburg Town Council has proposed a time of 6 p.m. for a May 15 meeting with the Board of Supervisors.



over 2.1 million dollars to the Montgomery County Schools Public unanimously approved by the board of supervisors during Monday night's meeting as well.

Annie Whittaker, Deputy Superintendent, requested the funds from the supervisors for CARES/ ESSER and insurance reimbursements to the school operating fund. According to the resolution presented at the board meeting, CARES/ESSER funds are to cover the FY 2022-23 retention bonus for non-SOQ (Standard of Quality) positions and ESSER position salaries and benefits. Specific information on reimbursement requests can be found on the county's meeting agenda at www.montva.com.

"There are different reimbursements," Whittaker explained to Blevins expressed. the board. "One is from insurance, as you know, we had some significant weather issues over the holiday at winter, so that is, we pay it out of our operating and they reimburse us. The other is ESSA reimbursements, again we pay it out of operating and they reimburse us the funds after we have spent them."

Sometimes it just gets confusing if you are

the spending money that is coming out of operating, but it was not actually designated for operating. You could be in a deficit if you already spent that money," Chair Sherri

Also on Monday, Brea Hopkins, Director of Planning and GIS Services, addressed the board to request a special use permit for a lighted park; Auburn Park located at 3595 Riner Rd. in Riner. "We do propose the

installation of lighting for the fields," said Hopkins. "It does consist of the following lights: 21 sixtyfoot poles, 1 seventy-foot, and eight 80-foot poles for a total of 144 downcast lighting fixtures. So, additional lighting does create a safer place for our kids to play. They will be LED lights, they will only be on during use . . . and shielded to only light the areas needed and prevent glare."

Additional information presented by Hopkins stated that the park and recreational department will regulate play hours and when lights will be on, but all games will end prior to 10 p.m.

Board members responded with a few questions for Hopkins, following her presentation. April DeMotts asked if the lights would be programmable from the government center office, similarly to a previous park in the area. Hopkins confirmed this would be

Supervisor Todd King asked about the size of the field in response to a previous citizen request. Hopkins explained they are looking at extending softball field two for the purpose of accommodating the 13-18 age group of

boys.
"We're looking changing one of the fields from a 225-foot fence down the line to a 300foot, 350-foot in the center with a 90-foot base pass, to accommodate traditional baseball sized field; 90-foot bases and 60-foot pitching mound" Bradley St. Clair, Assistant County Administrator added.

The BOS approved the special use permit for the installation of the park lights with unanimous approval from all seven board members present.

other In county business, David Clarke, Virginia Department of Transportation Residency Administrator, updated the board on road improvements and repairs. Citizens can expect to see piping replaced, tree cleanup, road patching, and ditching repairs in various locations of the county. High Top Road has been completed. Some of the other roads VDOT is currently working on are Huffville Road, with work expected to be completed on 615/Christiansburg

Pike Road as well. Clarke shared that Blacksburg's Glade Road, although expected to be done, will not be completed this year.

"The only six-year plan project that is going to occur this year is the bit of Craig Mountain Road that we have in between the end of pavement and where we did about a half-mile section a few years ago; we are going to connect that about one-third mile gap," Clarke said.

Additional areas on the schedule for VDOT work are Taylor Hollow off of Luster's Gate and the design of Poplar Hill.

Board members joined Clarke recently on a driving survey of the county's roads. Fijalkowski thanked Clarke for riding with the board members in surveying the county's roads. "When you hear about

a lot of these roads that aren't in our own districts, which we all know our districts fairly well, it really benefits us to get a good idea what's involved, and by having you there riding with us, you can really give us the realistic opinions that you've seen through your own experience" Fijalkowski said. Citizens spoke in

Gaines, Linda Lee Wilcher


Linda Lee Wilcher Gaines passed away the Episcopal Church of the Ascension. peacefully at home with her



The Motor Mile Speedway, located near Radford, is changing its name.

During a press conference on Wednesday, local officials gathered to hear the new name "The Pulaski County Motorsports Park."

The Rusty Wallace Racing Group took over the speedway three years ago. The track has been known over the years as the New River Valley Speedway and has changed its name four times since its opening over 20 years ago.

A five-year agreement was signed in 2020 by RWRG. The multi-year lease agreement allows the RWRE to take over venue operations, with the speedway becoming the home track for the RWRE and its companion

At the time, former NASCAR driver Rusty Wallace called Motor Mile Speedway and Dragway, one of the finest grassroots motorsports facilities in the nation.

"We're excited to confirm a full schedule of racing and could not have picked a better home track for The Rusty Wallace Racing Experience and Pure Speed Drag Racing Experience," said Rusty Wallace. "The opportunity to call this amazing short track home for our more advanced programs has us primed for 2021 today. I can't wait to get up there in the spring." Pulaski County leaders joined in this

The Radford University men's basketball program has been invited to participate in the Sun Chlorella presents World University Basketball Series 2023 (WUBS 2023), a champions league-style tournament for world-class university basketball teams.

The tournament will take place in Tokyo, Japan this

It is an honor to be invited to compete in the World University Basketball Series 2023," said Head Coach Darris Nichols. "This will be a tremendous opportunity for us to learn and grow both on and off of the court."

WUBS 2023 is hosted by the All Japan University Basketball Federation (JUBF) with operation support provided by Rakuten Sports, a Rakuten Group business focused on creating partnerships

with professional athletes and other sports services. Held again with presenting partner Sun Chlorella, this year's tournament marks the second in the series following last year's inaugural WUBS and will be held from August 10 to 13 at the Yoyogi National Stadium Second Gymnasium.

For 2023, an expanded roster of universities will compete, with a total of eight men's university basketball teams from seven countries and regions - Australia, Chinese Taipei, Indonesia, Japan, the Philippines, South Korea and the United States.

The teams will compete in a series of 12 knock-out tournament games over three days from August 11 to August 13 to determine the 2023 series champion. In addition, on August 10, an "Opening Night" exhibition game will be held between the U-22 Japan national basketball team (university students) and WUBS 2022 champions, Ateneo de Manila University.





James Johnson returns to the university after serving as the head coach of the men's basketball team from 2011-2014. Previously, he had served as an assistant for three years prior and compiled a 22-41 overall mark as the head man on the sidelines.

His new title will be director of high school relations.

Johnson had replaced his former boss, Seth Greenberg, at Virginia Tech but struggled in two seasons.

Johnson spent two seasons with Jim Larrañaga at George Mason. The Patriots advanced the 2006 NCAA Final Four before falling to eventual national champion Florida.

Johnson served as an assistant coach under Ed DeChellis at Penn State from 2003-2005. Johnson was also the recruiting coordinator for the Nittany Lions during his time in State College.

Blacksburg slips by Franklin County Young Hokies put nation on notice

When things get hard, that's when Jersey native wrapped a bow on his you have to be great.

It's the mentality that true freshman Caleb Henson has lived by his entire life — and it resonates through the entire Virginia Tech wrestling room.

Similar values and beliefs have helped foster and maintain a culture of relentlessness within the program from the top down. Despite each facing adversity at

different points in their respective tournament runs, Henson and fellow underclassman Eddie Ventresca battled their way to All-American status in their first NCAA tournament appearances. They were two of Tech's five All-Americans in Tulsa — the program's most since 2017. While Henson entered the 149-

pound bracket as the No. 4 four seed the highest seeding for a true freshman in program history — Ventresca was awarded only the No. 27 seed at 125

After his rocky start to the regular season, the low seed was warranted, but it didn't discourage the redshirt freshman. He viewed it as a chance to reveal how talented he truly is as a wrestler — and he delivered.

"I think that I proved myself [to be a force at 125]," Ventresca said. "Don't get me wrong, there was a lot of doubt, which I don't blame anybody. Me coming in as a No. 27 seed, not having a crazy strong season — people didn't really know what to expect. But also I just had that confidence because I know the work that I've put in and all the dedication I've put into this sport and I feel like other people don't see that. I give credit to my coaching staff because they were always making sure I was in a good mental standpoint [in the] second half of the season, making sure I was confident in myself, confident in my wrestling and I think it showed at the NCAA tournament."

The first domino to fall in Ventresca's underdog run was Northern Colorado's No. 6 Števo Poulin (4-2), who he edged out in overtime. Then he took down Minnesota's No. 11 Pat McKee (4-2) in the second round.

Ventresca's pair of upset victories were two that few saw coming, but he didn't shock himself at all.

'I feel like in the regular season, every match that I lost, I felt like I was one takedown away," Ventresca explained. "[I was] one little peek away. One little technique standpoint or mental standpoint away from winning those matches.

"I knew that if I figured it out before the NCAA tournament that I was going to be able to make a run

Following a narrow overtime loss to Nebraska's No. 3 Liam Cronin (3-1) in the quarterfinals, he continued to fight back. Ventresca nabbed his third top-11 win in the consolation blood round over Wisconsin's No. 9 Eric Barnett (3-1) to secure his All-American finish.

After falling to Arizona State's No. 10 Brandon Courtney (4-2) in the consolation quarterfinals, the New

tournament with a win against West Virginia's No. 28 Killian Cardinale (7-6) in the seventh place match.

His 20-point jump from the No. 27 seed to his seventh place finish was one of the biggest leaps in the entire tournament — proof that he'll be a threat at 125 for years to come.

"It was a great feeling," Ventresca said. "I felt like there was a lot of shenanigans going on at the end of the year with who was starting [at 125] and people obviously didn't know what was going on in the room or anything. It was a good feeling. That blood round match, obviously I was a little nervous for it, who wouldn't be nervous for it. It's kind of do or die in that match and when that last buzzer rang and the whistle blew, I just had this big smile on my face. It was more of a relieving feeling."

Henson faced early adversity in his

first NCAA tournament as well.

The ACC freshman of the year was knocked out of the championship bracket in the second round by Indiana's No. 20 Graham Rooks (5-4). The upset loss meant he needed threestraight wins to earn All-American honors.

Already being lauded as a favorite to finish in the top eight at 149 pounds before his first bout in Tulsa, the true freshman never wavered despite the initial hurdle.

"Pressure makes diamonds," Henson said. "I embrace it. It's another part of the tournament that's going to come with years to come. So having that pressure and those expectations, it's something I already have for myself." Henson grinded out an overtime

win over Central Michigan's No. 19 Johnny Lovett (5-3) in the second round of the consolation bracket, before besting Penn's No. 11 Doug Zapf (3-2) a round later. Facing his first top ten opponent

of the tournament, he handled Northwestern's No. 7 Thomas Yahya (7-2) in the consolation blood round to clinch an All-American finish in his first collegiate season.

"Just not having fear," Henson explained his mindset during the clutch run. "Allow my mind and body to do what I've worked so hard [for], just wrestle." Henson lost to Penn State's No. 12

Shane Van Ness (5-3) in the consolation semifinals, but dominated Iowa's No. 8 Max Murin (12-3) in the fifth place match to finish in the top five at 149. With a year of starting experience

under their belts, Henson and Ventresca will be even more prepared heading into next season — and both are on a mission to ascend to new heights in 2024.

"I'll go back and watch some film and then get to work in the offseason," Ventresca said. "I didn't win [the national championship], so there's obviously places for me to improve. So that's our mentality over the next year.'


