New River Health District warns of rabies concerns

The New River Health District is warning the public about rabies concerns in the health district.

Two foxes testing positive for rabies have been found in the same general area of Christiansburg within the past 10 days, marking the fifth laboratory confirmed case of animal rabies in Montgomery County and the twelfth in the New River Health District this year. In May, the City of Radford notified residents a raccoon in Radford tested positive for the rabies

"On Aug. 5, 2023, a fox testing positive for rabies was found in a neighborhood around Blake Drive in Christiansburg,' the NRHD stated. "This is the second confirmed case of animal rabies in Christiansburg within the past week. A few days prior, another fox testing positive for rabies was located in a neighborhood around Dunlap Drive in Christiansburg. In each incident a person was reportedly exposed to the animal."

The New River Health District asks anyone who may have come into contact with either of the foxes in or around the area of Blake Drive or Dunlap Drive to call the Montgomery County Health Department at 540-585-3300.

Due to the relative proximity and timing of these cases within Christiansburg, the New River Health District wants to remind everyone, and especially pet owners, of the risks of rabies.

Rabies is a deadly disease caused by a virus that attacks the nervous system. It is almost always fatal, unless preventive treatment is administered before symptoms develop.

"Ît is important to keep your pets properly vaccinated and to seek medical attention promptly if you or your pet are exposed," said Dr. Noelle Bissell, director for the New River Health District.

Steppin' Out celebrated 42 years, but some may remember the event as Deadwood Days

Every summer, around the first week of August, the streets of Blacksburg are filled with festivalgoers to partake in the entertainment, vendors, crafts, food, and drink of Steppin' Out, but many people do not know that the event was once called the Deadwood Days Summer Festival.

Stop in and visit with John Kline of John's Cameras and Vinyl Records at 213 Draper Road NW in Blacksburg and he can tell the story of a time in the 70s when the event looked a lot different than today. How does he know? Kline has been a Blacksburg business owner since the beginning of the festival in 1976. He even has the posters to prove it.

"In the summer of '76 it was pretty slow, I mean like real slow," Kline said. "Deadwood, South Dakota had a party a mile long, a parade, so we became the sister city to Deadwood, South Dakota."

According to Kline, the Blacksburg Town Council met during that time and decided to bring in business with the creation of Deadwood Days, mirroring the

CHRISTIANSBURG Residents against a conditional use permit requested by DAJ Ventures LLC's to allow 21 townhouses in during Christiansburg Tuesday's town council meeting. The townhomes would

During the August 8 Christiansburg Town Council meeting, Justin St. Clair, Assistant Engineering Director, presented an update on funding programs and capital Council member Johana Hicks asked

for further information on the Cambria Connector project and if public hearings had been conducted prior to applying for funding to pay for the project.

A petition presented in a previous council meeting with over 200 citizen signatures requested Council to not seek funding from VDOT for a road that would connect Route

continuing program of providing support to local schools' need for clothing and supplies, the Kiwanis Club of Christiansburg delivered a Walmart gift card to Falling Branch Elementary.

the Planning Commission had included the townhome developers to add dumpsters from one to two and with an additional recycling bin. Balzer and Associates has made these adjustments to their waste facilities.

Council member Johana requested further information from Semones on the proximity of the proposed townhomes to the car wash.

"Is there anything that's going to be covering the backs of those townhomes?" Hicks said.

"There would be landscaping that would go across, we don't have that specified yet," Semones said.

Hicks also asked about the neighboring Headstart preschool building, and how busy the street can be at times when the school is open.

"They are not supposed to be parking on this property, but we understand from some of the neighbors that they park... along the street to drop the kids off, but again, that is not part of this project," Semones said.

Norma-Jean Landis spoke on behalf of her mother who lives very close to the proposed DAJ townhome project. Both mother

and daughter are opposed to the construction of the townhomes based on the proximity, but also the size of project.

"The DAJ Ventures application to build 21, let that number sink in, 21 townhomes and 60 parking spaces...on a 2.149-acre lot has been adopted by the Planning Commission. I'm here to speak out against this build," Landis said.

Landis also asked if impact studies neighboring on residential areas surrounding the townhomes had been completed.

Another Montgomery Street resident, John Dunning, also urged the Council to reject the permission to build 21 townhomes on the lot located near his residence.

"I would like to share why I bought a house in Christiansburg in 1999," Dunning said. "The lady selling the homes [said] this is a great place for a kid to ride a bicycle."

Dunning recommended building single-family small homes in the location versus a townhome complex.

"I highly encourage you to think of it as a citizen side, not just think of it as this is going to bring revenue to the town. It

will bring revenue to the town, but I don't think it's long-term revenue," Dunning said. "Build generational wealth."

Barbara Early also spoke against the project as a long-time resident of the neighborhood near the proposed townhome

We bought our retirement home in the '80s that was built by Robert Gearheart that used to work in this town," Early said. "We pay our taxes and pay our taxes on time. We are natives of this area, and we are very much against this project because it affects our property."

and cats four months of age and older be vaccinated for rabies by a licensed veterinarian, and that vaccinations be kept current.

Additional steps to protect against rabies exposure:

Do not feed stray animals. Avoid wild animals, especially raccoons, bats, foxes and skunks. Feed your pets indoors and do not let them wander.

Make sure your pets are vaccinated against rabies and their shots are up to date. By law, all dogs, cats and ferrets must be vaccinated against rabies.

Teach children to avoid contact with wild animals and pets they are not familiar with.

Do not handle sick, injured or dead

Keep wild animals out of homes by

capping chimneys with screens and blocking openings in attics, cellars and porches. Ensure trash cans have tight fitting lids.

Do not try to trap or handle stray and

If you are bitten by a wild or stray animal, do not panic. Wash the wound(s) thoroughly with warm soapy water and contact animal control,

your doctor or the Montgomery County Health Department for further

recommendations.

"So, right now we have revenue sharing and transportation alternatives and the highway safety improvement program funding process where we would apply for those projects, deliver different information to them. Some of those are competitive scoring. Some of those are just a pool of money that's distributed kind of evenly across the Commonwealth," St. Clair said.

St. Clair also stated that the even years are the bigger projects like the Smart Scale program, which is the program that would pay for the Cambria Connector project and are one hundred percent approved by the state.

One safety improvement that residences may notice is the replacement of stoplight signal backplates. They will be highly reflective, instead of the black backplate previously used, and will be a safety improvement for drivers, St.

Clair said.

The bridge local drivers use when turning on Depot Street from Roanoke Street has also received one hundred percent funding for replacement. This project that would have had a price tag of over five million dollars will not need any funding from the town of Christiansburg.

In other Council business, Hicks made a movement to approve items on the consent agenda. This included an awarded contract to Boxley Materials Company in the amount of \$731,290.25 for construction of the primary extension paving of Roanoke Street and Peppers Ferry Road. The contract was approved unanimously by the Council.

We had Associate Press, we gave Willard Scott on The Today Show a t-shirt, Deadwood Days. Everyone dressed up in cowboy outfits; it was a bit wilder, I mean a lot wilder," Kline said.

Previously, Kline also owned a store across the street from his current location on Draper Road that was called DaVinci's Attic that had a variety of


I took a big weather balloon, filled it full of helium. I put a Deadwood Days poster on it and let it go up, well we had it tethered, and it crossed over Main Street," Kline said.

That night, Kline and friends took the same balloon and sent it up untethered with glow lights attached, appearing much like a UFO in the sky, causing quite a stir with the people viewing the night sky. The balloon was tracked all the way to West Virginia, Kline said.

"Steppin' Out has been going for 42 years but they didn't have it in '80," Kline said.

According to a Roanoke Times article published on July 9, 1980, in Virginia Tech's Special Collections and University Archives, Blacksburg Town Council voted 5-1 rejecting the festival's request to hold the event that year.

The original Deadwood Days in South Dakota was held in remembrance of the shooting of Wild Bill Hickok, a famous gunfighter and outlaw on the western frontier. The Blacksburg Deadwood Days began to resemble the wild west when the event increasingly became a place of lawlessness and out of control partying resulting in numerous arrests, the

article said. When a local teenager was shot and killed after leaving the festival, the 1980 Deadwood Days Summer Festival was canceled.

In 1981, the family friendly Steppin' Out festival began after local merchants got together to change the face of the event. This August, Steppin' Out 2023 hosted thousands of visitors and over 200 vendors according to Downtown Blacksburg, Inc., the organizer, and host of

Parker urged Council to let the history of the historical importance of African American culture in Blacksburg speak for itself without interpretation. "Maybe if we let history speak

for itself, we will question why we immortalize these slave-owners, these native killers," Parker said. "It may...even reveal some conflicts of interest in the present. Like how the same bank started by Alexander Black shared the same president and director as the Blacksburg Museum and Cultural Foundation up until 2017," Parker said. Brandy Faulkner of Blacksburg

represented the New River Valley chapter of Virginia Organizing, a non-profit organization. According to the organization's

website at www.virginia-organizing. org, their mission is to "challenge injustice by empowering people in local communities to address issues that affect the quality of their lives.' Faulkner stressed the need

for Council to consider how not supporting the restoration and maintenance of a historical location would negatively impact the communities of Blacksburg. Additionally, she expressed concern for the previously mentioned harassment of board members based on gender and race. Among other obligations the

Council has to the historic location its associated supporters, Faulkner said, "to take seriously the allegations of harassment and inequity and mistreatment from employees, current or past of an organization that you help to fund."

In other business, Blacksburg Town Council has scheduled a public hearing for September 12, 2023, concerning Ordinance 2023. This ordinance, if approved, would authorize the lease space on the North Main Street water tank to New River Valley Unwired Ventures,

A public hearing for Conditional Use Permit Request (CUP 23-0003) for Hotel Use and additional height in the Downtown Commercial Zoning District at 501 South Main Street has been postponed. The Blacksburg Town Council

voted unanimously in approval of Ordinance 2025, vacating a waterline easement on land located at 615 Southgate Drive, situated on Virgina Tech property. Town Attorney Larry Spencer

introduced Ordinance 2025 during the public hearing segment of the council meeting on Ordinance "They're constructing a new

hangar and they need to vacate part of this easement to facilitate construction of the new hangar. They can't build the hangar on top of an easement," Spencer said. Citizens did not come forward to

address the ordinance. also Spencer introduced

Ordinance 2016, which proposes to amend Westview Cemetery Rules and Regulations to establish green burials along with a fee structure. Linda Plaut of Blacksburg

responded in support of the ordinance that would permit green burials in Blacksburg. Plaut serves as the Secretary of the Funeral Consumers Alliance of the Virginia Blue Ridge and shared a personal story with the Council about a recent green burial of a friend.

"It was an honor to be part of the internment ceremony. Just standing around with a small group of friends, talking about our loved one and tossing flowers on the grave before he was lowered in a very simple shroud" Plaut said. "It was a beautiful ceremony, but we had to drive an hour to get to the nearest place that we could do this and there was expense involved."


Blacksburg Town Council voted 6-0 in approval of Ordinance 2016, with Mayor Leslie Hager-Smith absent from the meeting.

Ordinance 2029: Ordinance to Amend Town Code Sections 7-100, 7-103, 7-104, 7-105, 7-108 and 7-109 Pertaining to the Town Cemetery, were approved 6-0 by Town Council.

"The Town Code has a chapter that addresses Westview Cemetery and is part of updating the Rules and Regulations which are separate" Spencer said.

The Town Attorney went on to

say that although he has made some changes in adherence to the rules and regulations for green burial, this chapter has not been looked at for some time, meaning there are outdated provisions that should be corrected. However, Spencer said these are minor changes that need to happen.

Virginia's infamous hitchhiker is on the move again: the spotted lanternfly.

These insects colonize quickly, disrupt native ecosystems, and potentially cause problems to human health and agriculture.

College Agriculture and Life Sciences and Department Entomology at Virginia Tech and the Virginia Department of Agriculture and Consumer Services have partnered to empower the citizens of the commonwealth to take action themselves on these most unwelcome visitors.

"We need to prevent spotted lanternfly from going somewhere else and becoming a problem. Make sure it does not move on vehicles or plants

and remove and squish any you find," said Eric Day, manager of the Insect ID Lab in the Department of Entomology.

If seen, join the effort by stomping, treating, and checking for this destructive, invasive insect. Cooperative Virginia Extension has resources for controlling the spotted lanternfly.

Before you move items stored outside, check for spotted lanternflies on:

- ATVs, RVs, boats, hunting stands, trailers, and portable buildings
- materials and stones
- machinery







EDDIE BUTLER Baseball | 2010-12

There is no disputing that Butler was one of the most talented players to ever don the Radford Baseball uniform. The righty was a two-time All-Big South selection and was voted as the Big South and VaSID Pitcher of the

Year in 2012 after the school's single-season ERA record. He ranks second in program history for career wins (22), third for career shutouts (3), fourth for career strikeouts (232), seventh for career starts (43) and eighth for career ERA (3.84). Butler went on to become the first player in Big South history to be drafted in the first round of the Major League Baseball First Year Player Draft, going 46th overall to the Colorado Rockies. Softball program, Dean cemented himself as one of the greatest coaches ever to represent the Highlanders. His teams achieved an overall record of 241-116 (.675), including an 84-21 (.800) in the Big South Conference, making Radford the winningest program in the state of Virginia from 2006-09.
