## **BOS approves Prices Fork** Road property amendment

Senior Planner Justin presented Sanders information at a public hearing during the Monday, Feb. 12 Montgomery County Board of Supervisors addressing meeting a request for Shah Development, LLC to amend proffered conditions of the approved rezoning at 3966 Prices Fork Road in the Prices Fork Village.

The proffered list amendment will give flexibility to business uses for the property owner compared to the prior auto repair business (M&M Tire) that was only permitted there previously.

According to Sanders, most of the surrounding properties are either zoned

A1 Agricultural or Planned Development Unit Residential, but there is also an R1 Residential area for Sterling Manor subdivision. The property is the previous site of the M&M Tire business and was rezoned to Community Business in 2019.

The original nature of the business that was located at the site allowed for automotive service uses without the availability of the sale of motor fuel.

"The applicant does not currently have an identified use for the property, and they are looking again for that flexibility to determine a future use and market the site accordingly," "They Sanders said. have proffered a list of potential uses that would be allowed by-right. The applicant also proposes

additional proffers to address concerns about that future development of the parcel."

Additional landscaping, aesthetics, and signage are also included in the proposal. Buffering would be required between the proposed property and nearby residential zoned parcels. Land use goals for this area do suggest the promotion of expansion, Sanders said as part of the Comprehensive Plan.

Sanders also said that the property would meet several policy goals for the Prices Fork Village Plan; including but not limited to meeting requirements for signage, tree placement and vegetative buffer zones.

Further policies and regulations involving environmental issues,

Board of Supervisors meeting

VDOT updates given at

Virginia Department of Transportation (VDOT) Resident Engineer David Clarke addressed the Montgomery Board of Supervisors with an update on county transportation maintenance and projects at the board meeting Monday, Feb. 12.

Clarke said some projects have been met with satisfaction while others are still a matter of concern.

According to Clarke, recent immediate concerns for VDOT have focused on weather-related events such as snow and rain, filling in potholes on paved and unpaved roads, and adding stone to roads where needed.

For future discussion, Clarke also mentioned the time is drawing near for the six-year plan and associated public hearing.

"We were going to set that for April 8th, if it agrees with everyone that works out at a good time," Clarke said.

A few board members requested additional information on road or other transportation projects in their representative districts.

Supervisor Sara Bohn requested an update on Mill Point Road, to which Clarke responded that this project has

been completed. Clarke added VDOT had spoken with a resident in that area following recent rains and "the drainage has worked out well."

Supervisor Todd King requested an update on the Union Valley and Route 8 review due to concerns of congestion and accidents.

According to Clarke the review has been completed and no recommendations have been made at this time to make changes to the area.

"Have they been out there in the mornings when kids are trying to get to school?" King asked.

"Will you request that they go out there in the morning?"

Clarke did not know what time of day the study was completed but said he would look into it.

King also requested additional information on a large pothole located at the intersection of Tyler Road and Stanley Road.

Clarke said VDOT is looking at

# Virginia State Police investigating fatal Mongomery Co. crash

MONTGOMERY Co. – The Virginia State Police is investigating a two-vehicle crash which resulted in a fatality on Route 11 on Monday.

The crash occurred at 2:20 p.m. on Route 11, one mile south of Plum Creek Road in Montgomery County.

A 2010 Chevrolet Impala was traveling south on Route 11, when the vehicle crossed the centerline and struck a 2016 Ford F-150 head-on.

The driver of the Ford was identified as Jesse Allen Jones, 29, of Floyd. Jones was not wearing his seatbelt and died at the scene. The Chevrolet was driven by Richard S. Helm, 41,

of Shawsville. Helm was not wearing his seatbelt and was transported to the hospital for injuries received in the crash.

Charges are pending. The Virginia State Police Crash Reconstruction Team assisted with the crash. The crash remains under investigation.

## Blacksburg Town Council approves amendment civil penalties for trash violations

BLACKSBURG - The Blacksburg Town Council approved amendments to the town code establishing civil penalties for certain trash violations with a unanimous vote at its regular meeting Tuesday, Feb. 13.

According to Ordinance 2038, trash could include "abandoned personal property, garbage, refuse, litter or debris openly lying on any parcel, which might endanger the health of residents of the town.

Section 14-201 specifies it is the

it's a maximum fine of \$50," Spencer said. "It just fills a little bit of a gap in our current processes."

Council members also unanimously approved an amendment to Ordinance 2040 establishing the new Section 17-315 prohibiting overcrowding in buildings. This in conjunction with the fire code already in place and allows that any event, restaurant, bar or other establishment, upon discovery of an overcrowded situation, can be stopped by fire authorities or their representatives until the situation is corrected. According to the ordinance, this type of violation is classified as a Class One Misdemeanor.

In 2016, Sands – now in his ninth year as Virginia Tech's president - published his "Beyond Boundaries: A 2047 vision" document that serves as a long-term vision for the university. In 2019, he and his staff released a complete version of a strategic plan that includes four priorities: advancing regional, national, '2024 will be a significant and global impact; elevating the Ut Prosim difference; being a destination for talent; and ensuring institutional excellence.

Affordability a concern

In light of the rising cost of tuition nationwide, Virginia Tech officials launched Virginia Tech Advantage in mid-October. The multiyear \$500 million fundraising initiative serves as the university's commitment to offer a broad educational experience to undergraduate students from Virginia who experience provides our have financial need.

The initiative is designed to increase scholarship dollars for in-state students, provide basic support for unmet needs, help with career preparation, and be used to offer transformational learning experiences.

More than 5,500 Virginia Tech undergraduate students who hail from Virginia have demonstrated financial needs. The money from Virginia Tech Advantage will be used to close the gap between the cost of attending Virginia Tech and students' abilities to contribute their own resources.

Sands said the gap between student financial need and the aid and support currently provided by Virginia Tech is approximately \$52 million annually.

"During the last decade, we have been successful in improving access for students who might not otherwise have chosen Virginia Tech, but we know that access alone is not enough to ensure success," Sands said. "Students who lack generational wealth often miss out on broader educational opportunities. They work 20 or more hours per week in jobs unrelated to their studies and

take on oppressive debt just to remain in school. They don't develop the workplace skills and networks that are strong predictors of a successful launch after graduation.

"The full Virginia Tech graduates with opportunities to begin a fulfilling career with the skills and networks needed to succeed and without the heavy burden of excessive student loan debt."

Sands said in addition to raising \$500 million to address affordability, the university plans to incorporate paid internships other and "bridge' experiences into every degree program.

Virginia Tech Global Distinction

Sands' other top strategic priority, Virginia Tech Global Distinction, centers on the university's commitment to elevate the international prominence of the institution and strengthen our capacity to act as a force for positive change.

Sands and other university leaders aspire to see the university ranked among the top 100 global universities and the top 10 U.S. public land-grant universities in the Times Higher Education World University Rankings. Times Higher Education is a publication that focuses on higher education issues.

The publication releases its World University Rankings each fall, and Virginia Tech was ranked in the 251-300 band in last fall's rankings -17th among U.S. public landgrant universities.

"To grow our global reputation and impact, we are focused on enhancing the impact of scholarship; extramural funding; faculty awards, fellowships, and memberships; and doctoral education and postdoctoral associate training," Sands said. "This will be accomplished through investment in prioritized research frontiers and providing world-class shared research tools and facilities."

Executive Vice President and Provost Cyril Clarke selected the members of a steering committee to lead the university's efforts toward global distinction goals. Dan Sui, senior vice president for research and innovation, and Executive Vice Provost Don Taylor serve as co-chairs.

Sands also pointed out the growth of Virginia Tech's research enterprise - one of many metrics used by Times Higher Education when comprising its rankings. Externally sponsored research growth grew by 13.4 percent during the last fiscal year, reaching \$415 million. That surpassed the university's strategic plan milestone two years early.

"Both Virginia Tech Advantage and Virginia Tech Global Distinction share one important principle," Sands said. "Our strength is in our community and our people. Faculty, staff, and students are the university's most important assets."

Additional updates

For the fourth consecutive year, Virginia Tech set a new high for the number of first-year applications for admissions, with a total of 52,365 - an 11 percent increase from last year.

The number reflects the growing interest and reputation of the university, but Sands said that the university will be reducing the percentage of applicants accepted primarily because of limited on-campus infrastructure and limited local availability of housing.

"As we look toward the future, housing availability and affordability is one of a number of headwinds that we must address, but not alone," he said. "Now is the time for the university, the town, the county, and surrounding region to join and find a strategic path to improve our community for all. I'm pleased that progress is being made, and hopeful that, in the coming weeks, Virginia Tech and our community neighbors will be able to





Select some towns to be your cities of refuge, to which a person who has killed someone accidentally may flee. They will be places of refuge from the avenger, so that a person accused of murder may not die before he stands trial before the assembly. (Numbers 35:11,12).

God commanded that if anyone died because of violence, and murder was assumed, the murder suspect was not automatically to be considered guilty. Instead, he was allowed to flee to a city of refuge (one of six to be chosen in the Promised Land) that would assure the accused would be treated justly and justice would be done. In this way God provided justice in a culture where protecting the innocent was not a typical response.

When we hear accusations of guilt against others, our first response should be to provide them with a place of refuge in our hearts. That is, we should not rush to judgment, assume their guilt, and be careless in our speech about them. We should treat them fairly, as God intended.

Prayer for Today: Ask the Lord to make your heart and mouth a place of refuge rather than a fount of accusation for others.



this problem to find the best solution since it is a large pothole with some drainage issues.

"It will take some coordination with the house, I think they run a business out of there as well," Clarke said. "We can bring that entrance and tie it into Stanley, or continue it the way it is, leave it the way it is, but that gives us two entrances off of Tyler Road which is kind of awkward."

Lastly, King requested an update on the drainpipe located on Poff School Road in Riner. Clarke confirmed VDOT has looked at the condition, but he has not received an update yet.

Vice Chair Steve Fijalkowski asked Clarke for an update on Craig

announce a plan for a productive dialogue to heighten our understanding of needs and develop a path to address our shared goals."

Among other updates, Sands announced that the first building of Virginia Tech's Innovation Campus in Alexandria, Virginia, is scheduled to open next year. Innovation Campus' academic programs opened in fall 2020, and now, 376 master's degree-seeking students are enrolled in computer science and computer engineering.

In addition, among facilities projects, Hitt Hall, Perry Place Dining Hall, the Undergraduate Science Laboratory Building, the War Memorial Gym renovations, the elevators next to Derring Hall, and the Multi-Modal Transit Facility all will be complete by this fall.

Also of note, Sands highlighted the growing relationship between Virginia Tech and Botswana, a nation in southern Africa. As part of a project spearheaded by Kathleen Alexander, the William E. Mountain Road study that is ongoing.

"Yes, that came back. I believe there was no recommendation for a speed change on that," Clarke said. "I'll doublecheck and make sure I have the documentation on that, and we'll get in contact with the citizen that requested it."

Fijalkowski also discussed a previous citizen request for a crossover at Cove Hollow Road.

"A citizen makes a good case that it could possibly be safer to have one there," Fijalkowski said. "I'm not sure, I know traffic flies pretty quickly down through that stretch." Designing for а

previously approved intersection at Alleghany Springs and Route 460 in Shawsville has begun, according to Clarke. As of now, Clarke does not think a date has been set for construction.

'That will definitely be welcomed there, Fijalkowski said. "I think the only turn lane that's there is on the westbound side and is about 20 feet long, maybe."

Clarke welcomed the new board members with an invitation to reach out to his office with any questions or concerns. He said there is a manual for Board of Supervisors, of which he would try to get copies to them. The manual lays out processes, information on the sixyear plan, and other important information, which is also available on the VDOT website.

stormwater runoff and transportation would be reviewed later once the use of the property is specified.

The Planning Commission recommended approval of the site with the property by-right uses being limited to those listed in the proposal and shall remained zoned as Commercial Business.

Supervisor Todd King requested clarification on the current use of the property being limited to an auto repair shop if the amended proffered list proposed by the applicant did not receive approval.

"That's correct, so the existing proffer states that it could be an automobile repair shop without motor fuel sales in a building that is 2,000 square feet or less," Sanders said.

Engineer John Neal from Foresight Design Services presented additional information to the board.

"Just to point out, we are talking about 1.5 acres of land," Neal said. "The intent, when we went through the rezoning, to Community Business from Agriculture, with M&M Tire operating as a community business for 20-plus years, when it was zoned agriculture, we did it to kind of keep things in line with what M&M was doing there. And the intent was that M&M would operate there for as long as they intended, and then unfortunately, they

moved on," Neal said. "So, Mr. Hagan had an opportunity to purchase the property and with our preserve, Walnut Springs, behind it, we thought it was wise to do that.

Neal also said there is a buffer of approximately 25 feet to the rear of the parcel and with an additional 50 feet of common space associated with the preserve, there is a total of approximately 75 feet allotted as a buffer to the nearest residential property.

At this time, VDOT is taking no exception to the proposed property, but a traffic analysis might be required once a determination of the property use is made.

Carol Hoge of Walnut

Springs, Blacksburg addressed the board during the public comment session of the meeting. Hoge and her family were previous owners of the property and still own an adjacent farm to the rear of the proposed commercial business site.

"My main concern is, we have a man-made pond that adjoins the property line that they're developing and it's an absolutely beautiful pond," Hogue said. "At the closing, we were asked by Shah Development if we would sign an addendum allowing them to have a water runoff or something... into our pond from their development. The lawyer told us that if we signed it,

we had nothing to worry about because the County would monitor this. Now, the construction has begun. I don't know if the County has done any monitoring, but every time it rains, our pond is filled with mud and runoff from the minimal amount of construction that has started."

Hogue also said that she has lived on the property since 1977 and the pond has never overflowed, but recently water has exceeded the pond's boundaries. There is a cottage that she uses as a rental located near the pond as well. In total, Hogue says that she has 300 acres of land now in conservation and has been in her family since the mid-1800s.

Supervisor Derek Kitts made a motion on the proffer amendment, suggesting the Prices Fork Road parcel proffer amendment to be moved to the next meeting on March 11, 2024. Kitts suggested that in light of the citizen's response, more opportunity for discussion may be necessary.

April Supervisor DeMotts agreed a delay on the amendment vote is understandable, but regrets it is also a delay to the applicant.

Supervisor Sara Bohn questioned if the neighboring landowner Hogue's statements are related to the amendment being discussed before the board. Kitts then withdrew his request to delay the vote.

The Prices Fork Road proffered amendment was passed unanimously by the board.

Virginia Tech shortstop Rachel Castine has been named the ACC Player of the Week, the league announced Tuesday morning. The junior earns the award for the first time in her career after leading the Hokies at the plate last week.

Castine led Tech offensively over the five games played, hitting a .583 batting average with 13 RBIs and four home runs, two of those being grand slams. The junior individually recorded more RBIs than any other team in the tournament. Belmont had eight RBIs, Illinois recorded 10, and Auburn put up 12.

In last week's opener win against Illinois, Castine went 2-for-2 with a grand slam, the Hokies' first home run of the season. She then hit her second grand slam of the day to put the Hokies up 8-1 in the extra inning victory against No. 20 Auburn.

with NC State at No. 6. Virginia Tech is No. 12, Notre Dame is No. 16, Louisville is No. 18 and Syracuse is No. 19. Duke and North Carolina are receiving votes.

The 2024 Ally ACC Women's Basketball Tournament will mark the 47th edition of the nation's longest running women's basketball conference championship. It will mark the 24th time in the last 25 years the Greensboro Coliseum has hosted the event.

Nine different ACC institutions have combined for 23 trips to the Women's Final Four, with 2023 ACC Tournament Champion Virginia Tech making its first-ever appearance a season ago. ACC teams have made five trips to the Final Four in the last five seasons. Over those five seasons, 40 teams have earned a spot in the NCAA Tournament, the most among all conferences. Since 2014, the ACC has combined for 119 NCAA Tournament wins, the next closest conference has just 105.

## CC announces championship locations

On Thursday, Feb. 8, the Atlantic Coast Conference announced Charlotte, Greensboro, Cary, Durham and Raleigh will play host to numerous future neutral site conference championships as approved by the league's membership.

Half of the conference's 28 sponsored sports are named, including the ACC Women's Basketball Championship and ACC Men's Basketball Championship, as well as Olympic Sports, including baseball, women's golf, gymnastics, men's and women's lacrosse, men's and women's soccer, men's and women's swimming and diving, rowing, and men's and women's tennis.

As was announced in April 2018, the ACC's Football Championship Game is scheduled to be played on the first Saturday in December at Bank of America Stadium through 2030.

"We are incredibly proud to announce this tremendous package of neutral site championships that will be held in the State of North Carolina, where the league was founded more than 70 years ago,"

said ACC Commissioner Jim Phillips, Ph.D. "Each of these outstanding cities and venues will provide a firstclass experience for our student-athletes, coaches, institutions, alumni and fans over the next seven years. We are also pleased to have been able to deliver so quickly on our commitment to continue to hold numerous tournaments and championships in cities across the State of North Carolina as part of the ACC Board of Directors' decision to relocate the conference office headquarters to

Charlotte."

TheACCMen's Basketball Tournament will take place in North Carolina for five consecutive years from 2025 to 2029. The historical postseason tournament will alternate years, taking place at the Spectrum Center in Charlotte in 2025, 2026, and 2028, and at the Greensboro Coliseum in 2027 and 2029. No venue has hosted the ACC Men's Basketball Tournament more than the Greensboro

## DeMartini embraces leadership role

As the 2024 baseball season nears, Virginia Tech third baseman Carson DeMartini has been steadily tabbed for his talent and grit on the diamond. The junior from Virginia Beach, Virginia, was praised as D1Baseball's No. 3 third baseman in the outlet's 2024 Preseason Player Rankings, has garnered 2024 Preseason All-American consideration from three leading outlets (D1Baseball, NCBWA,

Perfect Game) and ranks as the No. 43 overall prospect for the 2024 MLB Draft per mlb.com.

"It's the body of work that I put in," DeMartini said. "I've been working at this game since I was two years old. It's something that I've always done well. I've always worked my butt off at it."

During his sophomore 2023 season, DeMartini started 52 games, batted .323, had an on-base

percentage of .455 and boasted a .947 fielding percentage at third base. After sustaining a midseason injury that kept him from playing the field, he transitioned into the role of the Hokies' designated hitter, hitting triples during each of his next two games in the heart of Tech's lineup.

Back at full health in 2024, DeMartini has added a new role to his repertoire, one he has not truly held with the Hokies

until now – leadership. This offseason, Tech welcomed 24 newcomers and 13 true freshmen, leaving many new faces to integrate into the clubhouse.

"I think I'm one of the leaders on the team," DeMartini said. "I think that's fair to say. I feel like I've earned that role, both vocally and by how I carry myself. Throughout [my] years it has built [up], and this year is the climax of that role."

seasoned veteran with the Hokies, having started all but two of the team's 112 games since arriving as a freshman in 2022. As a rookie, he slugged .659 on Tech's 2022 NCAA Blacksburg Super Regional team, hammering 15 home runs while totaling 50 RBIs.

This season, DeMartini anchors the infield alongside a core group of returners

who are poised to lead the Hokies to the program's first Men's College World Series appearance.

"I think it's huge having returning guys in every spot on the infield," DeMartini said. "We all know what to expect with the season. It's a lot. The game moves fast and it's tough to worry about everything else and still play well. I think we're able to loosen [the newcomers] up a little bit and in turn, they are able to have a better season."

Attitude and skill form the foundation to any third baseman, especially in DeMartini's case. His day-in, day-out demeanor helps him emerge as a player who can lead this 2024 team and he is prepared to do so. Virginia Tech baseball begins its 2024 campaign on Friday, Feb. 16, at Charlotte. Following a midweek away game at James Madison on Wednesday, Feb. 21, the Hokies will debut at English Field at Atlantic Union Bank Park on Friday, Feb. 23, against Rhode Island.

Starting this spring, the baseball conference championship will be hosted at Truist Field in Charlotte in 2024, 2026, and 2028, while Durham and the Durham Bulls Athletic Park will
